GLUM and confident of their decisions Saturday, Texas voters view with unusual silence the first Democratic primary, despite the last minute appeals of candidates prancing in their paddocks. From state governor to the office of justice of the peace, candidates have waged a vigerous campaign in the first peace-time election in six years. Many office-seekers have already announced that they have closed their campaigns and are awaiting the important pencil-markings which will add or subtract from their chances of election. Some observers believe the state will cast a record vote. Voters have been reluctant to express


Two REA Lines are Approved
