

Drys Win With Almost Three-to-One Victory

MOTLEY county is dry, politically. In fact Motley county is so dry, politically, that it probably set a record Saturday's local option election, in asserting its position among the arid counties of Texas.

Of the possible 1,400 voters in the county, 923 went to the seven voting boxes and buried "distilled spirits" under an avalanche of 669 dry votes. When all boxes were in it was found that 254 voters designated their ballots to indicate that they

were "against prohibition." Observers declare the vote usually large. Matador's two boxes polled 516 votes, with 350 drys and 166 wets. Roaring Springs was the driest box in the county with the drys polling more than five to one, or 159 for

prohibition and 31 wets. Single exception to the county's trend was remote Northfield in the extreme northeast corner of the county. Northfield went wet, with 17 drys and 22 wets. Whiteflat was more than four

to one on the dry side, with 61 drys and 15 wets. Union Corner polled seven votes and five of them were dry, two wet. The signal victory is attributed to churches in the county which were united in their campaign to defeat the possibility of

the intoxicating beverages being sold legally. The election was called through a petition circulated among church members, when it was disclosed that an appealed liquor violation case might result in the county being declared "wet". An old local

option election held in 1893 may be declared illegal because of irregularities when the case is brought before the Texas Court of Criminal Appeals. Regardless of the outcome of the case, Motley county is legally dry.

They frequently acted as a but later tied the mare and ate enough for two or three average hungry men.

Perhaps the incubency of modern living has pressed my attitude of appreciation into a grotesque shape, with the asperity of convenience causing my memory to molt some of the sharper qualities. Frequently, however, when I see copious quantities of crushed ice in beverage glasses, and attempt to satisfy my thirst, I remember my thirst as a boy. On special occasions my mother would send me to the well for a bucket of well water with which to make lemonade. It is probable that ice and flavorings might have improved its taste but not its thirst quenching quality.

SPUR—The two-year-old daughter of Mr. and Mrs. Robert M. Thompson, Jr., was drowned Tuesday afternoon and her father had a narrow escape in a rescue attempt as the family stood watching run-off waters from heavy rains at a bridge two miles southeast of town. The victim was Roberta Lynn Thompson.

The mishap occurred while the family was standing on the Blair bridge over Duck Creek, a usually dry stream. Thompson said the little girl pulled away from the family and toppled into the roaring stream.

Thompson jumped in and was swept under the narrow bridge by the current. He barely managed to swim to shore and immediately went for aid.

The child's body was found two hours later less than 20 feet from the bridge by members of the Spur Volunteer Fire department.

Lubbock Man Pays Fine After Wreck

J. B. Graham of Lubbock, driver of a Mistletoe Rapid Transit (mail) truck enroute to Lubbock, paid a \$13 fine Tuesday morning in Justice of Peace Henry Pipkin's court, after his vehicle had been involved in a collision.

The accident occurred about 7:30 a. m. when Graham attempted to pass a loaded truck on a hill about four miles west of town. Near the crest of the hill, Graham's truck met a 51 Chevrolet automobile driven by J. A. Parish, 78, of Earth, Texas. Mr. Parish, in attempting to avoid a head-on collision, applied his brakes. Because of the wet pavement his car skidded into the truck and caused extensive damage to his car.

Sheriff John Stotts, who investigated the accident, filed on Graham and charged him with passing without sufficient clearance. No one was injured in the accident, which occurred on the same hill where four people lost their lives last year under similar circumstances.

Rainfall Brings Relief From Sun

Cool Wave Sweeps Out Intense Heat

REFRESHING rain in the wake of a cool front which struck this area about five o'clock Monday afternoon, has revitalized the rapidly wilting crop outlook.

Rain began falling here shortly after midnight Monday night. It started gently without wind, hail or lightning. After a few brisk showers in Matador, slow, steady rain set in and continued until about 10 o'clock Tuesday morning. Rain gauges here registered from 78-inch at the city wells, to more than one inch on private rain measures.

Roaring Springs registered from one inch to about one and one-half inches. Further south the rainfall was heavier in some places. Altho many believed the slow night rain indicated that the drought had been broken, reports Tuesday morning declared that 15 miles north the rainfall was too slight to measure. Unconfirmed reports said Northfield did not receive rain.

Cool Wave Welcomes

Almost as welcome as the rainfall was the respite from the excessive heat which had held West Texas in its grip for almost a month. Mercury dropped rapidly after the mass of cool air struck and many who had been seeking to evade the blistering sun and wind in the afternoon, were seeking "wraps" by nightfall. Air-conditioners were shut off Tuesday as cool and cloudy weather continued.

Cotton and other row crops which have "held up" exceptionally well will benefit most from the cool weather and moisture. Range conditions will also be improved, stockmen declare.

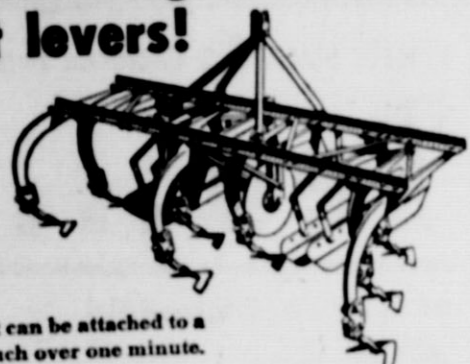

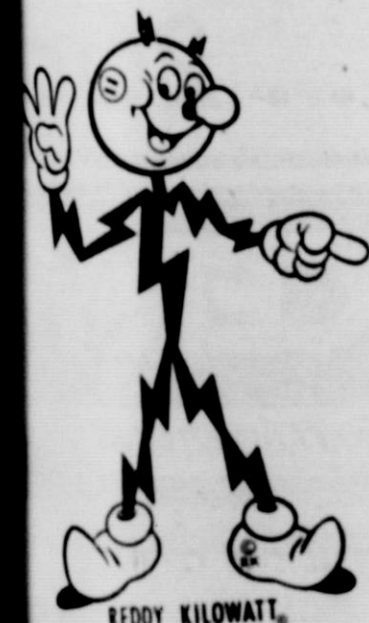

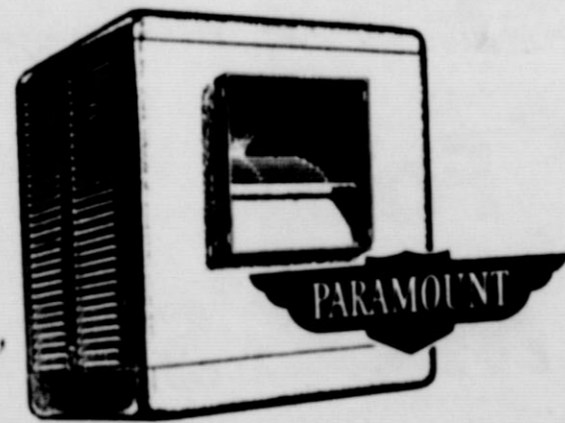

to push through the Legislature and I do not intend to change a bunch of things because they do not suit me, personally. After all, this is your job, you give the orders as to what you want done and it is the sacred duty of your State Representative to carry out your orders and not to carry a personal legislative program. I make only one promise and that is this: Let me be your hired hand in Austin during the next term of the Legislature and tell me what you want done, and I will do my utmost to carry out your orders as I have always done in every job I have ever had, because I will be representing you.

"I moved to Turkey with my parents when I was eight years old and lived there until I entered the army in March 1942. After serving for a short time with the 90th Division, I received a disability discharge. I went to Amarillo where I was employed by the Pantex Ordnance plant in the timekeeping and general auditing departments, until the end of the war. After the war I was employed by the Texas Employment Commission until June 15, 1951, when I became manager of the Clarendon Chamber of Commerce, which

position I still hold. I have been active in civic and service organization work for a number of years. I have been especially active in the American Legion, serving on post, district, state and national committees. I am a church member and a member of the Clarendon Lions Club."

Faulkner declared he will spend the next 15 days contacting the people of the four-county district. "There will be a number of the more than ten thousand people in this district that I will not be able to meet," he declared, "but I want them to remember me when they go to the polls and to please consider this as a personal solicitation of their vote if I should fail to meet them."

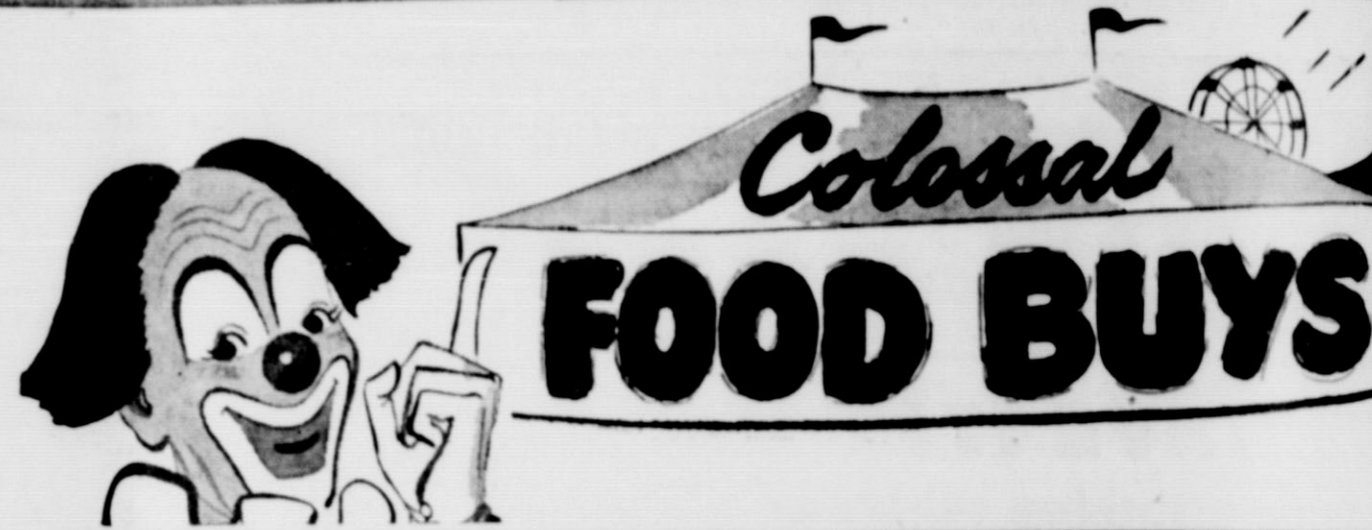
