# Commissioners remind residents that County fire ban is still in effect

Motley County is still under county. Commissioners approved payment of all bills and a burn ban. Commissioners' Court reminds the community of the extreme danger of fires that exist in our county and elsewhere. Violations are a class C misdemeanor and citations will be issued for violating this ordi-

The Court met for their regular meeting, Monday, March 13. Members of the court present were County Judge Ed D. Smith; Commissioners, Ronnie Davis, Precinct 1 Donnie Turner, Precinct 2, Franklin Jameson, Precinct 3, Russell Alexander, Precinct 4; County Clerk, Kate Hurt. Also in attendance were County Attorney Tom Edwards, and Sheriff Jim Meador.

Mrs. Hurt read the minutes from the previous meeting. Outstanding bills were reviewed, as well as reports by the Treasurer, Tax-Collector, Justice of the Peace, Library and County Agent. Judge Smith presented reports submitted by Marisue Powell for the Motley County Historical Commission and Sheriff Jim Meador for the Racial Profiling Report for Motley

all reports.

Judge Smith informed the court the Judges and Commissioners Association dues went from \$700 yearly to \$1,000. Commissioners approved the transfer of \$300 from the Insurance Risk Management Line item to the Judges and Commissioners line item to cover the increase.

The County has received the funds from the State of Texas to make payment to Hart Intercivic for the purchase of seven electronic voting machines in the amount of \$77,890,00.

The 79th Legislative Session amended section 61.005 and added section 61.0015 to the Government Code to increase juror compensation and set out the state's reimbursement to counties for juror compensation. The legislation took effect on January 1. The Government Code amendments increase jury pay of a grand juror or petit juror from \$6.00 to \$40.00 per day after the first day of service.

The state shall reimburse the county \$34.00 per day after the first day. Judge Smith made the motion to adopt a court order to juror from the second day for-

Petit Juror for the first day of service and then \$40.00 per day for every juror or perspective pay \$6.00 to a Grand Juror or ward. The court approved.



After reading and reviewing the minutes for February 9, Council asked that one correction be made to the dates of termination for Casey Lawrence. This was approved. The minutes of the February 20 meeting were also approved, as well as the minutes of March 6.

Council approved payment

The Council discussed repairs needed to the Water Tower. It was approved to request bids for the repair.

# Panhandle wildfires burn 750,000 acres Matador VFD responds to local fire calls

Gov. Rick Perry announced on Tuesday that he directed additional state resources to fight the deadly Panhandle wildfires, which have burned nearly 750,000 total acres and claimed 11 lives since Sunday. On Tuesday, six fires were burning in the "Right now we are focused

on containing the blazes, with heavy dozer crews on the ground and heavy air tankers dropping fire retardant," Perry said "We are also pre-positioning assets in preparation for the next 48 hours by bringing man-power and equipment from less threatened areas to high threat areas. We are using the largest air tankers available in the nation in this effort, and I have activated available air assets from the Texas Army National Guard - two CH-47 Chinook helicopters and two UH-60 helicopters - to fight these wildfires.

Luckily Motley County has been spared the devastation of such fires, but the Matador Fire Department has been busy answering calls, and responded to three incidents during the week

of March 6 through March 12. The first call on Monday, semi-tractor trailer at the roadside park east. 



Council asked that personnel reviews and salary raises be put on the agenda for the April 13 Council meeting.





## Fewer restrictions will lead to new advancements in transgenic crops

by Blair Fannin Texas A&M University

College Station -- Less regulation will allow public entities, including universities, to pursue more transgenic crop research, which will help reduce the number of diseases found in plants, a researcher said Wednesday.

"The impact of regulatory costs on getting a transgenic crop to the field and commercialized is very high," said Dr. Roger Beachy, president of the Danforth Plant Science Center.

With commercialization costs of \$1 million to \$50 million, most research investment is spent on high-return crops, such as cotton, corn and soybeans, Beachy said.

But the small crops that are important to Texas and California, like vegetables, they are mostly locally-grown produce and are inaccessible," he said.

Beachy was the keynote speaker at the Molecular and Environmental Plant Sciences Symposium at Texas A&M University.

This high cost for commer-cialization "prices us from par-ticipating in this sector," Beachy said. This means bacterial dis-

eases and fungi on smaller-re-turn crops will continue to be treated by chemical pesticides. "We are being hamstrung, I think, by current policies on regulation and the cost that regulation imposes," he said. "Don't get me wrong regulation "Don't get me wrong, regulation is important, but let's do it with the sense of what agriculture is

and can be, and how biotechnology can plan an important role.

'We don't want to expose the public to danger; that's not my point. My point is there are some things out there that we know are safe ... these are genes moved from one plant to another than the same other plant. There's a great op-portunity for plant biologists and biotechnologists such as those within the Texas A&M University System to contribute."

Beachy, who in the 1980s pioneered the development of virus-resistance in plants through the use of transgenic technology, continues to examine protein movement in tobacco mosaic virus.

Another area of his research is mechanisms which express viral coat proteins responsible for disease-resistance in transgenic plants.

His discoveries in the 1980s were part of an effort to combat tobacco streak virus in India's transgenic groundnuts. The disease has also affected cotton, marigolds, okra and sunflowers, he said

'It looks like this 20-year-old technology will be useful in India, and it does it in a setting where it will affect up to 20 mil-

lion farmers," he said. Beachy said his approach to studying viruses transmitted in transgenic plants is to fully understand what the pathogen

'Otherwise, you're taking a shotgun approach," he said.



#### **Farm Service Agency News** by John Bird, CED

**FSA ACCEPTING** EMERGENCY LOAN APPLICATION

Hall and Motley Counties were declared eligible for Farm Service Agency (FSA) disaster emergency loans on March 7,

Generally, that means farmers who have lost at least 30 percent of their production due to severe drought conditions, above normal temperatures, and an extremely high number of wildfires on April 1, 2005, and continuing. Proceeds from crop insurance are taken into account when determining eligi-

FSA Farm Loan Manager, Larry Goetz, is urging farmers who are interested in receiving an emergency loan to get their applications into FSA as soon as possible. Goetz said, "We hope farmers will get their applications in early rather than waiting until near the deadline which is November 7, 2006, for production and physical losses. The longer they wait, the more chance there is for long delays. If the applications come in early, we can avoid backlogs and speed up the process."

The FSA offices are located at 1002 W. Noel St. in Memphis and 700 Dundee St. in Matador. The Memphis telephone number is 806-259-3579 and the Matador number is 806-347-

PROVIDING INFORMATION TO INSURANCE

COMPANIES FSA Offices are now required to give acreage reports and maps to the producers rather than to an insurance company. Only in cases where a claim has been filed and an adjuster requests information

may we provide it. Producers will then supply their agents with the needed information.

#### **NEW LDP FORM** CCC-633 EZ

There is a new form, the CCC-633 EZ, for requesting loan deficiency payments. The new form is designed to simplify the LDP process by combining the old CCC-633 and CCC-709. The new form will be effective for 2005 and subsequent crop years.

The CCC-633 EZ is a threepage form. Page 1 is completed once per crop year for all eli-gible crops and indicates the producer's intention to receive LDP benefits. To receive an LDP benefit, the producer must complete and submit page 2 to the county office staff. Page 3 is used for cotton LDPs.

For the 2005 crop year, county offices will honor CCC-709s and CCC-633 LDP requests that have been submitted and are currently on file. Beginning with the 2006 crop year, CCC-633 EZ and eLDP online requests

The third call came about midnight the same day and extended for eight and one half hours through Monday morning. This was a mutual aid call to the Paducah VFD and was located about five miles north of Paducah. This fire involved approximately 2300 acres. The Paducah VFD was called out to several other fires on Sunday including one large fire south of Childress. Paducah resources were stretched to the limit and the Matador VFD provided much needed assistance to a neighbor.

Since Monday, aircraft have flown 133 missions and dropped more than 135,000 of fire retardant in the Panhandle. Those efforts are credited with saving about 450 homes.

In addition to the firefighting crews from Oklahoma and New Mexico who have been working in Texas since the weekend, six engine crews from New Mexico have arrived in the Panhandle. Six heavy dozer cress from Georgia, and one dozer crew and three heavy engines from South Dakota were enroute to Texas on Tuesday.

Monday night the bodies of four fire victims were found in a vehicle in Roberts County. The fires have also claimed the lives of three persons in Hutchinson County and four in Gray County. Three volunteer fire fighters from the city of Howardwick Volunteer Department in Donely County have been critically injured and being treated at the Northwest Texas Hospital in Amarillo; two are in the intensive care unit.

The Governor's Division of Emergency Management is coordinating staffing and equipment for the statewide response, while the Texas Forest Service is leading fire fighting operations from a command post at the Tradewind Aircraft Service Center in Amarillo. The Texas Department of Public Safety is continuing to provide traffic control and aerial surveillance assistance, while the Texas Department of Transportation has provided personnel, equipment and fuel.

Since Dec. 26, more than 10,365 separate wildfires in Texas have burned nearly 3.7 million acres and destroyed 397




