### Organization formed to support jail renovation project

The Motley County Historical Commission announces the formation of a new organization to support the historic preservation of the 1891 Motley County

Friends of the Historic Motley County Jail met on August 9 in the district courtroom of the Motley County Courthouse. A new 12-member board was announced, consisting of Ronald and Kay Bailey, Nell Berryman, Carol Campbell, Judy Cartwright, Ted Davey, Pat Groves, Marilynn Hicks, Roy Hobbs, Ed D. Smith, Douglas Wilson and Geneva Wilson. Officers of the board are: Carol Campbell, Chair; Ed D. Smith, Vice Chair; Marilynn Hicks, Secretary; and Roy Hobbs, Trea-

The purpose of the organization is to seek funds and provide support for the repair and renovation of the historic 1891 Motley County Jail; and to partner with the school and the community to raise awareness of the importance of preserving the past for future generations.

The group is in the process of establishing a 501 (c) 3 nonprofit agency in order to write grants to private foundations and accept donations for the purpose of the organization.

The Diekemper Family Foundation recently donated \$15,000 to the jail renovation project. In addition, local residents Keith and Joan Patton donated \$600.00. The county is submitting a grant to the Texas Historical Commission for \$30,000. The THC, Texas Preservation Trust Fund, is a dollarfor-dollar cash match grant. Donations will be used to meet the match requirement. In addition to the support from the county, other grants have been written to private foundations to help meet the match.

Market Matador accepted the donations in behalf of the new organization, until nonprofit status can be fully established. Diane Washington, CPA, has volunteered to help with the exemption paperwork. The agency should be fully formed in about 120 days.

The group discussed a "Friends in the Park" barbecue and entertainment venue as a fund-raiser. The date has not been set but is expected to beheld sometime in October in the City Park.

A tri-fold brochure was adopted by the group, and will be available at the Matador Branch bank and the Senior Citizens. Membership is available to the Community. Membership for one year is \$25.00. With membership to the Friends of the Historic Motley County Jail, members will receive a beautiful, frame-able print of the jail, and a monthly newsletter with updates on the renovation and photographs of the progress. The court agreed to have courthouse maintenance repair and painting the gazebo, preserving the murals.


Judge Smith reminded the court of the Beans and Cornbread lunch at the Library August 24. Members of the court are invited to help serve.

#### A Joyful Noise

It's interesting to notice how the Psalmist sings about God. It seems that everything he encounters about his relationship to the

ters about his relationship to the Almighty causes him to want to sing a song. In Psalm 98, he sings about God's righteousness. In Psalm 99, he sings of God's exalted place of authority. In Psalm 100, he sings of God's enduring love, which demands and deserves admiration and adoption by His people. In view of the character of God, the Psalmist will pledge his obedience (Psalm 101), expresses his dependence (Psalm 102), and speaks of his gratitude toward God for His rich blessings (Psalm 103).

Psalm 103 is particularly interesting because, as one writer put it, David constructs a "circle of praise" toward God. The center of the circle has "Bless the Lord" as its core. It is surrounded by all that blesses God: "My soul" (verses 1-6, 22), the people of God (verses 6-18), and the Heavenly Hosts (verses 19-22). And David ends where he began: "Bless the Lord, O my soul."

The Bible reminds us that we are to sing to God. It is just a natural response of the heart to sing praises to the Lord! You are not required to make beautiful noise, but only a joyful noise to the Lord. That is good news in its own right.

Spend a few minutes today singing some of your favorite spiritual songs. Sing some of the new songs we've been learning lately. Think about the words to each verse you sing. You'll have a son in your heart all day long! Go ahead, sing praises...





## **PROOF** OF THE TRUTH

THE DEAD DON'T REPRODUCE OR EVOLVE!

When considering Intelligent Design of biological systems, the most important factor is the Law of Cause and Effect. But the next most important matter is the title to this memory. This simple concept seems rational, sensible and obvious to anyone, even a child, but it appears to be beyond the comprehension of modern Darwinian Evolutionary Biologists.

It will be "deselected" and die, before its evolutionary "tree" even gets started. The rational alternative is that all living things are and were pre-programmed (designed) from the start to be what they are and

NOTICE OF AN APPLICATION FOR A WATER USE PERMIT AND PUBLIC MEETINGS

APPLICATION NO. 12151

SUMMARY. The North Texas Municipal Water District (Applicant) has applied for a Water Use Permit to construct and maintain a reservoir, known as Lower Bois d'Arc Creek Reservoir, on Lower Bois d'Arc Creek, Red River Basin, Fannin County, Texas. Applicant requests authorization to divert and use water from the reservoir for municipal, industrial, and agricultural purposes, including the right to use water within the reservoir for in-place recreational purposes. Applicant requests interbasin transfer authorization to use water from the reservoir within its service area in the Red, Sabine, and Trinity River Basins, and within Fannin County in the Sulphur River Basin. NTMWD's service area is currently located within the following counties: Collin, Dallas, Denton, Fannin, Hopkins, Hunt, Kaufman, Rains and Rockwall. Applicant requests authorization to use the bed and banks of Pilot Grove Creek and the East Fork Trinity River to transport water diverted from the reservoir for subsequent diversion and use from Lake Lavon. Applicant further seeks authorization to reuse return flows generated from the diversion and use of water from the proposed reservoir. Applicant indicates that diversions from the reservoir may overdraft the firm yield of the reservoir as part of a system operation with existing and future supplies. A total of three public meetings will be held in the Red, Sabine and Trinity River Basins. More information on the application and how to participate in the permitting process is given below.

The application was received on December 29, 2006. Additional fees and information were received on March 21, 2007, and June 13, 2007. The application was declared administratively complete and filed with the Office of the Chief Clerk on June 26, 2007. The Executive Director has not completed the technical review of the application.

PUBLIC COMMENT / PUBLIC MEETINGS. The Texas Commission on Environmental Quality (TCEQ) will hold public meetings to receive comments on the application for a Water Use Permit filed by North Texas Municipal Water District. The public meetings will consist of two parts, an Informal Discussion Period and a Formal Comment Period. During the Informal Discussion Period, the public is encouraged to ask questions of the Applicant and TCEQ staff concerning the application, but comments made during the informal period will not be considered by the Commissioners before reaching a decision on the application and no formal response will be made. During the Formal Comment Period, members of the public may state their comments into the official record. The Executive Director will summarize the formal comments and prepare a written response. The written response will be considered by the Commissioners in the decision-making process and upon request will be available to the public.

Box 2408, Wylie, Texas 75098, seeks a Water Use Permit pursuant to Texas Water Code §§11.121, 11.085, 11.042, and 11.046 and Texas Commission on Environmental Quality Rules 30 Texas Administrative Code §§ 295.1, et seq. Pursuant to 30 TAC §295.155, published and mailed notice of the application is being given to all of the water right holders of record in the Red River Basin, the basin of origin, and the Sabine and Trinity River Basins, receiving basins. Although the Sulphur River Basin is a receiving basin, it is exempt from notice requirements pursuant to 30 TAC §295.155(d).

Applicant seeks a Water Use Permit to construct and maintain a dam and reservoir (Lower Bois d'Arc Creek Reservoir) with a maximum normal operating capacity of 367,609 acre-feet of water and a surface area of 16,526 acres on Bois d'Arc Creek, tributary of the Red River, Red River Basin in Fannin County. Applicant seeks authorization to divert and use not to exceed 175,000 acre-feet of water per year from any point on the perimeter of the proposed reservoir at a maximum combined diversion rate of 365.15 cfs (163,889 gpm, 236 mgd) for municipal, industrial and agricultural purposes, including the right to use water within the reservoir for in-place recreational purposes. Applicant requests interbasin transfer authorization to use the water within its service area in the Red, Sabine, and Trinity River Basins, and within Fannin County in the Sulphur River Basin. NTMWD's service area is currently located within the following counties: Collin, Dallas, Denton, Fannin, Hopkins, Hunt,

The proposed Lower Bois d'Arc Creek Reservoir will be located 15.2 miles in a northeast direction from City of Bonham and 9.7 miles in a north-northwest direction from the Town of Honey Grove, Station 42+33 on the centerline of the proposed dam will be S 23.2677° E, 514 feet from the southeast corner of O.H.P. Wood Survey, Abstract No. 1177, in Fannin County, Texas, also being at 33.7180° N Latitude, 95.9822° W Longitude. The proposed dam will be located in the George W. King Original Survey, Abstract No. 604, the James Kerr Original Survey, Abstract No. 614, and the John Reynolds Original Survey, Abstract 931 in Fannin County, Texas. The proposed dam and reservoir will be located on the land of the Applicant, which will be acquired prior to construction.

Applicant also seeks authorization to use the bed and banks of Pilot Grove Creek and the East Fork Trinity River to transport up to 725 acre-feet per day (236 mgd) of surface water from the proposed Lower Bois d'Arc Creek Reservoir to Lake Lavon at a maximum discharge rate of 365.15 cfs (163,889 gpm) for subsequent diversion from any point on the perimeter of Lake Lavon at a maximum combined diversion rate of 365.15 cfs (163,889 gpm) for the previously stated uses. The discharge point into Pilot Grove Creek will be located approximately three to seven miles upstream of Lake Lavon within the stream reach between F.M. 545 and F.M. 2756. Applicant indicates that losses associated with the bed and banks transport will be 0.2% per mile of

Applicant also seeks authorization to reuse return flows generated from the diversion and use of water from the proposed reservoir. Until facilities are developed to reuse said water, return flows may be discharged to the Red, Sabine, Sulphur, or Trinity River Basins.

Applicant indicates that diversions may overdraft the firm yield of the reservoir as part of a system operation with existing NTMWD supplies to achieve maximum conservation of limited water resources.

The Commission will review the application as submitted by the Applicant and may or may not grant the application as requested.

Information relating to the contract price of the water to be transferred; a statement of each general category of proposed use of the water to be transferred, and a detailed description of the proposed uses and users under each category; the cost of diverting, conveying, distributing, and supplying the water to, and treating the water for, the proposed users; and the projected effect on user rates and fees for each class of ratepayers can be obtained without cost by submitting a written request to Mr. Robert McCarthy at P.O. CONTESTED CASE HEARING. The TCEQ may grant a contested case hearing on this application if a written hearing request is filed within 30 days from the date of newspaper publication of this notice. The Executive Director may approve the application unless a written request for a contested case hearing is filed within 30 days after newspaper publication of this notice.

To request a contested case hearing, you must submit the following: (1) your name (or for a group or association, an official representative), mailing address, daytime phone number, and fax number, if any; (2) applicant's name and permit number; (3) the statement "[1/we] request a contested case hearing"; (4) a brief and specific description of how you would be affected by the

application in a way not common to the general public; and (5) the location and distance of your property relative to the proposed activity. You may also submit proposed conditions for the requested permit which would satisfy your concerns. Requests for a contested case hearing must be submitted in writing to the Office of the Chief Clerk at the address provided in the information section below

If a hearing request is filed, the Executive Director will not issue the permit and will forward the application and hearing request to the TCEQ Commissioners for their consideration at a scheduled Commission meeting.



# RESTRUCE DAYS GONE BY

Stories of days gone by in and around Motley County

The XOX cattle on the Clear Fork in Fisher County were there in the Seventies. Franker Parker of Roby, Texas, now deceased, drew money for working with them for years.

Dan Waggoner's Three Inverted D and the Burkburnett's 6666 were in Wichita and Wilbarger Counties in the Seventies. John Babb, now living in Garza County, worked for Waggoner in 1873 when the country was black with buffalo. The Waggoner brand was not always as it is today, for it has undergone changes down through the years to fit the ten-dencies of the times and the inclinations of a few of their neighbors.

The 8 Up and 00 Down, usually called the Straight 8 to distinguish it from a neighbor ranch known as the Scab 8, is a brand established in Palo Pinto County in the Seventies and moved to King County about 1882 and later became the Burnett Four 6 ranch. Bud Arnett was manager and wagon boss for many years. John Harrington and Sam Graves are two of the boys who helped drive the cattle west. Harrington, now deceased, lived at Spur and I believe Sam Graves still holds out in King County.

As mentioned elsewhere, the Horse Shoe, the HIT and the 00 were among the first on the Double Mountain River, and I believe among the earliest to enclose their lands under fence. Bill Hitson had his range fenced near the Double Mountains in 1882, a man by the name of McClain being the contractor.

Harwell Kidwell, a banker of Weatherford, landed on the Yellow House and McClusky (MAK) brand from Parker County came to Dickens County. J.D. Kutch was McClusky's right hand bower and when the MAK cattle were sold to the Matadors, Jeff Kutch went along with them, so the Matadors bought a good hand, as well as a bunch of cattle already in their range.

John Shelton, mentioned before, also moved to Dickens County in the early Eighties with his JS cows and Lazy S steers and ranched on the head of Duck Creek, moving again to Wheeler County in 1886. John Porter was the key man for Shelton.



### Interested residents urged to join Caprock Wind Energy Organization

by Ryan Martin Motley County Extension Agent

The Public Utility Commission of Texas met on July 20, 2007. During this meeting the PUC designated several CREZ's in which Motley County was included in CREZ 2. Motley County was included in CREZ 2 only by a statement at the last minute by Commissioner Barry Smitherman to add Motley. If Commissioner Smitherman had not stated that he would like

to add Motley County, we would not have been designated in CREZ 2.

As of this time, these are only preliminary zones. There are several specifics that have to be addressed including boundaries, transmission capability, costs, etc. Also, if an appeal is presented by a county that was left out of the designations or by any other group or company, this would only prolong the final order to be issued by the PUC.

Since the PUC has designated preliminary zones, ERCOT is in the process of developing studies as to where transmission lines will run. It was thought at first that if Motley County was included in a CREZ that we would have transmission lines for the development of wind farms. However, right now there are companies in the process of presenting ERCOT with proposed trans-mission line routes. These proposals will hurt Motley County in two ways. One way being that the lines completely bypass Motley County and secondly, these lines will be operating at

their capacity, therefore leaving

Motley County without any

room to transmit any electricity produced by wind farms. As Mr. Tom Edwards stated, "Currently there are forces at work that if successful would prevent Motley County from either getting any new power lines or power lines that Motley County interests could tie on to.'

Persons, groups or compa-nies that have interest in Motley County are asked to help out either by joining the Caprock Wind Energy Organization or if you are in the process or have leased your land to a wind energy company, mention to that company to support Motley County in the CREZ process to ensure we receive transmission lines in our area.

HORSE TESTS POSITIVE FOR WEST NILE VIRUS

A horse in Randall County tested positive for West Nile Virus this week according to Dr. James Alexander, DVM, MPVM, DACVPM, of Texas Department of State Health Ser-

This is the first positive WNV sample in Potter or Randall Counties this year. State statistics show no reports of WNV, in horses, animals or humans in the Panhandle. Only 10 WNV cases in horses have been reported in other parts of the state in 2007, according to the Department of State Health Services website.

Matt Richardson, Director of Public Health, said, "This confirms that we have West Nile Virus in mosquitoes and that the public should take precautions." He emphasized using measures to avoid mosquito bites such as staying indoors at dawn and dusk, using screens on windows, wearing long sleeves and pants and using insect repellant that contains DEET. The peak season for WNV is August through late September. With the rainfall and heat we have experienced this season, we may see more positive WNV tests.



**OIL & GAS REPORT**

MOTLEY COUNTY: On August 1, 2007, Palo Duro Energy, Inc. issued a press release containing information on the Bankers Petroleum (US) Inc. Cogdell "64" lease well #1 and Black 4 Lease Well #1. Palo Duro Energy, Inc. holds a twenty-seven percent working interest ownership in Bankers Petroleum (US) Inc. Palo Duro

Basin acreage and operations.
Palo Duro Energy, Inc. reported the Cogdell "64" Well #1
was tested in the Granite Wash Sands at a rate of 325 mcf per day of Gas, but has down hole mechanical issues. Palo Duro Energy, Inc. also indicated plans for a possible horizontal completion of the Cogdell "64" Well #1. Currently the Upper Penn Shale Zone is being tested.

Palo Duro Energy, Inc. reported the Black 4 Lease Well #1 has been drilled to total depth and that the well logs are being reviewed.

Palo Duro Energy, Inc. also reported that an Airborne Electro-Magnetic Survey had been completed over portions of Motley and Floyd Counties.

MOTLEY COUNTY: On August 9, 2007, Bankers Petroleum (US) Inc. issued their 2007 Second Quarter News Release reporting on both their Black 4
Lease Well #1 and on their Cogdell "64" Lease Well #1.

Bankers Petroleum reported the Black 4 Lease Well #1 "encountered a more thermally mature 280 feet thick Bend Shale Interval as well as numerous potentially productive Granite Wash Sand intervals." Bankers Petroleum plans to test the Granite Wash Sands and fracture stimulate the Bend Shale Zone.

Bankers Petroleum reported the Cogdel "64" Lease

Bankers Petroleum reported the Black 4 Lease Well #1 had been fracture stimulated in the Granite Wash Sand Zone and was able to flow at a rate of 325 mcf per day. Bankers Petroleum further reported that a casing problem had been en-countered after the fracture stimulation, but the well was still able to flow back.

On August 10, 2007, Bankers
Petroleum (US) Inc. filed an
Amended Application for Permit to recomplete the Cogdell
'64' lease well #1 as a horizontal wellbore. The horizontal recompletion formation penetration point will be located 1593 feet from the North Line and 1230 feet from the West Line of Section 64, Block T, and the


