



Higher postal rates will be as follows; first class matter will go from 3c to 4c an ounce; air mail raised from 6c to 7c; air mail postal cards will be 5c; "penny" postal cards, now 2c, will go to 3.

The Red Hatters returned to Matador and enjoyed lunch at Main Street Café. A good time was had by all.







We all influence someone, and probably several, by our lives each day. Really, we have no choice as to whether or not we will influence someone. We do have the choice however, as to


whether our influence will be good or bad.



The Public Utilities Commission has given preliminary approval to the wind power project in Texas, the decision Motley County has been waiting for for such a long time. And it is not the decision we wanted.

According to the charts, the transmission lines to be constructed to carry electricity produced by the wind turbines will follow Scenario 2, which means that the lines will form roughly a square around, but not through, Motley County.

But they should run close to the boundaries of Motley County, really close. So the hoped for direct increase in the tax base will not be realized. Maybe there is a chance for Motley County to turn this disappointment to a success after all.

The transmission lines will be close, so there may well be a chance for local residents to get jobs in and around their construction. And there may be a chance for locals to be employed around the tur-


bines that will be constructed to produce the energy the transmission lines are supposed to carry.

Maybe out of town people working on the transmission lines will choose to live in Motley County, temporarily or permanently. There are houses for rent as well as houses for sale here. Not only that, but short term lodging can be had at the local hotels and motels.

And of course it still may be possible for wind turbines to be erected here and connected to the transmission lines running close by. That would increase the tax base, and not only provide long term employment for locals, but undoubtedly bring in new residents, the out of town workers employed in connection with the turbines.

Maybe the transmission lines themselves have negative effects, and they certainly are not things of beauty. How might they effect the desirability of Motley County for those seeking hunting leases here?

So maybe, just maybe, this disappointment is not the whole story, and some good will yet come of it all, and help Motley County in the end.
