Matador Water District Board and City Council Meet

The Matador Water District met at City Hall at 6:30 p.m., Thursday, July 12, 2012. Board members present were Bobbie Brown, Bobby Klodginski, Alvin Alexander, and Debra Scott. Absent was Shane Jones. Alvin Alexander was elected as president of the board; Bobby Klodginski, vice president; and Debra Scott, secretary-treasurer, all by unanimous vote.

A bid was opened for a land lease located at the city wells in Roaring Springs with Don Stuckey, Roaring Springs, submitting a bid of \$900.00. The board accepted the bid by unanimous vote.

A proposal was made by Debra Scott to allow the Water District board members attending the City Council meeting to aptrict Board. A motion was made by Bobby Klodginski, seconded by Bobbie Brown, and carried by unanimous vote.

Following the Water District Meeting, the Matador City Council met with a full quorum, consisting of Councilmen Rodney Williams, Alvin Alexander, Bobby Klodginski, Betty Rob-

erts, and Shane Jones. Also attending were Mayor Pat Smith and City Secretary Debra Scott. Absent was City Superintendent Steve Barton.

Mayor Smith reported that the City Superintendent said the wells were doing good, although down about two feet from last month. Water flow use was down about 120,000 gallons from last month.

City Secretary Debra Scott reported that she attended a called meeting of the Texas Department of Housing and Community Affairs held at the South Plains Association of Governments in Lubbock on July 10, 2012, to learn about the Reservation System program. Also attending the meeting were Roaring Springs Mayor Corky Marshall and City Secretary Lisa Perryman; and Motley County Judge Jim Meador.

The City of Matador as well prove all bills for the Water Dis-, as the City of Roaring Springs and Motley County have all disassociated with SPCAA who failed to meet deadlines with the Texas Department of Housing, thereby requiring TDH to de-obligate almost \$1.3 million in funds to support low income families. Applicants that meet certain criteria, including income criteria, will be eligible

to submit applications through the Reservation System.

"We have to publicize a proposal to secure a consultant," she said. Applicants eligible for the program have to be below 80 percent of the Medium Area Income; and one out of four applicants must be at or below 30 percent," she said.

The program design will rank applicants by criteria to determine their eligibility. For example, a point system applied to income, household size, age and disability will factor in the

A motion was made by Alvin Alexander, seconded by Shane Jones to solicit a consultant to administer the Reservation System. The motion passed by unanimous vote.

In other business, Scott announced that the depository contract with Matador Branch, First National Bank of Seymour is up for renewal in October, 2012. The Council voted unanimously to advertise for a checking account depository.

The City Secretary distributed financial statements on the General and the Water Works funds, comparing the budget to the actual expenditures. All budgets are within the expected guidelines.

Called meeting of Council revisits housing grant

The regularly scheduled Matador City Council meeting for June 14, 2012, set the stage for new council positions and board appointments.

New councilmen Rodney Williams and Betty Roberts and Mayor Pat Smith were administered the Oath of Office, serving two-year terms. Mayor Smith will begin his fourth term of office, serving the City of Matador since 2006.

In other business, the Council appointed Debra Scott and Alvin Alexander to the Matador ney Williams to the Matador Appraisal District Board. Additionally, a ban on the sale of fireworks in the city limits was imposed.

A called meeting of the Council on June 26, 2012, included a discussion with City Attorney Tom Hamilton about the Texas Department of Housing and Community Affairs (TDHCA) grant. In a conference call with Senior Program Specialist Terry Newman, the council was informed that required benchmarks were not met and therefore, the funds for the City of Matador had been de-obligated.

According to City Secretary Debra Scott, South Plains Community Action Association (SP-CAA) was the contract administrator of the grant that defaulted.

SPCAA, located in Levelland, Texas, is a non-profit corporation which administers federal, state, and local contracts for programs in a 37-county West Texas area, including Motley County.

While \$425,000 was deobligated for both Motley County and the cities of Roaring Springs and Matador, in comparison, the TDHCA awarded \$435,000 to Muleshoe, Texas, in April, 2012; and \$522,000 to replace older homes and revitalize neighborhoods in Lockney, Texas, in May, 2012.

In an interview with the *Tri*bune (June 28, 2012), William Powell, Executive Director of SPCAA, stated that in the past when they had difficulty in meeting the deadline an extension for filing was always granted. However, in 2010 the Texas Department of Housing made a decision not to grant extensions. SPCAA was unaware of this change, Powell said. Appeals to Senator Duncan for intervention in receiving an extension were unsuccessful.

Fifteen residents, consisting of five applicants in the unincorporated areas of Motley County and five applicants for both the cities of Roaring Springs and Matador for a total of almost \$1.3 million, applied for housing funds through the HOME Reservation Program in 2011. Eligible participants had to

complete a comprehensive application process, consisting of supporting documentation that involved a long list of requirements, including free and clear warranty deeds and environmental assessments.

In a telephone interview with Gordon Anderson, a communications spokesperson for the Texas Department of Housing in Austin, supporting documentation has to be filed within 12 months and there is little "wiggle room" with federal grants.

"I don't really know what went on between the grant administrator and the city, but the funds had to be de-obligated and moved to other grants to be used. There are rules set by the US Department of Urban Development that have to be met," he explained. "We have a lot of people in the state of Texas in need of housing."

However, in spite of this misstep, participants in the housing program may still get funding - just a little later than they expected, he said.

"Most likely, participants in Motley County, including the cities of Roaring Springs and Matador, applied before the relatively new Reservation System was in place," Anderson said. "We have been working on the Reservation System in the HOME program for about a year."



I have realized there is a direct correlation between mindfulness and maintaining sanity here in Kolkata. Here on these active streets, I must always be aware of my thoughts. If these thoughts are able to run rampant, the results can be disastrous. In a city in which poverty is everywhere, suffering is almost universal, and mental and physical exhaustion can be overwhelming, the ability to focus the mind is imperative.

When I arrived in Kolkata and had my first breakfast at the Mother House, I blindly signed up for an opportunity that was posted on the bulletin board. Though, anyone who has served with the Missionaries of Charity, or been to India in general, knows nothing is ever by accident. The only description written on the sign-up was, "Allday prayer retreat at St. Mary's. Breakfast and lunch provided." I had just arrived in this enormous metropolis and was eager to start soul-searching, so I put my name down. On Thursday March 29th, the volunteers and two of the MC Sisters met at St. Mary's for the retreat. This was an all-day silent retreat and there was no talking between breakfast at about 9:00 a.m. until evening Mass at 5:30 a.m. Sister Mercy Maria reminded us of a saying by Mother Teresa: "In the quiet of the mind, God speaks."

This retreat allowed me to find refuge from the teeming, polluted streets of Kolkata. In a normal day of volunteering and walking, I think I smoke the equivalent to about one pack of cigarettes (unfiltered)! The smog is thick no matter where I go, and the swarm of people and traffic forces a person to watch their step at all times. Crossing over the threshold of the doorway in the enormous stone wall surrounding St. Mary's, the total sense of mayhem was extinguished. The guides me in this ability to accept sound of birds chirping took the place of the incessant car horns. I felt blessed to have been invited to such a sacred place and be allowed to share this retreat with the Sisters.

The day of quiet allowed me to reflect on why I was here and what I wanted to accomplish. I


knew the impact I will make in Kolkata is insignificant when I think of the millions of people who are suffering in Kolkata, in India, in the world. It is overwhelming when thought about on a grand scale like that! That is the beauty of mindfulness, though, and that is what I am working on today, and ultimately, for the rest of my life. The dialogue I have with God is what that which I cannot change.

Within the past two weeks, I have already witnessed the incomprehensible sorrow that I am surround by everyday. A man came into the clinic with a hat on his head. He was filthy, reeked of decaying flesh and wore rags that were falling off his skeletal frame. He was speaking so rapidly and with such angst, that the other nurse gave him a sedative and he fell into a more tranquil sleep than he has had in a very long time. I'm positive of that! We took his hat off and he had a necrotic tumor that was infested with hundreds of maggots literally eating away at his head. Three of us (two nurses and a doctor) spent an hour removing the little white worms, one by one, from this mans head. They had burrowed tunnels in the rotting tumor. The smallest maggots, about 1/8 of an inch, were fleeing the scene of destruction crawling quickly away from the gaping hole, while the larger ones, about 3/4 of an inch, were peaking their heads out of the tunnels they produced, only to be plucked from their comfortable homes in this man's flesh to be drowned in betadine. After an hour, one of the Sisters came in and looked in the little metal cup

full of betadine and dead maggots, and said, "We call this chow chow!" I was holding back dry heaves looking at the concoction and thinking about what I had just witnessed!

At this same home, named Kalighat, lives a boy of about fourteen. He is wheel-chair bound and may never walk, but he has the most beautiful eyes with gorgeous long eyelashes. He looks up at you and asks if he can go for a walk. There is a lot that needs to be done: laundry, dinners, med distribution, cleaning. His smile melts me and I take him for walks, pushing his wheelchair around the courtyard, several times in one afternoon. He points to the Convent located on the grounds and we visit the Sis-. ters. One Sister comes out with a present. Its a hardboiled egg! His face brightens and he eats it happily. The Sister takes the rosary from around his neck and rinses it with water to "wash it off." As with the vast majority of individuals in these homes, this boy has a devastating story. Either he was born with disabilities, or his disabilities are a result of abuse. Regardless, he has been severely abused in several definitions of the word. He has been addicted to drugs since he was seven, and his skin is marked with the scars of neglect and beatings. His family hasn't come to visit since he arrived, and at fourteen years old, he is homeless and forsaken by those that brought him into the world. The smooth, velvety, dark skin on his face, with his bright eyes and exceptional smile light up the room, though, and he convinces me to take him for another walk.

ENCLOSURE 1:

PUBLIC NOTICE REQUIREMENTS FOR SYSTEMS CONVERTING TO CHLORAMINES

A public water system (PWS) must notify its customers, in writing, at least 14 days prior to commencing the use of chloramines. This notification must contain the <u>Sample Language for Notification Upon Changing from Free Chlorine to Chloramines</u> included below. The notification should be provided to the news media, renal disease facilities, dialysis clinics, hospitals, physicians, local health departments, etc.

Sample Language for Notification Upon Changing from Free Chlorine to Chloramines (English)

"On 8.1.12 the City of Roaring Springs will be changing the disinfectant that we use from chlorine to chloramines. This change is intended to benefit our customers by reducing the levels of disinfection byproducts (DBPs) in the system, while still providing protection from waterborne disease.

However, the change to chloramines can cause problems to persons dependent on dialysis machines. A condition known as hemolytic anemia can occur if the disinfectant is not completely removed from the water that is used for the dialysate. Consequently, the pretreatment scheme used for the dialysis units must include some means, such as a charcoal filter, for removing the chloramine prior to this date. Medical facilities should also determine if additional precautions are required for other medical equipment.

In addition, chloraminated water may be toxic to fish. If you have a fish tank, please make sure that the chemicals or filters that you are using are designed for use in water that has been treated with chloramines. You may also need to change the type of filter that you use for fish tanks."

OPTIONAL: When the chloraminated water first flushes out the chlorinated water there may be a slight taste and odor, and possibly discoloration for a short period of time. This will not compromise the safety of the water.

Sample Language for Notification Upon Changing from Free Chlorine to Chloramines (Spanish)

"El 8.1.12 el City of Paring Springs cambiará el desinfectante de cloro que usamos a otro de cloramina. El propósito de este cambio es beneficiar a nuestros clientes reduciendo los niveles de los productos secundarios relacionados a la desinfección (DBPs) en el sistema, proporcionando al mismo tiempo la protección contra las enfermedades originadas por los gérmenes del agua.

No obstante, el cambio a cloramina puede causar problemas a las personas cuya vida depende de las máquinas de diálisis. Si el desinfectante no es completamente eliminado del agua que se usa para la diálisis, puede conducir a una anemia hemolítica. Por lo tanto, el esquema de tratamiento previo usado por las unidades de diálisis debe incluir algunos medios, tales como filtros de carbón, para eliminar la cloramina antes de esta fecha. Las instituciones médicas deben determinar si otros equipos médicos también pueden requerir precauciones adicionales.

Además, el agua con cloramina podría ser tóxica para los peces. Si tiene un tanque para peces, asegúrese de que los filtros o los productos químicos que están siendo usados están diseñados para ser usados en agua que ha sido tratado con cloramina. También puede ser necesario cambiar el tipo de filtro que usa para el tanque."

OPCIONAL: Al tiempo de la primera aspesión del agua cloraminada, se puede percibir por periodos cortos de tiempo algún sabor, olor y posiblemente alguna pérdida del color del agua. Esto no compromete la seguridad del agua.

Important notes:

- 1) The PWS may not begin using chloramines prior to the date shown in the notice.
- 2) The TCEQ does not currently require the PWS to include the name or contact number of a PWS employee that the customers can contract if they have questions. However, several systems have included this additional information as a courtesy to its consumers.
- Some PWSs find it beneficial to periodically convert back to free chlorine for 7 14 days once or twice each year. This procedure can minimize the growth of nitrifying bacteria and make it easier to maintain an adequate chloramine residual during the rest of the year. If the PWS wishes to use this procedure, it must notify the TCEQ and any wholesale customer prior to making this type of temporary switch. The TCEQ also suggests that the PWS notify its customers just days before making the temporary change because this procedure occasionally results in slight changes in the taste and odor of the water. However, it does not have to reissue the public notice described above.



in scope, it is far more flexible, communities to meet federal guidelines will be waived in this program," he said. "It is a firstcome, first-served program with no benchmarks. Our goal is a happy ending," Anderson said. "We want to speed up new housing and improved housing on the ground."

Currently, the HOME Reservation Program has about \$12 million available for housing programs in Texas. Additional federal allocations will be made in fiscal year 2013, Anderson said.

Documentation paperwork that has already been compiled can be used to submit new applications. But before applications can be submitted, the county and cities have to contract with a new Grant Administrator and select applicants.

The City of Matador will submit a public Request for Propos-

While the program is smaller al to administer the program. Following the RFP process, the he said. "All of the obstacles city will be required to procure a experienced by the smaller consultant and submit an agreement. Once a Grant Administrator has been selected, then the work begins - again.

"The City Council will have to set up criteria for accepting successful applications," City Secretary Debra Scott said. Then, criteria will be evaluated on a point system. Medium Area Income is one of the criteria; points will be added for the disabled or over 65 years of age. Only five participants at a time can be submitted, but as one drops off, another can be added," she said.

According to the Housing of Urban Development, the Median Area Income for Motley County in 2012 is \$48,900. Successful applicants must be below 80 percent of the area medium income; and one out of four applicants must be at or below 30 percent of the Medium Area Income.

Medium Area Income is based on Fair Market Rent values determined by a complex formula consisting of trending and yearly update factors, based on the census and other community surveys over time.

At 11:00 am the Childress Chamber of Commerce will be selling hamburgers and fixings at the City Auditorium. Cost of the burger meal is \$5.00.


