Mayor Corky Marshall called the meeting to order at 5:00 pm. All council members were present: P. K. Green, Kelly Keltz, Timmy Brooks, James McKleskey, and Alex Crowder. Also attending were City Secretary Tina Brooks and City Superintendent Robert Osborne. Alex Crowder gave the invocation and P. K. Green led the pledge of allegiance.

The minutes were ac-

cepted as read and the bills were accepted and paid. The council went into closed session and emerged to reconvene to entertain a motion concerning the Christmas bonuses. James McKleskey moved and Kelly Keltz seconded the motion to give the employees equal bonuses. The motion passed with a unanimous positive vote.

In other business the council voted to publish a notice for bids on three items that are currently in the now vacant supply building. Tina Brooks informed the council that she now has a notary license and can perform those duties. There being no further business the meeting was adjourned at 5:45 pm.

The challenges facing the new board will be to have it's 501 c 4 status reinstated in order that it may continue to accept donated lots; continue acquiring adjoining lots which could be sold for industrial purposes; research abandon lots to determine ownership; and offer lots with an expressed interest up for bid.

Prior to offering lots for bids many lots sold for \$30 to \$100. As a result of the last bid some lots were sold for \$400.



ing. The discussion centered around the possibility that the City of Matador may have to be part of a group of cities that are having paving jobs done at the same time to cut costs. There was also a mention of a way to raise revenue for the street repairs to come from a charge for the mowing that the City does during the summers.

The council then voted for approval of the minutes of the previous meeting. The council then went into closed session to discuss Christmas bonuses and upon reconvening of the open meeting there was a motion by Alvin Alexander to set the bonuses at \$650 per full time employee and \$150 per part time employee. Shane Jones seconded the motion and it carried with a unanimous vote.

The next item on the agenda concerned dogcatcher options. Mayor Smith read a letter from the City of Floydada that described a possible contract that specified \$10 per day per dog with \$40 or more for disposition by adoption or euthanasia. There was discussion about how the dogs would be transported to Floydada and how many days

a dog owner would have and how much they would have to pay for the retrieval of their pet. Roberts moved to table the issue until more information could be obtained and Alexander seconded which followed with a vote of four to zero in favor of tabling the issue.

Next there was discussion of the appointment of board members for Market Matador with the result of Roberts making a motion to appoint Lee Hurt, Ronnie Vandiver, and Libbie Cruse to the Market Matador board. The motion was seconded by Klodginski and carried by a vote of four to zero.

The next item on the agenda concerned funding for the Motley County Senior Citizens' Center. Mayor Pat Smith circulated a letter from City Attorney Tom Hamilton. The letter stated that the MCSC furnishes noon meals to senior citizens and the general public five days per week; the food used to prepare the meals is federally subsidized food and other food purchased by the MCSC on the open market; and employees are hired by the organization to prepare the meals furnished to senior citizens and the general public. The letter concluded: "Consequently, the City cannot use tax revenue to pay the Senior Citizens Organization funds to furnish noon meals to the general public. The City's use of tax revenue for this purpose would not be legal."

After all council members had a chance to read the letter, there was discussion concerning the use of tax revenues to support this organization. Klodginski made a motion to provide the Center with water, sewer, and garbage service. Jones expressed concern if that was legal. Mayor Pat Smith pointed out that it was still revenue. "If you start giving free water to one, how do you distinguish another such as churches?" Smith

Klodginski asked why there were funds for the jail, library and fire department. Smith answered that it was because they came from different funds. 4A money is set for a specific uses such as industry. 4B money is to improve the community in such a way that would make the town more appealing for people to move to. Hotel Motel tax revenue is for promoting tourism and events such as the centennial.

The library and fire department receive money because there are no other for profit businesses that offer the same services. Jones suggested funding only a portion of the delivered meals to shut-ins part of the Senior Citizens services.

Alexander talked about the conflict between non-profits and businesses. He asked the director's salary, which Klodginski could not answer. Alexander suggested MCSC provide more information regarding their financial status and needs.

Roberts considered Hamilton's letter an opinion and asked, "Where is the law that says that the council can or cannot provide support." She then seconded Klodginski's motion for the city to provide water, sewer and garbage service. Further discussion culminated in Roberts rescinding her second and making a new motion to table the issue so more information could be researched regarding the legality with the matter.

Next item was to approve and pay bills, followed by a financial report from Debra Scott that revealed that funds were at normal levels for the time of year. The meeting was then adjourned.



AgriLife Research scientist: Soil-water profile key to wheat root system, drought survivability

AMARILLO - Without soil moisture, roots don't develop and grow. Without a strong root system, a crop cannot survive in a drought year, according to a Texas A&M AgriLife Research crop stress physiologist in Amarillo.

While most producers realize water is the most important limiting factor affecting wheat production in semi-arid areas such as the High Plains, Dr. Qingwu Xue said the past two years of drought have emphasized the key role of soil water availability at planting time.

Long-term field research at Bushland and in western Kansas demonstrated that wheat yields are closely tied to seasonal evapotranspiration, which is determined by soil water storage, seasonal rainfall and irrigation, Xue said.

"If you don't have a good soil-water profile at plant-

ing, and you are a dryland farmer, you may need to just not plant, or wait for more moisture," Xue said. "You may be better off letting the profile fill up for the next crop."

He said the difference between water storage during a three-month fallow period and an 11-month fallow period can be tremendous in a dry period.

Xue said if wheat producers were at the end of a longer fallow period and had the soil moisture, then the second part of the equation is how to effectively use the soil moisture. In this case, a healthy and strong root system plays an important role for water use also.
