RC&D council awards Transmission line upgrade equipment grant to local video project is "done deal" TxDOT to let bids in October for US 70 west

The Motley County Commissioner's Court met July 11, 2011, in regular session, covering a 13-item agenda including an update on transmission line upgrades in Motley County.

Attending were Commissioners Franklin Jameson, Roy Gene Stephens, Donnie Turner, and Russell Alexander with County Judge Jim Meador presiding. Also in attendance were District and County Clerk Kate Hurt, County Attorney Tom Edwards, Sheriff Chris Spence, and Ben Kautz, TxDOT; and guest Beth Ware, wife of Deputy Sheriff Chad Ware.

"The Electric Transmission of Texas (ETT) consortium of AEP is completing a transmission line upgrade from Matador to Paducah - it's a done deal," County Attorney Tom Edwards said. According to Edwards, this will include 18.12 miles of lines in the county at an estimated cost of \$807,000 per mile, totaling about \$14.5 million.

Last month in Commissioner's Court, Edwards said if the Southwestern Public Service Company (SPS) line is constructed, it could place about 30 miles of transmission lines in Motley County.

"The SPS line is also possible in the county - but currently, these negotiations are too delicate to comment on," Edwards added. However, "if all landowners pull together for the benefit of the county,

then we may have a shot at securing these lines."

In other business, Commissioner Turner announced the pending completion of the Flomot Water Project. The new system will be checked for nitrates on Wednesday, July 13, followed by a state audit of the project toward the end of the month, Turner said.

Ben Kautz, TxDOT, announced the completion of all bridge work in Motley County. He also announced that TxDOT has about 500 square-yards of salvage base left over from the project. He offered the base to the county for bridge approaches. Applying the base to the bridge approaches will save the bridges from "beating out on the ends," Commissioner Stephens said.

Kautz also said that bids to surface US Highway 70/62 west from the city limits will be announced in October, 2011. "It has been seven years since the road from the city limits of Matador west to the Floyd county line has been surfaced," he said. Additionally, he said, TxDOT is mowing a full width of grass on both sides of the road to "hopefully, help prevent fires." On behalf of the court, Judge Meador complimented TxDOT on their response and hard work in Motley County during the fires. "We appreciate the response of TxDOT to the fire dangers in the county," he said.

Last month, the court accepted a housing grant in the amount of \$415,000 for 15

new homes in Motley County - five new homes in the City of Matador; five in the City of Roaring Springs; and five new homes in the county proper. The county advertised for a coordinator for the project, receiving two applications. Following a debate on the merits of selecting a local applicant as opposed to a consultant hired out-of-county, the court voted 3-2 to select the South Plains Community Action Association (SPCAA) application for the home reconstruction project.

Casting the dissenting votes were Commissioners Jameson and Alexander. The other applicant was community service activist Marilyn Hicks, Matador. "I would like to keep the job in the county," Commissioner Jameson said.

"These grants are a nightmare to administer," Judge Meador countered. "I just feel like we should go with a proven association that has the staff to help administer the project."

Several months ago, the court voted to pay the state rate on per diem and travel for county employees. In a vote of 4-for, and one against, the court voted to change the Travel Reimbursement policy from the state rate of 55.5 cents per mile to 45 cents per mile. Judge Meador cast the dissenting vote.

Commissioner's Court meets the second Monday of every month at 9:30 a.m. in the Commissioners Courtroom, first floor of the courthouse. The next meeting is set for August 8, 2011.

Ron Bailey, board member serving on a 13-county council for Four Winds Resource Conservation and Development area (RC&D), recently awarded a \$500.00 matched grant to the Motley County Historic Jail video project. Accepting the award in behalf of the Friends of the Historic Motley County Jail was Carol Campbell.

The 50-50 matched grant was used to purchase video equipment to be installed in the historic jail as a play-back system for self-tours. The video

documentary will focus on the history and unique landmarks of Motley County; and early-day sheriffs that served the county from the late 1800s to the turn of the century.

"Rural community development encompasses a wide range of approaches and activities that aim to improve the welfare and livelihoods of people living in rural areas," Bailey said.

Four Winds, as a branch of community development, pays attention to social issues in rural

communities, Bailey said. "With a shrinking economy, Motley County is attempting to revitalize their economy through tourism," he said, adding, "The video project is a creative solution."

Resource Conservation and Development (RC&D) is a unique program under the USDA and led by local volunteer councils that provide a way for people to work together to promote local economies and improve the quality of life in rural communities.

FSA County Committee Nominations Started June 15, End August 1st

Motley County USDA Farm Service Agency (FSA) Executive Director Amy Hackler, announced that county committee election nominations began June 15, 2011. Farmers, ranchers and landowners are encouraged to nominate farmer and rancher candidates to serve on their local FSA county committee by the August 1, 2011 deadline.

Elected county committee members serve a three-year term and are responsible for making decisions on FSA disaster, conservation, commodity, and price support programs, as well as other important federal farm program issues.

"County committee members are a valuable asset because they are local producers who participate in FSA programs themselves and have a direct connection to farmers and ranchers in the community," said Hackler. "I would like to see a high level of participation in this year's nomination and election process."

she said.

Producers may nominate themselves or others as candidates. Organizations that represent minority and women farmers and ranchers may also nominate candidates. Nominees must participate in a program administered by FSA, be eligible to vote in a county committee election and reside in the local administrative area (LAA) in which the person is a candidate. To become a nominee, eligible individuals must sign form FSA-669A. The form and more information about county committee elections are available online at: www.fsa.usda.gov/elections.

"It is important that the county committee reflects the demographics and agricultural interests of the community these individuals represent," Hackler said. "I strongly encourage all producers, including women, minority and beginning farmers and ranchers to participate in the nomination and election process."

Perry Gullede was appointed to serve as board member for the Appraisal District.

Mayor Marshall will be contacting the city's attorney for revision in our city's ordinance on property maintenance to enforce cleanup.

Learning to do the math is our new assignment for money management. For us that starts with knowing exactly how much it costs to travel. We have an envelope that we keep in the car. Whenever we make a trip we calculate the cost and put the cash in the envelope. Then, when we buy gas that is the cash we use. The money that is left-over is used for repairs. Like the \$1200 recently needed to fix the air conditioner.

Based on the price of gas, according to the IRS Travel Reimbursement policy, it costs 55.5 cents per mile. I appreciate that they did the research on this since I want the maximum amount of deductions at the

end of the year when we file our taxes. However, it is a hard fact to face when I calculate the cost every time I drive.

Recently I needed a new iron. I wanted a professional one since I use it frequently and want plenty of high powered steam. I knew I could get it at Lowes but there isn't one where I live. That meant I would have to drive 40 miles to the next large town. When I got home I did the math. Eighty miles round trip at 55 cents per mile meant I had to put \$44 in our travel envelope. Add that to the \$92 price of a professional iron meant my true investment was \$136!

Even now, whenever we are in Matador we calculate even the smallest trips. We used to travel back and forth frequently to Roaring Springs. Now we know that each round trip costs \$8.

Oh my. I forgot to buy cream while I was shopping. It's 12 miles to town meaning that cream would cost me \$13. Better do without. I'll get it later.

Searching for Doan's Crossing

Tucked somewhere back in the sand hills of the Red River Valley is a small adobe house, preserved since 1881 when Doan's Store could completely outfit the trail drives with supplies, Winchesters, cartridges, "sow bosoms," and even a Stetson. Then thousands of long-horns were gathered into pens and corrals and road branded for the trip or rested on the flat before attempting to cross the treacherous quick sand of an eternally fickle water course. Doan's Crossing, the "jumping off place," was the last bit of civilization the cowboys would see until they hit the Kansas border. Ahead were many physical challenges, hostile Indians and Anglo desperados, dangerous water crossings, and stampedes.

It was July 7, a year to the day since my husband Ralph Powell had passed away. I was feeling a bit melancholy, missing him, when I took my granddaughter to meet her father half-way between Matador and Southlake. Emma and I had spent several days together doing what she had told her dad, Richard, we were going to do, "ride horses, look for rocks and pick up bones" (...as well as feathers, wildflowers, snake skins, armadillo parts, and a few other treasures). At eight years of age, she amazed me with her knowledge of prairies, native grasses, and habitat. Southlake is doing a great job on teaching conservation awareness.

On the return trip home I

detoured at Vernon, headed not for a destination that Ralph and I had enjoyed together on our many adventures, but to a place we had only talked about. On my way to the Red River on Highway 283, I was drawn by its name to the tiny cemetery of Fargo, located between a field and a pasture. The 111 degree heat was stifling so I didn't tarry long among those granite tablets of history.

However, just down the road was a small roadside park where red granite marker had its own version of history. Pete Ackley had erected the marker and claimed (wrongly, I learned later) that this was the Chisholm Trail and drovers had sent some 6 million cattle up the trail to markets in Kansas. At least I was on the right track. Doan's Crossing must be nearby.

Not to be misled from the adventure of discovery by On-Star or Global Positioning Systems, I turned off on a side road that looked promising. After all, this was the way I had found the Cynthia Ann Parker recapture marker near Old Margaret. Nothing beats that "eureka" moment of discovery. I passed by the neat little village of Fargo and continued east past wheat stubble, irrigation pivots, and fields broken by groves of trees. As I approached a junction with houses on either side, I was ready to admit defeat.

Then looming at the corner was a gigantic red granite marker. On it were brands

and the sixty-one names of ranchers or ranches that had driven cattle through Doan's Crossing. Giants of the industry, names like Goodnight and Adair, John Blocker, the Eddleman Brothers, Richard King, Masterson, Littlefield, C.C. Slaughter, Waggoner, and Burnett.

Under a grove of trees, with its back to a sheltering sand-hill was the small adobe store. Here, at this very spot, C. F. Doan watched the first herds go up the trail in 1879 and he kept a tally of how many crossed that year, 100,000 head of cattle! In 1881 when the adobe was built, 301,000 cattle paused here before crossing the Red over into Indian Territory. As Andy Adams wrote in The Log of a Cowboy, the Red River was "a terror to trail drivers." The river claimed its own tariff, and cowboys who drowned were buried nearby as Adams noted in his book.

A new marker was emblazoned with the words "The Great Western Trail" in red letters on a white wooden post. It was dedicated at Doan's Crossing in 2004 as the first of many to mark the trail from Bandera, Texas, to Dodge City, Kansas. The Great Western Trail, not as popularly known as the Chisholm Trail, actually started at

the tip of Texas at Brownsville, clipped San Antonio and Bandera, then near Ft. Griffin split, with the off-shoot Potter-Bacon Trail going to Matador and Kit Carson, Colorado. At Doan's Crossing, the Great Western Trail headed to Clinton and Woodward, Oklahoma, before hitting Dodge City. It continued for two thousand miles and was in use for 12 years.

Despite what the Ackley marker claimed, the Chisholm Trail crossed at Red River Station, Texas, and continued on to Enid, Oklahoma, and Wichita, Kansas or branched to Abilene, Kansas. The Jesse Chisum Trail did not cross into Texas but went from Ft. Sumner to Kit Carson and beyond. Ackley had his own ax to grind evidently.

After spending some time reflecting and soaking up my history imaginings of Doan's Crossing, I drove away from the this special place toward the super highway crossing on 283. I knew Ralph would have gotten a kick out of being here with me, just as much as being at Red River Station and Old Spanish Fort. When on the dirt road I encountered a second Great Western Trail marker, I couldn't help but utter a little "Eureka, we found it." History's fun. Go discover it!

New Driver's License Law ... Unintended Consequences?

SAN ANTONIO, Texas - A new law that ties citizenship and immigration status to issuance of a Texas driver's license could cause harmful unintended consequences, according to its critics. It requires the Texas Department of Public Safety (DPS) to ask for proof of citizenship or legal status from anyone seeking new or renewed Texas driver's licenses.

After failing to make it through the Legislature on its own, the provision was inserted into SB 1, the school finance bill that passed both chambers this week. Supporters claim it is necessary for national security.

Luis Figueroa, an attorney with the Mexican American Legal Defense and Educational Fund (MALDEF), says it does alleviate some of his organization's

long-standing concerns, such as allowing certain temporary visa holders to obtain licenses. But he warns that immigration issues are too complex to leave to the DPS clerks who will be charged with enforcement.

"They're the judge and jury. There's no appeal process; there's no complaint process. There's no immigration attorney to be able to determine whether someone is getting the appropriate license."

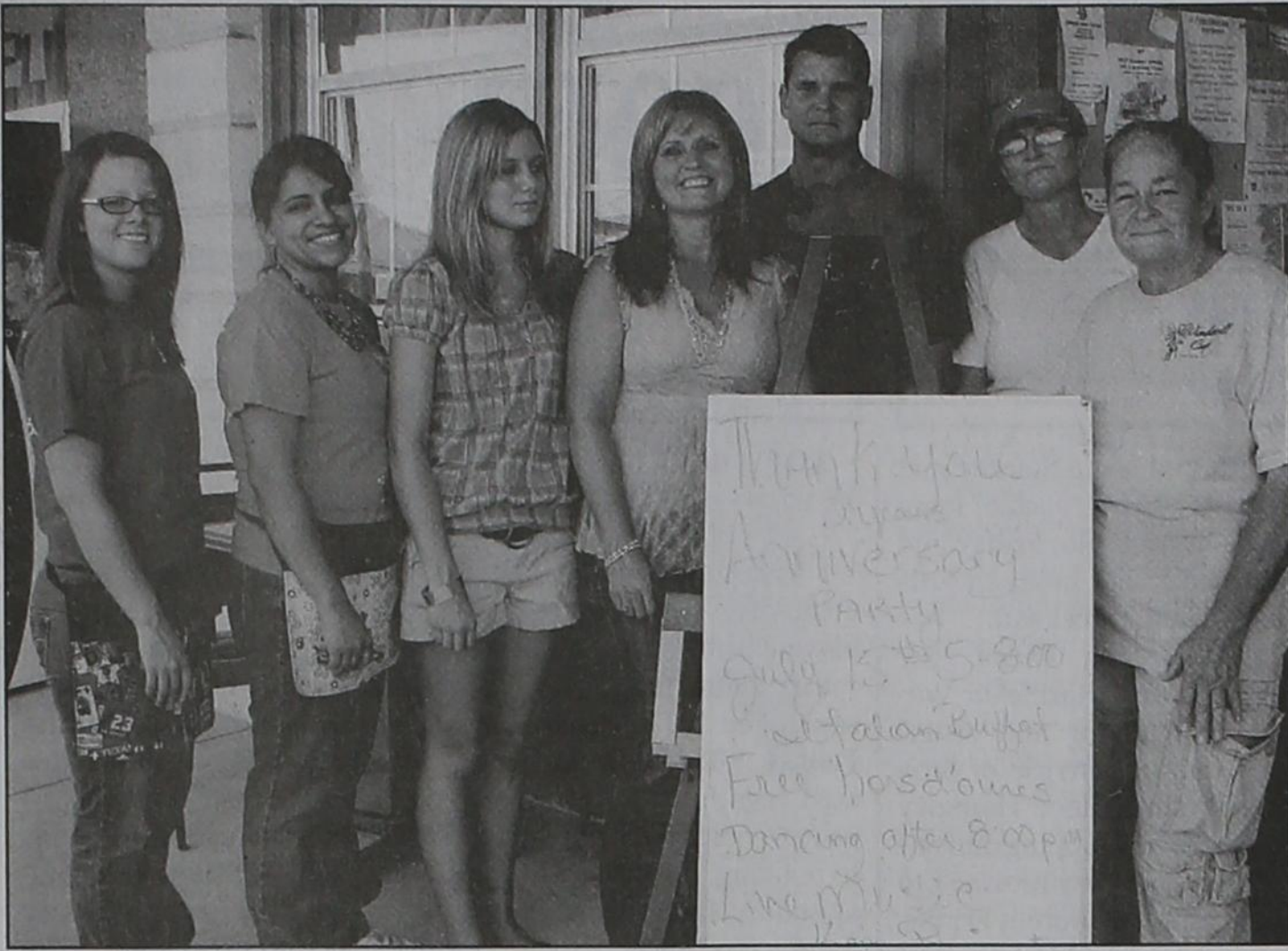
He says the law needs to be fixed to ensure that a qualified driver can't be denied a license because of non-typical immigration status. He also wants assurances that new databases won't be abused, and that the added difficulty in obtaining a license doesn't hamper anyone's access to services and benefits.

In addition, Figueroa predicts the new procedures will

magnify the consequences of another newly-passed measure - a photo identification law that imposes some of the strictest voting requirements in the nation. A loss of driving privileges could amount to a simultaneous loss of voting privileges - further disenfranchising the state's most vulnerable citizens, he notes.

"People who don't have driver's licenses are often the most vulnerable. People who are poor. Students. The elderly. These are always the people we should be trying to ensure that their rights are protected, not taking their rights away."

He says even Texans who can easily produce their birth certificates or passports should be concerned about the law for their own safety - since he predicts it will lead to more unlicensed drivers on the road without liability insurance.

Texas Public School Advocates Already Regrouping for Next Battle

AUSTIN, Texas - The fight for public education funding is far from over, according to several hundred school advocates from across the state who gathered in Austin this weekend. The conference was organized by the grassroots organization Save Texas Schools, which was created during the past legislative session as lawmakers were proposing billions of dollars of education cuts to help balance the state budget. Jason Sabo, an Austin public school parent and a volunteer for Save Texas Schools, says the message going forward is "Get ready!" Families, he says, need to brace not only for the impact of a \$4 billion

shortfall to schools, but also for additional cuts if the next legislature doesn't fix structural budget problems. "Get ready for the 2012 elections, because public school parents and people who are concerned about public education will have a louder voice in 2012 than they have ever had in the history of this state." Sabo expects to see hundreds of house parties in the next few months hosted by concerned parents trying to mobilize their communities into supporting pro-public-education candidates - regardless of party."

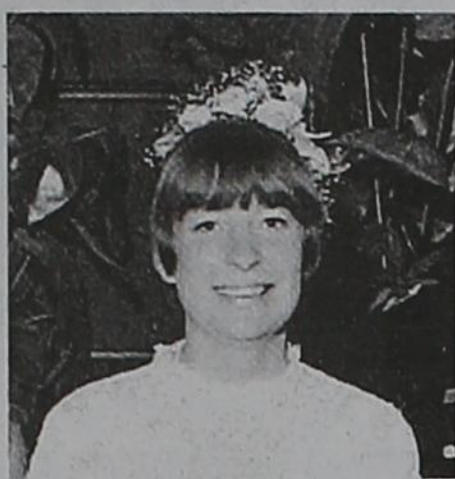
Obituaries

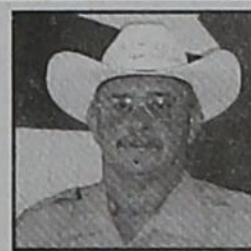
