District Lions Meeting Held Here Sunday

More than 175 Lions and Lionesses representing 38 of the district's 73 clubs, convened at Motley County High School Sunday for the first Cabinet Meeting of the year for District 2-T2 Lions International.

The Matador Lions, who organized 51 years ago, hosted their first ever Cabinet Meeting, and kicked off the day's activities with a bang with a noon luncheon prepared by Walter Jones and with piano music by Gerald Pipkin, both Matador Lions.

District Governor Marshall Cooper of Whiteface, introduced to the throng by immediate past district governor N. K. Snodgrass of Lubbock Southwest, announced his goals for the 1980-1981 Lions Year. Those goals follow the guidelines set by International President William C. Chandler of Alabama, whose theme is "Touch a Life with Hope."

Cooper's 14 goals for the year include a net increase of 400 members and at least two per club; three new Lionesses clubs; submittal of membership goals for all clubs to the international headquarters by Oct. 1, 1980; participation in the president's program to seek and to serve children in need; 50 percent of the clubs in District 2-T2 beginning a new youth program or conducting two or more youth programs; a net district gain of one club; a district membership seminar for club membership chairmen and 10 clubs in the district with a net gain of at least 10 members each.

Along the club membership line, Carl

Looney, president of the Lubbock Lions, the largest Lions Club in the continental United States, reported that his club has a goal of 150 new members this year.

Lamesa will host the mid-winter conference Jan. 31 to Feb. 1, 1981. Whiteface will be the site for the Nov. 9, 1980 cabinet meeting and the Lubbock South Plains Club will serve as host of the district convention at the Lubbock Civic Center May 21 to May 24, 1981, although Lamesa Noon, Slaton, Wilson and the Lubbock Club will be responsible for major items during that convention.

Five clubs will celebrate their 40th anniversary during the upcoming year, beginning with Muleshoe's celebration this week. Other clubs reaching that milestone include Seminole Noon, Amherst, Littlefield and Roby.

Cabinet Secretary-Treasurer Salt McAlexander presented a proposed budget of \$29,463 for the year, which was approved.

Club secretaries, presidents, deputy district governors, zone chairmen, taitwisters and lion tamers attended training schools. The president's school was led by past district governor William Hogge of Plainview and the secretarial school was directed by Jake Scharnberg of New Deal and past cabinet secretary Weldon Snodgrass of Lubbock. Deputy district governors at-large J. Ken Smith of Lubbock and Charles Couch of Plainview aided Hogge.

Bundy Campbell of Matador was emcee of the luncheon.

Robert Brandon Receives Award

Robert Brandon who graduated from Matador High School and later from West Texas State has just returned from New York where he received first place awards for National Press Photographer of the Year for television news stories.

He was accompanied to New York by his wife, Donna and was later joined in Kentucky by his children, Kristi and Ronald.

Robert first won this award in 1975, however this year he received three additional awards other than the first place for photography.

Robert Brandon and Phil Lauter went into free lance news photography business in 1979, and won the N.P.P.A. Ernie Crisp award the same year. Robert being the recipient.

Brandon's winning entry included the coverage of an apartment house fire while he was still with KPRC-TV in Houston. The story being about a certain type of shingle being used in construction that seemed to burn faster than others.

Other coverage in Brandon's winning entry were magazine pieces done for the National networks. One being a story for 20/20 about a confrontation between Vietnamese settlers and local people.

Robert covered a meeting where all of the parties were brought together to try to resolve the conflict.

He says that several features done for "Prime Time Saturday" with correspondent Bob Dotson gave him time and opportunity to tell stories the way he likes to tell them. One story about a rodeo clown school and another being a group of retired men, all 75 years old or older, playing softball in Florida.

Robert also was the first news photographer permitted to land on the rim of the crater in Mount St. Helen, going in with an army search and rescue team by helicopter.

"The News Photographer" and "Retrofocus" magazines gave Robert nice coverage, both photographic and printed.

Motley County Taxpayers

We, the Motley County School Board, feel we owe you an explanation of the proposed tax increase appearing in today's paper.

Motley County has not experienced a school tax increase since the school consolidation in 1972. At that time, the Flomot district taxes were lowered, Matador district taxes were raised slightly, and Roaring Springs district taxes remained the same. This action was taken in order to equalize the taxes county-wide.

We are sure you are aware of the effects of inflation during the last eight years; however, there are a number of other reasons why the district must ask you for more tax dollars.

The District's Average Daily Attendance (ADA) has dropped from 290 students in 1977-78 to 257 students in 1979-1980.

The number of teachers required remains the same because the drop in the district's ADA is reflected in the primary grades rather than in the high school. A cut in faculty would mean a cut in curriculum in high school in which enrollment and needs have not changed.

The drop in ADA has cost us state funds, and we are now paying four classroom teachers out of local funds. All other classroom teachers, teacher's aides, Title I teachers, Special Education teachers, and administrative personnel are paid from state and federal funds.

Over a period of three years, the state and federal government has withdrawn \$15,000 in 1977-78, \$25,000 in 1978-79 and \$45,000 in 1979-80 in funding. This loss is due to change in law and difference in state and local evaluation.

The drop in ADA or students has cost the local district an additional \$20,000 in two years with the possibility of another \$10,000 in 1980-81.

You may ask why we have not proposed a tax increase before now. In the mid 1970's, the district was able to build a surplus of some \$90,000.00. That surplus has been used to cover the loss of state and federal funding and inflated expenses over the last few years.

The tax hearing, on August 5, 1980, is open to the public. At this time, we will attempt to answer any questions from concerned citizens regarding this proposal.

Baptist WMU Observes 100th Year

Observance of the 100th year of the Baptist Women's Missionary Union in Texas began Tuesday, July 8 by the local organization of First Baptist Church, with a morning coffee and book review in the home of Mrs. Bill McCaghen.

Other features of the observance, which will continue through October, will include a style show August 5, in the home of Mrs. Larry Hoyle. Fashions from 1880-1950 will be modeled by members of the WMU.

The book, "Century One...A Pilgrimage of Faith" by Inez Boyle (Mrs. H. C.) Hunt was reviewed by 12 WMU members, several of whom wore dresses which depicted the years during which the early presidents served. The book covers the tenure of the 12 Texas WMU presidents during the century.

Introduction was by Mrs. Stuart Dixon, general chairman. Mrs. McCaghen gave the history of the organization of women's missionary organizations in Texas, under the first president, Mrs. Fannie Breedlove Davis from 1880 to 1895.

Following in order of their elections were Mrs. W. L. Williams, 1895-

1906, by Mrs. Douglas Meador; Mrs. F. S. Davis (Mary Hill), 1906-1931 by Mrs. C. D. Garrison; Mrs. B. A. Copass, 1931-1946 and Mrs. Earl B. Smyth, 1946-1949, by Mrs. Edgar Lee; Mrs. R. L. Mathis, 1949-1955 by Mrs. Bill Dunning.

Mrs. Clem Hardy, 1955-1961 was reviewed by Mrs. Larry Hoyle, and Mrs. Bert Black of Crosbyton who served from 1961-1963 was given by Mrs. James Stanley. Four women were in office intermittently during the following year, and in 1964 Mrs. C. J. Humphrey was elected, serving until 1968, as told by Mrs. Roger Vinson. Mrs. Roy Stephens reviewed the next president, Mrs. H. C. Hunt, from 1968-1972; Mrs. Earl W. Johnston, 1972-1976 was by Mrs. Fred Risser, and Mrs. Larry Neighbors concluded with the current president, Mrs. Elvis (Hue Coy) Egge, who took office in 1976.

Mesdames Hoyle, Stanley, Vinson, Stephens, Risser and Neighbors are members of the Baptist Young Women and several had worked as members or leaders of Girls Auxiliary organizations under the more recent presidents, adding an interesting personal note to their

comments.

Mrs. Stanley grew up in Denton and served as advisor when Shirley Cothran (Miss America of 1975) was in Girls Auxiliary. "That was my nearest brush with fame," Mrs. Stanley said, although later she admitted that she and Phyllis George (Miss America of 1971) graduated from Denton High School in the same class, and were both in the senior class play.

Present, in addition to those mentioned were Mesdames France Barton, Tom Moore, Robert Darsey, Dowell Garrison, Eddie Russell, Alvin Stearns, Velma Fulfer, I. C. Hinson, Audrey Price and Cecil Shelton, and Miss Rachel Patton.
