## J H Seventh Grader Wins Spelling Bee

### Local People May Receive Lost Money

State Treasurer Ann W. Richards said Monday that more than 110,000 Texans have \$60 million in lost or forgotten money coming to them this year.

The 110,000 are named in the 1989 version of the Texas Treasury Unclaimed Money Fund List which will be published statewide on Sunday, March 5, in 19 major daily newspapers.

"Each year, we try to locate as many people as we can and return this money to them," Mrs. Richards said. "Last year about \$22 million was given back to rightful owners."

#### Driver Listed As 'Critical'

Friday morning, the Amarillo Daily News reported the following information:

"A circulation driver for the Amarillo Daily News remained in critical condition Thursday at High Plains Hospital in Clovis, N.M., from injuries he received in a one-vehicle rollover 9.5 miles west of Muleshoe on U. S. Highway 84.

"Clarence Shanks received multiple fractures and lacerations in the accident, a nursing supervisor for the hospital said Thursday.

"At approximately 5 a.m. Wednesday, Shanks was traveling east on Highway 84 when his vehicle hydro-planed, causing him to lose control, Lacie Kirk, a Texas Department of Public Safety trooper, said. Kirk said it was raining and the road was slick.

"The vehicle, Kirk said, turned 180 degrees and entered into a freshly plowed field on the east side of the highway. The vehicle then rolled twice before coming to a rest upright, he said. Shanks, who was not wearing a seatbelt, was ejected from the vehicle, Kirk said."

**SWC Director Has Retired**

Harvey Davis, executive director of the Texas State Soil and Water Conservation Board announced his retirement effective February 28.

Davis, a native of Williamson County, began his career with the TSSWCB in 1954 when he was employed as the agency's assistant executive director. He was promoted to executive director in December, 1961 and held that position until November, 1977 when he was appointed first executive director of the Texas Department of Water Resources.

Davis headed the TDWR until he returned as executive director of the TSSWCB in January 1983. In total, Davis has 34 years of public service to the state of Texas.

Davis plans to continue living in Temple and become more active in his farming and ranching business.

Robert G. "Bob" Buckley of Little River, Texas has been named by the Texas State Soil and Water Conservation Board to succeed Davis.

Buckley was employed by the TSSWCB in 1975. He served as

the agency's chief accountant until his promotion to Director of Programs in 1978.

The Texas State Soil and Water Conservation Board's chief responsibility is to coordinate the programs of Texas' 208 soil and water conservation districts.

Bunkley is a graduate of Temple Junior College and the University of Texas. He holds a Bachelor of Business Administration degree with a major in accounting.

Buckley serves on the Academy Independent School District's Board of Trustees. He and his wife Brenda have two children.

All members are needed at the Parent/Student night scheduled for Monday, March 6 at the high school cafeteria. All area parents and high school students are urged to attend.

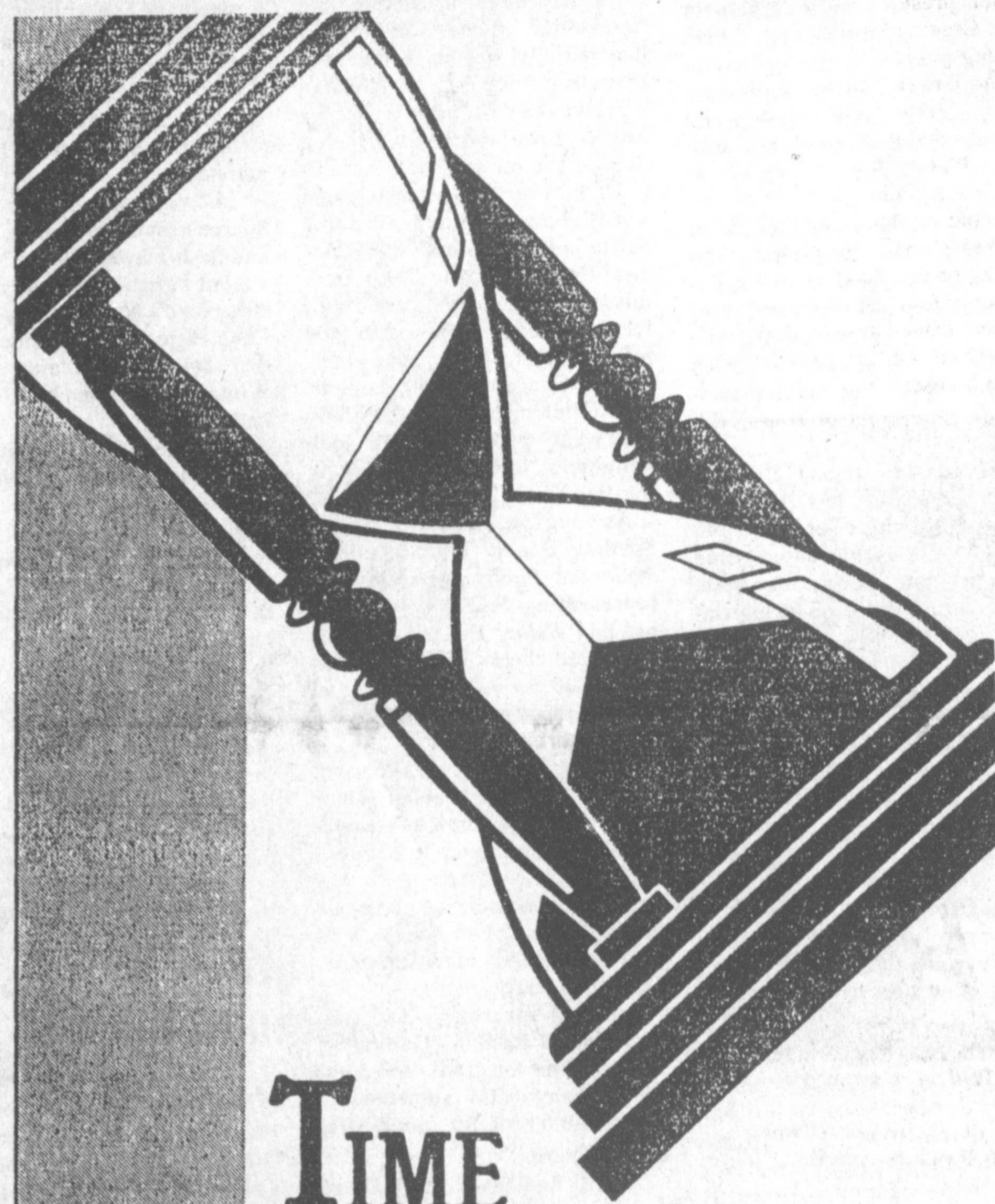

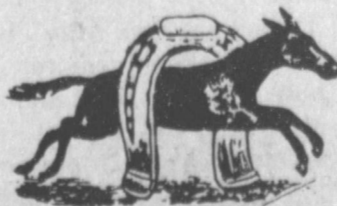

## School Week

Cont. From Page 1

Texas Public Schools Week March 6-10, 1989.

"Although now celebrated during the first full week of March, Texas Public Schools Week was first established by the Masonic Lodges of Texas to coincide with the March 2 anniversary of Texas Independence Day.

"In 1836, the Texas Declaration of Independence cited the failure of the Mexican government 'to establish any public system of education, although possessed of almost boundless resources,' as one of the key reasons for severing political ties with Mexico.

"Education has been stressed by Texans ever since. The first state constitution provided for the establishment of an educational fund for children of indigent parents. In 1854, the Legislature set aside \$2 million to set up the first Texas school districts. The Texas Constitution, written in 1876, provided for a perpetual public school fund.

"During the 1980's, the Texas Legislature has reaffirmed this belief and refined the public school system. House Bill 246, approved in 1981, required a uniform curriculum in 12 subject areas be taught in all Texas public schools. This legislation ensured that students across the state were given the opportunity to study the same essential elements of every subject at every grade level.

"These requirements for teaching the 'essential elements' were phased in over a period of several years and were fully implemented during the 1985-86 school year, which coincided with the implementation of provisions of House Bill 72.

"In passing House Bill 72, Texas Legislators left the curriculum provisions of HB 246 intact, and also mandated some new programs requiring state guidelines. This piece of legislation revised the state funding system, looked at requirements and incentives for teachers and administrators, set a statewide passing standard of 70 (on a scale of 100) and prohibited social promotion for students, initiated the no-pass/no-play rule, and required high school students to pass an exam in English language arts and mathematics before receiving a diploma.

are from checking and savings accounts, utility deposits, oil royalties, and corporate stocks.

Most accounts must be dormant from three to five years before they are turned over to the state.

"There is no set time to make a claim on these accounts," Treasurer Richards said. "Money turned over to the State Treasury can be claimed at any time in the future by the original owner or his or her heirs."

Persons who find their names on the list can call the Texas State Treasury on its toll-free telephone line at 1-800-654-3463 or they can write the State Treasury at P. O. Box 17728, Austin, TX 78745. The toll free line opens at noon today, March 5.

During the first few weeks after the list is published, the toll-free line is often tied up by the volume of calls. The lines, however, are kept open for an extended period and there is no

time limit for making a claim.

The Unclaimed Money Fund List was first published shortly after Mrs. Richards first took office in 1983 and she has made collecting and returning unclaimed money one of her top priorities.

Since she took office in 1983, the Treasury has collected more than \$209 million in unclaimed funds, which is almost 83 percent of all such funds ever collected in the State of Texas. About 95 percent of all funds returned in the 27 year history of the program have been returned during the six years of the Richards Administration.

Money that is not claimed by owners is used by the state for education and general state services such as highways and law enforcement. Last year, for example, \$30 million in non-tax revenue was turned over to the Foundation School Fund and the General Revenue Fund.

Contracted services as well as the consultants and services that the Education Service Center provide were then elaborated on to give a better idea of what the Special Education Department offers.

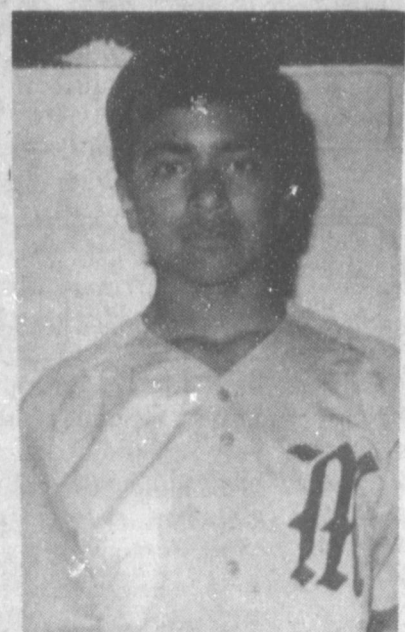

### CAN LOWER THE PROPERTY TAXES ON YOUR HOME

A homestead Exemption lowers the property taxes on your home by lowering its taxable value. For example, if your home is valued at \$50,000 and you receive a \$5,000 homestead exemption, your home will be taxed as if it were worth only \$45,000.

**You qualify** for a homestead exemption if you owned your home on January 1 and used it as your primary residence on January 1. It doesn't matter whether your home is a house, a condominium or a mobile home.

**Exemptions are available** to all homeowners on their school taxes. Additional exemptions are available to homeowners who are disabled or age 65 or over. Other exemptions may be offered to homeowners by school districts, counties, cities, and special districts. All taxing units offer exemptions to disabled veterans.

If you received a homestead exemption on your present home in 1988, you won't need to apply again for 1989 unless the chief appraiser requires you to reapply.

However, if you passed your 65th birthday or became disabled before January 1, file a new application to receive the additional exemptions.

If you haven't received an exemption on your present home, or if you've moved to a new home, make a new application for 1989.

**The deadline** for applications is April 30, 1989. Contact your appraisal district before then if you need more time.

# From The Senate

For a nine-year old boy a tour of the Texas Capitol is fun, but a tour of the Capitol dome is "neat!" The tour of the Texas Capitol is full of interesting historical facts. For example, the top of the dome stands 366 feet above the ground. This makes it taller than the United States Capitol in Washington, D.C. Or consider the fact that the entire Capitol dome is made not of pink granite but of sheet steel painted to look like the pink granite of which the rest of the Capitol is built. But maybe the "neatest" fact for a nine-year old is that of the four people who have died in our State's Capitol, one was a workman who, while working on the star at the very apex of the dome, and fell the entire 366 feet to the main floor, crashing through the floor and landing in the basement.

Anyone who is not bothered by climbing over 100 narrow, steep steps can go on a tour of the Capitol dome. The tours begin on the fourth floor of the Capitol building just next to the chapel. I took my son, Andrew, and his friend, Tate, on a tour of the Capitol dome recently. We were guided by Officer Fisher of the Capitol police. He stood straight and tall and was full of "neat" facts. The boys thought he was wonderful.

There is not much inside of the Capitol dome. Sitting on the floor beside the steps is a telephone. Officer Fisher asked the boys if they knew why there was a telephone way up here in the Capitol dome. Andrew's friend, Tate, responded instantly that its purpose must be to enable people to "report if they see something amazing."

Of course, beneath the dome there is an amazing amount of activity that takes place. Last week, among other things, Senate Resolution 167 was filed. I filed this Senate Resolution to allow the Boards of Trustees of West Texas State University, Texas A&M University, and the University of Texas to study the possibility of merging WT with one of these flagship institutions of higher education.

Since taking office, I have had as much constituent interest on this issue as I have on almost any other. I believe it is safe to say the catalyst for this interest was action taken in the last session of the Legislature wherein a Senate resolution was passed that authorized a study similar to this affecting several universities in South Texas. That study produced a recommendation that Pan American University merge with the University of Texas and Texas A&I University, Laredo State University and Corpus Christi University merge with the Texas A&M system. The Boards of each of these institutions voted to merge. Approval of these mergers is currently pending before the Texas legislature.

I have talked to many constituents including students, faculty, and administrators at West Texas. I have also spoken either directly or indirectly with every member of the Board of West Texas, University of Texas and Texas A&M as well as their presidents. Responses of all of these people to the idea of a study ranged from "I would not oppose such a move" to enthusiasm. I was informed by the folks at U.T. and A&M that they believe they need some type of legislative approval to engage such a study. A Senate resolution which is not required to pass the House of Representatives nor be signed by the Governor was sufficient authorization for the South Texas study. This being the case, it seems that a Senate resolution is the simplest way to go so as to facilitate a WT study.

So the purpose of the resolution is simply to allow the three schools to engage in a study. I took my lead from action taken by the WT Board the week previous to filing the resolution. The Board voted to create a subcommittee to study the positives and negatives associated with a merger. My resolution simply allows that study to be conducted with input from all sides.

There is one aspect of the resolution that I believe to be important. I believe that a question of this magnitude should not be answered without appropriate input from students, faculty, and alumni of WT as well as input from concerned citizens

of the region. Therefore, I made certain that the resolution called for this input.

The 71st Legislature has wisely adopted new rules severely restricting the number of legislatively authorized studies that can be staffed at State expense. This action was taken in response to a skyrocketing number of studies that cost the State of Texas a great deal of money. Because of these new rules, Senate Resolution 167 does not call for staffing at State expense. However, I was pleased to see that the Panhandle Area Alliance has volunteered its services to WT for purposes of staffing such a study.

It is obvious from the fact that I authored and introduced Senate Resolution 167 that I support study of the possibilities of merger between West Texas State University, University of Texas or Texas A&M University. But that is where my support

stops. At this point, I have no preconceived ideas as to whether a merger would be good for higher education in our part of the State or bad. Universities by definition provide a forum for the acquisition of knowledge through study. On occasion I believe it is entirely appropriate for universities to study themselves. Through this endeavor we will be able to gain knowledge-knowledge on which to base important decisions affecting the quality of higher education in Senate District 31.

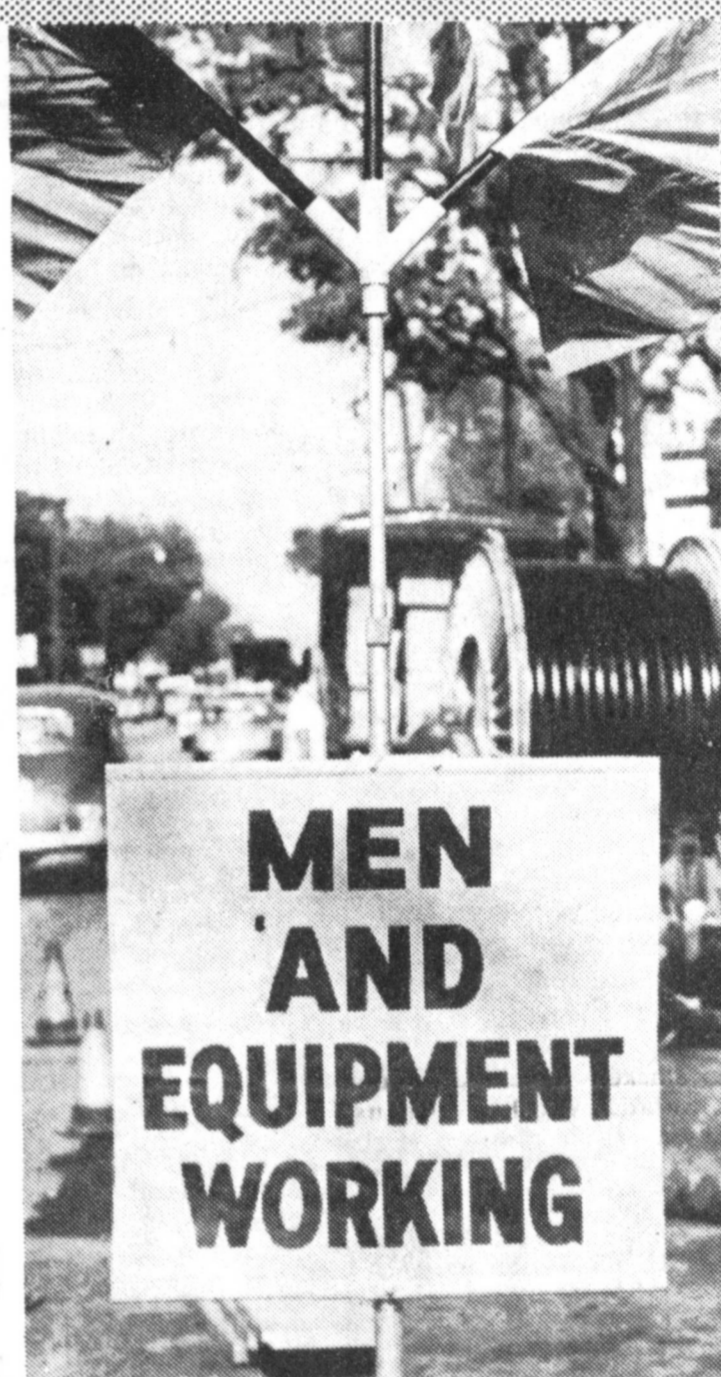

### MOCK TRIAL COMPETITION

One of the pleasures of being a teacher of young people is the opportunity to challenge them to stretch and reach difficult goals. There is no activity which challenges young students more or requires more effort than participating in the now national Mock Trial competition.

In order to make the team, the students compete with other students in the Muleshoe High School civic classes to show their proficiency. After making the team, they must accept the challenge of meeting a team from a much larger school district, a team which has had the opportunity to meet other teams in competition with the benefit of being critiqued after each competition. Because no other schools in Muleshoe's district enter this competition, the team members simulate this situation by competing within the team, the plaintiff's side against that of the defense.

After the team members accept this rather disadvantageous situation, they must also accept the knowledge that, unlike almost any other competition, all of the judges will be from the opposing team's city. Each year of the competition, the team members have accepted these conditions and have worked enthusiastically, giving up much of their free time, as well as forfeiting their ski break.

The Mock Trial members over the years have had some real advantages, however, in that the entire town and school of Muleshoe fully support them. Two local attorneys, namely Lindy Elder and Gordon (Corky) Green, freely give their time to help train the team member in courtroom procedure; interested merchants sponsor a TV video of the team presenting the case

over Channel 6, and local newspapers, TV Channel 6 and radio station KMUL all graciously give the team free advertising.

Muleshoe High School's Mock Trial team this year was made up of the usual high caliber of young students, Debbie Brown and Justine Hanes acting as attorneys for the plaintiff; Selina Gonzalez and Brandon Wilson acting as attorneys for the defense; Norma Jean Del Toro and Dusty Rhodes acting as witnesses for both the plaintiff and the defense; and the hard working alternates, Julie Crittenden and Troy Evins.

These team members were willing to spend many long, grueling hours preparing for the competition, and as they approached D-Day for the competition, team members felt they had anticipated many of the pitfalls which might befall them at the regional competition. Thus, the Muleshoe team met the best team from Lubbock, this year the team from Monterrey High School, at the Texas Tech Law School on Saturday, February 25, at 8:30 a.m. Muleshoe's defense first went up against Lubbock's plaintiff's side, each side performing almost to perfection. Although the Muleshoe team scored higher than the Lubbock team, the Lubbock team was chosen on "presentation." Next, Muleshoe's plaintiff's side went against Lubbock's defense. Again, each side performed excellently, but again, the Lubbock team was chosen and will proceed to the Statewide competition in Dallas.

Did the Muleshoe team lose? No, this was a team, as have been all former Muleshoe teams, which was willing to accept a difficult task against very formidable odds and were willing to work in order to make a presentation which thrilled those who watched. These students know that life has many lessons to learn, and as they go out into the world, they will be better prepared to accept the challenges of life. But losers, never!!!

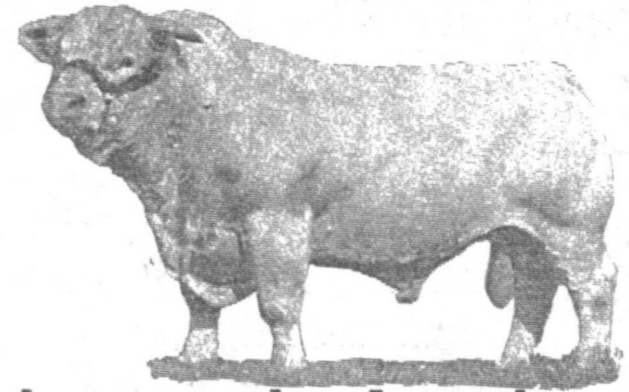
