SOME MORE EVERYDAY GOOD THINGS.

When one has a little leftover veal the following dish will be one worth considering.

Veal Stew.—Cut the remains of roast or cutlets into small morsels. Cover with cold water and cook over the simmering burner till very tender; add any remnants of gravy or of forcemeat and more seasonings if needed and bring to the boiling point. Thicken with a tablespoonful of flour or less of corn starch and cook ten minutes after adding.

Dumplings.—Take one cupful of flour, one teaspoonful of baking powder, one-fourth of a teaspoonful of salt and buttermilk to make a drop batter. Fresh milk may be used, adding a tablespoonful of butter to the flour mixture.

Potato Turnovers.—To one pint of hot mashed potato, seasoned well with salt, butter, cream and beaten egg, add one tablespoonful of flour and shape into round cakes rather thin. Place one tablespoonful of finely minced meat on top and fold over, pressing the edges together. Brush the top with egg and milk. Bake in a hot oven until well browned. Serve piping hot with

Brown Sauce.—Put one tablespoonful of butter in a saucepan and when brown add one tablespoonful of flour, mix and then add one cupful of hot stock with salt and pepper with onion juice if desired for seasoning. A half cupful of finely minced mushrooms will be an addition.

Cream Scones.—Take one cupful of flour, one teaspoonful of baking powder, two tablespoonfuls of butter well rubbed into the flour, one-fourth teaspoonful of salt, one well beaten egg and thin cream to make a mixture that will roll out, keeping it as moist as possible. Cut in diamond shapes, brush with egg, sprinkle with sugar and bake in a hot oven.

Coffee Creams.—Take one cupful each of strong coffee and thin cream, one-half cupful of milk, four eggs beaten until well mixed, four tablespoonfuls of sugar and a pinch of salt. Cook in cups set in hot water, baked in a moderate oven. Serve cold. Nice with scones.

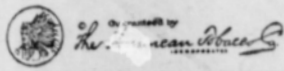

SAY NEW RELIGION SPREADS

Chinese Reported to Take to Mixture of Christianity, Taoism, Confucianism, and Buddhism.

It is reported that a new religion termed the "T'ai-chiao" has been established among the Chinese people of the upper and middle classes and is rapidly gaining ground. Teachers of the new creed state that it is a religion comprised of Buddhism, Confucianism, Taoism and Roman Catholicism and other Christian beliefs. The god, which is the object of worship, is T'ai-jen, a figure of imagination. St. Mary and the monk, San Tsang, who is said to have brought Buddhist scriptures to China from India in the Tang dynasty, are also worshiped. The scriptures, which take the place of the Bible in Christianity, are the Book of Lao-tze.

This new religion is now prevalent throughout all provinces in China. It was propagated in Shantung by, it is said, a former premier, Chien Neng-hsun, and he now has the following of many high and influential people. The believers hold three regular meetings a week, and go through ceremonies which require more than four hours for completion. In Peking, the religion is said to be gaining ground among the officials connected with the government. Apart from new religious reports have been coming from different places for some time of a revival of Buddhism, and not a little money is being spent in re-decorating temples and images.—North China Herald.

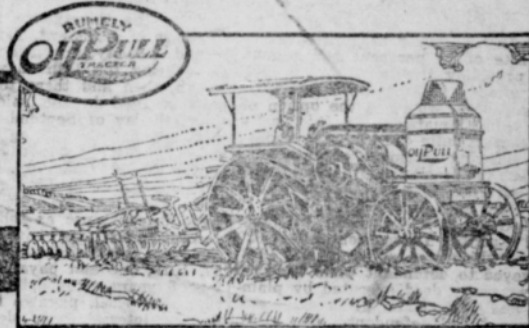

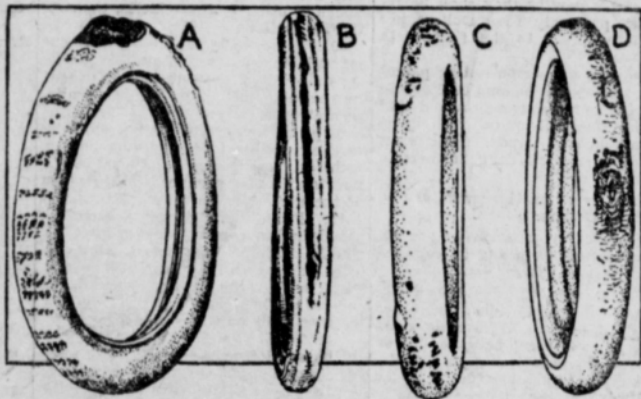

TIRE WASTE IS ESTIMATED AT \$150,000,000 IN THE YEAR 1920



Some Common Abuses of Tires—A Shows the Result of Improperly Fitted Tire Chains—B, Faulty Wheel Alignment—C, Neglected Cuts, and D, Results of Skidding.

We Americans have been extravagant. We have literally educated ourselves to be careless with the most expensive things we buy. It is conservatively estimated that the carelessness of American motor car drivers during 1920 cost them in round figures \$150,000,000, and this applies only to tires. What has been your share? You have contributed your bit. You must now take this tire problem seriously. Get every mile out of every tire that the manufacturer has built into it. If you don't you are the loser and if everybody is a loser then the tire deficit for 1921 will outrival last year, for there are more motor car owners today than there were a year ago.

Good Advice to Follow.

If you follow the advice given in this article you will get more service from your tires, and at the end of the season your expense will have been so much less than it ever was before that you will no longer neglect your tires.

The illustrations shown here are of the genuine abused tires, hundreds of which are discarded every day throughout the United States before they have given the service for which they were built. The mileage was built into each tire, but the car driver lost it through carelessness.

Illustration A shows the result of improper application of tire chains. When chains are used they should not be applied tightly. Leave them just loose enough so that every time the wheel turns the cross chains will not strike the same spot in the tire. If you do not heed this advice you

might preserve this illustration as an actual picture of your tire.

A more common tire injury is shown in illustration B. This effect is due to faulty alignment of the front wheels. A bent axle or steering knuckle may be responsible or possibly the demountable rim was not perfectly applied.

Accidents are not always responsible for the front wheels being out of alignment, but frequently this is the case. All cars, through no fault in manufacture, are subject to this condition, and the first indication will be given when you notice the tread of one or both tires wearing as though a rough file had been used on them. If the tread becomes worn through and the fabric affected, then the tire is beyond repair. Correct trouble quickly to avoid necessity of this. There is but one remedy, and that is care. Test your front wheels frequently and be sure that they are in proper alignment.

Neglected Cuts.

Illustration C shows a casing with two-thirds of its life wasted, for neglected cuts in the tough rubber tread have caused it to blister. In this instance sand and dirt have been forced into the cuts and worked around under the tread. Note the several large bumps where the sand and dirt have accumulated. If a tire is carefully watched for these cuts a plastic will heal them quickly and no damage will result.

The tire shown at D shows the effect of skidding, caused by a sudden application of the brakes. Part of its face has been scraped off. Purely carelessness.

THE EULOGY ON THE DOG

Missouri Masons love this little speech, so full of love of God and man:

"The Eulogy on the Dog," one of the most famous speeches ever made by the late Senator George G. Vest, of Missouri, was made in the course of a trial of a man who had wantonly shot a dog belonging to a neighbor. Vest represented the plaintiff, who demanded \$200 damages. When Vest finished speaking the jury, after two minutes deliberation, awarded the plaintiff \$500. The full text of the speech follows:

"Gentlemen of the Jury: The best friend a man has in this world may turn against him and become his enemy. His son or daughter that he has reared with loving care may prove ungrateful. Those who are nearest and dearest to us, those whom we trust with our happiness and our good name, may become traitors to our faith. The money that a man has he may lose; it flies away from him, perhaps when he needs it most. A man's reputation may be sacrificed in a moment of ill considered inaction. The people who are prone to fall on their knees to do us honor when success is with us may be the first to throw the stone of malice when failure settles its cloud upon our heads. The one absolutely unselfish friend that a man can have in this selfish world, the one that never deserts him, the one that never proves ungrateful or treacherous is his dog. Gentlemen of the jury, a man's dog stands by him in prosperity and poverty, in health and in sickness. He will sleep on the cold ground where the wintry winds blow and the snow drives fiercely, if only he may be near his master's side. He will kiss the hand that has no food to offer; he will lick the wounds and sores that come in encounter with the roughness of the world. He guards the sleep of his pauper master as if he were a prince. When all other friends desert he remains. When riches take wings and reputation falls to pieces he is as constant in his love as the sun in its journey through the heavens. If fortune drives his master forth an outcast in the world, friendless and homeless, the faithful dog asks no higher privilege than that of accompanying him to guard against danger, to fight his enemies, and when the last scene of all comes, and death takes the master in its embrace and his body is laid away in the cold ground, no matter if all other friends pursue their way, there by his graveside will the noble dog be found, his head between his paws, his eyes sad but open in alert watchfulness, faithful and true even to the end."

Concrete Boats in Italy.

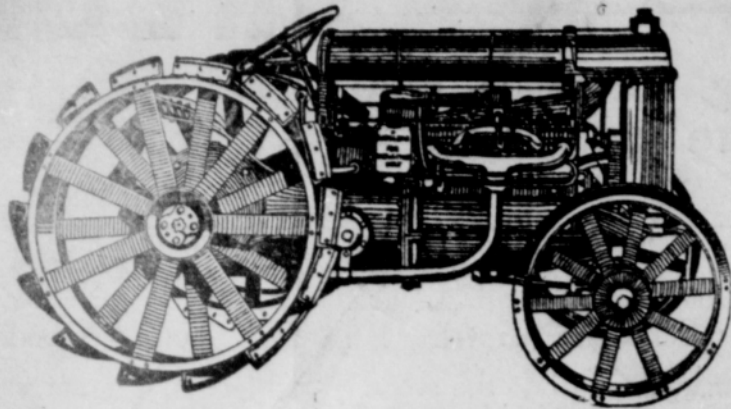
Some years ago there was first broached the question of using concrete for shipbuilding, and since that time there have been many successful and practical applications of this idea. Indeed, the inventor Gabriellini has succeeded in inducing the Italian government to adopt it for certain purposes connected with the navy. These boats have double skins and water-tight compartments, and, being craft of about 100 tons each, are able to withstand shocks by collision to a surprising extent. Their draft is little more than that of wooden vessels of the same size. A special advantage is that they neither rot nor rust; and they are easily kept clean. Many canal barges of the same material are in use in Italy; and concrete has been found particularly well adapted for the constructing docks and caissons.

CITY ORDINANCES

Passed by the Aldermen of the town of Spearman, Texas, in Regular Session Assembled:

In the interest of better government and the general welfare of the community, it is necessary that the Board of Aldermen of the Town of Spearman, Texas, establish a set of rules or ordinances suitable for the proper administration of the community affairs.

Therefore, be it ordained, by the Board of Aldermen, of the Town of Spearman, Texas, that the following set of rules or ordinances be enacted, published and spread on the minute book of the said Town of Spearman, Texas:

AN ORDINANCE TO LEVY AN ANNUAL OCCUPATION AND LICENSE TAX ON OCCUPATIONS IN THE CITY OF SPEARMAN, TEXAS, AND TO PROVIDE FOR THE COLLECTION THEREOF.

Art. 1. Be it ordained by the Board of Aldermen of the town of Spearman, Texas, in council assembled:

That there shall be levied on and collected from every person, firm, company or association of persons pursuing any of the occupations named in the following subdivisions of this ordinance in the city of Spearman, Texas, an annual occupation tax, which shall be paid annually in advance, except when otherwise provided, on every such occupation or separate establishment as follows:

1. From every merchant who may remove from place to place and offer for sale bankrupt stock of goods, or advertise fire sale or water damaged sales for a limited period of time, the sum of Fifty Dollars per month, for the first month or less than a month, and for each additional month the sum of Ten Dollars per month, provided that where they remain in town for a period of six months they shall be required to pay only Five Dollars per month in addition to the first Fifty Dollars.

2. From every person selling patent or other medicines, the sum of Twenty-Five Dollars per annum, provided that this article does not apply to wholesale salesmen soliciting trade from merchants doing a legal drug business in this town.

3. From every auctioneer an annual tax of Five Dollars.

4. From every person, firm or association of persons selling on commission, the sum of Five Dollars.

5. From every itinerant physician, surgeon, oculist or medical or other specialist of any kind, traveling from place to place in the practice of his or her profession, except dentists practicing from place to place in the county of their residence, the sum of Twenty-Five Dollars.

6. From every person or firm operating a shooting gallery at which a fee is paid or demanded, the sum of Fifteen Dollars.

7. From every foot peddler, every peddler using wagon and team, and from every peddler using automobile or truck, the sum of Five Dollars per annum, provided nothing herein shall be construed as to include traveling vendors of poultry, vegetables, fruits or other country produce exclusively, when such country produce is actually raised or produced on the farm of the person or persons selling same.

8. From every circus or wild west show, where rough riding or acrobatic feats are performed or exhibited for pay, the sum of Seventy-Five Dollars.

9. From every menagerie, side show or carnival, the sum of Five Dollars for each performance, or in case of a carnival, the sum of Five Dollars for each stall, knife rack, doll rack, or any other attraction connected with such carnival where an admission fee is charged or collected or where any article is sold.

10. From every exhibition where acrobatic feats are performed and an admission fee is charged or collected, the sum of Five Dollars for each such performance.

11. From every sleight-of-hand performance or exhibition of ledger domain, not connected with theatre or circus, the sum of Twelve Dollars and Fifty Cents.

12. From each owner or keeper of a motion picture show, used for profit, the sum of Twelve Dollars Fifty Cents.

13. From each person or firm engaged in the general merchandise business, the sum of Twenty-Five Dollars.

14. From each person or firm engaged in the dry goods business, the sum of Twenty Dollars.

15. From each person or firm engaged in the ladies' and (or) gents' furnishing business, the sum of Twenty Dollars.

16. From each person or firm engaged in the retail grocery business, the sum of Twenty Dollars.

17. From each person or firm engaged in the retail drug and (or) notion store, the sum of Twenty-Five Dollars.

18. From each person or firm engaged in the retail hardware and (or) furniture business, the sum of Twenty-Five Dollars.

19. From each person or firm engaged in a general retail lumber business, the sum of Twenty-Five Dollars.

20. From each person or firm engaged in the hotel business, the sum of Fifteen Dollars.

21. From each person or firm engaged in the business of running a barber shop, the sum of Ten Dollars.

22. From each person or firm engaged in the business of running a public garage and (or) dealing in automobiles, the sum of Twenty-Five Dollars.

23. From each person, firm or association of persons engaged in the business of buying, selling grain and operating elevators, the sum of Twenty-Five Dollars.

24. From each person or firm engaged in the business of buying, selling or brokering real estate, the sum of Twenty Dollars.

25. From each person, firm or corporation engaged in the business of selling oils and gas at wholesale, the sum of Twenty-Five Dollars.

26. From each person or firm engaged in the practice of medicine, or of law, or any other profession for

which a fee is charged, the sum of Ten Dollars.

27. From each person or firm engaged in the business of draying or transferring or running a livery business, the sum of Fifteen Dollars.

28. From each person or firm engaged in the running of a restaurant or eating house, where meals or short orders are served to the public, the sum of Ten Dollars.

29. From each person, firm or corporation engaged in the general banking business, the sum of Twenty-Five Dollars.

30. From each person or firm engaged in the business of running a newspaper print shop or job print shop, the sum of Twenty Dollars.

31. From each person or firm engaged in the business of running a blacksmith shop, the sum of Fifteen Dollars.

32. From each person or firm engaged in the telephone business operating a switch board, the sum of Twenty Dollars.

33. From each person or firm engaged in the abstract business, the sum of Fifteen Dollars.

34. From each person or firm engaged in the shoe repair business, the sum of Five Dollars.

35. From each person or firm buying, selling and shipping country produce, the sum of Fifteen Dollars.

36. From each person or firm engaged in selling meat at retail over the counter in a meat market or upon the streets from house to house, the sum of Ten Dollars, provided that nothing herein shall be construed as to include persons who actually raises the meat so sold from house to house.

37. From each person or firm engaged in the business of running a wagon yard, the sum of Ten Dollars.

38. From each person running a feed store and (or) feed mill, the sum of Ten Dollars.

39. From each person or firm running a filling station, for automobiles, trucks or other motor vehicles, the sum of Five Dollars.

40. From each person or firm engaged in the business of peddling, selling or offering for sale any article of merchandise, including meats, fruits, vegetables, etc., the sum of Ten Dollars, provided nothing herein shall be so construed as to include vendors of such articles herein mentioned when such is raised or produced on the place of the person or persons selling same.

41. From every person or firm engaged in the contracting business, including building contractors, stone or brick masonry, or any other avocation where work is done under contract, the sum of Fifteen Dollars, and sub-contractors shall pay the same license.

Art. 2. The receipt of the City Marshal, as collector of taxes for said town of Spearman, Texas, shall constitute the license of the persons pursuing the occupation herein taxed, and all taxes are payable in the currency or coin of the United States.

Art. 3. It is hereby made the duty of the collector to report monthly, at the regular meeting of the Board of Aldermen, the amount of occupation tax collected. If the collector knowingly fails to collect or try to collect any occupation tax, or shall receive any occupation tax without giving therefor proper receipt, as herein provided for, he shall, upon conviction, be deemed guilty of malfeasance in office and summarily dismissed therefrom.

Art. 4. The mayor shall have occupation tax receipts, in blank, printed with their signatures and stubs in blank, which shall show when a receipt was issued, and for how long it was issued. The mayor shall take the collector's receipt for the number of blanks issued and at the end of each month shall collect the same up and see that he has accounted for all receipts issued up to date.

The foregoing ordinance was passed by resolution at a regular meeting of the Board of Aldermen, in council assembled, this 18th day of October, 1921.

ORDINANCE NUMBER 2

An Ordinance pertaining to and establishing a street tax.

Be it ordained by the Board of Aldermen of the town of Spearman, Texas, that there shall be assessed against each and every male resident of the town of Spearman, Texas, between the ages of twenty-one and forty-five, both inclusive, except ministers of the gospel actually engaged in the discharge of their duties, an annual street tax in the sum of Five Dollars, which street tax may be paid in money or in labor upon the streets of the town; provided that the one so working on the streets shall receive not more than the sum of One Dollar per day for such work on the streets.

The foregoing ordinance was passed by resolution at a regular meeting of the Board of Aldermen, in council assembled, this 18th day of October, 1921.

ORDINANCE NUMBER 3

An Ordinance regulating the use and driving of automobiles and other vehicles on the streets of the town of Spearman, Texas:

Be it ordained by the Board of Aldermen of the town of Spearman, Texas, that all persons operating automobiles, truck or other vehicles on the streets of the town of Spearman, Texas, shall drive on the right hand side of the street, and shall drive to the center of the intersection of cross streets and turn around the markers in the center of street crossings on all streets of the town, where markers are erected. It shall be unlawful to drive any motor vehicle on the streets of Spearman, Texas, exceeding a speed of ten miles per hour, and be unlawful to drive at night on such streets without proper lights. All cars shall be parked in the center of the streets on all business streets, and when starting the driver must back his car to the side of the street from which he turned in and continue on the right hand side of the street.

ORDINANCE NUMBER 4

An Ordinance providing a penalty for the violation of the provisions contained in Ordinance Number Three.

Be it ordained by the Board of Aldermen of the town of Spearman, Texas, that persons violating any of the provisions contained in Ordinance Number Three, shall be fined in any sum not less than Five Dollars and not more than One Hundred Dollars, and such fines may be payable either in money or in labor upon the streets of Spearman, Texas, at the rate of One Dollar per day.

ORDINANCE NUMBER 5

An Ordinance defining what shall be termed misdemeanors, and prescribing penalty for same:

Be it ordained by the Board of Aldermen of the town of Spearman, Texas, that it shall be unlawful for any person or persons to engage in fights or affrays within the town of Spearman, Texas, and it shall be unlawful to use vulgar, profane or obscene language in any public place within such town, or to commit any act which, by the statutes of Texas, constitute a misdemeanor. The penalty for which shall be a fine in the sum of not more than One Hundred Dollars, and such fine may be payable either in money or in labor upon the streets of Spearman, Texas, at the rate of One Dollar per day.

The foregoing ordinance was passed by resolution at a regular meeting of the Board of Aldermen, in council assembled, this 18th day of October, 1921.

ORDINANCE NUMBER 6

An Ordinance prescribing the duties of the town Marshal:

Be it ordained by the Board of Aldermen of the town of Spearman, Texas, that it shall be the duty of the city marshal, in addition to the regular duties prescribed by the statutes, to take care of the city well and water works; he shall have the authority of street overseer, being empowered thereby to warn out persons to work on the streets and to collect the street taxes from such persons who prefer to pay cash. He shall have charge of all persons working out their fine, as imposed by the ordinances; shall perform such other duties as may be prescribed by the Board of Aldermen. It will also be his duty to assess and collect occupation tax from the various persons or businesses on which an occupation tax has been levied.

The foregoing ordinance was passed by resolution at a regular meeting of the Board of Aldermen, in council assembled, this 18th day of October, 1921.
