More than a year has elapsed More than a year has elapsed since the American Red Cross launched, in August, 1930, its first moves for relief of the drought stricken farmers, and in that time more than 2,750,000 persons were given food, clothing, medical aid shelter or other type of assistance. At no period during this year were there fewer than 70,000 persons being aided and at the peak of the relief work on March 1, last, more than 2,000,000 persons were being helped. helped.

Today, still as a result of the drought, the Red Cross is giving extended relief in parts of North Dakota, Washington and Montana hundreds o resources families were wiped out this past when a second and more weather was


