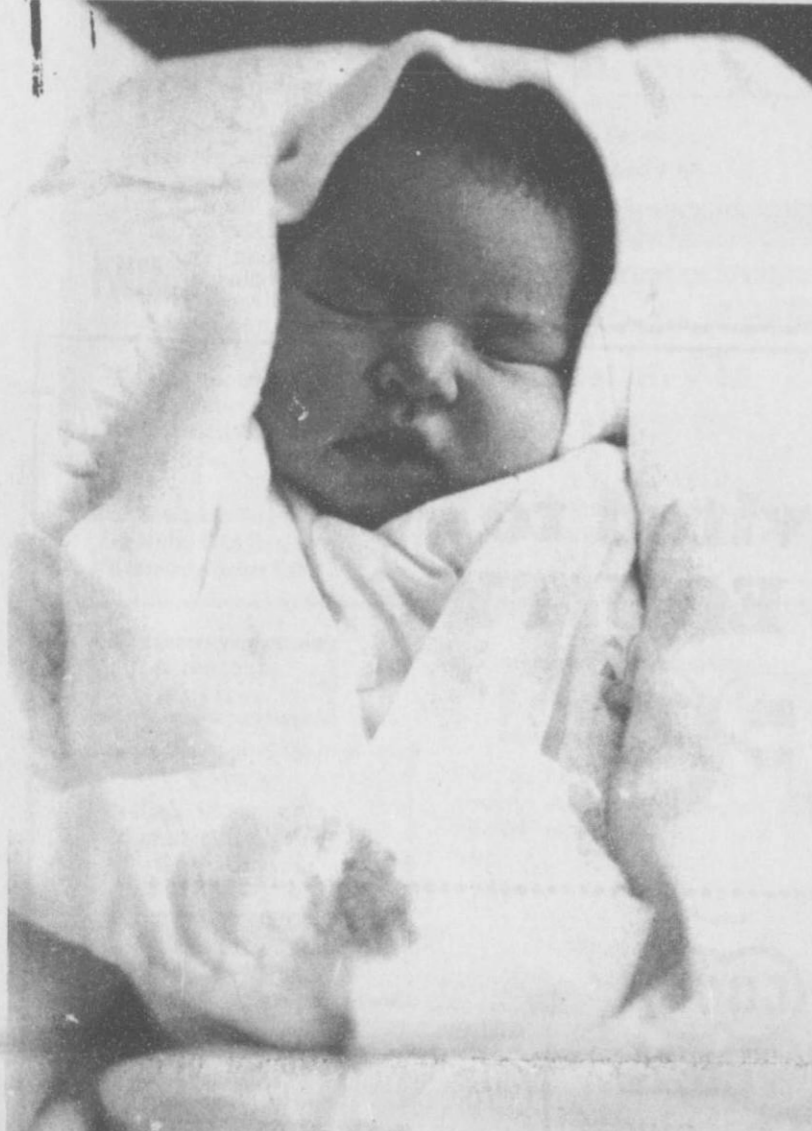

Wheat, barley, oat deficiency payments made in county

The Hansford County office of the U.S. Department of Agriculture is in the process of distributing a final deficiency payment to producers of wheat, barley and oats, Keith Martin, manager of the local ASCS office said.

Due to a central computer foul-up in Kansas City, Martin said, some of the PIK certificates came out with the wrong amounts.

Martin said the first deficiency payouts made in 1986 were ignored by the computer, resulting in PIKs which reflected a too-large amount.

Checks sent out by the same office were more accurate, Martin said.

"We're writing a lot of checks ourselves, plus making advance payments and loans, and we're just swamped," Martin said.

In spite of the computer errors Martin stated that Hansford County would receive 4.8 million dollars for the PIK program. The wheat program with payments made in June, July and December total 9.4 million dollars.

The target price set for 1986 wheat by the federal government was \$4.38; the loan level was \$2.40. This left a deficiency payment due the producer of \$1.98.

An advance payment of 91.5 cents was requested by most producers, leaving a balance of \$1.065. In some cases, an additional 10 percent payment was made.

The first of the final payments was due Dec. 15, but were not made because of the computer errors. Each payment is now being manually rechecked by the Hansford office, with new payments being issued in case of computer errors.

The deficiency payment was 65 cents per bushel for barley, and 37 cents for wheat. Eligible barley and oat producers will receive additional deficiency payments in July if the national average market prices are below the loan rates.

Milton Hertz, administrator of the national ASCS program, said the additional deficiency payments will be paid 50 percent in cash, and 50 percent in Payment in Kind certificates.

The cash payment however, will be subject to a 4.3 percent reduction to comply with provisions in the Gramm-Rudman Hollings balanced budget act.

Farmers are reminded that the ASCS office will be closed from 8:00 a.m. to 12 p.m. on Tuesday and Thursday to do the paper work to serve our farmers better.

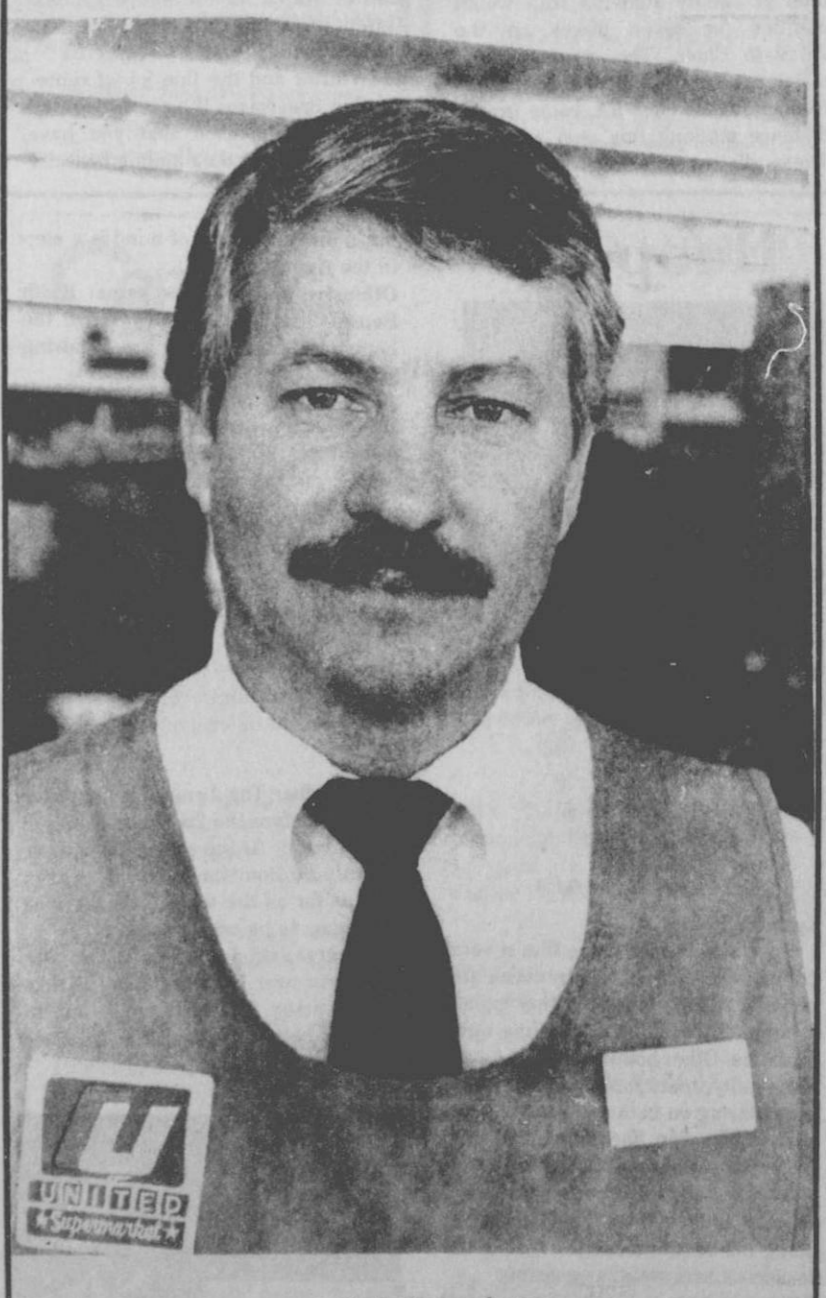

Kellie McWhirter makes the All State Choir First Chair

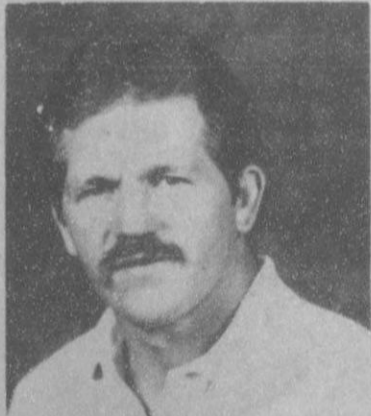

but a positive frame of mind is a step in the right direction.

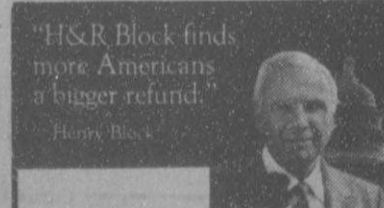

\$35.1 Billion to finance the State's Budget for 1988-89

AUSTIN, Tex.—State Comptroller Bob Bullock Friday forecast Texas will have an estimated \$35.1 billion to finance the state's 1988-89 budget, down slightly from the past two years.

"Whether this means there will be a deficit—or what size it might be—rests squarely with the Legislature because they set the level of spending," Bullock said, "but even if they hold the line as suggested by the LBB, we're looking at a \$5.8 billion shortfall."

"Neither state finances nor the Texas economy are as vibrant as they have been in the past and the state's economy will expand modestly in the next two years."

Bullock's estimate also cautioned that there will be less money available for general spending because of the state's heavy reliance on dedicated funds and the \$1 billion deficit being carried over from the current budget.

"The final story will be determined by how the Legislature mixes and matches income with costs," he said.

The bulk of the money to operate government will come from the tax collections, which are expected to total about \$20 billion.

Tax receipts are expected to be about three percent less than currently being collected and the drip is the first biennial decline in some 30 years.

Sales tax collections, which account

for more than half of all collections, will increase by only 2.5 percent above the current level because of modest economic growth and the 1987 temporary tax rates expire on August 31, 1987.

Oil taxes are expected to fall nearly 20 percent over current levels because of low prices and declining production. The revenue estimate is based on an average price of \$15 a barrel of oil.

The revenue estimate also noted that Texas' tax system is out of step with the state's economic system.

"The state's tax system leans too heavily on oil and gas, barely touching the service-producing industries that will be growing in 1988 and 1989," the estimate noted.

Income from oil and natural gas taxes amounted to 12.7 percent of collections in the 1986-87 budget, but will only account for a total of 10.3 percent in the next two years.

Key economic assumptions in forecasting revenue to Texas government show the state's population is likely to grow only 2.3 percent in the next two years, compared to 3.1 percent in 1986-87 and more than 4.4 percent in the 1984-85 period.

The value of the state's gross product will climb from \$283.6 billion in 1987 to \$290 billion in 1989, a modest 2.3 percent.

Calcium Intake And Kidney Stones

More and more women are turning to calcium supplements to help ward off osteoporosis, the bone-thinning disease that strikes half of all women in the United States over age 45 and 90 percent of those over 75.

Researchers believe that most women simply don't get enough calcium in their daily diet, a major risk factor for osteoporosis, and that calcium supplements are an easy way to get the required daily amount of the mineral.

But can there be too much of a good thing? The answer is a qualified maybe. Megadoses of calcium may lead to kidney stones in certain individuals.

When it comes to kidney stones, medical opinion differs widely on the role of calcium in that painful condition. Some researchers dismiss the notion of any link between dietary calcium and kidney stone formation. But most experts caution that calcium consumption should remain within recommended limits (not exceeding 1,500 mg per day) and should be combined with lots of liquids throughout the day to add an extra margin of safety.

Dr. Charles Y. Pak, one of the country's leading experts on calcium and chief of the University of Texas Health Science Center's mineral metabolism department, says: "There are very few documented publications dealing with stone formation in people taking calcium, but there are a lot of anecdotal experiences." He plans to conduct a study soon which may lead to some much-needed answers. In the meantime, Dr. Pak has identified individuals who may be at risk of developing kidney stones. They are people with a family history of kidney stones, a history of gout or bowel disorders, or patients taking certain diuretics (water pills). Men are three times

more likely than women to develop kidney stones, and young women are at greater risk than those who are of middle age and older.

On the other hand, some authorities minimize the role of calcium in kidney stones. Dr. Louis Avioli, professor of medicine at Washington University in St. Louis states: "While calcium is present in a variety of kidney stones, the most important factors in stone development in the normal population are low urinary output and high levels of urinary oxalate or uric acid. These substances come from things in the normal diet like spinach, meat, fish and fowl, sodium, refined carbohydrates, Vitamin C supplements, tea and cola drinks."

Where does that leave women who wish to ensure good bone health through calcium supplementation? Many medical issues and treatments must be looked at in the context of benefit and risk. For most women, the risk of developing brittle bones is far greater than that of developing kidney stones.

Dr. Avioli stresses the need for women to get at least 1,000 mg of calcium per day, either from food sources or from calcium supplements like Os-Cal. Those individuals who fall into a risk group or are worried about developing kidney stones should seek their doctor's advice before making any major diet changes.

Q. I pay \$400 a month in child support. Need I include a new IRS form signed by my ex-wife with my 1986 tax return to continue claiming my children as dependents?

A. You do. IRS Form 8332 is required for non-custodial parents claiming the dependency exemption.

Q. Can I claim my ex-wife as a dependent for that part of 1986 in which we were still married?

A. No. Your marital status at the end of the year determines your filing status. You may deduct alimony if it was paid under a written separation agreement, even without a court decree.

Q. Can I report some of the interest income on U.S. Savings Bonds (E bonds) if I've been deferring reporting till they mature?

A. Maybe. You first have to get permission from the Commissioner of the IRS to change your reporting method.

Q. In 1985, my husband and I filed separate federal income tax returns. We have since discovered we could have saved had we filed jointly. Can we do anything about that now?

A. Yes, you may change to joint returns for 1985. If you filed the original returns on time, you have until April 15, 1989.

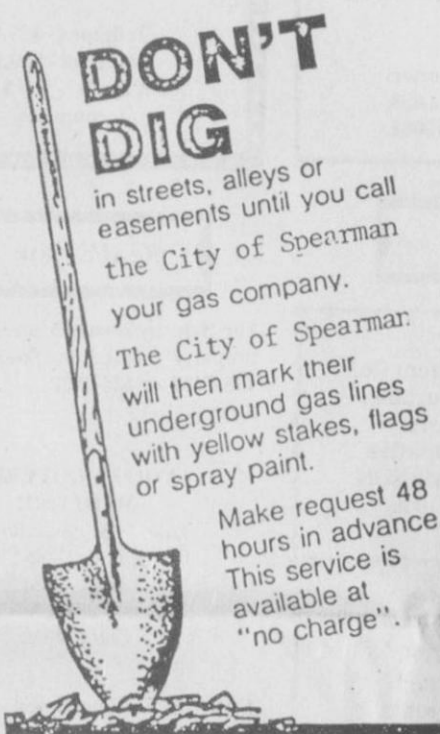

Selective Service System

Men turning 26 in 1987 reach an important milestone

The selective service system has announced that men who will reach their 26th birthday in 1987 are reaching an important milestone.

Beginning on Jan. 1, 1987, men who were required to register with selective service in 1981 will be turning 26. Selective service does not have the authority to accept registrations after age 26. By failing to register before turning 26, a young man will have permanently forfeited his right to certain benefits including federal student aid, job training and federal employment. In addition to these federal benefits, some states require registration for state student aid, entrance to a state supported college or university, state employment and permission to practice law.

Many of the 25-year-olds who have still not registered may be unaware of the requirement or do not understand the importance of the obligation to register. Some may even have served in the military but failed to register either before entering the armed forces or after leaving active duty. Others may have been institutionalized or incarcerated at the time of their 18th birthday and not realized that they were required to register if released prior to age 26.

For those men born in 1961 who have registered, 1987 also marks the year that ends their eligibility for selection for induction under present law should there be a return to the draft. Over 17 million men, age 18 through 25 have registered with selective service since registration was

reinstated in 1980. These men comprise over 97 percent of those required to register.

Men age 18 to 25 who have not yet registered still have a chance to avoid risk of prosecution and loss of benefits by registering promptly at any local Post Office. Failure to register is a felony punishable by a fine of up to \$250,000, up to 5 years in jail, or both.

Drug and Alcohol Update

RECOVERING SUBSTANCE ABUSERS CAN PREVENT RELAPSE BY AVOIDING ROADBLOCKS TO RECOVERY

Lydia Seemed to have everything. Fashionable friends. Expensive clothes. A prestigious job.

But for several years, Lydia, who was addicted to alcohol and valium, had been holding together her seemingly perfect life threads.

At her husband's insistence, she sought inpatient care several times. But within months after leaving treatment she slipped back into her old patterns of use and abuse until she had been hospitalized five times in as many years.

Some may consider Lydia the victim of her own lack of self-discipline. But in reality she was suffering from an illness that, not unlike other serious diseases, entails a slow, sometimes painful healing process and the ever-present risk of relapse.

But setbacks can be prevented if the chemically dependent person is continually vigilant about the following roadblocks to recovery encountered by virtually every newly sober person.

--Impatience. Recovering people, anxious to feel good as quickly as possible, often are discouraged when occasional feelings of anger, frustration or depression still occur weeks or months after treatment.

--Boredom. Those in recovery frequently don't know how to fill the extra time on their hands since they're

no longer spending much of their day using or pursuing their drug of choice.

--Loneliness. Newly sober alcoholics or drug abusers often feel extremely isolated since they usually must sever all ties with friends who still drink or use drugs.

--Complacency. Once they're sober a while, recovering people may feel overly confident about their ability to resist drugs or alcohol. They may skip more and more meetings of Alcoholics Anonymous or Narcotics Anonymous until they rarely, if ever, go.

Guarding against these roadblocks entails knowing how to maneuver around them.

One of the best detours is the maintenance of close, continual contact with the recovering community--especially when one doesn't feel the need. Former CareUnit patients retain ties with other newly sober people by regularly attending aftercare meetings. Others can frequent gatherings of Alcoholics Anonymous or Narcotics Anonymous.

Another important key to maintaining sobriety is to fill new-found spare time with activities--sports, exercise classes or active hobbies such as woodworking or gardening.

Avoiding old friends or former "watering holes" which may tempt one to drink or use again is another critical part of the recovery process.

Recovering people also need to be vigilant about less obvious forms of temptation. Many medications, candies--even toothpastes--contain alcohol or drugs that can send the unsuspecting chemically dependent person into relapse.

Special caution in avoiding the roadblocks to recovery should be taken by the newly sober person who lives alone, doesn't work or who is surrounded by people still using or who don't understand chemical dependency.

by perhaps the most important thing to remember about relapse is that it doesn't have to be permanent.

For Lydia, lasting sobriety resulted when she finally accepted the severity of her illness after her husband confronted her with snapshots he had taken of her while she was passed out on the kitchen table following a drinking binge. After five relapses, she's celebrating her fifth year of sobriety.

Although the tendency among those who "slip" and drink or use again is to feel they're a failure, the best response is to put the relapse behind them and continue working at sobriety one day at a time. It's also essential to talk about the relapse with someone who understands and can help prevent a recurrence.

But if relapses occur over and over with increasing regularity and severity, one may need to seek help through further treatment.

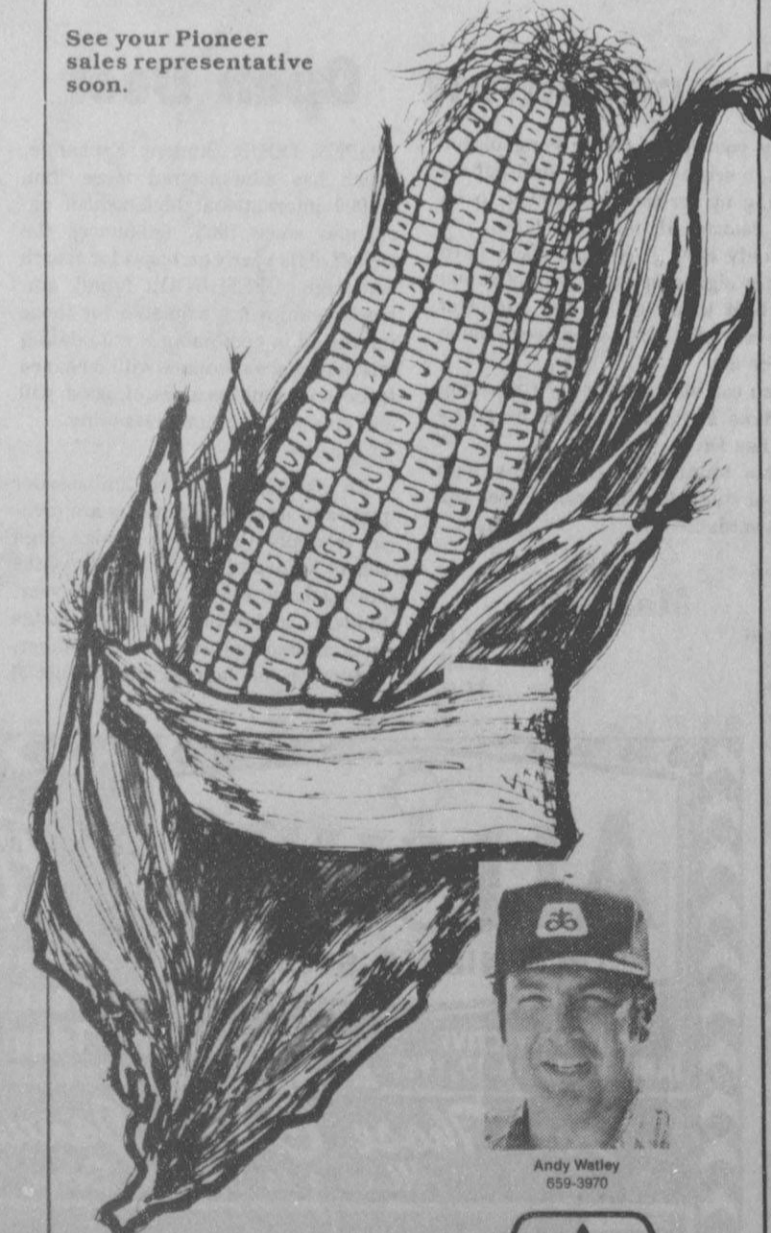

Finally, parents can initiate discussions at home and with other parents about services offered by community-operated, school-based family planning clinics to make counseling by trained personnel accessible to students.
