## Second Annual Panhandle Relays

## Raise \$1,500 For Center

An early-morning swim kicked off the Second Annual Texas Panhandle Relays, and a latemorning run ended the relay along a 43.2-mile course, beginning at Borger and ending at Spearman.

The Aug. 19 race began at 7:40 a.m. with a 400 meter swim at the Borger Community Activity Center and ended with the last runner crossing the finish line, near Spearman's Swimming Pool Park. at 11:39 a.m. that morning. The distance in between was covered in varying increments by runners and bicyclists in an effort to be part of the team with the quickest elapsed time.

The anchorwoman for the first place team crossed the finish line at 10:22 a.m.!

A total of 13 teams, made up of 117 people, were entered from Spearman, Borger, Pampa, White Deer, Panhandle, Sunray, Amarillo, Fritch. Dumas, Stinnett and

## Farming Is A

## Dangerous Profession

Farming is America's most dangerous profession, according to statistics released recently. Agriculture's accidental death

rate is five times the national average for all injuries, said Thomas D. Valco, agricultural engineer for safety and mechanization with the Texas Agricultural Extension Service.

Valco said the Texas safety picture parallels the national scene.

"The summer and fall months typically are the worst for farm and ranch fatalities," he said.

A total of 82 fatalities occurred on Texas farms and ranches in 1988, Valco said. Records of fatalities were obtained from death certificates and newspaper clippings.

'Most fatalities took place as a result of farm/ranch activities, but several deaths were a result of recreational activities such as hunting, swimming and horseback riding," he said.

Valco said the highest number of fatalities took place in July, with 13 deaths; while September followed with 12 and October with

The age group between 20 and 29 recorded the highest fatalities with 15 deaths. About 47 percent of these were from gunshot

Next highest age category was between 60 and 69 years, with 12 deaths recorded. This group was followed by those 70 years or

older, with 11 deaths. "Eight children under age 10 died as a result of farming accidents. Many resulted from youngsters riding on farm tractors that hit a bump causing the child to fall under the equipment. Tractors have only one seat, and extra riders should not be permitted," Valco said.

He said tractors and associated machinery were the cause of 28 of

all the recorded fatalities. Fortyeight percent of the machinery accidents was the result of people being run over by the tractors and equipment. Another 40 percent of the fatalities occurred from tractor

"Simple rollover structures could have prevented most of these deaths," Valco said.

Fatalities involving firearms were the next most frequent killer with 14 deaths. Most happened while hunting, being shot by another hunter or mishandling their firearm.

'Many of these victims lived in urban areas. Ranch owners need to insure that visitors follow safe hunting rules and require them to take firearm safety training,' Valco said.

High frequency accidents categories also were fires and explosions with seven fatalities, three of which occurred during grass

Other farm vehicles, including pick-up trucks and all-terrain vehicles, and highway accidents resulted in seven deaths.

Three deaths occurred from falls, five involved animals, four resulted from drownings, five from being struck by objects, four from electric current, three from lightning and two from exposure and insect bites.

Valco said it is estimated that with every fatality, there are 100 permanently disabling injuries and 1,000 injuries that require hospitalization.

He said that National Farm Safety Week, as well as Farm and Ranch Safety Week in Texas, will be observed Sept. 17 through 23.

"Safety on the farm and ranch is a concern for everyone. By reviewing these statistics and incorporating safety into your farming activities, accidents can be prevented," Valco said.





## Library Book Notes

The lunar eclipse of last Wednesday night was just a small reminder of the drama that is constantly unfolding above our heads. The Panhandle heavens set the state for exciting visual displays--thunderheads boiling up and blowing over, lightning shows, dazzling sunsets, the spectacular rise of a harvest moon.

The library has two new books which elaborate on the wonders of the visible universe.
