# Lynx Post First Win Over Roughriders

The Lynx got their first win of the season Friday night in front of what was described as a "packed hometown crowd.

The Lynx offense scored 14 points. The defense scored eight points and held Boys Ranch to only 13 points to give the Lynx a 22-13 victory over the Boys Ranch Roughriders.

The Lynx opened the scoring with a seven yard run by Chris Williams for a touchdown in the first quarter. Cody Reynolds kicked the PAT to make the score seven to zero in favor of the Lynx.

The score remained 7-0 until the end of the second quarter, when a Roughrider receiver was allowed

to get free and score a touchdown. With the good PAT kick, the score was tied at seven apiece to end the

The score remained tied until the fourth quarter. The Lynx again opened the scoring this quarter with a seven yard scoring run by Scott Wilkerson. The PAT kick by Reynolds was good and brought the score up to 14 to seven.

The next Lynx score came from the defense. Edgar Nova intercepted a Roughrider pass and returned it 40 yards for a touchdown. Edward Mayfield connected with Williamson for the two point PAT conversion to bring

The final score of the game came when a Roughrider receiver was allowed to get free and catch a 30 yard pass for a touchdown. This lead to a final score of 22 to 13.

According to the coaches' scoring system the top player on both offense and defense was Tim Dooley. "On some plays he was blocking two and three people." said Coach Don Mullins.

Other outstanding individual performers were Wilkerson, who had 138 yards on 24 carries including a 55 vard kick off return, and Nava, who returned an interception 40 yards for a touchdown.

'We are seeing improvement, especially in the younger players, each week," said Coach Mullins. He further stated that Friday night's game at Canadian is going to demand even more improving this week.

The coach is anticipating the Wildcats will have a quick, aggressive and deceptive offense. The Lynx team will have to be ready to make quick adjustments to what the Wildcats will be doing.

# EMS Purpose To Help When Needed

It's Emergency Medical Services (EMS), and some of the terminology and techniques are new. "The purpose is the same as it's always been," says Michele Davis, Spearman's EMS Director, to get help to sick and injured

people when they need it.' EMS in Spearman is trained EMS professionals, hospital pernnel, physicians, and people in the community all working together," says Mrs. Davis. Emergency medical service in Spearman is provided by H & S EMS. The service consists of two ambulances and works in conjunction with the police, fire, and rescue departments. H & S EMS is funded by the city, the county, and the hospital district. Currently, our trained personnel include three Paramedics, three EMT-Special Skills, two EMTs, and two First Responders, who volunteer their time to see that

The Bureau of Emergency Manof Health (TDH), helps Texas cities give better emergency medical care through its concept of EMS planning and development. The Bureau provides consultation for local EMS planning and development. "The Bureau pro-

vides consultation for local EMS planning and development. "The Bureau provides consultation for local EMS services and helps the service define the local problems and then solve them," says Gene Wetherall, Bureau Chief. Regional personnel also help set up EMS certification courses in local areas. "All the finest equipment in the world won't save lives if people don't know it's there or won't use it," says Wetherall. "That's why it's so important that the people in Spearman are aware of the care they can receive."

But Wetherall stresses that, even with the help available from the department, what makes EMS succeed is the local community. "It all comes back to local resposibility. Communities have to be committed to improving emergency medical services for their citizens," says Wetherall. And in Spearman, they are committed. "We want to save lives," says Mrs. Davis. "It's as simple agement of the Texas Department as that. And with everyone's help,

## NUTRITION AFTER FIFTY

Good nutrition is vital for everyone, but it becomes even state. more essential as we age.

Americans are living longer and enjoying life more. Many consumers remain as an integral part of the workplace, while others use did. the freedom of retirement to pursue favorite interests. For these active people, sound nutrition and the good health that comes with it have never been more important.

Based on a report by the National Academy of Sciences' Committee on Diet, Nutrition and Cancer, the American Institute for Cancer Research recommends four basic dietary guidelines that may reduce cancer risk. These compare with the dietary guidelines for all major chronic diseases and provide a sound basis for healthy eating:

1. Reduce intake of fat--both saturated and unsaturated--from the current average of about 40 percent to a level of 30 percent of total calories.

2. Eat more fruits, vegetables and whole grain cereals.

3. Consume salt-cured, smoked and charcoal-broiled foods only in moderation.

4. Drink alcoholic beverages only in moderation.

These guidelines apply to people over 50 as well as to younger adults. Scientists are not completely certain how effective these guidelines are, regardless of age. However, they represent the best understanding to date--based on research studies and observations in people around the world-of steps that seem likely to lower cancer risk.

Research has suggested that for some forms of cancer, following a guideline early (such as reducing fat intake) may be more helpful in lowering cancer risk. No evidence exists, though, to indicate that changing dietary habits stops being effective at any age.

These dietary guidelines offer other benefits, too, especially for older adults. Fat is one of the most concentrated sources of calories. and older adults need fewer calories but certainly not fewer vitamins and minerals. Avoiding excess fat limits calories without compromising nutrients.

Eating more fruits, vegetables and whole grain cereals provides more fiber as well as many valuable nutrients. Fiber is helpful in preventing constipation and may play a role in reducing the risk of colon cancer.

Avoiding excess alcohol makes sense for several reasons in addition to reducing cancer risk. If you take one or more medications. they may interact with alcohol. Alcohol may also have direct toxic effects, especially if your ability to

## **RELAXING WITH AROMAS**

Push back in your recliner. Breathe deeply. Are you wondering "what's for dinner?" or are you just relaxing? Probably both. Psychologists are learning that food odors and imagery can have calming effects.

In a study at Yale University, psychologists looked at the relaxation-inducing potential of three odors: spiced apple, eucalyptus and lavender. Spiced apple showed the strongest calming effects in a relaxed but awake

Psychologists then tested to see if simply thinking about food or an imagined relaxing event would produce the same results. It

Earlier research has found that various food odors, including spiced apple, can lower blood pressure in some people. It is though that when a person savors a pleasant fragrance, the individual takes deeper and slower breaths, thus relaxing the respiratory pattern--much as one does in meditation. The odor also might serve as a distractor, focusing attention on or inducing positive memories and emotions.

Food odors and imagery have definite potential as adjustments to standard stress-reduction

Whether you're enjoying the potpourri pot, dreaming of a hot fudge sundae or thinking about your favorite country dinner, you are being good to yourself. In. addition to the pleasure and health benefits, imagery and aromas have fewer calories than consumption.





The elephant collection of

Jean Ann Behney is currently on display at the Hansford County

The first point that Jean Ann emphatically emphasizes concerning he elephants is that they are NOT politically significant. "If they were," she said, "I would have to collect donkeys for every other election year.

Jean Ann's interest in elephants was kindled when she was in 3rd grade and learned that elephants were pregnant for two years. Since that time she's been fascinated by these amazing animals.

Years later she inherited a portion of her grandmother's elephant collection, which was accumulated in part while her maternal grandparents were pioneering educators in South

Elephants included in the collection on display are a lovely antique beaded one from 19th Century Thailand and several from years 1920-1940. There are elephants of onyx, brass, wood, glass, soap-stone, a tiny jade one, and one of Jean Ann's favorites, a nandmade stone vase with elephant head handles that was made in China as a friend watched.

An elephant not included in the collection is one that was presented as a gift to Jean Ann's sister when she worked as a nurse in the United Arab Emirates. which borders Saudi Arabia. The

elephant given to her was a full-grown, healthy, LIVE one.

Elephants are also referred to as "Pachyderms," which means "thick-skinned." Their distinctive trunks can be used for eating, smelling, drinking, feeling, giving themselves showers, grasping foes while in combat, or caressing an elephant loved one. The life span of an elephant is about 60 years.

Some books at the library featuring elephants are: THE ELEPHANT'S CHILD by Rudyard Kipling, ELLA by Bill Peet, POPE LEO'S ELEPHANT by John Lawrence, FROM TRUNK TO TAIL: ELEPHANTS, LEGEN-DARY AND REAL by Suzanne Jurman, and 17 KINGS AND 42 ELEPHANTS by Margaret Mahy. These delightful books are all located in the children's section.

Jean Ann, who is originally from Indiana, is married to Dr. Laurence Behney. They have 3 small children. Her pachyderms will be on parade at the library through October.

BRIEF EXPLANATORY STATEMENTS OF PROPOSED

## CONSTITUTIONAL AMENDMENTS SPECIAL ELECTION

#### PROPOSITION NO. 1 ON THE BALLOT

House Joint Resolution 102 proses a constitutional amendment that would increase the salary of members of the legislature to onefourth of the Governor's salary and increase the salary of the Lieutenant Governor and the Speaker of the House of Representatives to one-half of the Governor's salary. The annual salary of members of the legislature, the Lieutenant Governor, and the Speaker of the House of Representatives is currently \$7,200. Under this provision, the annual salary of the Lieutenant Governor and the Speaker would be \$46,716, and the annual salary of members of the legislature would be \$23,358, based on the Governor's current annual salary of \$93,432. The increase for the Speaker and the members of the legislature would take effect when the legislature convenes for its regular session in January 1991. The increase for the Lieutenant Governor would take effect when the term of that office begins in 1991. The salary increase for the Lieutenant Governor would not make members of the legislature ineligible to run for the office of

The proposed amendment will appear on the ballot as follows:

Lieutenant Governor.

"The constitutional amendment to limit the salary of the licutenant governor and the speaker of the house of representatives to not more than one-half of the governor's salary and to limit the salary of a member of the legislature to not more than one-fourth of the governor's salary."

#### PROPOSITION NO. 2 ON THE BALLOT

Senate Joint Resolution 5 proposes constitutional amendment Development Board to issue an additional \$500 million of Texas water development bonds. The additional onds are to be used as follows: \$250 million of the bonds are to be used for water supply loans and facilities acquisition; \$200 million of the bonds are to be used for water quality enhancement projects; and \$50 million of the bonds are to be used for flood control. The legislature may provide that \$100 million used for subsidized leans and grants to economically distressed areas of the state for water and vastewater facilities.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to authorize the issuance of an additional \$500 million of Texas water development bonds for water supply, water quality, and flood control purposes."

#### PROPOSITION NO. 3 ON THE BALLOT

House Joint Resolution 51 proses a constitutional amendment that would authorize the legislature provide for the issuance of general obligation bonds to provide money to establish a Texas agricultural fund, a rural microenterprise development fund, a Texas product development fund, and a Texas small business incubator fund in the state treasury. The Texas agricultural fund would be used to provide financial assistance to develop, increase, improve, or expand the production, processing, marketing, or export of crops or products grown or produced in Texas by Texas agricultural businesses. The rural microenterprise development fund would be used to stimulate the creation and expansion of small businesses in rural areas. The Texas product development fund would be used to aid in the development and production of new or improved prodicts in this state. The Texas small business incubator fund would be used to stimulate the development of mall businesses in the State.

The principal amount of bonds outstanding at one time could not exceed \$25 million for the Texas agricultural fund and \$5 million for

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to authorize the legislature to exempt property of nonprofit vetcrans organizations from ad valorem taxation."

#### PROPOSITION NO. 5 ON THE BALLOT

Senate Joint Resolution 11 proposes a constitutional amendment that would provide an exemption from ad valorem taxation for goods, wares, merchandise, other tangible personal property (including aircraft), and ores (other than oil, gas, and petroleum products) if the property is acquired in or imported into the state and is destined to be forwarded out of the state, regardless of whether the intention to forward the property existed when the property was acquired or imported into the state, if it remains in Texas for 175 days or less for assembly, storage, manufacture, processing, or fabrication. The proposed amend-ment would authorize the governing body of a county, municipality, school district, or junior college district to prevent the exemption of this tangible personal property from tax-ation by taking official action before April 1, 1990. A county, municipality, school district, or junior college district could rescind a decision to tax the property, in which case the exemption would become effective in the year of the rescission and the

The proposed amendment will ap-

pear on the ballot as follows: "The constitutional amendment promoting economic growth, job creation, and fair tax treatment for Texans who export goods to other states and nations by restoring and allowing, on a local option basis, an ad valorem tax exemption for certain personal property that is in Texas only temporarily for the purpose of assembling, storing, manufacturing, processing or fabricating."

### PROPOSITION NO. 6 ON THE BALLOT

House Joint Resolution 4 proposes

would enable the legislature to pro vide, by general or special law, that members of a hospital district board may serve terms not to exceed four years. Currently, hospital district board members' terms are two years. The proposed amendment will ap-

pear on the ballot as follows: "Authorizing the members of a hospital district governing board to serve four-year terms."

## PROPOSITION NO. 7 ON THE BALLOT

House Joint Resolution 40 proses a constitutional amendment that would change the format of the oath of office for officeholders in this state. All elected and appointed officers would be required to take an oath or affirmation swearing to faithfully execute the duties of office and to preserve, protect, and defend the constitution and laws of the State and the United States. In addition, each elected and appointed officer would be required to sign a sworn statement that he or she had not paid, offered, or promised any-thing of value for a vote or to secure appointment to an office, as applicable. The written, sworn statement would be filed with the secretary of state. The information in the statement is currently contained in the oaths of office taken by elected and appointed officials.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to require that a member of the legislature, the secretary of state, and an elected or appointed officer, before assuming office, sign a written oath stating that the member, the secretary of state, or the officer did not engage in bribery to obtain the office."

## PROPOSITION NO. 8 ON THE BALLOT

Senate Joint Resolution 24 pro oses a constitu ional amendment that would allow he legislature to authorize the issuance of up to \$400 million in general obligation bonds. The proceeds of the bonds could be used to acquire, construct, or equip new corrections institutions, mental health and mental retardation institutions, youth corrections institutions, and statewide law enforcement facilities and to repair and renovate existing facilities of those institutions. The bonds would constitute a general obligation of the state. The bonds and interest on the bonds would be paid from the first money ming into the treasury that is not otherwise appropriated by the consitution, less any amount in a sink-ing fund at the end of the preceding fiscal year that is pledged to payment of the bonds or interest.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment authorizing the issuance of general obligation bonds for projects relating to facilities of corrections institutions, youth corrections institutions, and mental health and mental retardation institutions and for the expansion of statewide law enforcement facilities."

#### PROPOSITION NO. 9 ON THE BALLOT

House Joint Resolution 101 proposes a constitutional amendment that would authorize the legislature to pass laws to organize and combine state agencies that perform criminal justice functions. The legislature could combine into one or more agencies all agencies that have authority over the confinement and supervision of convicted criminals, that set standards for or distribute state funds to political subdivisions with property could not thereafter be authority over the confinement and taxed. supervision of convicted criminals, and that gather information about justice administration. Agencies that could be combined would include the Texas Department of Corrections, the Board of Pardons and Paroles, and the Texas Adult Probation Commission. The amendment would also authorize the legislature to pass laws authorizing the appointment of members of more than one department of government

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment authorizing the legislature to organize and combine various state agencies that perform criminal

#### PROPOSITION NO. 10 ON THE BALLOT

Senate Joint Resolution 4 proposes constitutional amendment that would authorize the legislature to enact laws requiring or permitting judges to advise juries that a de-fendant convicted of a criminal offense can receive credit for good conduct that results in a shorter prison term and that eligibility for parole or mandatory supervision can also affect the length of time a convicted criminal serves in prison.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment authorizing the legislature to require or permit courts to inform juries about the effect of good conduct time and eligibility for parole or mandatory supervision on the period of incarceration served by a defendant convicted of a criminal offense."

#### PROPOSITION NO. 11 ON THE BALLOT

House Joint Resolution 102 proses a constitutional amendment that would increase the per diem of members of the Legislature. The amount of per diem allowed during a calendar year would be equal to the maximum amount allowed for federal income tax purposes as of January 1 of that same year as a deduction for living expenses in-curred by a state legislator. The per diem of \$30 would increase to \$81, which is the current maximum living expense deduction.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to set the amount of per diem re-ceived by a member of the legislature at the amount allowed for federal income tax purposes as a deduction for living expenses in-curred by a state legislator in connection with official business."

#### PROPOSITION NO. 12 ON THE BALLOT

Senate Joint Resolution 53 prooses a constitutional amendment that would authorize the legislature to provide for the use of the permanent school fund and the income from the permanent school fund to guarantee bonds issued by the state for the purpose of providing loans or purchasing the bonds of school districts to acquire, construct, renovate, or improve instructional facilities. If the permanent school fund were required to make payment as a result of its guarantee of bonds issued by the state, the fund would have to be reimbursed immediately from the state treasury. The amount of bonds guaranteed by the perma nent school fund could not exceed \$750 million unless a higher amount was authorized by a two-thirds vote of both houses of the legislature. If a school district were to become deinquent on a loan, the amount of the delinquency would be offset against other aid to which the district was entitled.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to provide for using the permanent school fund and its income to guarantee bonds issued by the state for the purpose of aiding school dis-

### PROPOSITION NO. 13 ON THE BALLOT

House Joint Resolution 19 proposes a constitutional amend that would provide a bill of rights for crime victims. This constitutional amendment would give crime victims the right to be treated with fairness protected from the defendant. On his request, the crime victim would have the right to notification of court proceedings, the right to be present at all public court proceedings unless a court determines that the victim's testimony would be affected by hearing other testimony, the right to confer with a representative of the prosecutor's office, the right to restitution, and the right to information about the conviction, sentence, imprisonment, and release of the defendant. The legislature would be authorized to enact laws to define the term "victim," to enforce the rights of crime victims, and to provide that certain public officers and agencies are not liable for a failure to protect a victim's rights.

The proposed amendment will appear on the ballot as follows: constitutional amendment providing a bill of rights for crime

#### PROPOSITION NO. 14 ON THE BALLOT

Senate Joint Resolution 71 proposes a constitutional amendment that would require the district attorney in Fort Bend County to be elected and serve terms at the same times as criminal district attorneys in the state. Currently, criminal district attorneys are elected in gubernatorial election years and district attorneys are elected in presidential

election years.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment requiring a district attorney serving in Fort Bend County to be elected and serve a term in the manner provided by general law for criminal district attorneys."

### PROPOSITION NO. 15 ON THE BALLOT

House Joint Resolution 32 proposes a constitutional amendment that would authorize the legislature, by general law, to permit charitable raffles conducted by qualified non-profit organizations. The amend-ment would require that the raffles be conducted, promoted, and administered only by members of the quali-fied nonprofit organizations and that the proceeds from the sale of raffle tickets must be spent for the charitable purposes of the organiza-

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment authorizing the legislature to permit and regulate raffles conducted by certain nonprofit organizations for charitable purposes."

### PROPOSITION NO. 16 ON THE BALLOT

Senate Joint Resolution 34 proposes a constitutional amendment allowing the legislature to pass general laws authorizing the creation of hospital districts upon approval of a majority of the qualified voters of the district. The amendment would also permit the legislature to authorize the creation of hospital districts by general or special law in counties with populations of 75,000 or less and to authorize the commissioners courts of such counties to levy ad valorem taxes and issue general obligation bonds for the support and maintenance of such districts.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment granting to the people the right to decide whether to create and maintain hospital districts to protect the public well-being in a manner independent of the legislature."

### PROPOSITION NO. 17 ON THE BALLOT

House Joint Resolution 33 proses a constitutional amendment that would allow the legislature, by general law, to authorize the use of public money to provide local fire lepartments and other public firefighting organizations loans or other financial assistance to purchase firefighting equipment and to aid in complying with federal and state law. The legislature would also be allowed to authorize the use of public money for scholarships and grants to educate and train members of these organizations. Part of the money could be used for administrative costs of this program. The legislature would provide for the terms and conditions of all such scholarships, grants, loans, and other financial assistance.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment fiscal year. authorizing the state to provide scholarships, grants, loans, and other financial assistance to local fire departments and other public fire-fighting organizations to purchase fire-fighting equipment, to aid in providing necessary equipment and facilities to comply with federal and state law, and to educate and train their members.'

Currently, the constitutional prohibition against a grant of public money to an individual, association, or corporation or against becoming a stockholder in a corporation, association, or company prevents local governments from making some kinds of investments. This proposed amendment would allow local governments to make any investments authorized by the legis-

The proposed amendment will appear on the ballot as follows:
"The constitutional amendment to authorize local governments to in-

vest their funds as provided by law."

#### PROPOSITION NO. 20 ON THE BALLOT

Senate Joint Resolution 16 proposes a constitutional amendment which, if passed, would abolish the office of county surveyor in Cass, Ector. Garza, Smith, Bexar, Harris, and Webb Counties. A majority of the voters in an affected county amendment before the office is abolished in that county. If the office of county surveyor is abolished in any of these counties, the powers, duties, and functions of the office are transferred to a county officer or employee designated by the commissioners court of the county in which the office is abolished.

abolish the office of county surveyor in Cass. Ector, Garza, Smith, Bexar, Harris, and Webb

### PROPOSITION NO. 21 ON THE BALLOT

Senate Joint Resolution 74 proposes a constitutional amendment that would authorize the legislature to enact laws authorizing the Texas Higher Education Coordinating Board or its successor to provide for, issue, and sell an additional \$75 million in general obligation bonds as college savings bonds. The form, terms, and denominations of bonds would be prescribed by law. The interest rate and installments would be prescribed by the Texas Education Coordinating Board or its successor. The maximum net effective interest rate would be set by law. Proceeds from the sale of the bonds would be credited to the Texas opportunity plan fund, which is used to make loans to students to attend institutions of higher education in Texas. The bonds and interest on the bonds would be payable from the first money coming into the treasury in each fiscal year that is not already appropriated by the constitution, less the amount remaining in the sinking fund at the close of the prior

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment providing for the issuance of general obligation bonds as college savings bonds to provide educational loans to students and to encourage the public to save for a college education."

State Comptroller Bob Bullock said that coin collectors and investors will have some extra change in their pockets beginning Sept. 1 when certain purchases become exempt from the state sales tax.

"Legislators brought back a tax exemption that's a lot like one they cut during the state's economic crunch in 1987," Bullock said. "The fact that they were able to bring it back is another welcome sign of a recovering economy.'

The sales tax exemption includes the sale of gold, silver or collectible coins, or the sale of platinum, gold or silver bullion.

The total sales price must be at least \$1,000 to qualify for the tax exemption.

"The tax break means that consumers could save up to eight percent in local and state taxes on their purchases," Bullock said.

The state sales tax rate is six percent and the local sales tax rate can be up to two percent.

The exemption does not include mounted coins used or sold as jewelry, Bullock said.

Companies Assessed \$27,500 In Penalties

The Railroad Commission assessed a total of \$27,500 in administrative penalties this week to eight oil and gas companies for problems under commission well plugging and pollution rules.

D.K.W. Energy of San Antonio was penalized \$1,500 for a problem with one well on the C.C. Grobe lease in Bexar County; Gary Bucher and William R. Akers DBA Rover Oil Company of Fort Worth were fined \$3,000 for a problem with one well on the Watkins lease in Brown County: W.J. Whitt of Moran was penalized \$1,000 for one well on the F.G. Coates Unit lease in Shackleford County: Woodside Oil Company of Lubbock was fined \$6,000 for a problem with one well on the E.Y. Murphy lease in Borden County: and, Great South Oil Corp. of San Antonio was penalized \$10,000 for one well on the Baird lease in Lee County.

Three operators agreed to pay penalties without admitting any violation of Commission rules. Jam Resources, Inc. of Caldwell paid \$500 for one well on the Colvin No. 2 lease in Lee County; Service Clearing Corp. of Dallas paid \$500 for one well on the Cowan-McKinney "A" lease in Archer County; and, Three P Operating Company of Newcastle paid \$5,000 for problems with fluid oil and saltwater discharge from a storage tank on the Johnson H-S lease into Brushy Creek in Young County.

To date in 1989, the Commission has levied more than \$739,000 in pollution and well plugging penalties, Last year, the Commission assessed some \$951,000 in such penalties.


