In comparison, Spearman was returned a total of \$20,472.59 in November 1988, while Gruver received a check for \$4,737.37 last year. 1989 disbursements to Spearman have totaled \$169,192.80, up 5.95 percent from year-to-date receipts in November 1988, which amounted to \$159,685.61. Year-to-date figures for Gruver are \$41,801.46, representing a decrease of 1.24 percent from the \$42,325.08 total received through November 1988.

Statewide, State Comptroller Bob Bullock said that sales tax payments to Texas cities reached \$125 million this month, up more than 5 percent from last November's payments and over 9 percent higher than last year's total at this time. Checks to counties were up a healthy 7 percent over last November's payments.

'The economy is looking up for merchants in Texas and that means another good month for local governments," Bullock said.

This month's checks reflect local sales taxes collected in September by businesses that file monthly tax returns and taxes collected in July, August and September by businesses that file quarterly returns.

Businesses collect the state and local sales tax and send it to the Comptroller's office along with their tax returns. The state keeps its 6 percent share and returns the local sales taxes to local governments.

Cities and counties may levy a combined tax of up to 2 percent, Bullock said.

Houston received a check for \$22.6 million, which is 8 percent more than last November's payment. Dallas received the second largest payment at \$13.9 million, up 10 percent over last year's.

This month's payments to counties totaled \$11 million, compared to \$10.2 million last November. Bullock noted that the total payments to counties in 1989 show an increase of 43 percent. He explained that much of the increase is because 10 more counties started collecting tax in January of this year and another one started in April.

THC Book Award Attracts Top Judges

Three outstanding scholars in the field of Texas history have agreed to serve as judges for the 1989 T.R. Fehrenbach Publications Award, one of the most prestigious writing competitions in the state.

The competition, named in honor of well-known historian and THC chairman T.R. Fehrenbach of San Antonio, will award up to three \$1,000 cash prizes to authors of outstanding publications on Texas history or prehistory. Entries will be accepted until December 31, and winners will be announced next spring.

Serving as judges for the 1989 competition are Dr. T. Lindsay Baker, curator of history at the Fort Worth Museum of Science and History; M. Dora Guerra, director of Special Collections at the University of Texas at San Antonio; and Dr. Ron Tyler, director of the Texas State Historical Association (TSHA) and professor of history at The University of Texas at Austin.

Dr. Baker, the author of more than 10 books and numerous articles, is a popular speaker around the state and nation. He frequently presents living history programs for historical groups, schools, and other organizations, and he is well-known for his expertise in various fields, including engineering and architecture. The winner of various grants and awards, Dr. Baker currently is working on a book on Texas' historic lighthouses.

Ms. Guerra, who has served as head of UTSA's Special Collections since 1980, has extensive experience in the history of The

West, Southwest, Texas, San Antonio, and Spanish Colonial Mexico. She has lectured across the state and nation, and is frequently called upon as consultant on projects relating to the history of San Antonio, Familiar with several languages, Ms. Guerra has interpreted 16th, 17th, and 18th-century Spanish Colonial manuscripts of historical significance for various state agencies and private individuals.

Dr. Tyler balances dual roles as

director of TSHA, the state's oldest heritage organization, and professor of history of UT Austin. He is the author of more than 10 books and numerous articles, and has been recognized by several organizations for his outstanding contributions to the field of Texas history. Formerly associated with the Amon Carter Museum in Fort Worth, Dr. Tyler has organized several exhibitions across the state, and he lectures widely, both in the United States and in Poland





First Baptist Church Sends Reps **To Convention**

Six local Baptists joined over 5,000 others from across the state of Texas at the 104th annual meeting of the Baptist General Convention of Texas in Lubbock on November 7-8. The six local messangers were from the First Baptist Church and its mission church, Primera Mission Bautista. Pastor Russ Gibbs, Betty Uptergrove, and Glen and June Day represented First Baptist, Reverend and Mrs. Romeo Reyes went from Mission Bautista. "I felt it to be very inspirational." said Pastor Gibbs on his return. "It was an excellent conference to set the stage for the National Convention in New Orleans in Tune.

In Lubbock, the First Baptist Church messangers participated in the election of new officers, approved a \$63.5 million dollar budget, and met with other Texas Baptists to establish goals for the group in the coming year.

Texas Baptists elected Phil Lineberger of Richardson as president, approved a \$68.75 million challenge budget and adopted a five-year, long-range state missions plan at their annual con-

Lineberger, pastor of Richardson Heights Baptist Church, was elected on the first ballot, defeating John Morgan, pastor of Sagemont Baptist Church, Houston, and H. Bailey Stone, pastor of First Baptist Church, Odessa.

Winfred Moore, pastor of First Baptist Church, Amarillo, nominated Lineberger, citing his church's record on evangelism and missions. He noted the 4,000member Richardson congregation gave more than \$550,000 to missions causes last year.

Ed Rogers, pastor of First Baptist Church, Dumas, was elected first vice president. He defeated Gary Don Miller, pastor

of First Baptist Church, Borger, and Dennis Hochgraber, pastor of Parkside Baptist Church, Deni-

William Ray Parmer Jr., pastor of First Baptist Church, Valley Mills, was elected second vice president. Other nominees were Greg Wallace, pastor of First Baptist Church, Atascocita, and Richard Barret, a deacon at First Baptist Church, Denton.

At a news conference following his election, Lineberger affirmed the course set by previous leaders while encouraging Texas Baptists to "loosen up, lighten up and stop being so serious about each other.'

Shunning labels that have characterized the 10-year controversy within the Southern Baptist Convention, Lineberger said, "I dislike labels. They cause us to dismiss people too quickly.'

Underscoring support for Texas Baptist leadership and institutions, Lineberger said, "Our Texas Baptist work has been so strong, it would be difficult for anyone to attack Texas Baptists in the area of leadership. A glaring weakness would be hard to find.

Messengers approved a \$63.5 million basic Cooperative Program unified budget and challenge goal of \$5.25 million for 1990. The basic budget recommendation was the same as in 1989, while the challenge portion represents an increase of \$250,000.

Worldwide Southern Baptist mission causes will receive \$23,270,210 (36.65 percent) of the basic budget. Those funds will help support more than 7,500 missionaries in about 110 nations, six seminaries, the Radio and Television Commission and other missions endeavors.

The remainder will be used in Texas to support 23 Texas Baptist educational and benevolent institutions and a variety of state missions causes.

Convention messengers also adopted a long-range plan for 1990-1995, "Mission Texas: Reach, Grow, Serve," an emphasis on reaching people, developing believers, strengthening missions

and ministering to persons.

Goals of the plan include: increasing Sunday School enrollment up 1.75 million and average attendance to 750,000 in the next five years, starting 1,500 new churches and missions by September, 1995; and involving 2,000 churches in new ministries to

persons with critical needs. In the annual convention sermon, B O Baker, an international evangelist and longtime pastor of Irving, Texas challenged Texas Baptists to follow Jesus' example of humble servanthood.

'We are entering the era of the 90s desperately separated, significantly wounded and bleeding from the blows of our brother's sword," Baker said.

"We dare not continue to barter the influence of Southern Baptists upon the game table of denominational politics. It is imperative that we close ranks, sound the certain sound and move out upon the common agenda of missions and world evangelism.'

In other business, the Texas Baptist convention approved resolutions opposing a state lottery, affirming small membership churches, calling for prayer, urging support for cooperative missions and evangelism, and underscoring the need for integrity in church finance.






