



family to Oklahoma. There were ten covered wagons on the trip which included the Snowden and Martin families. They all took a squater's claim on land at Hammon, Okla. Later the families moved to what is now Elk City, Okla. There was no town there then. Mr. Martin helped build the first building in that city. The house he built for his family to live in cost 2½ cents -- which was paid for the hinges on the door. It was built out of logs with a brush and sod roof. Windows were croked places in the logs.

In February of 1902 the family moved to Ochiltree County, Texas where Mr. Martin purchased 4 sections of land for \$800.00. Then the plains of Ochiltree county were strewn with buffalo hides and bones everywhere

To help improve his homestead in Ochiltree County. Bob Martin gave Tom Brown one section of land to drill a water well on hil place. To purchasse more livestock to go with the one he herded up from Oklahoma, he gave another section of land for cows and calves. When he planted his crops; corn, maize, cane and all kinds of vegetables, his harvests were abundant. The land was very good.

The Martin children attended school at the Black school house, walking 5 miles each day.

Later Mr. Martin purchased land at Old Hansford and in 1906 they moved there. He put in a livery stable and bought buggies. Men from the northern states would come to Guymon by train and from there to Hansford on the mail hack. Martin would rent them a buggy and team and they would have John Collard go with them to show places for sale. This is the way the country was settled. John Collard sold a lot of land in Hansford and adjoining counties.

Bob Martin was elected Sheriff of Hansford County in 1909. Mrs. Martin cooked food for the prisoners. The "jail" was holes dug in the wall of the basement of the court house at Old Hansford. Martin refused to put prisoners in these holes, so he slept with them chained to him.

Mr. Martin served the county as Sheriff only 2 years before he lost his life. He is the only law enforcement officer in this county to lose his life in the line of duty. He had gone to arrest P.P. Fifer concerning the boundary line between Fifer's place and the Norton place. The decision in Federal Court in Amarillo had gone against Fifer in the boundary line suit. Accompanied by Deputy U.S. Marshall L.J. Bolton of Amarillo, Sheriff Martin went out to the Fifer place to tell him of this decision. When they got there, Fifer ran into the calf shed and when the Sheriff walked up to the door to talk with him, Fifer shot him in the stomach. The U.S. Marshal ran away and Sheriff Martin was found dead the next morning. Fifer was arrested and placed in jail by Ochiltree County Sheriff Sid Talley.

Sheriff Martin died in 1911 leaving seven children and his wife at home. Ten children had been born to this union; one girl died while quite young. Mrs. Martin lived to be 82. She died May 30, 1953.

Four Martin children survive: Mrs. Lilly Bowling, R.E. (Hoots), Homer (Chip) and William (Bill) all of Spearman.

The family tree, just now in the compilation stage, reveals 27 grand children, 59 great grandchildren, at least 23 great-great and five great-great-great grandchildren.

MARTIN FAMILY HISTORY

Story by Lillie Martin Bowling; Researched by Sylvia M. Robertson.

Our family moved to Hansford in 1906 from the Black Community in Ochiltree County. Father, Robert Eli Bob, was born March 11, 1868 in Erath County, Texas, to Eli and Harriet Martin. Father had a full brother, Peter, and a sister, Flora, and he had 8 half brothers and sisters by his father's first wife, Nancy. His mother died about 1874, and his father married Martha Lamb in 1877, and she raised the 3 children. Mother, Sophi, was born March 17, 1870 in Hopkins County Texas to Levi C. and Malinda Jane Alexander Snowden from Mississippi. There were 10 children in her family. Sarah, Fanny, Ransom, Theophilus and Sophi were twins, Betty, Lula, Isabel, and twins Ollie and Allie. Grandfather Snowden served in the Civil War from Titus Co.

My parents were married April 4, 1889 in Jack County Texas where we lived until 1897. Their first 4 children were born at Joplin in Jack County, Clarence September 11, 1890, me, Lillie Belle July 2, 1892, Mack, Feb. 11, 1894, and Millard, Feb. 12, 1896. Father wanted land to live on when they were old, so we moved to Oklahoma. There were 10 wagons in the group that left Jack County. The Snowden families came also. The women drove the wagons and the men herded the cattle, crossing the Red River on flat boats. It took us about 30 days to reach Hammon where we took a squatters claim, you could file on it later if you wished. Father sold the improvements on that place and we moved to Elk Creek near what is now Elk City. The house he built for us on

Elk Creek, cost 2½ cents, for the hings on the door. It was built of logs with a brush roof the crooked places in the logs forming the windows. Homer was born in that house, July 28, 1898 and Mattie in 1900. Father helped build some of the first buildings in Elk City when it became a town.

Grandfather and Grandmother Martin came and lived in a small house father built for them near us. My Snowden grandparents lived nearby. They are all buried at Grandview Cemetery near Elk City.

In February 1902 we moved to Ochiltree County where father bought 4 sections of land. He traded one to Tom Brown for drilling and well and putting up a windmill and sold another for cows and calves. We lived in a small shack on the place until father hauled lumber from Canadian to build a large 2 room house. He traded our mules for Clydesdale horses, their big hooves enabled them to cross the Canadian River easier. Buffalo bones and hides were still on the prairie when we came to the plains. The land was good, producing abundantly anything we planted, corn, maize, cane and all kinds of vegetables. Mr. Abernathy made syrup for us from our

Roy was born May 13, 1902 on this place. While mother was still in bed with him, Mattie ate too many dried apples and was very sick. No Doctor could attend her and she died. The next year we went back to Elk City to get our cows, picking cotton to help with expenses. Mother canned peaches in syrup buckets, sealing them with sealing wax. We went again the next year, father was working at \$1.00 a day for Mr. Parcell who had cattle on the open range, and couldn't go. My brother and I attended the Black School, walking several miles. Hoots and Minnie were also born there, he, May 23, 1904 and she, March 25, 1906.

In 1906 father sold another section of land and bought one close to Hansford and we moved again. He put in a livery and rented rigs to the men who came from the north to buy land. They came to Guymon on the train, to Hansford on the mail hack, and Mr. J.R. Collard took them to see the land for sale.

In 1907 father worked as Deputy Sheriff for Bert Cator. He can for Sheriff in 1908 and was elected. At this time the only place to hold prisoners was in holes dug out of the Court House basement walls. Rather than put prisoners there, father often slept chained to them. Mother cooked for the prisoners, and to supplement the salary as Sheriff, father took care of the Court House.

Father built a 5 room house on that place. He sold the livery business and just ran horses and mules. Clarence and I both were married in 1907, and Dec. 1, 1908 my parents last child, William (Bill) was born.

Two months after he was sworn in for a second therm as Hansford County Sheriff and Tax Colector, father was killed. On Jan. 26, 1911 he accompanied U.S. Deputy Marshall Bolton of Amarillo to see Phil Fifer about a boundary dispute on his land, Phil shot father and he died that night and was buried at Black Cemetery with Mattie. About 5 years ago, their remains were moved to lie in the Hansford Cemetery.

Mother was left with 7 unmarried children at home. About 1915 she moved her family to Colorado to

homestead, proving out the claim. They returned, and moved to Spearman when the town moved. About 1922 Roy, Minnie and William accompaned her to Cherokee, Okla. to try their hand at running a hotel, again they returned to Spearman. Mother lived the remainder of her life in this town, weathering the deaths of husband and 6 children and the dust bowl days during the depression. When Minnie died in 1934, she took her 3 children to raise. In May, 1953 she died in her home on Hoskins St. In 1974, at the first family reunion following her death, there were 132 family members in attendance.

Credit problems can occur if you lose income, become unemployed or go from two incomes to one in the family. Problems can also come from taking on too much credit at once.

To prevent problems, a general rule is to limit minimum monthly payments and installment payments to 20 percent of your monthly net income. Some advise having no more than 15 to 17 percent as your target maximum.

If you own several credit cards, it can be eassy to charge more than you can handle. There are danger signals of too much credit. They include:

\*Total monthly payments keep increasing.

\*You are at or near your credit limit.

\*You can only make minimum payments.

\*You extend payments.

\*You use savings to pay bills. \*You work overtime to make ends

Before taking on new credit obligations, add up your current monthly payments to be sure that you do not overextend yourself. Consider how long you are committed to making cannot meet your credit obligations. If this happens, contact the creditor, explain things and try to work out a new agreement. But don't ignore the

Think through your use of credit. Control it and let it add to your financial lifestyle.



The good news is - you can have the VCR, furniture and car right now and pay later. The bad news is - you're legally obligated to pay even if your income goes down, misfortune comes your way, or you have overestimated how much you can afford.

Most credit agreements involve a signed contract. Before signing a contract ask yourself two questions: Do the payments fit into my budget? Can I make the payments for the length of time agreed upon?

If you agree to make large payments and money becomes tight, you could find yourself in a difficult situation.

If your income situation is not stable, it may be better to keep your monthy payments smaller for a longer period of time than pay out more money than you can afford each month. Although a longer term of payments costs more in interest, you can pay off the debt sooner if money is

What are the consequences if you default on the agreement? What will you lose? When an installment contract is not paid by the terms agreed, the creditor can repossess the collateral. You would lose not only the item but also any money that you have already paid. Read the fine print before you sign a contract to avoid situations you can't handle.

Credit is like food, clothes, appliances or any other product - you buy it. Therefore, you should "shop" for credit as you would any other product.

To find the best value, understand how much it costs, what you get for your money and compare different agreements.

For example, repayment terms can vary from creditor to creditor. The creditor determines these variables, but you can find credit to suit your needs and situation on terms you can live with-if you shop around.

## **Bank Franchise Tax** Up In Hansford Co.

State Comptroller Bob Bullock Thursday said checks totaling \$13 million were sent in this years' second allocation of the state's freanchise tax on banks to 2011 local taxing jurisdic-

Taxing jurisdictions in Harris County received \$5.2 million. The Houston Independent School District received \$2.1 million and the city of Houston got \$1.5 million. Payments to taxing units in Dallas County totaled \$2.6 million. Dallas ISD's payment was \$1 million and the city of Dallas received \$806,336.

Tarrant County checks totaled \$415, 409 and total payments in Bexar County were \$851,367 million. Travis County taxing districts received a total of \$207,406 million. El Paso County's checks were for \$353,833.

The legislature in 1984 brought banks under the franchise tax for the first time and allocated receipts from the tax to cities, counties, school districts and other local taxing units where the banks are located.

Banks are taxed at the same rate as other Texas corporations. Previously, bank stocks from property taxes, substituting the new bank franchise tax. Collections are prorated among local taxing units based on their tax

The City of Spearman recieved \$807.55 franchise tax payment from the banks in Spearman for this period. Comparable payment to date last year was \$16,246.70. 1986 payment to date is \$23,798.69, up 46.48 percent over this time last year. 1985 payment was \$16,246.70.

The city of Gruver received \$173.48 dollars for this pay period, and the comparable pay period prior year to date, \$4,206.93. 1986 payments to date, \$4,772.42. 1985 payments to date, \$4,206.93, up 13.44 over last
