### Councilmen discuss airport improvements

The governing body of the City of Spearman met Tuesday night, Nov. 15 at the city hall to discuss items on the agenda for the meeting. After the pledge, invocation, and minutes of the last meeting were read, the next item on the agenda was consideration of a drainage study report for the alley between the 700 through 1000 blocks of Gibner Drive and Walter Wilmeth Drive. Dwight L. Brandt prepared the study and no action was taken on the matter. Council decided to table the matter for further review.

The next matter before the council was the consideration of change order No. 1 in the amount of \$13,157 with Depauw Construction Company for the Spearman Municipal Airport improvement project. This involved a previous request that had been denied by the FFA for 12 tie downs pilots requested and a ten foot strip of paving adjacent to each hangar. This was now approved and 90% of the cost will be paid by the FFA, and the other 10% by the city.

Next on the agenda was consideration of a contract with Dwight L. Brandt Engineering for professional services to design the automation and control for the gas, sewer and water system. Ideas were exchanged on the matter, and the subject was tabled for further study.

Also at the meeting were representatives from Mission Cable Company to discuss an agreement between the Spearman Cable TV System and the City of Spearman. The cable companies listened to complaints from citizens and suggested possibilities of service to the City of Spearman and residents. No action was taken on an agreement.

Approved was item number seven, the joining of the Panhandle Conference of Mayors with annual dues of \$75. Also on the agenda was the consideration of ordinance No. 571, an ordinance amending Chapter 2, airport and aircraft of the Spearman city code, reducing the rate for t-hangar rental, and providing for an effective date. The matter was tabled for further study. Other routine matters were discussed such as consideration of reports from the police, municipal court, fire department, and animal control officer, and consideration of monthly bills. The meeting was adjourned. The next meeting is set for Nov. 29 at City Hall.


### Christmas parade set for Nov. 30

### A mateur archeologists contribute in Indian dig

A love of history and the hobby of collecting Indian artifacts has brought the family of Mike Minter, of Gruver, into many interesting persuits.

I visited Mike, who is market manager of Jack and Jill in Spearman, and his wife, Pat, who works at the Gruver school cafeteria, Kerri, their 17 year old daughter, Cathy, 15 year old daughter, and Michael, 9 year old son, after hearing about their extensive arrowhead collection. Mike began his hobby as a young

man. But his interest and his knowledge has kept growing. I was shown mounted arrowheads, hanging on the wall, jars full of arrowheads, and jars of broken arrowheads. They were impressive, but not near as impressive as the man (Mike) that could tell me where he found each artifact, what period the piece probably came from, and what type of rock each was made from. He also showed and explained the bone needle, bone awl, drill, ceremonial Washita arrowhead, beads, pipe, knives, and so on. I learned a grinding stone is actually called a Mono. And, yes, Mike has several of those.

Arrowheads, what the Plains

Indians made to put at the shooting end of their arrows, were made from many different materials and made in many different forms. The type of material and the way the arrowhead was made can tell Mike whether it is a Star, dating 900-1800 A.D., a Scallorn, dating 500-1200 A.D., a Harrell, 1100-1500 A.D., or a Fresno, 800-900 A.D. Mike has arrowheads in his collection made from alibates, petrified wood, obsidian, bone, and metal to name a few.

"An Indian, and not always the males as is commonly thought, used a buckhorn to chip the stone into an arrowhead. Pressure was applied until the flint flaked away," said Mike.

Also included among his artifacts is a shaft straightener that was used to grind arrows to make them straight, which he found in New Mexico. Bone beads he found also in New Mexico, shell beads from Lake Fryer, a national beads from Lake Fryer, a nation fourbeveled knives. A bone needle he found on the Canadian River, a bone awl that caught his attention near Morris, and even an 1897 V nickel he once found while hunting you a "young growler." An arrowhead made with inferior craftmanship is explained as "his belly was growling when he made it," said Mike.

Beside hunting for arrowheads whenever possible in New Mexico, Oklahoma, and Texas, the Minters love of art has led into a little amateur archeology.

In 1987 they attended a field school sponsored by the Texas Archeology Society near Perryton. The Minters, and many others, were involved in the excavation of a Plains Indian buried city. The city may turn out to be the first permanent living quarters in the Panhandle. It is believed this city

contained the largest concentration of people in the Panhandle, in 1100 A.D.

Also in the past year the Minters became involved in the study of the archaeology of Palo Duro Creek, In the book, Prairie Hinterland: The Archaeology of Palo Duro Creek, author John Allen Peterson says in the acknowledgements, "Aboveand-beyond-the-call-of-duty kudos go to Mike and Pat Minter and family of Gruver, Texas, for not only sharing their archaeological collection, but for inviting us to dinner and working with us in the field ... " This historical study is being made of all the area that may someday be underwater, after the Palo Duro Dam is built.

Mike and Pat have met many interesting people with their collecting, and are always willing to help anyone they can with their information. While I was talking to the Minters, Eldon Sparks, a college student, brought some books to have a student, brought and boy scouts from the area have visited them as a troop and learned something about the Indians. Even little Michael can teach you, something about Indian artifacts, if you listen!

### Turkey handling important for consumer safety

Improper thawing of a turkey, and mishandling of leftovers, are the two most common mistakes holiday cooks make during Thanksgiving and Christmas. That is the opinion of Lenwood Scholtz, Assistant Director of the Texas Department of Health's Food and Drugs Division.

"A turkey should be thawed in the refrigerator, or under cold, running water (at 70 degrees or below)," Scholtz said. "Many people make the mistake of thawing the turkey at room temperature, allowing the surface to stay warm before the rest of the turkey can thaw. That creates conditions where bacteria can reproduce and

cause food poisoning."

Scholtz said thawing in a microwave oven is only safe when the food will be immediately cooked. When thawed, the turkey should be thoroughly rinsed and dried, inside and out. If you plan to keep the leftovers, cut the meat off the bone and refrigerate it. A safe rule of thumb is to freeze any portions you want to keep beyond two days of refrigeration, Scholtz advised.

The following suggestions in preparing and serving holiday turkey can help ensure against salmonella poisoning, perhaps the most common form of food poisoning in the home.

Prepare the stuffing immediately before cooking. You may wish to mix the dry ingredients in advance, but eggs, oysters, butter, or other moist ingredients should be added at cooking time.

Cooking the stuffing in the turkey cavity may result in its not being fully cooked in the center.

portions of the meat, such as the thighs, should have reached at least 180 degrees Fahrenheit, measured with a meat thermometer.

Never leave the turkey, the stuffing, or gravy unrefrigerated for more than two hours.

If you are using a microwave oven, rotate the turkey to ensure uniform cooking. Be certain to wash your hands,

cooking surfaces, utensils, and all foods thoroughly.


