

## Tracksters take third and fourth at state meet



Both Spearman girls and boys high school track teams excelled at state competition last Saturday. May 13 at Memorial Stadium in Austin. The Spearman boys finished the year with a third place at the meet, making the community exceptionally proud and also speaking well of the high school coaching staff. The Spearman high school girls track team came in fourth place overall in the Class 2-A meet.

Some events had to be delayed at the meet due to the weather conditions. It began a cool day. but the wet track gave tracksters the most problems. Spearman still shined taking the most golds in the Class 2-A competition. Matt Tucker took a gold with the shot with a put of 57' 3 3/4''. This was more than ten inches better than the next runner-up. Lance Swan also captured a gold in the discus. He had a throw of 169' 4''. Tucker took third in that event, throwing 165' 6'



### City council meets

Tuesday evening, May 9 in their (Thursday) to evaluate the first regularly scheduled meeting of the month. After considering the minutes of the last meeting. the council canvassed the ballots of the city election which was held Saturday. May 6 and administered the oaths of office to the three re-elected aldermen, Mike Cudd, Burl Buchanan, and Wilson McClellan.

After the oaths of office, the councilmen considered the removal of the three meter (high) diving board at the Spearman Municipal Swimming Pool. Council agreed that removal was necessary due to the fact that the swimming pool does not meet all of the Texas Department of Health's minimum design standards to have the three meter board.

Next, the on-going status report from the city council's committee reviewing the Spearman Volunteer Fire Department's organization was heard. The committee is still gathering information from area fire department's to decide on possible improvements for the Spearman VFD.

Next a status report was heard on the problems with the failure of the paint system on the water storage tanks. The City has engaged Brandt Engineering Services who in turn have employed Southwest Laboratories of Houston to make an inspection of the problem. Employees of Southwest

> Then council decided to join with the Spearman Independent School District and Hansford Hospital in an auction that will enable the City to dispose of surplus equipment. Some of the larger items that the City will have in the auction include a 1979 Chevorlet pickup, a 4-wheel drive eep, and a dozer and scraper. Other items, and the time and place of the auction will be decided at a later time.

Councilmembers then authorized the city manager to accept bids on a mowing contract at the Municipal Airport. Council decided not to authorize the city manager to accept bids on group health insurance for city employees at this time. They will wait and see how the correct coverage plans costs may change.

The City council then agreed to a contract with Southwest Aerial Services, Inc., to perform aerial application of a chemical mosquito control program. This contract will be at the same cost that the city paid last year for the service.

Reports were then heard from the fire, ambulance and police departments, as well as the municipal court and animal control shelter. Before adjourning, council considered the monthly revenue and expense report. Council was within budget for the month of April.

Historical painter may have sold works in area

The strange and exciting story of an artist who sold her works all over the Southwest at the turn of the century to help free her doctor son from a Mexican prison, may very well have a Spearman connection, because some of the paintings are believed to be privately owned here.

Her beautiful pastoral oil-on-tapestry paintings have brightened homes and churches and brought joy to their owners throughout the Southwest since the turn of the century.

Very few know of the despair that accompanied every painstaking stroke of her brush. Certainly every painting had its message, but the strange, remarkable, untold story of the artist and the calamity in her live that motivated her for years is a much greater picture. She painted with a purpose.

And before her story was finally played out over international borders, she would have become involved in the sphere of diplomatic relations, political lobbying and even into the areas of helping finance a foreign revolution.

Texas and American national officials up to and even including the President got to know her well, and foreign revolutionaries felt her influence. She was a mother praying, fighting and laboring for one of her children who she believed had been wronged.

Mexican legend Pancho Villa would prove to be the pivotal key in re-uniting the fragile artist and her physician son who had been a longtime prisoner in a Mexican dungeon.

Putting all the pieces of the strange puzzle together began with a modern

woman's determination to identify the artist of a large painting she had bought during the disposal of furnishings from a large nearby home.

The trail took many turns, including the National Archives, crumbling newspaper files, fading memories, interview, letter writing and days of library and cemetery research. None of the informants knew the whole story. A piece was added here; a new name turned up there; many other paintings came to light and, little by little, the story of Anna Laurie Harle unfolded.

Truly, it was a classic example of international intrigue that was so much a part of the Southwestern History in the early 1900's. The thoroughly documented account reads today like pure fiction, but its principals actually lived it.

There are believed to be hundreds of the paintings by Mrs. Harle throughout the Southwestern States, many hung in major churches, and

for economic


#### development

Hansford County is one of the eight counties in the Texas Panhandle that has been selected for a new economic development initiative by the Texas Agricultural Extension Service of The Texas A&M University System.

The other counties of Dallam, Sherman, Hartley, Moore, Ochiltree, Lipscomb, and Hutchinson will also be the focus of a new effort to aid rural communities hampered by adverse economic conditions, said Dr. Ronald D. Knutson, an Extension economist who will help coordinate the project.

Knutson said the year-long process will include development of a demographic and economic profile of the counties prior to development of a comprehensive strategic plan for economic development.

The new initiative will be jointly sponsored by the Texas Bankers Association with funding from the Extension Service, the Kellogg oundation and the Farm Four dation.

Specific populations are more at risk for being skin cancer patients. Heavy sun tanners, farmers and construction workers who spend their days in the sun and those who use tanning booths often show signs of skin cancer. Sun exposure can happen even when the body is covered when the rays of the sun penetrate light-weight or light-colored clothing or the rays are reflected from clothing onto the face even though a person is wearing a hat for protection.

The Harrington Cancer Center will co-sponsor a free skin cancer screening clinic Saturday, May 20, from 9 a.m. to 3 p.m. in the downstairs clinic area at the Center. The American Academy of Dermatologists, the Texas Dermatological Society and the American Cancer Society will also participate as co-sponsors in the clinic.

The skin cancer screening, done in a private exam room, covers mole checks in exposed and unexposed areas. Physicians will check any part of the skin for abnormalities. If an abnormality is found, the participant is referred to his or her doctor for additional examination.

The physicians will ask for a family history of skin cancer when they examine a person who participates in the free clinic. They will also check on a history of x-ray treatments for acne or other skin conditions. And they will look for any pigmented spots which have changed size recently, and they will determine each participant's skin type in its ability to tan or burn.

Information on skin cancer will be provided, and registered

nurses will be available to teach skin self-examination. Dermatologists will also be present to answer any questions.




