Now my eyes were rolling back in my head. It was like hearing that my son's Terrible Twos would only last a year. Here I was with the sole yard in town that ought to boast a Condemned sign and she was telling me to wait. We were

talking about WAR here...the classic battle of Man versus Nature!

Seeing my disappointment, she consoled me with a gigantic bag of fertilizer and a cute little gizmo on wheels for dispensing it, kind of a wheelbarrow with teeth. Armed with these weapons, I went home.

I crunched my way around the No Man's Land at my home pushing this cart, only to watch the little particles of fertilizer blow merrily away in the ever-present Panhandle gale known locally as 'a nice little old breeze." Most of it blew into a nearby yard which already boasted a lush emerald green growth. Obviously, the allies were crossing enemy lines.







Pilot survey finds steroid use a problem in Panhandle area

definite problem in the Texas Panhandle physician.

Results of the survey published in May 1989 of Texas Medicine, the official journal of the Texas Medical Association (TMA), showed 48.5 percent of Panhandle area physicians surveyed had received inquiries about anabolic steroids, 29 percent had seen patients they felt were taking steroids, and 15 percent had received inquiries about growth hormone. They survey was conducted by Drs. Paul S. Salva and George E. Bacon of the Department of Pediatrics, Texas Tech University Health Sciences Center, School of Medicine, Lubbock.

Anabolic steroids are compounds derived from testosterone, a hormone, or prepared synthetically to promote body growth. They are legitimately used in the treatment of certain types of anemia, leukemia and other conditions, but are taken by some athletes to increase their body strength and improve athletic performance. Synthetic growth hormone also promotes body growth. It is appropriately used in helping children with a family history of short stature achieve average height.

Salva and Bacon limited their survey to family physicians, general practitioners and pediatricians practicing in a 41-county area encompassing both Lubbock and Amarillo. Questionnaires were mailed to all members of the Panhandle District Medical Society who identified themselves as falling within those three practice categories. One hundred of 180 questionnaires were returned.

"The results of this pilot survey suggest that there is definite interest in and, more ominously, use of anabolic steroids among high school males," Salva and Bacon wrote. "Furthermore, interest in these substances apparently is not confined to people involved in organized

Forty-eight of the 100 responents reported at total of 213 to 225 inquiries about anabolic steroids. All inquiries were made by or for males, all but five of whom were white. Twenty percent were considered serious.

While four young adults sought steroids to secure or retain athletic scholarships, most were for body building or weight lifting pur-poses rather than collegiate athletic competition. Likewise, 60 percent of those perceived as already using steroids were weight lifters or body builders.

The 52 reported inquiries about growth hormone all were for white males, with 90 percent coming from parents. Fifty-six percent were considered to be appropriate because the children were very small and may or may not have had deficient growth hormone levels. However, 44 percent were made by parents for children of average stature and development or by normal adolescent wanting to increase their size for athletic purposes.


Salva and Bacon plan to expand their study to include all major Texas metropolitan areas to determine whether levels and patterns of interest are different for urban and rural area.

"While this investigation demonstrates a bona fide public interest in anabolic steroids and growth hormone, it quantified only those people who contacted physicians," the authors concluded. "What percentage of the total societal interest this represents is unknown."

Governor Clements signs jury measure

Governor Bill Clements has signed a "truth in sentencing" measure that will enable Texas juries to be informed of the consequences of parole if state voters approve a constitutional amendment in November.

We can no longer afford to handcuff our juries with a lack of information in sentencing criminal defendants," Clements said after signing the measure.

"If the jury can be trusted to make complex and difficult decisions concerning the defendant's guilt, then they should also be trusted to exercise the same care when setting a defendant's punishment. Texas juries have a right to know about Texas "parole

Senate Bill 54, the enabling legislation for the constitutional amendment, requires that a jury in a criminal case be given instructions regarding the award of good conduct time and eligibility for parole in certain circumstances.
