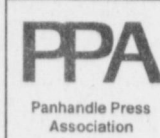

Big 2nd half lands Mules 37-6 victory

Muleshoe scored two minutes into the game and possibly were lulled into thinking it had an easy win.

But Sanford-Fritch Eagles had no intentions of being the Mules' Homecoming prey.

At least for a half.

But then Muleshoe exploded for 23 second-half points and sent a large Homecoming crowd home happy with a 37-6 District 1-3A win Friday at Benny Douglass Stadium.

Gilbert Vela rushed for a career-high 165 yards and four touchdowns as the Mules (3-5 overall, 2--3 in district) snapped a two-game tailspin.

Vela got plenty of help from Muleshoe special teams that set up three touchdowns and a field goal and an offense that produced a season-high 437 yards.

"After the early score, they thought it was going to be easy and they were just going through the motions," Muleshoe head coach David Wood said. "The thing that I was most proud of was that we had the best third quarter since I've been here."

Muleshoe capitalized on three Eagle special teams gaffs to score two quick touchdowns and a field goal in the third

quarter, turning a precarious eight-point halftime lead into a more comfortable 30-6 margin.

But Wood said the game's turning point occurred just before halftime, when the Mules drove 71 yards for a touchdown in a little more than a minute.

Vela scored from seven yards out to give the Mules a 14-6 lead, but it was the running of quarterback Matt McClanahan and fullback Greg Pena that set up the score.

Two McClanahan runs moved the ball to the Sanford-Fritch 46. Pena then bolted 37 yards to the Eagle nine and Vela scored two plays later.

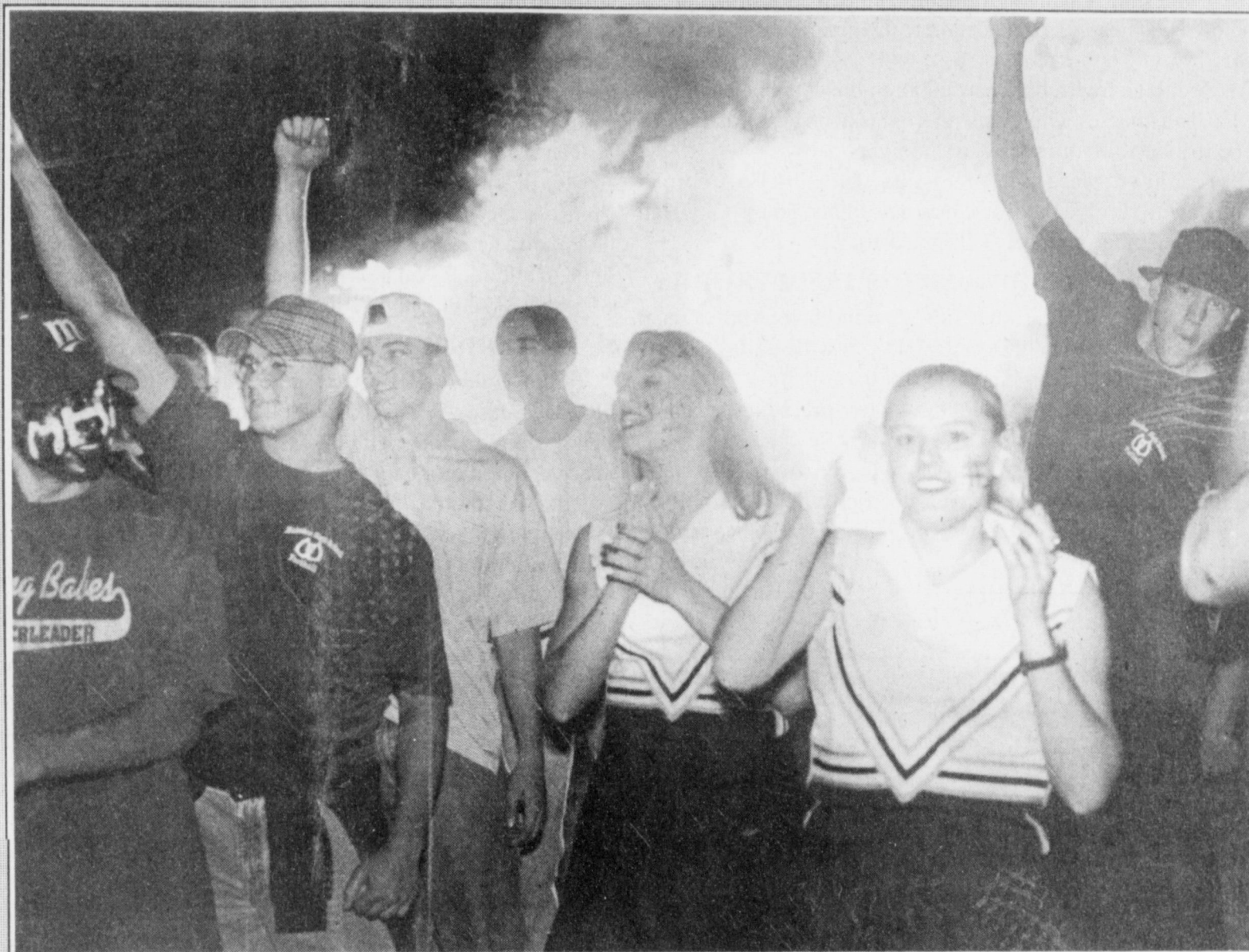
Wood said the touchdown helped the Mules regain the momentum. The Muleshoe coach then warned his team at halftime that "they better not letdown this time."

Vela has topped the 100-yard mark three straight games and has turned into the Mules' workhorse even though he's generously listed at 5-7, 165 pounds.

"He's got the biggest heart of any little player I've ever coached," Wood said. "He's been hurting all year with bumps and bruises, but when

Since President Bill Clinton has dropped his opposition to Congressional plans to reform the IRS, Republicans in the House of Representatives are pushing for the first sweeping changes of the IRS since 1952.

"We (Congress) are on the fast track," said Combest in a phone interview Friday about possible IRS reform. "It's very likely that we'll pass it (HR 2676)

Tribute to Vietnam Vets visits Clovis

CLOVIS — Years ago, Vietnam veterans returning home were given minimal respect for serving our country. But sentiment has changed and the veterans that didn't make it home are being welcomed, remembered and thanked as a "moving" Memorial Wall travels throughout the United States.

The tribute to the more than 50,000 fallen American soldiers of the Vietnam War has been brought to Clovis with the help of the Air Force

Sergeant's Association of Cannon Air Force Base.

"We can never forget what these people did for us. They gave their lives so today we may not have to give so much," said Air Force Technical Sergeant James Muldoon, a volunteer helping people find names and answering questions about the wall.

The moving wall memorializes 58,016 men, eight women, 16 chaplains and 242 Canadians that lost their lives in the Vietnam conflict.

"The wall is in memory of all of the victims

of Vietnam, MIAs, POWs, the servicemen and women that gave their lives, the ones that returned home, and even families and friends," said James McGregor, a history teacher from east Texas passing through Clovis.

"It's like the song says 'Some gave all, all gave some, but none returned the same' and that is very true," said Muldoon quoting the lyrics of a Travis Tritt song.

People started gathering at the wall as soon

ENFIELD, Conn. — Most school children know that President Clinton lives at 1600 Pennsylvania Avenue in Washington.

A letter mailed by an 11-year-old Enfield girl to "President of the United States, Mr. Bill Clinton," at that address, was returned stamped: "Moved, Not Forwardable."

White House spokesman Jon Murchison confirms President Clinton is still in fact a resident, and he expects to be until early in 2001.

Christina Reveruzzi legibly printed the address but admits she didn't use a zip code on her letter. A Post Office spokesman said that could be what led to the slip up.

The Setting Rays of "Sunshine On My Shoulder"

Some friends and I saw John Denver recently. Very much alive. And then... Well, and then, he wasn't. Two friends rode the hotel elevator with him. Twice. Several of us, unaware he was in the building, were pleasantly surprised as we saw him saunter nonchalantly, hair still wet from a shower, through the hotel lobby with a suit bag slung over his shoulder. My wife and a dear friend exchanged a word or two

(the kids didn't remember.) I knew he had a clear, sweet, unique voice. I knew he was really good at what he did and was very "successful." I knew that I liked him enough to hope that he was not one of those poor wealthy, wildly "successful" people for whom success means anything except happiness. None of us knew he'd be dead in two weeks.

May I state the obvious? John Denver didn't know either. Crashing an airplane into a bay was not in his plans. 52-year-olds may think more about death than 17-year-olds, but most of the 50-something folks I know aren't planning to die anytime too soon.

An influential minister in Austin, a fine and well-respected man, Lanny Henninger, died very unexpectedly just a few days before John Denver did. The day before he died, Lanny wrote about life's brevity. He quoted one of Neil Diamond's old songs, that we're "done too soon." He quoted James' words in the New Testament, "You are a mist that appears for a little while and then vanishes" (4:14). And he reflected: "So what to do? Two things, it seems to me. At least two. One: Use up each day. Fill it to overflowing with good. Deliberately enjoy. And two: Begin now. Mend a fractured friendship. Mail an overdue letter. Correct a misunderstanding. Repair a broken heart. Lay aside a grievance. Act on a noble impulse. As we all know, 'The night cometh.' Sometimes sooner than we'd think."

I came home and, I suppose, thought I'd impress some of the kids at church by saying that I got to see John Denver right up close.

"John who?" they asked. Dumbfounded, I replied, "John Denver. You know, 'Rocky Mountain High'?" They didn't know.

I knew. I knew that John Denver marked my teen years in a small, pleasant way with some good songs like "Rocky Mountain High" and "Sunshine on My Shoulder." (If those don't ring any bells, ask your mom or dad to hum a few bars.)

I didn't know (and I think I've got this fact right) that he was one of the five top-selling recording artists of all time. My last recording of his was on 8-track. (Hmm. No wonder

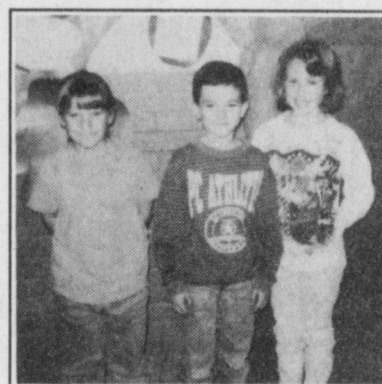

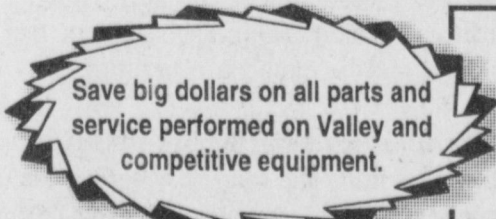

as it was erected Wednesday afternoon. Flowers, flags and mementoes have slowly started collecting in front of the 240-foot display.

Quiet and somber, the crowds walked along the wall, reading name after name.

Families cried and hugged as they found evidence of old friends and family members whose names have not only been etched in the wall, but also etched in history.

Not everyone was so lucky in finding the names of people they knew. Donna Cunningham of Clovis couldn't find her cousin's name because she didn't know his legal name. She had always called him by a nickname.

But the wall was still mov-

ing to Cunningham, who volunteered in 1972 to help at a Mississippi air force base when over 400 POWs returned home.

The wall, which has been traveling throughout the country for 13 years, will remain in Clovis until Oct. 29.

JV Mules drop Dimmitt 22-6

Lucio Soto blocked a punt and returned it for a touchdown, leading Muleshoe to a 22-6 win against Dimmitt in a District 1-3A junior varsity game Thursday at Benny Douglass Stadium.

Driven by a strong defense effort, the Mules (5-3 overall, 2-3 in district) avenged an earlier defeat to the Bobcats while playing at home for the first time in a month.

"That was one of our best defensive efforts of the year," Muleshoe coach Ron Welch said. "They really wanted to beat (Dimmitt)."

Jeff Bruns had two interceptions for the Mules, his fifth

and sixth of the year, and defensive tackle Bret Clements had a stellar game.

With Muleshoe up 14-6 midway through the fourth quarter, Soto slithered through a gap between center and guard, and blocked a punt. Soto scooped up the ball and raced 23 yards for the score.

James Barrett added the two-point conversion on a quarterback keeper.

Barrett gave the Mules an 8-0 lead in the first quarter when he hooked up with John McClanahan for a 35-yard pass on a fade pattern. Jesse Reyes

Vela runs wild in 36-6 win

DIMMITT — Dimmitt scored late in the fourth quarter Tuesday, edging the Watson Junior High 7th-grade Mules 16-14.

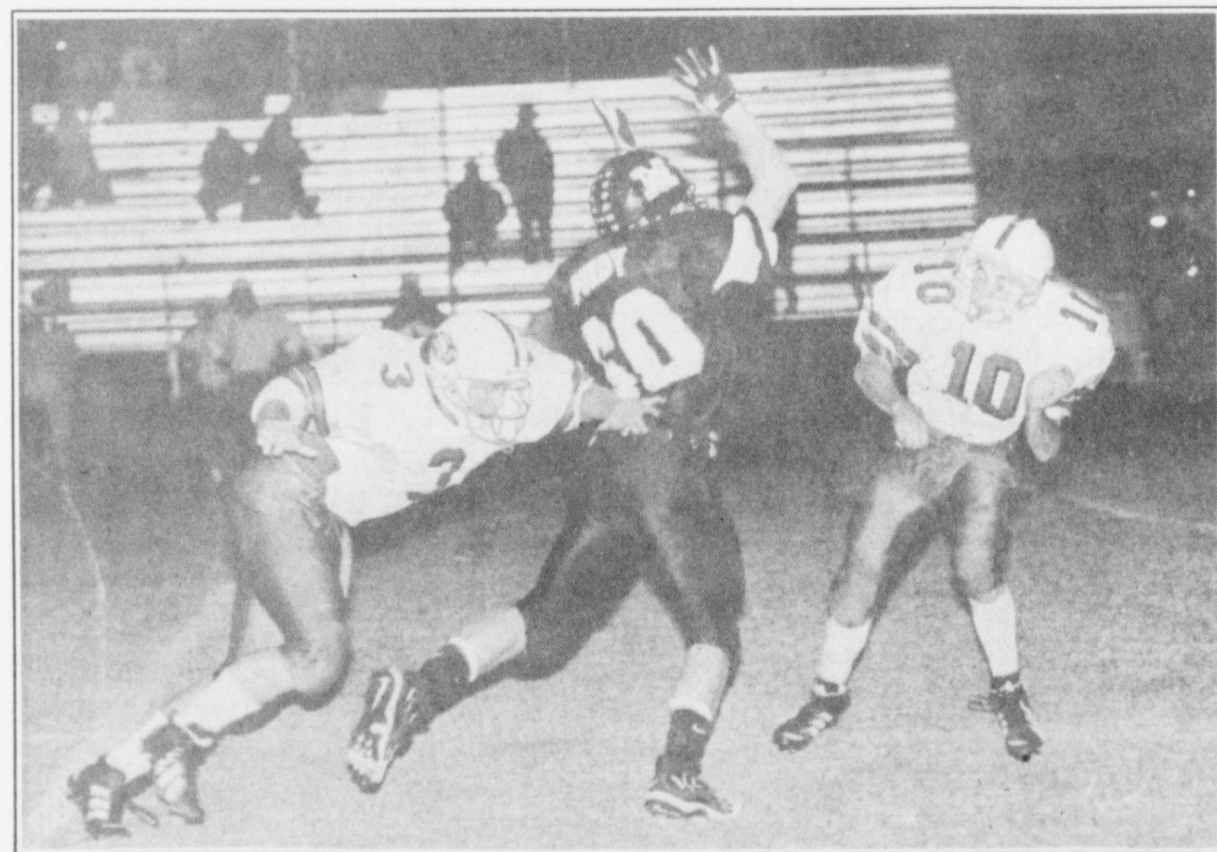
Micah Ruthardt scored both touchdowns for the Mules (1-

before we leave in early November. The Ways and Means Committee plans to bring it to the floor any day now and we expect it to be passed overwhelmingly," said Combest in a telephone interview Friday.

One of the first major changes that Combest pointed out is a shift of the burden of proof from the taxpayer to the IRS. No longer will taxpayers be "guilty until proven innocent."

Combest said that the main problem has been "how the IRS has been treated people."

Combest himself has been asked to intervene on behalf of citizens before, when the IRS has bullied and threatened people with unreasonable demands, demands that are sometimes the result of IRS mistakes.

In fact, Combest reported that in 1993 the IRS overcharged \$5 billion in penalties.

"The move is on to change the way the IRS does business and the next step will be a change in the tax code itself," said Combest. "I have spoken in complete agreement with taxpayers who simply wish to pay the taxes they owe and not have their money wasted."

USDA

reports high quality

LUBBOCK — Early samples moving through the USDA Lubbock Classing Office are reflecting high quality and good color grades according to Lubbock-based Plains Cotton Growers, Inc.

However, Wendell Wilbanks, Lubbock Area Director, USDA Cotton Division, has concern over the lower-than-normal leaf grades he is seeking. "In the first 100,000 or so bales classed this season,

we are getting a lot 5 and 6 leaf grades that otherwise is high quality and good color," says Wilbanks.

A leaf grade of 6 can decrease the value or sale price of that cotton by as much as 900 points, or 9 cents a pound, in the pricing system.

Wilbanks commented he exposed to a freeze. He considers some of the problem to be associated with plant regrowth that will discontinue after a frost or freeze finally terminates the crop.

Wilbanks expressed greater concern than 30 percent of the crop classed so far can be described as "Light Spot." "This is considerably higher than in past years," commented Wilbanks.

Patrolling takes up most of officer's time

When children pretend to be police officers, they excitedly scamper around chasing criminals and convicts, always ending with a dramatic shoot out.

But in "real" life there aren't constant chases or shoot-outs.

In fact, most police officers spend about 90 percent of their time patrolling, something that may not seem exciting to a seven-year-old, but something very essential to "real" police action.

"Quite a few people think we are just out to write tickets and generate revenue. We have no quotas and writing tickets has no effect on our pay. But,

working the streets is part of our job. We have to keep them safe," said Sergeant Randy Smith of the Muleshoe Police Department.

An average day for "Muleshoe's finest" includes a 15-minute briefing at the beginning of each shift to catch up on the day's events, tying up loose ends from the prior shift, running calls, and yes, the inevitable patrolling.

But patrolling never becomes routine, Smith said.

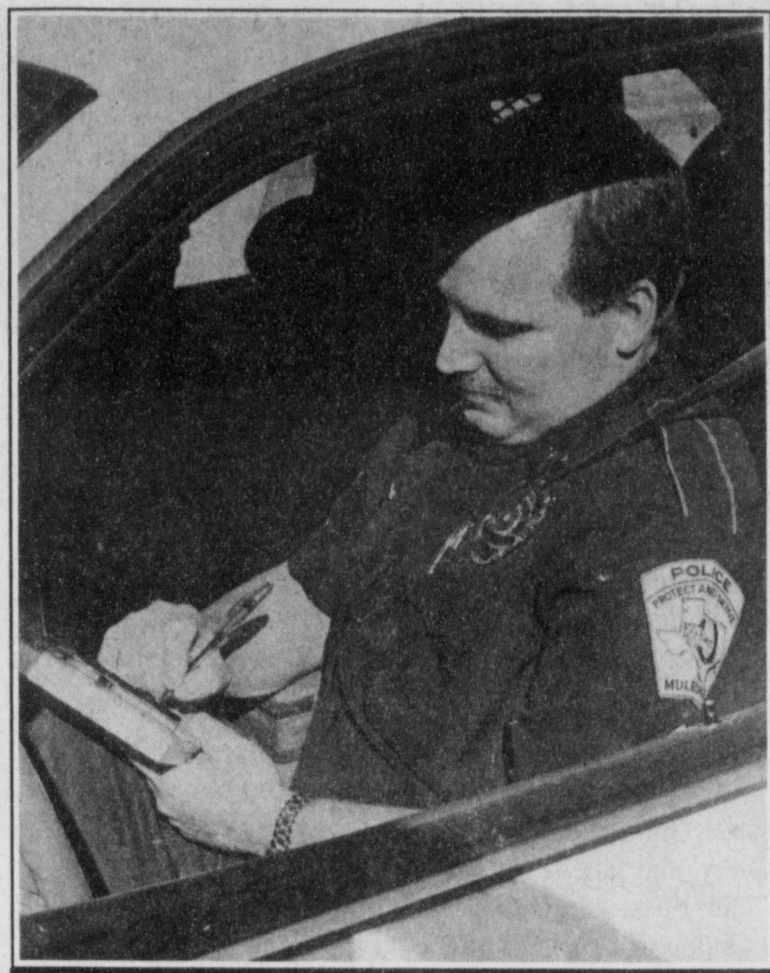
In fact, the officers make a point out of changing their patrol patterns in order to ensure maximum safety by being unpredictable to prospective criminals.

"Even though we spend a

lot of time in our vehicles, the job is still fun and exciting. Everyday is something new, and its not really repetitive," said 28-year-old Smith.

Although the force is working hard to make a positive impact on the everyday lives of Muleshoe's citizens, the public hasn't forgotten about problems in the past, Smith said.

"The public is still leery of the police department," said Smith. "We are still paying for problems in the past. It will take a while for them to believe in their police department again and to see that things have changed. We have a lot of plans and are hoping to do some good things."

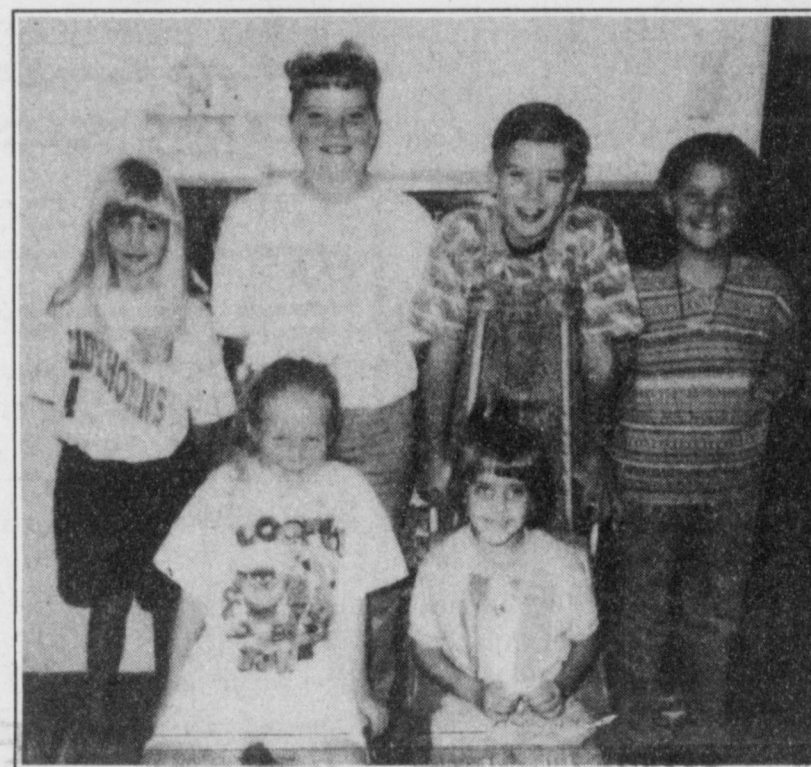

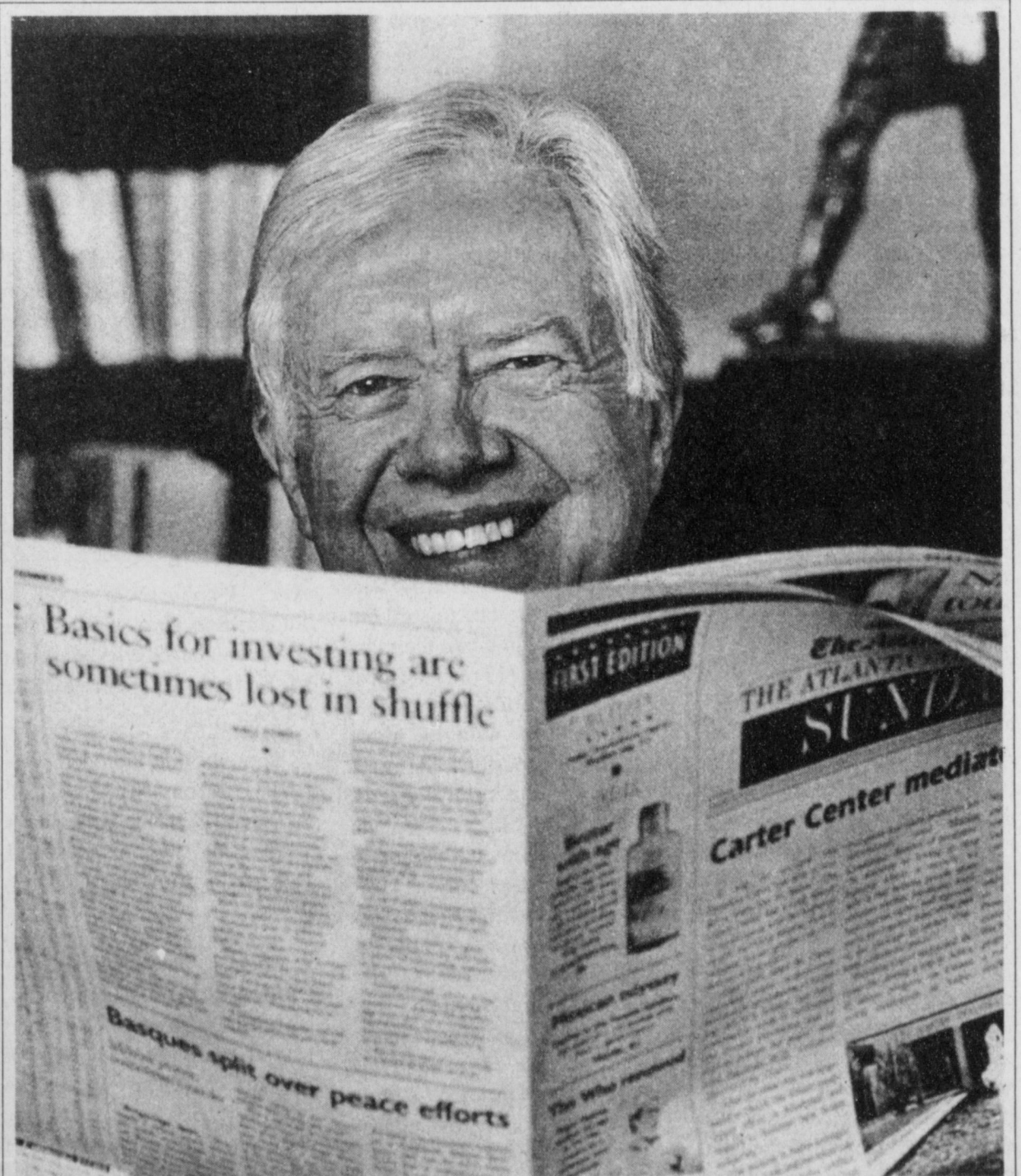

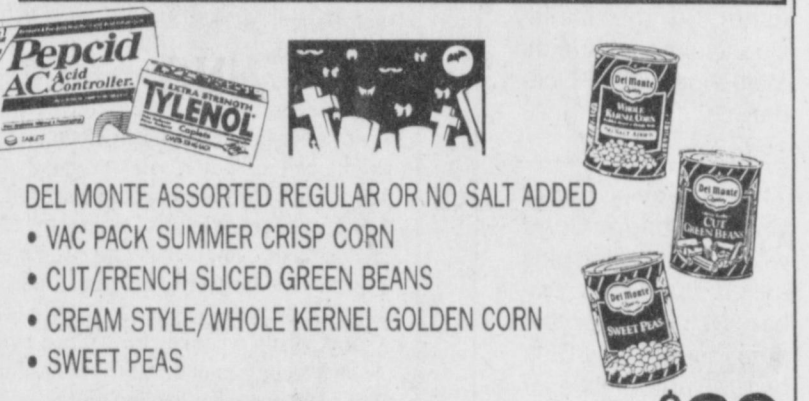
