



It is illegal to drive a motor vehicle while under the influence "Under the influence" does not but requires only that any of his drugs were prescribed by a doctor is not a defense for driving while under the influence of narcotics or other drugs. DWI may be a felony and it is

the responsibility of a citizen to prevent the commission of a felony. In discharging this responsibility a citizen upon observing a suspected DWI should immedlately call the nearest Police Station, Sheriff's Department or Highway Patrol Office and report the location and description of the vehicle and the direction driven by the suspected DWI. Officers will then make an investigation to determine, whether the driver is DWI.

Contrary to popular belief, tetanus is not restricted to farm areas. Any domesticated animal, including cats and dogs, are capable of carrying the organisms.

The tetanus bacteria cannot survive well in open air, but thrive in closed wounds, which they enter through breaks in the skin, establishing themselves in dirty wounds resulting from all sorts of accidents from highway accidents to the most trivial. penetrating wound.

The incubation period ranges. from two to 50 days after contact with the germ. The first signs are often stiffness in the neck and jaw, sometimes preceded by chills, fever and stiffness of the muscles near the original wound.

In time, if left unchecked, tetanus causes severe spasms involving the entire body and may result in death.

Fortunately serious damage from the infection may be avoided through innunization with tetanus toxoid and should be included in the routine vaccinations of children, with an occasional "booster" to insure immunity.

Barefoot time is happy time if your child is protected, but if he should suffer a foot injury from a cut or puncture, take him to the physician. It may be worth his life.







The Silverfish Menace Silverfish will devour anything that is glued starched or is snfe; nor is cotton, linen, rayon, silk or nylon. Silverfish damage pictures on the wall. This carrot-shaped, silver or gray insect may be found from the attic to the basement,

An infestation of bedbugs in homes and hotels is considered a sign of filth. But bedbugs are sometimes seen on public conveyances, hence anyone might take one home. Persons who do not notice the presence of bedbugs can easily be car-riers of them.

Bedbugs are tiny insects which can be found along the seams and in the buttons of mattresses, in the coils of bedsprings, in the crevices of bedsteads, in upholstered furniture and in picture backings. They can wedge their flat bodies into any tight crevice.


Bedbugs are nocturnal, for-aging out at night. When they bite, they puncture the skin to get their blood meal, causing a swelling and itching. Un-explained bites in the morning may denote the presence of this night visitor. Bedbugs lay their eggs in their hiding places



Are farm prices rising this year?

- There has been a slight rise in the over-all average of farm prices, that is the average prices farmers got for their produce in the past three months. However, the cost of what the farmer has to pay for the things he buys has gone up so that the Department of Agriculture says that purchasing power of farm commodities in June, 1957, sagged to the lowest point in 17 years. According to the report of the Department, prices received by farmers averaged 82 per cent of parity in the month ending June 15, or 4 points below the average of 86 per cent in June 1956, and the lowest for any June since 1940
- Q-How do the Steel Companies justify increased prices of steel to \$6 per ton following so closely on an \$8.50 boost a year ago as a result of an escalator clause pay increase due to increased living costs? -Some authorities claim the Steel Companies cannot justify the price boosts, since the raise they are giving their workers now is part of a deal made about a year ago for a three-year-no-strike pledge by the Unions. 


