Cotton Harvest Almost Over

The light rain this week postponed briefly the area cotton harvest, but it is expected to be completed in a few days. A total of 555 bales of cotton have been ginned at Santa Anna Co-op Gin this fall, according to William Brown, manager.

Most of the cotton processed here has been from the Gouldbusk area and some from Brown County. There was very little cotton harvested in the immediate Santa Anna area.

Although the cotton harvest is short, the quality is very good, Brown said. Price for cotton was 42 cents a pound last week.

The 1977 harvest will be almost twice that of last year when only 345 bales were ginned here.

Open Letter From The Mayor

Citizens of Santa Anna,

I have served on the City Council and in city government approximately 8 years. During this time all kinds of complaints have come in. Red water, low pressure, and delay of water because of breaks in water mains to name a few. There have been numerous water leaks and breaks in the water mains during the past few years.

In 1950 the city voted bonds to run water lines to Jim Ned Creek, At that time it seemed that would assure Santa Anna of adequate water supply, since it had been about 15 years since Brownwood Lake was completed and that portion of water supply had not been separated from the main channel of the lake at that time. Due to the building of flood control dams and the Coleman Lake, the water supply along Jim Ned Creek to Lake Brownwood has been reduced. Also the lack of rainfall in recent years caused a reduction in our water supply.

In early summer when Coleman County was declared "A Drought Disaster County" a state reperesentative, who was aware of our water condition, urged us to check the possibility of a grant and loan under this program. With a letter to Fm.H.A. in August the work began by the City Council and City Engineer to make a study of the town's water needs and to devise a plan that would best suit all the needs. It was proposed to extend the water line from the present pump station on Jim Ned Creek to the main channel of Brownwood Lake where the water is 40 to 60 feet deep. In the opinion of the City Council the new water supply without a distribution system would not solve all the problems.

So a new distribution system was planned. After making application we knew that the maximum amount of grant could not exceed 50 percent. Due to our extreme need we were awarded a grant (giff) of \$949,600.00 and a loan of \$977,000.00.

Due to circumstances and knowledge of construction cost going up every year, it was the decision of the Council to offer this choice to the voters for a bond election. We are aware that it will be a hardship on many city residents due to fixed income, but we also felt that being without water would make an impossible situation for the growth and progress of the town.

I want to urge each citizen to vote on this all-important project, for each property owner to consider the reduced value of his property should this town be without water. I urge each voter to make up his own mind. Do not vote for this project because I want you to, but vote for it because this is your home, your town and you don't want to run the risk of having no water.

Water Project To Be Decided December 17

The Santa Anna City Council, at a called meeting Friday, November 25, voted to call a bond election for December 17 for a water system improvement project.

Don Johnson, Coleman attorney, explained to the Council the procedure and presented the necessary paper work for the election. It was prepared by Elbert W. Morrow, a bond attorney from Dallas.

The election will be to approve or reject bonds to pay the Farmers Home Administration loan that was approved for the project. It includes \$750,000 in revenue bonds for not more than 40 years to improve the city water works system and a general obligation bond issue for \$400,000 for the same purpose.

Matching funds for the improvement project has been awarded Santa Anna in a Federal

A resolution to submit the bond issue to the voters of Santa Anna was read and Thomas Hays made a motion to pass it. Dale Bradley seconded the motion which passed unanimously.

The election December 17 will be held at the Coleman County Telephone Cooperative building.

WHEREAS, this City Council of Santa Anna, Texas, has determined that an election should be called to ascertain whether said governing body shall be authorized to issue bonds of said City in the amounts and for the purposes hereinafter mentioned; therefore,

"SHALL the City Council of the City of Santa Anna, Texas, be authorized to issue revenue bonds of said City in the amount of \$750,000 maturing serially in such installments as may be fixed by the City Council, the maximum maturity as being not more than FORTY (40) years from their date, to be issued and sold at any price or prices and to bear interest at any rate or rates as shall be determined within the discrestion of the City Council at the time of issuance, for the purpose of constructing improvements and extensions to the City's Waterworks System; to be issued in accordance with and in the manner provided in Articla 1111 et seq., V.A.T.C.S, and secured by a pledge of the net revenues from the operation of the City's combined Waterworks and Sanitary Sewer System, each bond to be conditioned that the holder thereof shall never have the right to demand payment of said obligation out of funds raised or to be raised by taxation?"

PROPOSITION NUMBER 2 "SHALL the City Council of the City of Santa Anna, Texas, be authorized to issue \$400,000 general obligation bonds of said City for the purpose of constructing improvements and extensions to the City's Waterworks System: said bonds to be issued in one or more installments, to mature serially over a period of years not to exceed FORTY (40) years from their date, to be issued and sold at any price or prices and to bear interest at any rate or rates as shall be determined within the discretion of the City Council at the time of issuance; and shall there be levied, assessed and collected annually ad valorem taxes on all taxable property in the City sufficient to pay the annual interest and to create a

sinking fund sufficient to redeem said bonds as they become due?"

SECTION 2: That paper ballots shall be used for said election, which ballots shall be prepared in accordance with the V.A.T.S Election Code so as to permit the electors to vote "FOR" or the aforesaid "AGAINST" propositions which shall be set forth in substantially the following form:

PROPOSITION NUMBER 1 "THE ISSUANCE OF \$750,000 REVENUE BONDS FOR WATERWORKS IMPROVEMENTS

EXTENSIONS" PROPOSITION NUMBER 2 "THE ISSUANCE OF \$400.000 GENERAL OBLIGATION **WATERWORKS IMPROVEMENT**

BONDS" The word "FOR" and beneath it the word "AGAINST" shall be made to appear on the left of each proposition. A square shall be printed on the left of each of the words "FOR" and "AGAINST". and each elector shall place an "X" in the square beside the statement indicating the way he wishes to vote.


