Suggestions For Projects List Youth, Clean-up, Dogs

Santa Anna Lions Club members have had a number of suggestions for community projects and improvement during the past week. The suggestions were read at the Tuesday meeting of the club by the group captains, M. L. Guthrie Jr., Anthony Strother, C. P. Wenzel, John Gordon and Rob Cheaney, filling in for group captain Wendell Sparkman.

The most frequent suggestion from the five lists included the control of stray dogs, a major clean-up of the town with the removal of abandoned vehicles and removal of vacant buildings and structures, and suggestions for youth activities and entertainment.

The need was cited for additional tennis courts, a youth center and city park. Support was urged for the County swimming pool.

Some of the suggestions

included support of the Boy Scouts, clearing street intersection obstructions, providing a taxi service on election days, purchase of a street sweeper and improving sidewalks, and organizing a

summer recreation program for young people. Suggestions also were to

promote additional rental housing, pave and repair streets. replace traffic signs, mark crosswalks at school and churches, renovate the baseball fields, and sponsor dances and games each month for young people.

Senior citizen projects and activities were mentioned; sponsor a rest stop for travelers on holidays; raise salary of law enforcement officers; sponsor a youth talent program, and seek help in finding jobs for young people each summer.

The Lions Club members were also urged to plan worthwhile programs for the club, stimulate members to take part in the club activities and to investigate the available funding for city-wide projects.

The club will be working within the committee in compiling the project list and will also meet with the City leaders to coordinate their projects.

Residents of the community have an additional week to submit suggestions for the projects.





Probated Term Assessed Political Coleman Theatre Owner Calendar

Arlie Clinton Berg entered a plea of guilty last wwe before County Judge W. W. (Pete) Skelton to the Class 'B' misdemeanor offense of commercially exhibiting obscene material in Coleman County. The offense for which Berg was convicted involved the showing of a 'socalled' XXX rated movie 'Loveland' at the Oak Drive-In Theatre in Coleman on the ninth day of November, 1977. The

charges against Berg were made in the form of an indictment returned by a Coleman County Grand Jury as a result of evidence presented to the Coleman County Grand Jury by Sheriff H. F.

Fenton. The Grand Jury was conducted by District Attorney Gary R. Price, Assistant District Attorney W. Stephen Ellis and County Attorney of Coleman

County, Joe D. LeMay.

The defendant was assessed a term of 180 days in the Coleman County Jail, which was probated on the usual condition of probation, plus additional condition that the defendant not commercially exhibit obscene material. The probation also carried the additional conditions of the payment of a probation fee and court cost by the defendant.

Pre-trial hearings were conducted by Judge Skelton in County Court in Coleman Monday, January 23. At the pre-trial hearing, the movie film was shown in the courtroom for

viewing of the Court, the attorneys and selected witnesses at the request of the defense attorney in connection with his preparation to defend Berg in the anticipated trial.

The case had been set for jury rial beginning Monday, January

The defendant, Berg, has indicated his intention to move from Coleman County, and the Court has given its consent to such a move by the defendant, the consent necessary under the conditions of probation.

District Attorney Gary R. Price stressed that the conviction of Berg was only connected with the particular film for which charges were initiated and have no legal affect on the showing of similar films at any theatre. The District Attorney did point out that the commercial exhibiting of obscene material by anyone would likely be promptly considered by the Grand Jury for appropriate action.

The Class 'B' misdemeanor conviction carries a maximum punishment of 180 days in jail andor a fine of any sum up to \$1,000. A conviction for a second offense by the same person would be a Class'A' misdemeanor which would carry a maximum punishment of up to 12 months in the county jail and-or a fine of any sum up to \$2,000.

The defendant was represented by Frank Shore, a Dallas attorney.



IRS Returns For Farmers Due March 15

While most taxpayers have until April 15 to file their 1977 income tax returns, the filing date for farmers and ranchers is much

'Agricultural producers who did not file an estimate of their income by January 16 and did not pay the estimated taxes must file their tax returns and pay due taxes by March 1, points out Dr. Richard Trimble, economist in management for the Texas Agricultural Extension Service. 'However if farmers filed an estimate, they have until the April 17 deadline to file final returns."

Trimble notes that several changes were made in the income tax law during 1977 which should be of interest to Texas farmers and ranchers.

A major change was the elimination of the standard. deduction and the low income allowance. These two items have been replaced by a flat amount called 'zero bracket amount.' this amount depends on you filing status.

'The zero bracket amount is not a separate deduction, but the equivalent amount is built into the new simplified tax tables and tax rate schedules,' explains the economist.

Another change is that the deduction of \$750 for each exemption and the general tax credit have been built into the new tax tables, so there is no need for the taxpayer to determine these. The general tax credit has also been revised to consider exemptions for age and blindness, adds Trimble.

Filing requirements have also been changed for the 1977 tax year

For example, an individual must file a return if his gross income is \$2,950 or more and a married couple under 65 years of age must file if their joint income is more than \$4,700. If both are 65 or older, they may make \$6,200 before being required to file a

There are many other minor changes, and Trimble suggests several publications that may be of help, available from the IRS or from any county Extension office.
