

BCWID Stalls Water Contract

Contract Extension To Be Given At Future Meeting Of Board

The Brown County Water Improvement District No. 1 Board of Directors declined to quote a price on water sold to the City of Santa Anna when the group met with Mayor Glen Copeland and City Engineer Wendell Sparkman last Monday in Brownwood.

The BCWID leaders granted permission for water to be taken from Lake Brownwood at the proposed pump station at the lake, continuing on the present price in the contract that runs to 1980.

In a story in Monday, February 6, issue of Brownwood Bulletin, the report indicated that the entire water project for Santa Anna was endangered by the Board's decision. However Sparkman stated that only a price quotation on water past the




FFA Members Place Well At Ft. Worth Show


Two Santa Anna FFA members with entries at the Fort Worth Fat Stock Show did well last week, placing in the large show.
