HUD Ruling Causes Move Of Plantings

A number of flower beds and shrubbery at the housing units in Santa Anna are being moved or destroyed as local administrators of the project are complying with a Housing and Urban Development ruling that requires no such growth within ten feet of the buildings.

The local apartment complexes, financed through the federal agency, have always been very attractive as most residents maintain beautiful yards and gardens. Many people are distressed that the landscaping is being moved, but the regulation is being observed in what is said to be move to protect the structures from too much water along the foundations.

Residents of the housing units are encouraged to maintain attractive yards, but are asked to note the ruling that plantings must be at least ten feet from the buildings.

Water Rationing Imposed

Watering Of Yards, Gardens, Prohibited For Duration

Santa Anna City Council voted Thursday night in regular session to impose restrictions on use of water in Santa Anna effective Saturday, March 11: The proposed plan is for voluntary rationing. prohibiting any watering of lawns or gardens by those using water from the City of Santa Anna system.

The Council made the decision after learning that the present water supply is only enough for approximately 90 days at the present rate of consumption.

The Council plans to study the water consumption rate at the end of the month, and at that time enforce the rationing if necessary by imposing fines on homeowners disregarding the voluntary request. At the present time there are no restrictions for commercial users such as the laundry, service stations and car wash.

Although the new water improvement project is progressing well, the city water supply will come from the present sources for a year or more. The city lakes are depleted and the Jim Ned pump site at Lake Brownwood is dangerously low.

City Council members also heard the report that Brown County Water Improvement District water rates are to increased from 7 cents to 17 cents

TFB Supports Legislation For Farmers

WACO- The Texas Farm Bureau will support legislation which would provide higher payment incentives for cutting acreages of wheat, feed grains and cotton this year, according to Carrol Chaloupka of Dalhart, president of the 214,000 -member organization.

The Texas Farm Bureau Board of Directors adopted February 24 a recommendation to the American Farm Bureau Federation which states, 'We support higher target prices and set asides such as those proposed in the Dole Bill,

'Our intent is to get a workable program that will pump money immediately into the farmers' pockets, reduce production and not be too costly to the taxpayers,' the Dalhart cattle and grain producer said.

We are not locking ourselves onto any one proposal, but are free to work in any way we can for the principles of the Dole Bill which is designed to cut production in return for higher target prices,' Chaloupka said.

Under the Dole Bill, a 50 percent reduction in wheat acreage would provide a target price of \$5 per bushel.

Corn acreage reduced 50 percent would result in a target price of \$3.45 per bushel.

Grain sorghum and other feed grains if the Secretary of Agriculture so designates them, would have a target price based on corn. Cotton producers could earn a target price of 84 cents a pound by cutting acreage in half.


