## **Exam Slated** For Substitute Mail Carrier

A Civil Service examination will be given soon for a Substitute Rural Carrier in the Santa Anna Post Office. Application to take this examination may be picked up from Postmaster John C. Gregg now and must be returned to the Post Office before 4:30 p.m. Friday, January 27.

The pay scale for this position will be from \$6.54 per hour to \$7.78 per hour, depending on the length and character of the route. All substitute carriers of record must furnish and maintain at their own expense vehicle equipemnt necessary for the prompt handling of the mails. They are given an equipment maintenance allowance based on the daily mileage scheduled.

All information you need to know is posted in the box lobby of the Post Office. Anyone interested is invited to come by the Post Office and read the requirements and pick up an application from Mr. Gregg.

The examination will be given at Abilene, Texas Post Office at a date to be announced later.

Most gold jewelry since ancient times has been alloyed, or combined with other metals, because 24 karat (24K) gold—pure gold—is generally considered too soft for practical use in jewelry.



Most American gold jewelry is marked 14K, which means it's made of 14 parts gold combined with 10 parts of another metal.

The karat mark (such as 14K or 18K) not only tells the buyer what proportion of the item is actually gold—it says that it has gold's special qualities: non-tarnishing, non-corroding and virtually indestructible. Buyers should look for the karat stamp—because only karat gold jewelry is real gold.

Eighteen karat gold, regarded by some as best for jewelry, is 75 percent pure gold, or 18 parts gold and 6 parts other metals for hardening. Ten karats, 41.6 percent gold, is the lowest karatage that can be sold as gold in the U.S., by rule of the Federal Trade Commission. Below 10K, many experts agree, the metal loses the special characteristics of gold.

AUSTIN--Texas farmers made a first of the year visit to Austin to discuss their plight with state officials and they went home confident that they had the support of Texas officeholders in their fight for a fair chance to earn their livelihood from the land.

Governor Briscoe and I at a Senate hearing released a joint announcement of our intent to stick up for the folks on the farm.

That message which will be sent to Washington says:

"A crisis situation has developed in American agriculture and we call on the national administration and the Congress to provide without delay immediate attention to this very severe problem.

"Our agriculture producers in Texas and throughout the nation are caught in a vicious cost-price squeeze that requires immediate attention. Our people cannot wait any longer for action.

"Existing federally-implemented agricultural legislation is not providing for the needs of all segments of the American agricultural indus-

"We believe the farmer has a right to an equitable profit for his labor and investment.

"We therefore lend our support in securing 100 per cent of parity in the market place for American agricultural products.

"American farmers should be praised and allowed a fair profit on the food and fiber they produce instead of being penalized for being efficient.

"Nations look first to food and fiber for their people. They are necessities which can buy peace or without which can cause wars. Nonproducing nations wither and


