



#### Disaster Loan Info Available By Telephone

Texas farmers and ranchers who want information about the disaster recovery loan program now have a toll-free number they may call, the U. S. Small Business Administration has announced.

"SBA has already assisted more than 10,000 agricultural producers in Texas," said Mercurio Martinez, SBA Regional Administrator, "This toll-free number will make it easier for farmers throughout Texas to receive information about the

SBA program."

Martinez explained how the telephone line will be operated by SBA. He said that persons who have questions about being eligible or how to apply for an agricultural disaster loan may receive a brief explanation by calling, toll-free, 112-800-692-4296 from anywhere within Texas. If a farmer has already applied to SBS for assistance, he may leave his name, address and phone number with the receptionist and a loan officer

familiar with the application will call back at once using another line rather than tying up the toll-free number for any length of time

Small Business Administration physical disaster loans are available in counties recommended by the Governor and subsequently designated by the Administrator of SBA. The loans are made only for crop losses not already covered by insurance or other disaster or deficiency payments.

year but through the next Fiscal Year as well. Although the EE program was not due to end until May 15, we were just about out of funds when the President signed the bill on March 30.

The EE program provides direct or guaranteed loans to farmers and ranchers who suffer economic hardship because of area or national economic conditions beyond their control.

Mr. Pieratt said the new law immediately increases the ceiling on outstaning principle for EE loans nationwide from \$4 billion authorized under the Agriculture Credit Act of 1978. The additional \$2 billion will be allocated to the states .

The new law requires that stronger "credit elsewhere" criteria be enforced before an EE loan can be approved. Any application for an insured loan of \$300,000 or more must be accompanied by letters from at least two private lenders explaining why they turned down the request for a loan.

The new law also requires the Secretary of Agriculture to conduct a comprehensive studey of the EE loan program and to recommend to Congress by March 31, 1981 whether or not the program should be extended beyond the September 30, 1981 expiration date.

# Age, Identity Evidence Are Required For S.S.

Everyone who applies for a social security number must provide evidence of age, identity, and U.S. citizenship or lawful admission status, including young children, Priscilla Tercero social security Branch Manager in Brownwood, said recently.

Parents sometimes have difficulty finding the required evidence for their children Tercero said. They especially have trouble with the idea of providing evidence of identity.

Proof of age is relatively easy-public or hospital record of birth recorded before age 6 or religious record of birth or baptism recorded before age 5. One of these documents will establish also citizenship. Tercero said.

Documents which will establish a young child's identity, and which are usually available to most families, include: report card, school identification card, baby's hospital wrist band, newspaper birth announcement, baby book, court order for name change, church membership or confirmation record, doctor or hospital records, vaccination

certificate, daycare or nursery school records, or child's membership in Boy Scouts, Girl Scouts, or other young organiza-

This is not an exclusive list. Tercero said. Any document providing identifying data such as a physical description, photograph, or signature may be used as evidence of identity.

Tercero said at least two documents must be presented one to establish age or citizenship and one to establish identity. Only original or copies certified by the issuing agency can be used.

For more information, contact the Brownwood social security office. The people there have a free leaflet, "Applying for a social security number." The office is located at 300 N. Main and the telephone number is 646-7533.

> Leath, who is a co-sponsor of H.R. 6725, said that a constituent of his, Charles Howard of Meridian, is currently engaged in a contract with the Department of Interior to study the effectiveness of a toxic collar and 1080. "To date, the results have been positive and I feel they will continue to be so." 1080 is used in conjunction with collared sheep in order to help control coyote kills of sheep and goats. When a coyote bites the throat of a collared sheep it receives a dose of 1080.

Q. If you have a car wreck on an interstate highway in a city, which police would investigate the accident?—B. L., San Antonio

A In most instances municipal police handle investigations on interstates within city limits. However, you may notify any police agency and give the location of the accident. The responsible agency will be dispatched to the scene.

Q. Is a flashing red light at night the same as a 4-way stop on a regular stop sign?— N. B., Austin

A. Yes. A flashing red light, day or night, means that you must make a complete stop until it is safe to continue. Yield the right of way to vehicles on your right.

Q. Is it courtesy or law to stop for a funeral procession?—T. K., Midland

A. Texas law does not require motorists to stop for funeral processions; however, some other states have laws granting funerals the right of way. Allowing members of a funeral procession to pass uninterrupted is considered a gesture of courtesy.

# **Deficiency Corrections** Noted At Comanche Peak

Texas Utilities Generating Company has informed the **Nuclear Regulatory Commission** of actions the company is taking to correct deficiencies in two areas at the Comanche Peak nuclear power plant which did not pass recent TUGCO quality assurance inspections.

TUGCO also announced that, routine inspections of Comanche Peak in February, the NRC found no items of non-compliance. The report on these inspections, which involved 54 inspector-hours by two inspectors, was released today by Texas Power and Light Company President Bob Campbell.

The two areas being corrected involve a manufacturing deficiency in discs in the service water control valves and certain welds which do not meet specificiations.

valves contain aluminum bronze discs which did not receive the required post weld heat treatment, the manufacturer reported to TUGCO.


TUGCO analyzed these valves and none was considered to be subject to failure that would affect safety due to gradual corrosion. However, TUGCO will return the valves to the vendor to be brought up to specification requirements.

An inspection by Comanche Peak quality assurance personnel also showed that several welds attaching the Unit I main control boards to support structures were undersized and that the spacing of some welds did not meet original specifications.

These weld configurations must meet certain seismic requirements and TUGCO has ordered them to be reworked. This should be completed by May 1. Also, further training will be provided for welders working on electrical equipment to prevent a recurrence of this problem.

Work at Comanche Peak that was found by the NRC to be satisfactory during February included overall construction progress and practices; installation and inspection of instrumentation components and systems; training quality of assurance personnel in instrumentation inspection; actions to insure pipe support base plate flexibility.

Comanche Peak is owned jointly by Texas Power & Light The service water control Company, Dallas Power & Light Company, Texas Electric Service Company, the Texas Municipal Power Agency and Brazos Electric Power Cooperative, Inc.

Coleman County grain sor-ghum producers have been mailed deficiency payments in the amount of \$39,946.58 for the 1979 crop year. Payments were made on 240 farms, which averaged \$166.44 per farm.

Though the payments in the county are not significantly large on a per farm basis, they do represent the payment rate guaranteed under the 1979 program. The deficiency payment rate is 13 cents per bushel, which was the difference in the \$2.34 per bushel target price level and the \$2.21 per bushel average market price.

Deficiency payments are made to program participants when the national market price for the first five months of the marketing year (October-Febuary for grain sorghum) falls below the government established target level for the commodity. The payment rate is the difference between the target level and the higher of the five-month average price or the national loan rate for the commodity.

Grain sorghum producers across the nation received \$61 million in deficiency payments. This is inevitably a large sum of money; however, it does represent the loss of income to the producers due to the low market price they received for the commodity.

The 1980 program is being operated under the same system. For 1980, however, there is a High and Low Level of participation. The High Level of payments will be applicable to those producers who do not exceed the farm's Normal Crop Acreage (NCA) in the planting of NCA crops.

Price support payments to wool producers in Coleman County totaled \$156,400.82 for the 1979 marketing year. The drafts were put in the mail on Tuesday, April 15, 1980, and should soon be in the hands of some 178 Coleman County producers.

The payment rate for the 1979 marketings was 33.3 percent of the net sales proceeds on shorn wool, and \$1.15 per hundred pounds liveweight on unshorn lambs. Promotion fund deductions amounted to 2.5 cents a pound for shorn wool and 12.5 cents a hundredweight for unshorn lambs.

There will be no support payments made on mohair for 1979 since the average price received by producers in the open market will be higher than the support price.
