## Guy Allen Champion Steer Roper

### Young Santa Anna Steer Roper

### Wins Second Championship Title

A 22-year-old Santa Anna man, Guy Allen, won his second World Champion Steer Roping title last weekend when he was major winner at the Steer Roping Finals in Laramie, Wyoming. Guy, the son of Mr. and Mrs. James Allen, won a total of \$8,940.00 in the competition, taking the World Championship of the PRCA event with a total of the year of \$20,567.18 in prize money.

The young man went into the finals in first place after winning money in 11 of the 14 PRCA rodeos in which he competed during the past year. Runner-up in total money won was Arnold Felts of Oklahoma with a total of \$12,467.78. Roy Cooper, the 1979 champion calf roper, was third.

Guy, a student at Sul Ross University at Alpine, rode a big gray gelding, "Wigwam" in the finals. He not only roped the fastest steer in the finals with 11.0 seconds, but recorded the most money won during one season. He was several thousand dollars ahead of his winnings when he took the 1977 title.

Guy's father, James, qualified for the finals as seventh place in total winnings, but was sidelined the week of the finals when he was kicked by a horse

at their ranch and hospitalized with a fractured hip. The mishap occurred as the Allens were preparing to leave for Laramie last week. Terry McGinley of Keystone, Neb. was moved into the finals to replace James and ended the competition as winner of the average for the ten go-arounds.

Ropers competed on ten steers, with Guy receiving "no

time" on his fifth steer. From that point he competed for the go-around time, placing first with three of the final five steers.

Guy Allen has been competing as a Professional Rodeo Cowboy since 1976 and has qualified for the finals all except one year since that time. He will be awarded his trophy saddle and belt buckle during the awards presentations at the National Rodeo Finals in Oklahoma City in December. At the close of the Sunday performance in Laramie he was awarded a

plaque and a hat.

On hand to watch the roping last weekend were his mother, Ann, and brother, Gip, also a PRCA roper. Guy and James left from Laramie for Pendleton, Oregon, for the rodeo that is underway this week.

James is in Brownwood Community Hospital and recovering well from the hip fracture. He is able to be up with the use of a walker and is expected to return home in a few days. He will be back on the roping circuit as soon as possible.



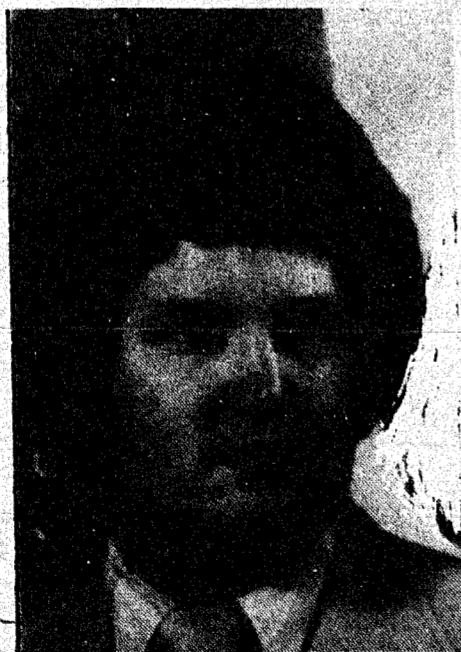

## Arson Suspected In Grass Fires In Santa Anna Community

Arson is suspected in several grass fires in the Santa Anna area, according to the Santa Anna Volunteer Fire Department. Two more grass fires were extinguished the past week, with firemen making two additional trips to the scene of one blaze before it was put out.

Approximately 30 to 40 acres of pasture land was burned on the Stevens place northeast of Santa Anna Friday, then grassland at the Hardy Blue farm east of town was burned that night. A fire last week burned a number of acres on the Richmond place in the Buffalo area.

Landowners and residents of the rural areas are urged to watch their property and make note of any unauthorized persons or vehicles in the area and to note descriptions and vehicle

license numbers that might be used in apprehending arsonists.

Another call made by the VFD last week was to a car fire on U. S. Highway 84/67 east of Santa Anna.

Hours of the day care center were planned from 7:30 a.m. to 5:30 p.m. but might be extended to accommodate working parents.

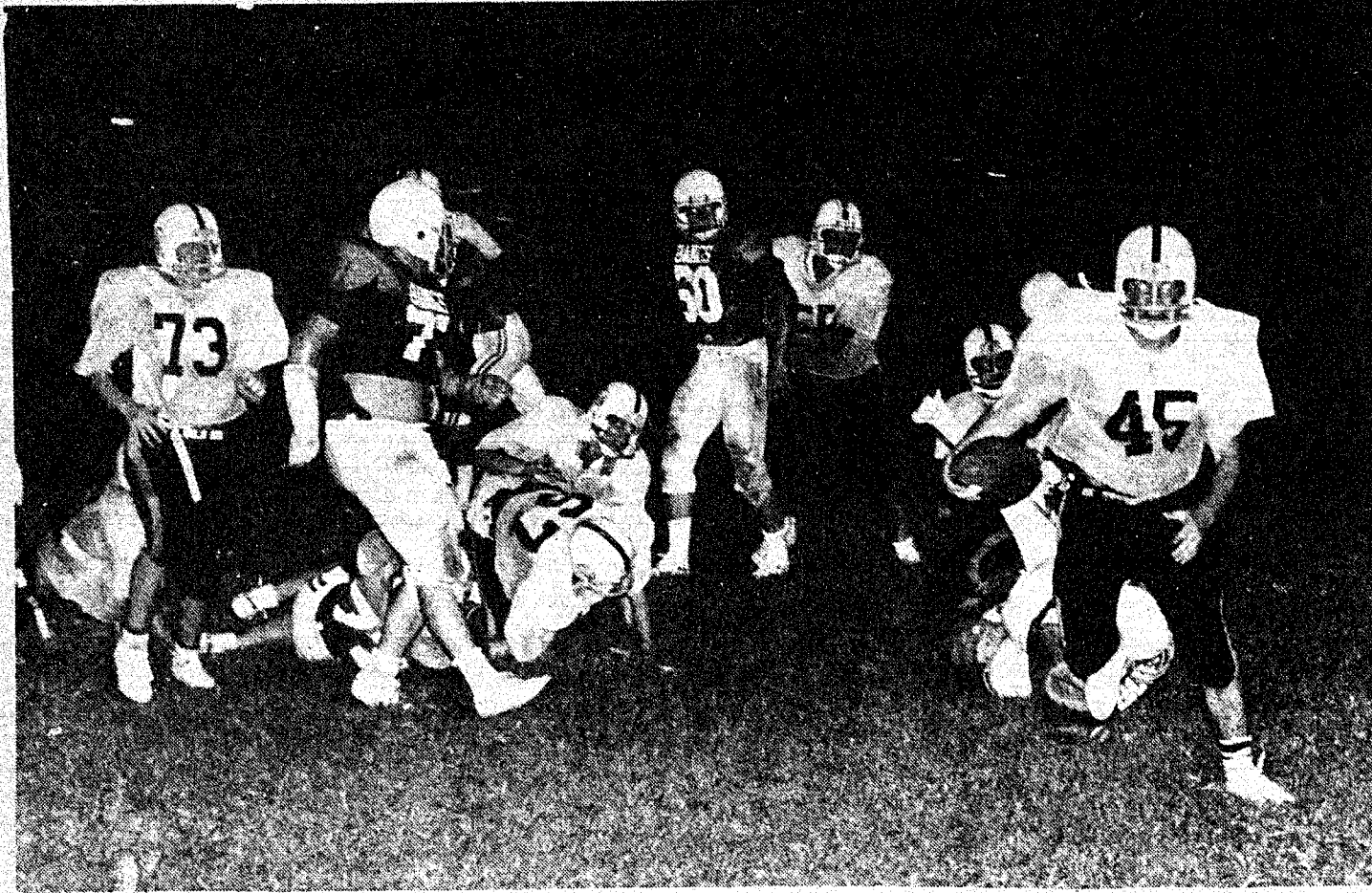
## Good Rains Fall in Area

The central Texas area received good rains early this week, a result of Hurricane Danielle. The moisture was the first of significance since late last spring.

R. W. Balke reported 2.75 inches at the official gauge in Santa Anna. The rainfall included moisture that fell from Saturday through Tuesday. The largest amount was Tuesday when over one inch was recorded.

Heavy rainfall was reported in other areas of the community, the unofficial measurements being from three to seven inches. The largest amounts were in the south part of the county.

Tanks and creeks were filled by the rainfall, and pastures and fields will benefit most from the moisture.

## Mountaineers Defeat Bangs; Evant To Play Here Friday

The Santa Anna Mountaineer football team ignored the pre-game predictions and proved they were not the underdogs when they defeated the Bangs Dragons 6 - 0 at Bangs Friday night.

The lone score came in the third quarter when Dwayne Warnock ran from the five yard line. The try for extra points failed.

The game was dominated by defense and turnovers, with Bangs losing the ball six times. Santa Anna fumbled four times and had one pass intercepted.

Santa Anna led in first downs with 17 to six for Bangs. The Dragons had 142 yards rushing and no passing yardage. The Mountaineers had 159 yards on the ground and 48 yards passing. Bangs punted four times for an average of 36 yards. Santa Anna had one punt

for 30 yards. Warnock led in yardage for the game, with Ernest DeLeon, Albert Collins and quarterback Rusty Buzzard also making good gains. Mike Salazar, middle linebacker, was outstanding on defense with the most tackles including numerous behind-the-line tackles. Others noted for defense were Jim Clifton, Ricky Perry and Dwayne Warnock.

The Mountaineers will have their first home game Friday night when they host the Evant team at 8 p.m. Evant was defeated by Johnson City 14 - 7 last week and will be seeking their first victory.

Two players were injured in the game Friday night with Mike Salazar getting a hand laceration that will keep him out of practice a day or two. Albert Collins has an arm injury that is expected to keep him out of action for several weeks.

Funeral services were held Thursday, September 4, at Trickham Union Church for Oscar Boenicke, 82, who died in Ranger Park Inn nursing home September 3 after a long illness. The Rev. Anthony Thibadeaux, pastor of First Christian Church, officiated at the services, with burial in the Trickham Cemetery under the direction of Henderson Funeral Home.

Mr. Boenicke was born in Austin County October 2, 1897, the son of Albert and Bertha (Wunderlich) Boenicke. He was a Brown County resident from 1904 until 1941 when he moved to the Trickham community. He married Mary Etta Shield in Coleman County January 21, 1925.

Mr. Boenicke was a stock-farmer, a member of First Christian Church, and had been a leader of the Coleman County Farm Bureau and a long-time president of Trickham Cemetery Association. He attended school in the Salt Branch Community in Brown County.

Survivors are his wife; three sisters, Mrs. Bertha Deere of Brownwood, Mrs. Lydia Eoff of Blanket and Mrs. Laura Harris of Bangs; a brother, Anton Boenicke of Bangs; and a

## DRIVELINE

**Maintenance Tips:** The torrid Texas summer is rough on cars, especially on long trips. Regular do-it-yourself inspections can prevent trouble on the road:

**Radiator:** Check the coolant level *regularly*, once a week. A 50-50 mixture of coolant/antifreeze and water has better cooling and anti-corrosion properties than water alone.

**Hoses:** Look for cracks, leaks, frayed surfaces. Before starting your car in the morning, squeeze the hoses. When cool, they should be flexible, not stiff. Think about replacing hoses every two years.

**Belts:** Inspect for cracks or frays. With your car engine off, press down on the middle of each of the belts to check the tension. They shouldn't yield more than about half an inch.

There is a traffic accident every six and a half seconds in America. Every sixteen seconds someone is injured in one of those accidents.

**Waterskiing On the Freeway:** *Everybody knows wet roads are slippery. But most drivers have never heard of the phenomenon of "hydroplaning." At speeds above 40-50 MPH your car's wheels can literally float free of the surface and skate atop the layer of moisture between tires and road. That's hydroplaning. Take your foot off the accelerator and keep the steering wheel steady. Don't jam on the brakes; it could cause a spinout. As your car slows, the hydroplaning will stop.*

## Home Arts Festival Division Chairmen Are Named For

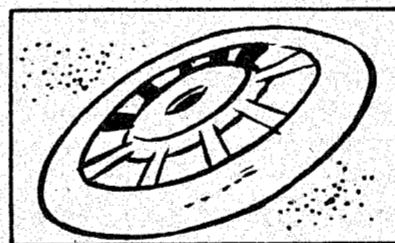

# Versailles Palace, Gardens A Place Of Great Beauty

There is no adequate way to describe Versailles, and to attempt to tell of the beauty and elegance of the former royal palace and gardens near Paris is almost impossible. It is a sight to be seen to believe!

The first pink brick and marble building was built in the early 17th century as a hunting lodge for Louis XIII. Each succeeding king added to the original structure, making a huge compound that includes an opera house and chapel, banquet halls, apartments and hundreds of rooms. A cobblestone courtyard about a city block in size is centered with a statue of Louis XIV. Facing the palace and about a quarter mile away are large stable buildings that housed the horses of the noblemen and soldiers.

At its zenith, Versailles housed as many as 1,000 noblemen and their 4,000 servants. Troops to protect the king and palace numbered 5,000.

The royal palace was a favorite spot of French royalty until early in the 18th century. Louis XIV and Marie Antoinette were living there at the time of the Revolution, fleeing into the country in an attempt to avoid execution.

The royal estate at one time covered hundreds of acres, all landscaped by horticultural designers. The current 250 acres is still landscaped with shrubs, trees and flowers of every description in the formal gardens and secluded parks within the wooded area. A main boulevard runs from the castle to a man-made lake that was used for regattas and boating during the royal tenure. Six hundred of the original 1,400 fountains are still in operation around the castle grounds.

The scope of the estate is understood when told that in 1635 there were 36,000 workmen and 6,000 horses engaged to work on the estate, diverting the River Beivre and draining and reclaiming land in

the marshy area to enlarge the estate.

The Trianon, a small palace, and the Petit Trianon, an even smaller structure, are located nearby where members of the royal court could retire from the crowds of the main palace. They, too, are decorated in the very grand style with ornate furnishings, paintings and statuary.

Marie Antoinette enjoyed "playing" as a peasant, so had a little farmstead constructed nearby where she and her maids-in-waiting went to feed the livestock, spin and weave. The adjoining woods provided a place to ride or walk.

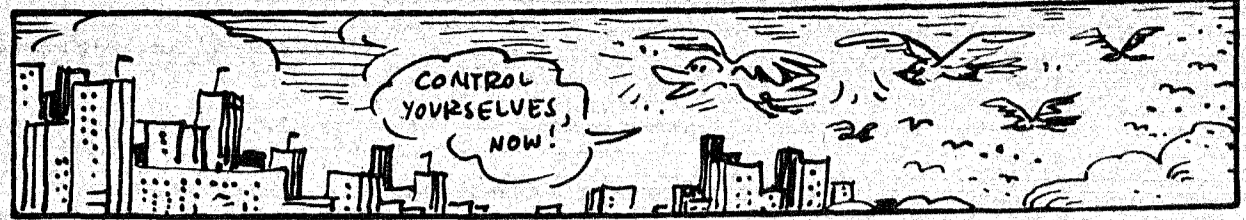
We took one of the several tours of the main castle, visiting the living quarters of the king. Renovation was underway and it was interesting to see the detail and precision involved in regilding the ornately-carved woodwork in the reception halls and rooms. Sand blasting was underway on the outside of the marble palace, removing years of grime and pollution and restoring it to its pink beauty.

I was surprised at the rather modern indoor plumbing, learning that the running water was provided by servants "running" with pails of water from downstairs to the roof-top storage tanks!

Beautiful art work is in every room, and on many ceilings. Room-size pictures and murals are ornately framed in gold. Many of the original paintings are now on display in the Louvre in Paris. There are also several museums within the compound.

As in most of the places we visited, tourists were en masse, with long lines waiting to tour the palace. However, once we left the main palace, there was room for everyone to stroll around the grounds, picnic on sandwiches and ice cream from vendors on the grounds.

We chose to walk the mile or so from the palace to the Trianons, enjoying the trees, flowers and magnificent statuary and trying to imagine what life was like during the heyday of the beautiful palace.

### PUBLIC NOTICE BRIEF EXPLANATORY STATEMENTS OF PROPOSED CONSTITUTIONAL AMENDMENTS GENERAL ELECTION NOVEMBER 4, 1980

#### PROPOSITION NO. 1 ON THE BALLOT

Senate Joint Resolution 35 proposes a constitutional amendment that would authorize the Legislature to permit banks to establish and operate unmanned teller machines within the county or city where the banks are located and to share the use of teller machines on a basis consistent with anti-trust laws, if it finds such operation will serve the convenience of the public. The Legislature has already passed enabling legislation (H.B. 1510) for this proposed amendment.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment permitting the legislature to authorize banks to use unmanned teller machines within the county or the city of their domicile on a shared basis to serve the public convenience."

#### PROPOSITION NO. 2 ON THE BALLOT

House Joint Resolution 97 proposes a constitutional amendment that would grant the State and the accused the right to an interlocutory appeal from the following trial court rulings in criminal cases: pretrial rulings on the constitutionality of a statute; on a motion to quash, dismiss, or set aside an indictment; and on a motion to suppress evidence.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment authorizing appeal of certain pretrial rulings of a trial court in a criminal case by either the state or the accused."

#### PROPOSITION NO. 3 ON THE BALLOT

House Joint Resolution 98 proposes a constitutional amendment that would require a single appraisal of all property subject to ad valorem taxation and would provide for a single board of equalization within each county. The con-

stitutional requirement that the county commissioners court sit as a board of equalization would be eliminated, and elected officials of the county or governing body of the taxing unit would be prohibited from serving as members of the board of equalization.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment requiring a single appraisal and a single board of equalization within each county for ad valorem tax purposes."

#### PROPOSITION NO. 4 ON THE BALLOT

Senate Joint Resolution 18 proposes a constitutional amendment that would allow the Legislature to authorize the conduct of bingo games by certain specified groups for charitable purposes, subject to the limitations that operation of the games must be approved in local option elections and that all proceeds must be spent in Texas.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to authorize bingo games on a local option election basis if the games are conducted by a church, synagogue, religious society, volunteer fire department, nonprofit veterans organization, fraternal organization, or nonprofit organization supporting medical research or treatment programs and if the proceeds are to be spent in Texas for charitable purposes of the organizations."

#### PROPOSITION NO. 5 ON THE BALLOT

House Joint Resolution 86 proposes a constitutional amendment that would allow the Legislature to exercise fiscal control over the expenditure of certain appropriated funds, subject to any conditions and limitations provided by law and subject to the ap-

proval of a budget execution committee that would be composed of the Governor, Lieutenant Governor, Speaker of the House of Representatives, Chairman and Vice-chairman of the Senate Finance Committee, and Chairman and Vice-chairman of the Committee on Appropriations of the House of Representatives.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to grant the governor power to exercise fiscal control over the expenditure of appropriated funds as provided by law."

#### PROPOSITION NO. 6 ON THE BALLOT

Senate Joint Resolution 8 proposes a constitutional amendment that would allow the Governor who appointed a previously confirmed official to remove that official from office subject to the advice and consent of the Senate; and if the Legislature is not in session, to call a special session of the Senate which may last no longer than 2 days for consideration of the removal.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to authorize the governor to remove appointed officers with the advice and consent of the senate."

#### PROPOSITION NO. 7 ON THE BALLOT

House Joint Resolution 121 proposes a constitutional amendment that would authorize counties with a population of 5000 or less to construct and maintain private roads if they impose a reasonable charge for the work. The Legislature by general law may limit this authority. Revenue received from private road work may be used only for the construction, including right-of-way acquisition, or maintenance of public roads.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment authorizing counties with a population of 5000 or less to perform private road work."

#### PROPOSITION NO. 8 ON THE BALLOT

Senate Joint Resolution 36 proposes a constitution-

al amendment that would change the jurisdiction and authority of the State's appellate courts. The amendment would change the name of the Courts of Civil Appeals to Courts of Appeal and provide that these courts have intermediate appellate jurisdiction over both criminal and civil cases. The amendment would change titles for the Associate Justices of the Supreme Court to Justices and would require members of the Supreme Court to be attorneys licensed in this state while holding office.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment to change the name of the Courts of Civil Appeals and the names and qualifications of the justices of the Supreme Court and to prescribe the jurisdiction and authority of the appellate courts."

#### PROPOSITION NO. 9 ON THE BALLOT

House Joint Resolution 54 proposes a constitutional amendment which defines separate property owned by either spouse as all property, both real and personal, of a spouse owned or claimed before marriage, and that acquired afterward by gift, devise or descent. Persons about to marry and spouses, without the intent to defraud pre-existing creditors, may by written instrument from time to time partition between themselves all or part of their property. Spouses may exchange a community interest in property owned or to be acquired for a community interest in other community property. The amendment would allow spouses to agree in writing that income or property arising from any separate property is to be separate property rather than as community property as it would be in the absence of an agreement. The amendment proposes that a gift from one spouse to another is presumed to include all income or property deriving from such gift.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment allowing spouses to agree that income or property arising from separate property is to be separate property."
