



Quail Bag Limit Stays The Same In Coleman Co.

Quail hunters in Texas will have lower daily bag limits this fall than the previous year in most counties.

The Texas Parks and Wildlife Commission meeting in Austin September 3 responded to quail census data which showed reduced populations by setting somewhat lower bag and possession limits.

Drought conditions during the nesting season severely hampered quail reproduction over most of the state, reducing populations from the high levels of 1979.

Most of the state will have a 12 quail per day limit, with possession limit of 36. Last year, high populations allowed

SSI Payments

To Children

Supplemental security income (SSI) payments can be made to disabled or blind children as well as to adults, Priscilla Tercero social security branch manager in Brownwood said recently.

SSI is a federal program that provides a basic cash income to people 65 or older, or blind, or disabled, who do not have much income and do not own much in the way of property.

There is no age limit for SSI payments to persons who are disabled or blind. Young children can qualify as well as people who are beyond 65.

For a child under 18 to be eligible, he or she must have an impairment comparable in severity to one which would prevent an adult from working for a year or more. Blindness is defined as central visual acuity of 20/200 or less in the better eye with use of a corrective lens or restriction of the visual field to 20 degrees or less.

In addition to meeting the disability requirements, a child must also meet the income and resources tests to get p ayments. The parents' income and resources count toward the child's eligibility after certain allowances are made. Generally SSI payments cannot be made to a person living in a public institution. But people living in a publicly operated community residence serving no more than 16 people may be eligible. The maximum SSI payment for an individual is \$238 a month, but this amount is reduced if a person lives with someone else or has income above a certain limit. A child cannot receive SSI payments and take part in the Aid to Families with Dependent Children program. The parents of a child eligible for both programs can choose the one that best fits the family. Screwworm Program Has Successful Year

Fast action to suppress any wild screwworm population, and to search for other screwworm cases in the vicinity of Kinney County's Rafter L Ranch, is apparently working, says Dr. James E. Novy.

No additional signs of screwworm activity have yet been discovered.

The director of the U.S. Department of Agriculture (USDA) Screwworm Laboratory says the second positive screwworm sample of 1980 reached the Lab and was identified August 27. By that evening fly trappers, a veterinary epidemiologist, and livestock inspectors were in the area.

Screwworm Adult Suppression System (SWASS) pellets were distributed in the area of the case the next morning. In the afternoon an airplane load of more than a half million sterile screwworm flies from San Luis Potosi, Mexico, was distributed in the area where the sample had been collected.

screwworm flies produced at the Mission Lab had been shipped, as pupae, to Tampico, Mexico. There they were boxed, allowed to emerge and mature, and then dispersed among wild fly populations. Consequently, the most immediately available sterile flies were 400 miles away, at San Luis Potosi.

On Saturday, August 30, dispersal of sterile screwworm flies boxed at Mission began from Del Rio. Now Del Rio Flying Service is distributing flies over 5600 square miles in the vicinity of the Kinney County case at the rate of 1700 per square mile weekly. Drops are made four days per week.

Fly traps are now operating within a 20 mile radius of the case. Texas Animal Health Commission is operating screwworm fly trap along the Rio Grande from Langtry to El Indio.

Novy says all of this action will continue at least until authorities are certain there are no additional screwworms in the area. Sheep and goat shearing is underway in the area. Novy says both stockmen and the Program will benefit if all wounds are treated to prevent screwworm infestation.



Dear Barbara:

I am reading your articles about Paris with great pleasure. Since you and I have both seen Versailles, Kin Louis XIV's place, I was especially interested in your Sept. 11 article and your statement: "Troops to protect the king and palace numbered 5,000."

A man named Antoine Crocketagne got a commission in those household troops of Louis XIV in 1664. Two of his sons were James Crockett (born 1674) and Joseph Louis Crockett (born 1676). Descendants of these men are of interest to us, as you will see.

Antoine was a Huguenot, and was martyred and exiled when the Huguenots were driven out of France. He went to England, then Ireland, changing his name to Crockett, Antoine's son, Joseph Louis Crockett, was an ancestor of Davy Crockett, also a martyr (at the Alamo).

Among James Crockett's descendants was T. Warsaw Hunter, son of T. W. Hunter and Tempie Conner, and a halfbrother of Lennie and Charlie Hunter of Santa Anna (Lennie had the meat market and Charlie the drug store).

In 1896 T. Warsaw Hunter married Kate Hubert, daughter of Will Hubert, former editor of the Santa Anna News, and founder, with son Harry Hubert and Warsaw Hunter, of the Coleman Democrat in 1897. Warsaw Hunter also had a half-interest in the Santa Anna

After a wedding trip to Grand Mesa, the couple are living in Tulsa, Oklahoma where the groom is a student in Rhema Bible College. He is a graduate of Rangley High School and served four years with the U. S. Navy.





Tips To Be Included

For Social Security

People who work for wages in social security-covered employment generally have their social security taxes withheld by their employers. In many instances, however, a person may receive cash income in the form of tips. When this occurs, the employer depends on the worker to report this form of income.

Tips received by waiters and waitresses often constitute the greater part of their income-even more than the salaries they are paid. Other people, including bell boys, barbers, and beauticians, also receive tips. This income, just like regular wages, counts for social security and brings the employees higher cash benefits in later years.

The amount of monthly cash benefits paid by social security to retired or disabled workers and their families and to the families of deceased workers is based on the employee's earnings covered by social security. This means that by including cash tips with their wages, they assure themselves of higher payments in future years.

Only cash tips totaling at least \$20 in a month of work for one employer count in earning social security protection. Other forms of tips, such as merchandise, do not count.

Persons receiving \$20 or more in tips a month are required to report the information to their employers within 10 days after the end of the month in which the tips are received. However, an employer can require these reports more often than once a month. The report can be made on Internal Revenue Service (IRS) Form 4070 (Employee's Report of Tips), which is available at any IRS office, or on any other form that contains the same information.

The report must include all tips and must be submitted on time. A late or incomplete report may subject the employee to a penalty of one-half where they are credited to the worker's earnings record. If you have any questions, contact a social security representative.

Almost all social security matters can be handled by phone. For general information or to report a change, call toll free 800-392-1603. Medicare questions or filing of medicare claims can be taken care of by calling toll free 800-442-2620. If you wish to file an application to establish your eligibility you may call collect 915/646-7533 in Brownwood.



Employers are required to deduct the employee's share of social security taxes on the tips reported, either from regular wages owed the worker or from money turned over by the worker for that purpose. The employer is not permitted to deduct either income tax or social security taxes from tips being held for the worker.

An employer who cannot collect all the social security taxes due on tips reported by an employee must give the employee a statement of the tax still owed. This permits the employee to meet his or her obligations by paying the tax directly to the Internal Revenue Service. Any portion still due IRS must be paid at the end of the year when the Federal income tax return is filed.

The employer reports both tips and regular wages to the Social Security Administration,

PUBLIC NOTICE BRIEF EXPLANATORY STATEMENTS OF PROPOSED CONSTITUTIONAL AMENDMENTS **GENERAL ELECTION NOVEMBER 4, 1980**

PROPOSITION NO. 1 ON THE BALLOT

Senate Joint Resolution 35 proposes a constitutional amendment that would authorize the Legislature to permit banks to establish and operate unmanned teller machines within the county or city where the banks are located and to share the use of teller machines on a basis consistent with antitrust laws, if it finds such operation will serve the convenience of the public. The Legislature has already passed enabling legislation (H.B. 1510) for this proposed amendment.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment permitting the legislature to authorize banks to use unmanned teller machines within the county or the city of their domicile on a shared basis to serve the public convenience."

stitutional requirement that the county commissioners court sit as a board of equalization would be eliminated, and elected officials of the county or governing body of the taxing unit would be prohibited from serving as members of the board of equalization.

The proposed amendment will appear on the ballot as follows:

"The constitutional amendment requiring a single appraisal and a single board of equalization within each county for ad valorem tax purposes."

PROPOSITION NO. 4 ON THE BALLOT

Senate Joint Resolution 18 proposes a constitutional amendment that would allow the Legislature to authorize the conduct of bingo games by certain specified groups for charitable purposes, subject to the limitations that operation of the games must be approved in local option elections and that all proceeds must be spent in Texas.

Senate Joint Resolution 8 proposes a constitutional amendment that would allow the Governor who appointed a previously confirmed official to remove that official from office subject to the advice and consent of the Senate: and if the Legislature is not in session, to call a special session of the Senate which may last no longer than 2 days for consideration of the removal.

al amendment that would change the jurisdiction and authority of the State's appellate courts. The amendment would change the name of the Courts of Civil Appeals to Courts of Appeal and provide that these courts have intermediate appellate jurisdiction over both criminal and civil cases. The amendment would change titles for the Associate Justices of the Supreme Court to Justices and would require members of the Supreme Court to be attorneys licensed in this state while holding office.

The proposed amendment will appear on the ballot as follows:

constitutional "The amendment to change the name of the Courts of Civil Appeals and the names and qualifications of the justices of the Supreme Court and to prescribe the jurisdiction and authority of the appellate courts."

PROPOSITION NO. 9 ON THE BALLOT

House Joint Resolution 54 proposes a constitutional amendment which defines separate property owned by either spouse as all property, both real and personal, of a spouse owned or claimed before marriage, and that acquired afterward by gift, devise or descent. Persons about to marry and spouses, without the intent to defraud pre-exist. ing creditors, may by written instrument from time to time partition between themselves all or part of their property. Spouses may exchange a community interest in property owned or to be acquired for a community interest in other community property. The amendment would allow spouses to agree in writing that income or property arising from any separate property is to be separate property rather than as community property as it would be in the absence of an agreement. The amendment proposes that a gift from one spouse to another is presumed to include all income or property deriving from such gift.

PROPOSITION NO. 2 ON THE BALLOT

House Joint Resolution 97 proposes a constitutional amendment that would grant the State and the accused the right to an interlocutory appeal from the following trial court rulings in criminal cases: pretrial rulings on the constitutionality of a statute; on a motion to quash, dismiss, or set aside an indictment; and on a motion to suppress evidence. The proposed amendment will appear on the ballot as follows:

"The constitutional amendment authorizing appeal of certain pretrial rulings of a trial court in a criminal case by either the state or the accused."

PROPOSITION NO. 3 ON THE BALLOT

House Joint Resolution 98 proposes a constitutional amendment that would require a single appraisal of all property subject to ad valorem taxation and would provide for a single board of equalization within each county. The conThe proposed amendment will appear on the ballot as follows:

"The constitutional amendment to authorize bingo games on a local option election basis if the games are conducted by a church, synagogue, religious society, volunteer fire department, nonprofit veterans organization, fraternal organization, or nonprofit organization supporting medical research or treatment programs and if the proceeds are to be spent in Texas for charitable purposes of the organizations."

PROPOSITION NO. 5 ON THE BALLOT

House Joint Resolution 86 proposes a constitutional amendment that would allow the Legislature to authorize the Governor to exercise fiscal control over the expenditure of certain appropriated funds, subject to any conditions and limitations provided by law and subject to the apThe proposed amendment will appear on the ballot as follows:

"The constitutional amendment to authorize the governor to remove appointed officers with the advice and consent of the senate."

PROPOSITION NO. 7 ON THE BALLOT

House Joint Resolution 121 proposes a constitutional amendment that would authorize counties with a population of 5000 or less to construct and maintain private roads if they impose a reasonable charge for the work. The Legislature by general law may limit this authority. Revenue received from private road work may be used only for the construction, including right-of-way acquisition, or maintenance of public roads.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment authorizing counties with a population of 5000 or less to perform private road work."

PROPOSITION NO. 8 ON THE BALLOT Senate Joint Resolution

Texas drivers are learning to live with 55 mph limit

COLLEGE STATION Some Texas drivers are slowly learning to live with the 55 mph speed limit, perhaps in time to save the state some federal highway money, says a Texas A&M University researcher.

Many drivers still exceed 55 mph "but overall we are getting closer to the 55 mph mark," said Dr. Quinn Brackett, research specialist with the. Texas Transportation Institute at Texas A&M.

"Several factors contribute to the better showing," explained Brackett. He cited the price of gasoline; smaller, more energyefficient cars which people tend to drive more conservatively, and public awareness of the effect of high-speed driving on fuel conservation and safety.




