MEDICARE BILL

Senator Lloyd Bentsen introduced legislation Tuesday to ease the financial burden on older Americans who are hospitalized for long periods of time.

The Bentsen bill provides for Medicare to pay hospital costs for an unlimited period of time. At present, Medicare patients hospitalized for more than 60 days must pay a share of hospital costs. The longer a patient is hospitalized, the bigger the share.

The Bentsen bill also permits Medicare recipients to purchase op-

tional coverage that would pay 100 percent of all reasonable doctors' fees. Medicare currently covers 80 percent of physician charges.

'Millions of elderly Americans live in dread of prolonged illness. They know that, all too often, they can survive the illness only to be ruined financially,' Bentsen said in remarks accompanying his legislation.

'The availability of Medicare and Medicaid provide some important protection. But, as millions of elderly can attest, there are gaps in the system that can quickly lead to

FIRE Bench Marks for 1984-85 School District Budgets in Texas

patients would pay a deductible charge for no more than two periods of hospitalization a year and an annual deductible for physician charges. This year the deductible for each hospital visit is \$356, for doctor fees it is \$75.

The increased hospital benefits would be financed by an additional premium, estimated at \$3.75 a month. The increased physician benefits, which would be optional, would cost an additional premium of some \$16 a month.

'My proposal is designed to protect older Americans against openended expenses associated with long-term illness, while at the same time maintaining the basic structure of the current Medicare program. My proposal is self-financing and will not exacerbate the solvency problems facing the Medicare trust funds,' Bentsen said.

City Notes

You may have seen the employees of the city driving different equipment around town and wondered why the city purchased new equipment. Well, the city has not purchased this equipment. The equipment and various operating supplies are received from Texas Surplus Supplies out of Abilene or Dyess Air-

Every three weeks an employee goes to Dyess to a 'screening' to see what the airforce is giving away. At that time the city requests a particular item. The request them goes to Ft. Worth and they allocate what non-profit organization receives the item. There is a very small fee charged for handling and paperwork. It is only a small percentage of the cost.

The average salary for classroom teachers paid by Santa Anna ISD in 1982-83 was \$16,396 which was 5.3

Texans increased spending on local public schools by \$552 million last year, as trustees in 1,069 school districts adopted school budgets totaling \$9.0 billion. That provided more than \$200 in additional funds for each of the 2,727,512 students in the state, according to the Texas Research League.

Local property taxpayers were tagged for an additional \$327 million to pay for the increase. The remainder was funded by increases in state and federal aid programs and by higher local fees.

The figures come from the latest issue of Bench Marks for 1984-85 School District Budgets in Texas, an annual publication of the Texas Research League, an Austin-based, educational corporation engaged in governmental research.

School budgets adopted for 1983-84 called for spending \$2,713 per student for current operations. Santa Anna ISD's budget provided for \$2,488.86 per student based on the 374 students in average daily attendance in 1982-83.

Four of five of these dollars were spent for salaries. Statewide, payroll expense averaged \$2,153 per student, as compared to \$1,769 in Santa Anna ISD. Payroll expense is a combination of salary levels and staffing patterns.

percent above the minimum salary prescribed by the state. The average among all school districts in Texas was \$19,501 per classroom teacher, or 21.8 percent over the minimum.

There was an average of one teacher for 85 students in Santa Anna ISD compared to a statewide pupil-teacher ratio of 1 to 16.4. The pupil-teacher ratio is not the same thing as the average class size because teachers and students are not necessarily in class the same number of hours each day.

Statewide, the ratio of teachers to students has remained the same the past three years. The report notes that during the 1980's school officials have used additional payroll dollars to increase salaries beyond the rate of inflation, whereas during the previous decade more dollars were spent to hire additional teachers while average salaries grew less than the rate of inflation.

Local property taxes were increased by \$327 million for a total of \$3.6 billion last year. Locally, the Santa Anna ISD's tax levy was increased by 3 percent for 1983-84, as compared to a 10 percent increase

for the average school district in

School property tax rates in 1982-83 averaged \$0.613 per \$100 of market value (selling price). The school tax on a property selling for \$100,000 was \$613 in the average school district. Locally, the rate on market value in Santa Anna ISD was \$0.730, or \$730 on a property selling for \$100,000.

If the property were a homestead or owned by a senior citizen, the school tax would be less because of various exemptions. Open-space land that qualified would be valued on its productivity value rather than market value.

Revenue lost from exemptions totaled \$679 million, which was \$125 million more than that exempted the previous year. To balance school budgets, the revenue loss from exemptions was imposed upon other taxpayers in the school district.

Preparing school budgets for next year, the report noted, will be difficult. Not only did the Special Session of the Legislature provide substantial additional funds, but also changed the method for allocating aid to different districts. School officials also must begin implementing a variety of new educational programs including new curriculum standards.

serious injury Friday afternoon, August 3rd, when their compact car was struck from the rear by a semitruck trailer. Chief of Police, Russ Ellis said the mishap occurred on US 67-84, east of town. According to Mr. Ellis, Dr. and Mrs. Filemon Cabansag entered the highway from the Ranger Park Medical Center and was struck by the truck a few seconds later. Members of the Board of Education of the Santa Anna Independent School District met in regular session Tuesday night and set Monday, August 30th, as the day for the beginning of the 1954-1955 school year.



Elder L. H. Carter of the Santa Anna Church of Christ, announced a revival meeting will begin at the church Sunday, August 8 and will continue through Sunday, August 15.

An emergency March of Dimes campaign will get underway over the nation on Monday, August 16 and continue through August 31. The immediate need for the National Foundation is \$20 million. POSTMASTER'S POINTERS

CERTIFIED MAIL.

What is certified mail?

This service provides proof of delivery and requires the addressee or agent sign for the article. Proof of mailing is given to the mailer at the time of posting.

How can the mailer obtain proof of delivery? How much does it cost?

The cost of certified mail is 75 cents plus the postage. Proof of delivery is obtained by purchasing a return receipt for 60 cents.

What may be certified?

Only items of no intrinsic value such as letters, files, records, etc..., that are sent Priority First Class Mail may be sent by certified mail.

Does the certified fee plus the return receipt fee plus the postage (total of \$1.55 for a one ounce letter) provide any insurance?

This is the great misconception about certified mail. No insurance coverage is provided against loss or damage for this service. For valuables and irreplaceable items, you should use insured or registered By Gary Absher

Is there any provision to guarantee that only the addressee receives the certified letter?

Normally anyone at the place of delivery or any customer presenting the notice of attempted delivery to the post office can receive the certified article. An additional fee of \$1.00 will restrict the delivery to only the addressee. Proof of identification will be required of the addressee if not known by the postal employee.

What items are mostly mailed cer-

The largest user of certified is the business which notifies it's customer of an insufficient check. Postal patrons use certified mail any time proof of mailing or proof of delivery is required.

In conjunction with the proclamation of Project Pay-Up, Mattoxunveiled a new logo for his Child Support Enforcement Division.

The logo was designed by Caryn Belikoff of Plano, who was the winner of a statewide art contest sponsored by Mattox to design a child support logo.

Mattox's Office took over the child support enforcement program in September 1983. Since that time, child support collections in Texas have increased by 41 percent.

We are reminded about the fact,


some of the tunnels were built in 1884 and the work was done by hand. We depart from Ischell and



HISTORY

As of late, quite a few folks have asked when the history book will be out. About a month ago, I announced that the publisher felt he could have the book out before Christmas. Publishing a book is a long process, especially when it is being bound in two volumes of 1200 pages total, as ours is. The book is taking about twice as long as we first thought because it is over twice as large as we expected, even with alot of editing. Most of you have been very patient, and I think you will be very glad that we took time to do it right. You can still order a set of these books for \$57.75, local or \$61.00, mailed (Coleman County Historical Commission, PO Box 958, Coleman, TX 76834). Contrary to popular belief, this is a very inexpensive price for this size and type of book. It will be out of print soon after it comes out. Most books that we have seen lately of this type, have been about \$40 for about 500 pages, and none are as concise as ours, and few even have indexes! At any rate, if the publisher does not have any problems, the book should be out before this year is over.

DEATHS IN CUSTODY

Attorney General Jim Mattox has announced that his office received reports of 139 deaths during the first nine months of a new law that requires officials to report deaths of persons in custody of law enforcement officers and of persons in jail or prison.

'That is about one reported death every other day,' Mattox said. 'We are finding that jails and prisons are very dangerous places.'

Mattox noted that while the

legislature mandated that law enforcement officials report all deaths of persons in custody to Mattox's office, no funds were appropriated to investigate such deaths.

While the majority of custodial deaths probably could not have been prevented,' he said, 'there have been a few situations where we needed further investigation to determine that fact. With our limited resources in this area, that has been quite difficult.'

Failure to report a custodial death is a Class B misdemeanor, punishable by up to six months in iall and or up to a \$1,000 fine.

The Texas Department of Corrections reported 66 custodial deaths between September 1, 1984, when the law took effect, and June 1, 1984. While 42 of the deaths were reported as natural causes, nine were suicides, eight were homocides. three were accidental and two were unknown causes. Also, TDC properly reported two deaths by execution, James David Autry and Ronald Clark O'Bryan.

Forty-one persons died in county jails, and 22 died in city jails. Ten other persons died while in the custody of law enforcement officers.

In the county jails, 17 persons died of natural causes, 18 by suicide, three by homocide, one accidentally and two by unknown causes.

In the city jails, six died of natural causes, ll by suicide, four by homocide and one accidentally.

Of persons who died while in custody of officers, one was natural causes and one was a suicide. Eight persons were killed while in custody. Of the 23 homocides reported, 10

were committed by other inmates and 13 by peace officers. Of the suicides, 36 were by hang-

ing, two by gun shots and one by stabbing. Twenty of the 39 suicides

were committed by persons between 20 and 29 years of age and 11 by persons 30 to 39 years of age. There were two suicides by persons under 20 years old and three each by persons 40 to 49 and 50 to 59.

Alcohol-related charges had been filed against II of the 39 persons who took their own lives.

Of the 66 persons who died of natural causes, 42 were heart attacks and similar diseases.

Only five of the custodial deaths were women prisoners. Two of the suicides were by women, one who shot herself while in custody of officers and one who hanged herself in

The racial break-down of the 139 total custodial deaths is 76 white, 33 black, 22 Hispanic, one Indian, one Oriental and six other.



THE STATES PATCHWORK QUILT PARADE

The quilt block described is one of 48 that form a States Patchwork Quilt. (This was before Hawaii and Alaska became states.) The pattern was originally printed in a 1934 Ft. Worth Star Telegram. With increased interest in this activity in our area, one block of the quilt pattern will be found in the paper weekly.

QUILT FOR CALIFORNIA The Forty-Niner

Surely we cannot dedicate this gorgeous old pattern to any State but California. The mere analytical quilt connoisseur will tell you it is on-

ly an Irish Chain Tripple Irish to be sure, but right we all are, because the triple Irish Chain did travel west with the eager gold prospectors, becoming to them and succeeding generations—the Forty-niner!

The plan is for three colors with white, as yellow, gold and orange, or pink, rose and violet or peach, orchid and green. The must follow each row of the pieced block exactly as shown, 81 square, 16 of which are white, 20 light, 28 medium and 17 dark. This will complete a pieced block about 16 inches square.

On the alternate white blocks, cut

finishes, applique the four corner groups composed of two light and one medium square. A quilt center 5x5 blocks will have 13 pieced and 12 applique blocks and be about 80 inches square. To this an 8-inch border composed of a white strip cut about 11/2 inches, a five-inch border pieced as shown with a two-inch strip at the outer edge."


Your pieced border and quilt center may best determine the width of the intermediate strips so the corners will exactly fit together.




