# Mountaineers

BLANKET. - The Mountaineers managed to elevate themselves to the number 10 spot on this week's Harris Poll despite a lackluster performance here Friday night. The offense seemed to forget what their job was until a worn down Blanket gave them scoring opportunities in the third quarter.

It appeared that the Mounties were still savoring last weekend when they ripped Bangs by a 19-0 count. "The defense had a good game, but the offense just didn't play up to anywhere near their ability. We looked sick, but we'll get over it," said Coach Gaylon Privett.

The first quarter saw Santa Anna's best drive, 60 yards in 12 plays, with Bebe Vasquez doing the honors from 10 yards out. Vasques booted the extra point to put the Mountaineers on top to stay by a 7-0 margin. Vasquez toted the ball 24 times for the night and scraped up 111 yards to easily be the top ground gainer.


Defensively, Curtis Puckett, a 6'1", 185 pound senior, had an outstanding game, as did 5'10", 175 pound senior defensive tackle Shawn

The game ground on until the Mounties cranked up a 45 yard, 10 play drive that was capped off by a 16 yard Russell Williams to Reece McIver pass for a touchdown with 5:58 remaining in the third quarter. Vasquez kicked the P.A.T. to up the score to 14-0. The Tigers left the ball on the





The proposed Stacy Dam on the Colorado River south of Coleman will be the greatest possibility for the west Texas area, and will affect towns and country as greatly as did the coming of the Santa Fe in the 1800's. Now approved by all agencies concerned except possibly the Environmental, the contract for the dam will be let in June of 1967, as told to Mrs. Bruce by Oscar Olivo, Supervisor of Surveyors for the project. The construction of the dam will start then, and the two-mile structure will take two years to complete. With little flow in the river normally, one great flood like that of 1936 could create a sizable lake, and after that the supply of water to dozens of towns and communities would be assured.

When filled to capacity, the lake will be three times the size of Lake Brownwood, and about as great as Lake Whitney. Access roads to the various arms of the lake are now being planned by Coleman County commissioners. Almost two-fifths of the lake will lie in Coleman County, and the dam itself will connect Col-



CONSTITUTIONAL AMENDMENTS **GENERAL ELECTION NOVEMBER 5. 1985** 

**PROPOSITION NO. 1** ON THE BALLOT

Sections 1 and 2 of House Joint Resolution 6 propose a constitutional amendment that would authorize the Texas Water Development Board to issue an additional \$980 million of Texas Water Develop-

will be dedicated for deposit in the Texas Water Development Fund. with \$190 million of those bond proceeds to be used for water supply loans and facilities acquisition and with \$400 million of those bond proneeds to be used for state participation in the acquisition and development of facilities for storage. transmission, transportation, and treatment of water and wastewater. Of the remaining bonds authorized, \$190 million will be dedicated for use in water quality enhancement projects, and \$200 million will be dedicated exclusively for flood control projects.

The amendment would also allow the legislature to provide for the creation, administration, and implementation of a bond insurance program to which the state pledges up to \$250 million of its general credit to insure payment of the principal of and interest on bonds or other obligations issued by political subdivisions of the state for water conservation, water development, water quality enhancement, flood control. drainage, recharge, chloride control or desalinization. Unless authorized to continue by a two-thirds vote of the members of each house of the Legislature, the bond insurance program will expire on the sixth anniversary of the date on which this section becomes a part of the constitution. Bond insurance issued before expiration of the program will not be affected by such expiration.

The amendment would authorize the legislature to create and appropriate money to special funds in the state treasury to make grants, loans, and other financial assistance available to governmental entities for certain enumerated water planning purposes. Also, the legislature would be permitted to extend the benefits of constitutionally approved water projects to nonprofit water supply

corporations. The proposed amendment will ap-

pear on the ballot as follows: "The constitutional amendment to authorize the issuance of an additional \$980 million of Texas Water Development Bonds, to create special water funds for water conservation, water development, water quality enhancement, flood control, drainage, subsidence control, recharge, chloride control, agricultural soil and water conservation, and desalinization, to authorize a bond insurance program, and to clarify the purposes for which Texas Water Development Bonds may be issued.'

#### **PROPOSITION NO. 2** ON THE BALLOT

Section 3 of House Joint Kesolution 6 proposes a constitutional amendment that would allow the Texas Water Development Board to issue and sell Texas agricultural

amount not to exceed \$200 million, if authorized to do so by a two thirds vote of the members of each house of the legislature. The Texas agricultural water conservation bonds would be general obligations of the State of Texas, and would be paid from the first money coming into the state treasury in each fiscal The amendment Texas agricultural water conservation bonds to be issued and sold only for four years after the date on which this Act becomes a part of the constitution.

Any legislative enactment permitting the expenditure of funds for such purposes would authorize the city or town to fix a lien on the property, with the owners' consent, for the cost of relocating or replacing the water laterals, and would provide that such cost shall be assessed against the property, with repayment by the property owner to be amortized over a period not to exceed five years at the rate of interest set by law. Such liens could not be enforced until after five years from the date the liens were affixed.

The proposed amendment will appear on the ballot as follows: "The constitutional amendment to

authorize the legislature to enact laws permitting a city or town to spend public funds and levy assessments for the relocation or replacement of water laterals on private property.'

**PROPOSITION NO. 4** ON THE BALLOT

Senate Joint Resolution 21 proposes a constitutional amendment that would authorize the use of the proceeds from the sale of permanent school fund land to acquire other land for the permanent school fund. Currently, the constitution requires that proceeds from the sale of such land be invested in certain

#### **PROPOSITION NO. 8** ON THE BALLOT

Senate Joint Resolution 9 proposes a constitutional amendment that would grant an additional \$500 million in bonding authority to the Veterans' Land Board for the veterans' housing assistance program. Under the current constitution, the Veterans' Land Board is authorized by Article III, Section 49-b-1 to issue and sell not more than \$800 million in bonds, \$500 million of which may be used for the Veterans' Housing Assistance Fund. This amendment would increase that authorization to permit the issuance and sale of up to \$1.3 billion in bonds, \$1 billion of which would be used for the Veterans' Housing Assistance Fund. In addition, the amendment would remove the current definition of "veteran" from the constitution and permit the legislature to redefine "veteran" as the changing times and circumstances

The proposed amendment will apnear on the ballot as follows:

"The constitutional amendment providing \$500 million in additional bonding authority for the veterans' housing assistance program and changing the definition of those veterans eligible to participate in the veterans' land program and the veterans' housing program by authorizing the legislature by law to define an eligible veteran for the purposes of those programs.'


