



SANTA ANNA NEWS **Pamela Miller-Richard Garrett United In Marriage**







> Children must practice fire escape and fire protection techniques if they are expected to react correctly in an emergency. The following is the last of six "fire drills" offered in this series designed to teach children how to survive a fire.

The drill called "Man the Hoses" teaches some principles of fire fighting. Every fireman knows how to put out a fire, and your children can learn elementary firefighting techniques. Although a child will never fight fire extensively, his quick action could save his life or your house.

Start a small paper or wood fire in the backyard-in a box, barbecue pit or trash burner-where you can control it. Show youngsters how to put it out with a bucket of water or a hose. A coarse spray nozzle is better than a steady stream. If you own a fire extinguisher, and you should, have everyone learn to use it. A practice session is worth the cost of a refill, for an extinguisher is useless unless you know how to work it.

Warn children never to throw water on an electrical fire because of the shock hazard or on a grease

fire because it may spatter. spreading the flames. Only an extinguisher designed for electrical fires will work on electricity. to squelch small grease fires, put a lid on the flaming pan or throw on several handsfuls of baking soda (never flour; it may explode). For ordinary combustibles such as wood, paper and cloth, water is the surest extinguishing agent.

Teach children exactly what to do if their clothing catches on fire. Let them pretend they are on fire and have them roll up in a blanket, rug, large towel or the quickest thing available to smother the flames. Empahsize that they should never run if clothes are burning because the breeze fans the flames.

In the fifth and last part in this series, a final "rookie" examination will be offered to determine whether your children qualify as "firemen."

Release of Funds

The City of Santa Anna will undertake the project described above with Community Development funds from the Texas Department of Community Affairs under Title 1 of the Housing and Community Development Act of 1974. The City of Santa Anna is certifying to TDCA that the City of Santa Anna and Joe Guerrero in his official capacity as Mayor consent to accept the jurisdiction of the Federal courts if an action is brought to enforce responsibilities in relation to environmental assessments, decision making and action; and that these responsibilities have been satisfied. The legal effect of the certification is that upon its approval the City of Santa Anna may use the Texas Community Development Program funds and TDCA will have satisfied its responsibilities under the National Environmental Policy Act of 1969.

Objections to State Release of Funds

Texas Department of Community Affairs will accept an objection to its approval only if it is on one of the following basis: (a) that the certification was not in fact executed by the certifying officer or other officer of applicant approved by TDCA; or (b) that applicant's environmental review record for the project indicates omission of a required decision finding or step applicable to the project in the environmental review process. Objections must be prepared and submitted in accordance with the required procedure (24 CFR Part 58.75) and may be addressed to Texas Community Development Program; Texas Department of Community Affairs, 8317 Cross Park Drive, P. O. Box 13166, Capitol Station, Austin, Texas 78711.

Objections to the release of funds on basis other than those stated above will not be considered by TDCA. No objection received after March 6, 1986 will be considered by TDCA. The Chief Executive Officer of the City of Santa Anna is Joe Guerrero, Mayor.
