Joe Taylor City Council Candidate

When asked what accomplishment he would like to see, Taylor replied, "Improvement in the water situation, pot holes in the streets, vacant lots cleaned—a general house cleaning for Santa Anna."

He is a candidate for this office because he wants to "try to help Santa Anna, because this is my home—and the town needs improvement, if possible."

Taylor feels the greatest need for the city is to have the streets improved and if possible, upgrade the water system.

graduate, with 1 term college and is a graduate of Vo-Tech School.

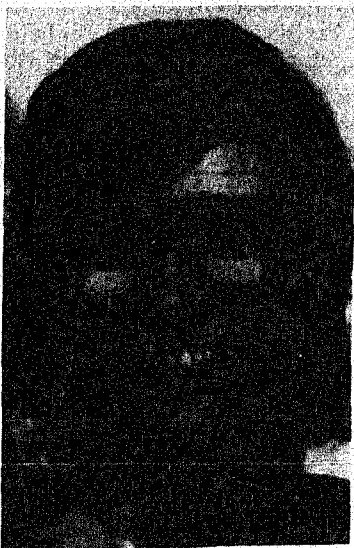

"I feel the greatest need of the city is to have long range planning for each department. This would ensure an efficient and economical operation," he stated.

Discussed was reprinting of the Coleman County History Book, historical markers that are being worked on, and purchase of equipment to be used in the Coleman County Archives. Report was given by Nan Markland, chairman of the Sesquicentennial committee, regarding tours of historical sites in Coleman County. After this report was given, it was decided that tours to these sites would not be practical, due to poor roads for a number of vehicles, run-down condition of many of the more important sites, distance to walk to several sites, and problems in allowing a number of people on property in the Stacy Lake area. It was decided that instead of actual tours, that a slide presentation and video presentation would be worked up instead, these being termed arm-chair tours.

Program Could Lose Texas Govt.

\$150 Million In Sales Tax

AUSTIN—State Comptroller Bob Bullock Friday warned that new rules of the federal food stamp program could cost Texas government \$150 million in lost sales tax revenue on candy and soft drinks.

Bullock said reauthorization of the federal program contained new provisions that forbid states from participating if they collect taxes on food-stamp purchases.

"We don't tax meat and potatoes, but we do tax candy, soft drinks and diluted juices," Bullock said.

Bullock said the Legislature will have to look at an option of creating a two-tier system to exempt these products when they are purchased with food stamps or totally exempt taxes on candy, soft drinks and diluted juices.

He said the state has until September 30, 1987, to exempt the items or be forced out of the food stamp program.

"It's a real dilemma for the state and another financial headache that will face the Legislature when the

session starts next January," Bullock said.

Bullock said that there are some 1.3 million persons in Texas eligible for federal food stamp assistance and that in 1986 an estimated \$714 million in food stamp payments will be made.

He said that unless Congress is willing to bend on the issue and make changes in the law before the deadline the state's food stamp eligibility will be threatened and another source of state tax revenue will be cut off at the knees.

Thoughts From Our Pastors

Rev. John Stanislaw First Baptist Church

Hebrews 10:25 "Not forsaking the assembling of ourselves together as the manner of some is, but exhorting one another: and so much the more, as you see the day approaching."

Do I have to go to Church to be a Christian?

NO! We become a christian by accepting Jesus Christ as our personal Lord and Savior and being born again spiritually. 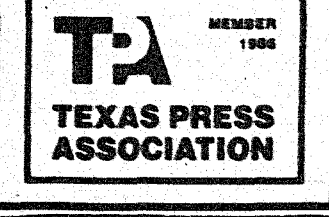

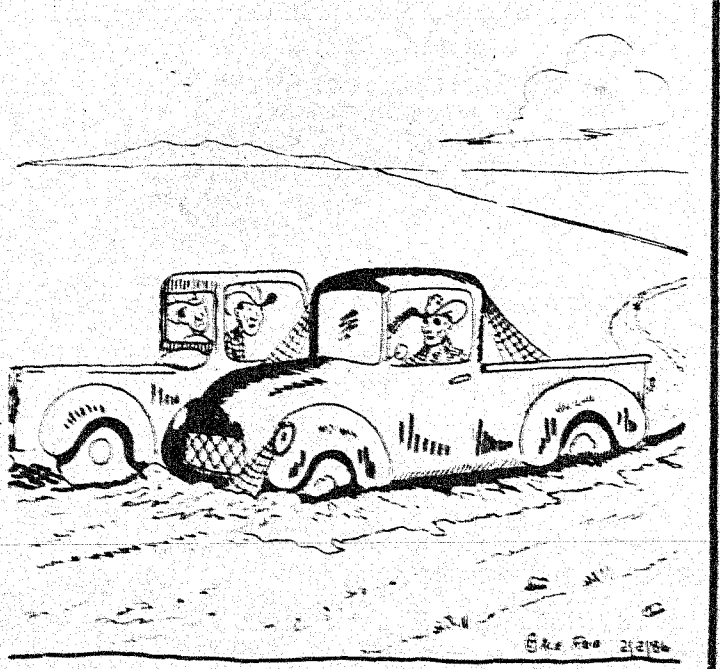

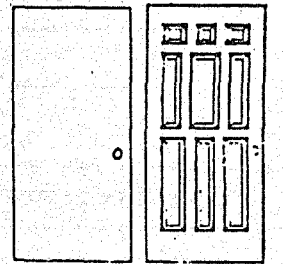

Veterans Administration News

(EDITOR'S NOTE: Following are representative questions answered daily by VA counselors. Full information is available at any VA office.)

Q-I have a VA insurance policy with a large loan on it. I have elected a lifetime annuity for the beneficiary. I know that this will reduce the amount of the payments if I die. Is there anything the beneficiary can do to receive the lifetime annuity?

A-Yes. The loan may be paid up after death by the beneficiary to receive the lifetime annuity. Other options, which could be of greater value to the beneficiary, will be explained when the claim is received.

Q-Does the law provide for a monthly benefit to the wife and children of a veteran if the veteran disappears?

A-The law makes no direct provision for a benefit for dependents of a veteran who disappears. Depending on the circumstances of the disappearance, if the veteran was entitled to benefits at the time of the disappearance, the VA may pay a special benefit for the veteran's dependents. After 7 years the VA may consider death claims based on a disappearance. The VA must, however, consider the circumstances behind the disappearance before deciding whether death benefits may be granted.

Q-Why are "points" charged on VA loans?

A-Generally, lenders require dis-

count points (a percentage of the loan) when they consider the maximum VA interest rate to be too low to produce the yield or income that other investments would provide. The amount of discount to be paid is a matter of negotiation between the seller and the lender.

Q-My husband died from a

service-connected disability and I have not remarried. Is it possible for me to obtain a VA guaranty on a home loan?

A-You would qualify for a certificate of eligibility to obtain a VA guaranty on a home loan. Eligibility for the actual loan would be determined by the lender.

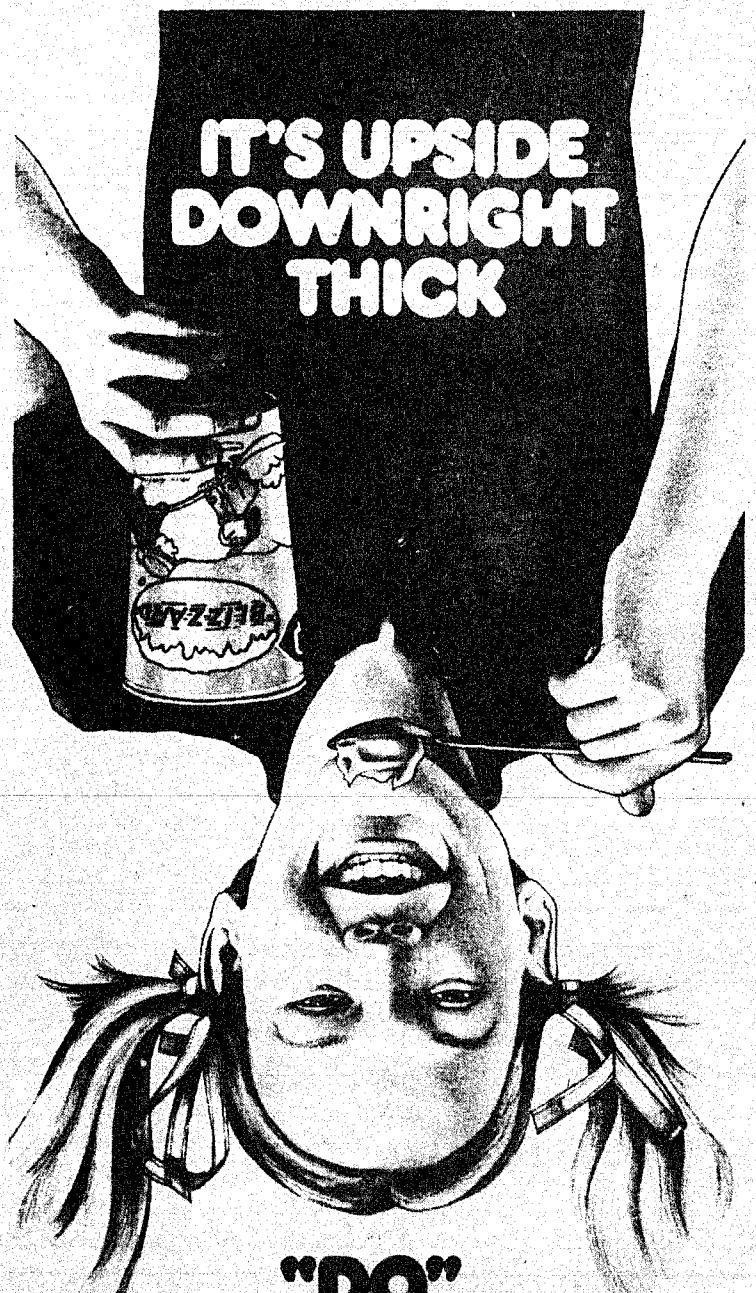

Veterans Administration News

(EDITOR'S NOTE: Following are representative questions answered daily by VA counselors. Full information is available at any VA office.)

Q-I have a VA insurance policy with a large loan on it. I have elected a lifetime annuity for the beneficiary. I know that this will reduce the amount of the payments if I die. Is there anything the beneficiary can do to receive the lifetime annuity?

A-Yes. The loan may be paid up after death by the beneficiary to receive the lifetime annuity. Other options, which could be of greater value to the beneficiary, will be explained when the claim is received.

Q-Does the law provide for a monthly benefit to the wife and children of a veteran if the veteran disappears?

A-The law makes no direct provision for a benefit for dependents of a veteran who disappears. Depending on the circumstances of the disappearance, if the veteran was entitled to benefits at the time of the disappearance, the VA may pay a special benefit for the veteran's dependents. After 7 years the VA may consider death claims based on a disappearance. The VA must, however, consider the circumstances behind the disappearance before deciding whether death benefits may be granted.

Q-Why are "points" charged on VA loans?

A-Generally, lenders require dis-

count points (a percentage of the loan) when they consider the maximum VA interest rate to be too low to produce the yield or income that other investments would provide. The amount of discount to be paid is a matter of negotiation between the seller and the lender.

Q-My husband died from a

service-connected disability and I have not remarried. Is it possible for me to obtain a VA guaranty on a home loan?

A-You would qualify for a certificate of eligibility to obtain a VA guaranty on a home loan. Eligibility for the actual loan would be determined by the lender.

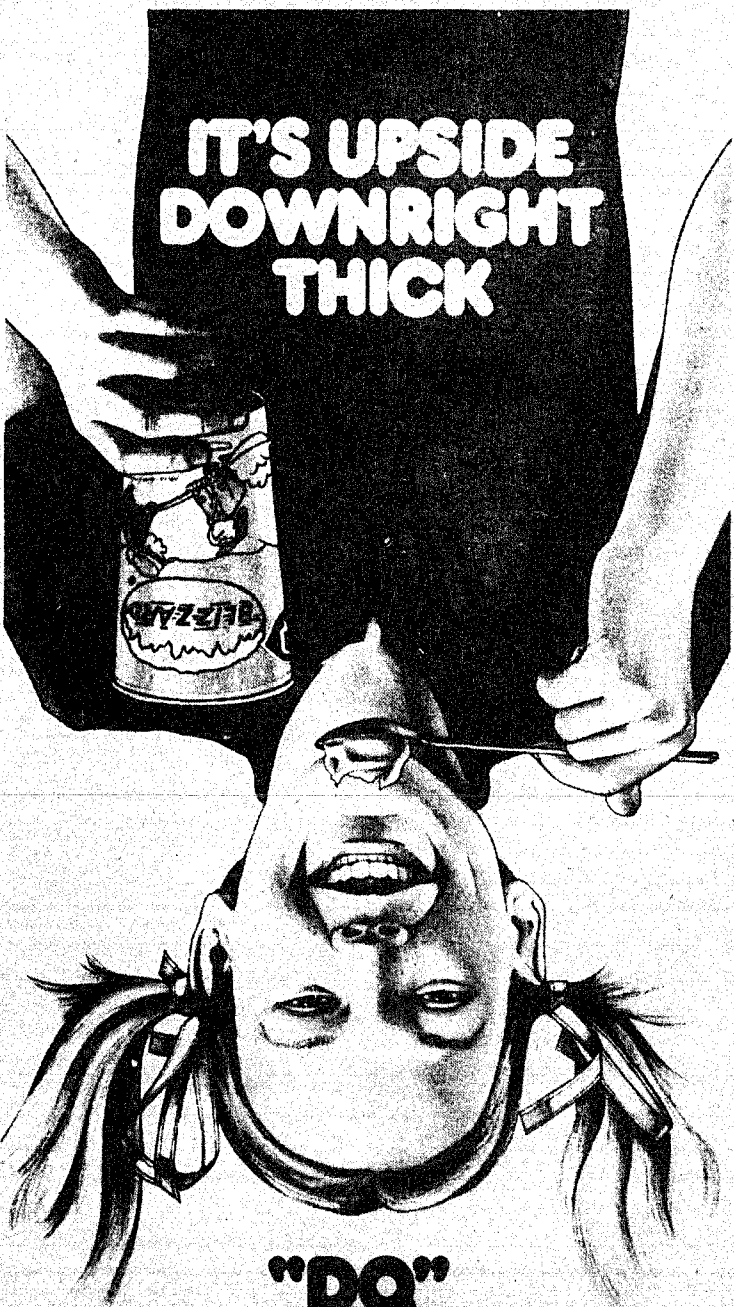

Texas 4-H Center To Host "Spring Fling"

LAKE BROWNWOOD—The Texas 4-H Center at Lake Brownwood will again host a "Spring Fling" this year for people aged 55 and older.

Spring Fling, in its eighth year and boasting almost 4,000 participants, will feature five special camps for individuals 55 and older dealing with a wide range of educational and recreational activities, points out Marshall Crouch, 4-H specialist with the Texas Agricultural Extension Service, the Texas A&M University System. Crouch supervises programs and activities at the 4-H Center which is about 11 miles north of Brownwood on Texas 279.

The five sessions are scheduled for April 8-11, April 15-18, April 22-25, April 29-May 2 and May 6-9. Registration is from 2:30 to 4 p.m. the first day of each session.

Those participating in Spring Fling '86 can choose from a multitude of activities, Crouch points out. All sessions will feature educational programs presented by Extension Service specialists in such areas as horticulture, insurance, entomology, gardening and foods and nutrition.

Nature hikes, boat rides, tennis, fishing, shuffleboard, dancing, bingo, social recreation and table games all are available for the enjoyment of those attending the camp.

Crouch assures that accommodations at the 4-H Center are comfortable and that the food is good. A dietitian is on hand to help with special dietary requirements.

Cost of each of the sessions is \$81. Individuals interested in attending should send in their reservations as soon as possible since each session is limited to 100 people. County Extension offices have reservation forms and additional information on Spring Fling '86. One day they struck the house of a man named Daily; he shot and killed one of them, and the others rode away. Warfare became open; a few miles from the fort, five men riding in a wagon were approached by a brave and a squaw, who rode close, shot one of the men, killing him instantly. The Indians rode calmly away, as if they had shot a snake. Nothing was done about the murder, but the men at the post, all infantry, could only stay inside the picket fence, leaving always in numbers and heavily armed.

Major Earl Von Dorn was the only commander ever to send out bodies of troops making scouting expeditions, but he was of the State Rangers (cavalry). Major Fitzhugh and Capt. Boggis, with infantry, could do nothing to protect the mail or the surveyors. In the spring of 1860 there were many fights. The mail riders were always harassed, racing into the fort for their lives. Mountain Pass was where the road went through a gap in the hills, and there many attacks occurred; in one of these, three of Adam Johnsons employees were killed and scalped and all livestock driven away.

Emma Johnson Elkins

Army Child On The Texas Frontier

CHAPTER 2

In 1854, when Emma Johnson was 6 years old, the military post of Fort Phantom Hill was abandoned by the United States government. Her father, Dudley Johnson, was Ordnance Sergeant and with the other forces was ordered to Fort Chadbourne, the post next in line toward Fort Concho, which was at the junction of the three Concho Rivers, now in San Angelo.

This would be a move of some sixty miles, and the wagons, drawn by oxen or mules, would make a long train, taking the military supplies, ordnance, stores of foods and uniforms, furniture for officers' quarters and all buildings. Whether there was cavalry to go Emma does not say; some of the infantry may have marched, but mounted guards, remount, non-commissioned officers families, officers' families in two or three seated hacks, which were called ambulances, made the train a long one. All the officers were mounted, as were the scouts and guards.

Most of those going probably looked back in relief at the post they were leaving, as it had proved to be poorly and inconveniently located, never having had adequate water or wood supply. They could not have made many miles before camping for the night. After dark, they looked back and saw Fort Phantom Hill going up in flames; the resentful Comanches although they had benefited there, set fire to every thatch-roofed building, the picket and log houses, and even the corral fences.

The move involved two or more overnight camps, and when they were nearing Fort Chadbourne, they were met by Jim Shaw, the trusted Delaware chief, who was one of their reliable guides. He had learned of the attack and murder of Major Sterm, a prominent United States officer of the area. Shaw knew that since the raiding band of Comanches was somewhere near, the train might be attacked at any moment. Now on the alert, a close watch was kept by sentinels, but the faithful Delaware would not rest. He sat up all night apart from the camp, watching for the attack which did not come.

Fort Chadbourne, at one time the extreme outpost on the frontier, was established in 1853. A fort had been started on the Concho and called Camp Johnson, but for some reason it was moved to Oak Creek in what is now Runnels County and named Fort Chadbourne in honor of General Chadbourne who had died a short time before. The first commander there was Capt. Patrick Calhoun, son of the noted statesman, John C. Calhoun. It was garrisoned by dragoons, or mounted troops, but in the summer of 1854 these were sent to Kansas and were replaced by two companies of infantry commanded by Capt. Samuel Eastman. Many famous officers were at Chadbourne from time to time; among them were Robert E. Lee, Earl Van Dorn, Col. A. S. Johnson and others. This new fort was in a beautiful location. On the east bank of the creek, it had a stream of pure and healthful water, and Church and Table mountains were blue in the smoky distance. It was considered by men and officers one of the most desirable posts on the entire frontier.

The Ordnance Sergeant's family were in the train of wagons, foot-soldiers, mounted officers, mule teams and oxen, troops and hangers-on that plodded for three days from Fort Phantom Hill to Chadbourne. On arriving at the new post, a time of confusion was inevitable, as the officers chose their quarters no matter who was occupying the desired house. Down the ranks the choices went, the non-commissioned officers getting whatever was left for them. The barracks for the enlisted men, the stables for horses, the sutler's store and the bakeries, wash-houses, the blacksmith shops and the carriage sheds, all were soon occupied.

It was not long until the Indians began coming into the post, begging for anything they wanted, stealing whatever they could; they were subservient and pretended friendliness to the whites, who treated them kindly and made every effort to keep them on peaceable terms. But Emma calls them treacherous brutes, who would be fed at the door in the daytime then lurk around those same houses and

shoot at anyone who stepped outside, at night. Emma remembered a young soldier who was waylaid as he was going across a small bridge over the creek; he was shot with nine arrows, one of them piercing his liver. He fell off the bridge, and the Indians, thinking him dead, sneaked off to their camp. Crawling from the water, the wounded man made his way to the house of an old couple, and was taken to the post hospital, where he had a miraculous recovery. This was a lesson to every white person at the fort.

It was with these camping Indians that they frequently saw a white girl, about nine years old, who had evidently been captured when quite small. Many of the Indians became known by sight, as they stalked grandly about the post, going into the houses if they wished, picking up any blanket or cooking-pot or hair-ribbon and walking out with it.

One white woman who came freely to the door of the Johnson house had gray or blue eyes, soft brown hair and a deeply sunburned face. She would stand just outside the door, with her begging hand inside, asking for food. So many at the post remarked that she was a white woman that she would stamp her foot and say, "No! Me Comanche." Later she made for herself a sort of bonnet of canvas, which she would hold over her hair and face with one hand while she held the other out, begging. The army officers knew all this quite well, but they made no effort to redeem the white child or to persuade the white woman to return to her people. They were supposed to keep the Indians on reservations, furnishing them rations and guns and ammunition for their hunting. In fact there was no such restraint; the tribes came and went at will, going to the reservation for their allotments and raiding the settlements to kill and steal. The foot soldiers were of course unable to contain them, their only concern became to evade the arrows or gunshots from the black shadows of night.

Emma often saw a proud chief on a prancing fine horse riding about the post, his long spear on display with the scalp of a white woman floating proudly before him. The long, wavy hair was stretched over a small hoop, marking the death of some defenseless woman in an isolated cabin. The agents and officers ignored these scalps, oblivious to the danger to their own wives and daughters. The soldiers and probably the noncommissioned officers, believed that the government supplies meant for the Indians were sold by the Indian agents to any traveler. At any rate, the Indians raided the settlements at will, and the army did not interfere or punish them.

Long afterward, when Emma had moved to Camp Colorado, and married there, it was learned that the

white woman was Cynthia Ann Parker, who had been stolen from Parker's Fort at nine years of age. She was rescued or captured in 1860 by a party of Texas Rangers in a battle in which her Indian husband, was killed and her baby daughter returned with her to her Parker family.

Emma was an observant child. She knew all the routine of the fort; in and out of her father's Ordnance shop, she knew who was issued ammunition and for what purpose; she saw the hunting detail go out to get deer or buffalo or other game for the commissary, the wood-cutters, their wagons heavily guarded by their dragoons, the arriving officers with their guards. Her schooling was of short duration, but as her family were literate, she was fortunate in receiving a better education than most pioneer children did.

The most welcome arrival at the post was the carrier of the U.S. Mail. The route circled all the frontier posts, coming from the north and going to Fort McKavett on the San Saba River. From a valuable book by Gen. Adam R. Johnson, published in 1904, we get a larger look at this mail service. A young man of 21, he bought the contract for the mail route, which went to all the forts on the frontier, and also to the stands of the stage lines then in operation. The Overland mail required that fresh teams be kept at all stations, with two or more employees to feed and harness the teams, having them ready so that only a few minutes would be lost when the mail-carriers arrived, either in carts or on horseback. Johnson invested heavily in animals and equipment, and hired only proven and dependable men for the stations. Since the Indians were raiding constantly, all involved were in great danger, and it was a common thing for him to receive word that this station or that had been raided, the employees killed and scalped, the stock stolen and the mail torn up or burned.

After one raid, Capt. Eastman sent a summons for the Indians to come into the post for questioning. Thirteen of the braves came, but no chief. These Indians were defiant and denied knowing anything about the raid. While they were talking, one of them dropped his blanket and his pistol could be seen. The captain asked to see it; the engraving on it meant nothing to the Indian, but the name was one of the murdered mailmen. Then another of the red men was rolling a cigarette in a torn letter, and on examining the paper it was found to be part of a letter from the mailbag.

Capt. Eastman ordered a body of soldiers to form a line to prevent the Indians from leaving. They broke through and a general fight took place in which nine of the Indians were killed. When the captain sent his report to the War Department, he was censured for the action. The fine officer resigned from the army and left the service, indignant that the high brass safe in their offices in Washington, could be oblivious to the terrible atrocities so common on the frontier.

Taxpayers Can Extend Their Filing Deadlines

The Internal Revenue Service (IRS) says you may receive an automatic 4-month extension of time to file your 1985 federal tax return. The application for the extension, Form 4868, must be filed by April 15.

The IRS stresses that this is an extension of time to file your return—not an extension of time for payment of taxes due. When filing for the extension, the taxpayer must estimate their tax owed for 1985 and send that amount with the Form 4868 to avoid interest and late payment penalties.

The IRS notes that a deduction for an IRA contribution can be claimed on a 1985 tax return only if the contribution is made on or before April 15, even for those electing an extension to file.



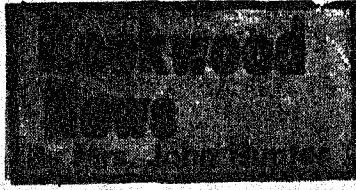

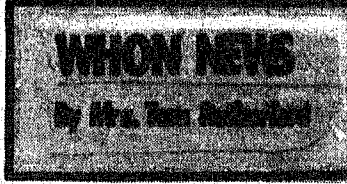

Seeking Volunteers

The West Central Texas Ombudsman Task Force is a volunteer group currently seeking volunteers from Coleman County to assist in local nursing homes. The Ombudsman Program is mandated by the Older Americans Act which is administered by the West Texas Council of Governments through the Texas Department of Aging. At this time there are no Ombudsmen in Coleman County.

Ombudsmen are advocates for nursing home residents and their families. They are trained and certified by the Texas Department on Aging in conjunction with the Texas Department of Health. In their roles as advocates the Ombudsmen attend inspections and public hearings conducted by the Texas Department of Health in long term care nursing facilities. The Ombudsmen may also refer complaints to the Texas Department of Health for investigation.

The West Central Texas Council of Governments serves the 19 counties of West Central Texas as the Area Agency on Aging. It is the hope of Dr. Jon Ashby, Professor at Abilene Christian University and Chairman of the Ombudsman Task Force, that Coleman County will soon be served by a local Ombudsman.
