WTU Changes Billing

To provide extra convenience and more account information to the people it serves, West Texas Utilities Company has improved the monthly bill it mails to customers.

Beginning May 14 the postcard-style bill customers have been receiving will change to a full-page, more detailed bill that will be mailed in an envelope. A return

envelope will be enclosed for convenience when paying by mail.

The most obvious change in the bill will be its appearance. The letter-sized format will be

noticeably larger, with a detachable bill portion at the top and a detailed statement below. The top portion of the bill will be identified by WTU's logo and light blue color.

While the new bill is more attractive, its real purpose is to serve WTU customers more efficiently. The biggest change

most customers will notice is how much more information the new bill provides about their accounts. "The new format has more space, so we can include additional

information regarding each customer account" said Charles Moore, Santa Anna Area Manager. "You'll see exactly how your bill is calculated with meter reading usage, fuel, and other factors."

Now customers will see a detailed breakdown of their energy usage and rates, as well as how much they owe. The bill will also show more

detailed information on other matters such as merchandise accounts.

Santa Anna — The Town

There must be something about this place called Santa Anna which inspires greatness. This past Funtier weekend I observed the same remarkable qualities of the human spirit which motivated me to focus my research on Santa Anna. In order to better appreciate what you have accomplished it is important to understand the conditions under which the Comanches, and other Texas Indians, officially left Texas. The following letter written by Texas Indian Agent Robert S. Neighbors was his last. He was shot in the back by an Indian hater at Fort Belknap on his trip home from escorting the Indians out of Texas.

(August 8, 1859; to his wife)

If you want to hear a full description of our Exodus out of Texas read the "Bible" where the children of Israel crossed the Red Sea. We have had about the same show, only our enemies did not follow us to Red River. If they had—the Indians would have in all probability sent them back without the interposition of Divine Providence.....My dear wife, the most painful task I have had to perform since I kissed you and the dear children goodbye was to separate from the Indians....I made my last talk yesterday....There were a thousand warriors present, and I shook hands with each of them. Some of the old warriors, whom I have known ever since I have been Agent among them, clung to me, and refused to let me go....I have labored hard for them, trying to discharge my duty, in the sight of God and man.

I thought of Agent Neighbors often during Funtier Days weekend and felt he would have been very proud to witness what I was seeing. Your town, in my opinion, is truly blessed.

past customers have expressed a strong wish for a return envelope to be provided with their bills. Now that bills will be mailed in envelopes, WTU will be able to provide this requested service.

The return envelope will have a window. The top portion of the bill you return to WTU, when placed correctly in the envelope, will position the address of your local WTU office in the window.

The full-page format fared well in selected customer testing early this year. WTU randomly chose 100 accounts company-wide to receive the new bill.

Afterwards, each of the 100 customers was called personally and asked for reactions. Some of the features customers especially liked included:

- * the new bill is easier to read;
- * having the return envelope provided for them;
- * the privacy of their account information going through the mail in a sealed envelope; and
- * having more detailed information about their accounts.

The only change customers should notice is more information and added convenience. There won't be an increase in customers' bills to pay for the new features.

Although the return envelope is provided for customer convenience, those who prefer to pay their bill in person at their WTU local office may continue to do so. Your favorite WTU office personnel can still take your payment in person.

Any customer with a question or comment about the envelope billing may call his or her WTU area office for more information.

Commissioners Seeking Grant To Help Implement 911

During the Commissioner's Court meeting Monday morning, May 10th, the first of two readings was completed concerning application for a grant amounting to \$5,000.00 from the Texas Department of Transportation to help implement the 911 system in Coleman. As no opposition was heard, the second and final reading will be held at the next regular meeting of the commissioners on May 28th. If no opposition is made at that time, the application process for the grant money will be initiated.

Addressing the court was Wade Turner, Coleman County Sheriff, concerning crowded conditions at the county jail which will possibly require more certified jailer employees in order for the facility to continue its certification under state standards. At the current time, there are six inmates residing in the county jail while awaiting acceptance into the Texas prison system. This backlog of prisoners, although temporary, has caused the concern there to exceed the number of prisoners who can be housed with the current number of certified

jailers.

More research into the matter will be done by Sheriff Turner and he will report back to the Commissioners his findings.

County Extension Agent, Marty Gibbs, appeared asking permission to replace the computer in his office. The current computer has been down for about 3 weeks and estimate of repair is \$650.00. Mr. Gibbs asked the Commissioners to approve participation in a cost-share program with Texas A&M University, through which a new computer may be purchased for \$1,595.95. The new equipment would allow more work to be done in a shorter amount of time. The consensus of opinion was that spending money on repair of the old system would be wasteful in the long term as the new computer would be under warranty and would do more work than the old system. With this thought, Commissioners approved the participation in the A&M program.

Final agenda item was the paying of bills with Commissioner approval upon their presentation by Shirley Sansing.



"The Need To Forgive"

In his book *God's Samurai*, Gordon Prange tells about one of Japan's military pilots, Mitsuo Fuchida, that lead in the attack on Pearl Harbor. Mitsuo Fuchida was a proud Japanese war pilot that greatly admired Adolf Hitler. He admired Hitler so much that he even combed his hair and grew a mustache like Hitler's. Fuchida took an active part in many of the major battles of the Pacific war including: the Battle of Midway, the Marianas Turkey Shoot, Leyte Gulf, and many others. He was even allowed to stand on the deck of the USS Missouri when Japan surrendered. Although they were defeated, Fuchida was pleased with his behavior as a pilot. After the war, he became confused. He was greatly surprised to discover that the Japanese POWs (Prisoners of War) were treated humanely, this was very different from the inhumane treatment the Allied prisoners received by the Japanese. He also learned of a woman who administered to the Japanese POWs. Her parents were missionaries to Japan who had their heads cut off by Fuchida's fellow countrymen, the Japanese. She had forgiven the Japanese for their terrible acts against her parents and she continued to meet the many needs of the Japanese soldiers. Her forgiveness and love led Fuchida to the Bible. He became a Christian, and later he became an evangelist. Fuchida died in 1976, but not before he lead many others of Jesus Christ in Japan and in the United States. The Change in Fuchida's life began when one woman made the choice to forgive like Christ did. A lesson we can all stand to learn, forgiving others the way Jesus Christ forgave us. Who do you need to forgive? Don't just think about it, do it. Jesus said, "And when you stand praying, if you hold anything against anyone, forgive him, so that your Father in heaven may forgive you your sins" (Mark 11:25 NIV).

Kitchen Tools For Lower Fat Eating

When you decide to eat more healthfully, lower-fat food, your first step, naturally, is to rethink your order. Higher fat meat cuts or processed meats give way to lean meat choices such as leg or loin choices from red meats, poultry or fish. Macaroni and cheese becomes noodles with tomato sauce, and french fries show up as baked whole potatoes. Even small changes in what you bring home from the grocery store and simple alterations in preparation can help you turn your eating habits around.

The same is true for your equipment. A few new kitchen tools will enable you to improve your diet, as will looking anew at your old utensils. The right equipment can make cooking easier and helps you prepare nutritious meals quickly and with minimum effort. Frequently the less expensive, more basic kitchen equipment can allow health-seeking and often hurried cooks to change their eating habits with ease. Now you can find out which tools help the most, along with how to use them and how much you should plan to spend on them. To begin cooking more

healthfully, the following equipment will make your challenge easier:

SHARPER KNIVES can mean the difference between cooking healthfully and not cooking healthfully, which is why it is the most important tool in any health-conscious eater's kitchen. For example, if you can cut up vegetables quickly and easily, you're likely to eat them more often in stir-fries and fresh salads. Slicing meat thinly will provide a smaller portion that will satisfy; three ounces, the portion recommended in government's Dietary Guidelines for Americans, seems much more generous (and appealing) as thin slices fanning out over the plate than as a thick slab. A combination of two sharp knives, a chef's knife and a smaller paring knife, used interchangeably makes nutritious meals a cinch.

BLENDERS can be used for making low-fat beverages, soups and vegetables. For example, blend a cup of skim or buttermilk with a cup of frozen strawberries for a thick, satisfying milk shake without the added fat that comes from ice cream.

A FOOD SCALE helps in portion control. Three ounces of meat would make a serving, but how many people actually know what that looks like?

Although the common analogy that a three-ounce portion is about the size of a deck of cards helps, but for those new to eating less flesh foods than formerly, a food scale gets the right portion on the table without any guess work whatsoever. Also, other foods can be weighed to ensure that the two-ounce brownie you've saved room for actually is only two ounces and not three or four.

A CHEESE GRATER will help in lower-fat cooking. While Americans have been cutting down on their intake of beef, cheese consumption has more than doubled in the last 20 to 30 years. This may be one of the reasons our fat intake has not dropped as dramatically as might be expected. It's great that

cheese is popular. It provides calcium, high-quality protein, riboflavin, and vitamin A. Grated cheese is easier to ration than big slices, stretching the impact of its flavor when sprinkled over food but with less fat. The most convenient, four-sided cheese grater with the handle on top is the best type to have on hand.

GRILLS whether kettle-shaped charcoal grills, hibachis, or indoor grills which fit over an electric or gas stove can make more than the summer time backyard barbecue fare of hamburgers, hot dogs and big steaks. They also add that special smoky richness to fish, vegetables, and fruits—without adding fat.

SKEWERS work wonders on three fronts...They make food ready to eat fast because the items that are stuck onto them are cut up into small pieces that cook quickly both on the grill and in the oven. Secondly, they provide the opportunity to make food healthful because they allow for instant fat and portion control. The bulk on the meal on the "stick" can consist of colorful vegetables placed between the morsels of flesh food. Thirdly, skewers make food look beautiful.

A NON-STICK SKILLET with a lid can perform any chore a pot can and more. In fact, just one 12-inch non-stick skillet, about three inches deep with a tight-fitting lid and an oven-proof handle allows baking, frying, sauteing and even boiling everything from chicken breasts to vegetables with much less fat than you might typically use. The lid allows for the slow cooking of vegetables without adding water, preserving water-soluble nutrients such as vitamin C that would leach into water during boiling and be drained away.

A POPCORN POPPER—Some ready-to-eat popcorn and pre-packaged ready-to-microwave varieties have as many as 10 grams of fat per serving, as much fat as rival small bags of potato chips. But kernels popped in your own air popper or your own microwave popper have all of popcorn's fiber—0 about four grams per three cups—and none of the fat.

punched with holes that sits inside another bread pan which allows fat to drip as it cooks. Other meats should be cooked on racks to allow fat to drip from the meat.

COFFEE GRINDERS make pounding spices a breeze. Many people today simply don't have time for pounding their spices to a powder. Commercially ground spices, while perfectly serviceable often lack the same quality of flavor enhancement. This is because once spices are ground, their aromatic oils are exposed to air and they lose their potency as they sit on shelves. Oils in fresh spices ground at home are not exposed to the air until the last minute.

Start by utilizing much of the equipment you already have at home to turn higher fat meals to lower-fat alternatives. These will better fit into lower-fat meals recommended by the dietary guidelines.

Capitol Comments

By Representative Bob Turner

One of the more important things I do as your State Representative in Austin is to keep Legislators who do not have the interests of Rural and West Texas at heart from introducing and passing legislation that might hurt us and our way of life. A few examples of the type things we have been able to catch and prevent from happening, just during this legislative session follow: One piece of legislation would have prevented farmers and ranchers from advertising seed wheat and seed oats from sale in their local newspapers. Needless to say, this bill was sponsored by the Certified Seed Producers. Our traditional method of saving our better seed in the barn and selling it as planting seed, in season, nets us a good profit over selling all of the crop as a feed product at harvest time. A proposed revision of the Penal Code and State Statutes would have made it against the law to sell, or give ammunition to anyone under 18 years of age. (This particular verbiage was tucked away in a 78 page bill and a little difficult to locate). I don't know about you, but there simply would not have been a Santa Claus at our house, had it not been for 22 shells and shotguns shells in our stocking. Shells for my gun were my favorite gift from 10 years of age until Santa quit coming to see me. Luckily we noticed this and were able to get it removed from the bill. One bill would have made it illegal to carry a dog in the back of a pickup truck. The people who propose this type of legislation are no doubt trying to protect pets, but have no earthly idea of how we in agriculture use cow dogs and sheep dogs. Another real "doozie" was a bill that would have required safety chains on gooseneck and cotton trailers. Can you imagine pulling two cotton trailers in tandem, and having them come loose from the truck, but still tied to you with a chain! I feel that it would be the beating of your life!

We were able to keep all of these above mentioned things from happening to those of us in agriculture, or rural Texas.

The situation as perceived by the courts and still meet a time frame that will keep the local school districts from missing their next state payment on June 25. I feel sure that some sort of method can be worked out, but as I have previously stated, as long as we continue to use property tax as our method of financing public education, there is no satisfactory way of solving the problem. I might add that the alternatives to the use of property tax are equally distasteful to many Texans. So!!! My word of caution would be to believe very little of what you hear from the major media about the solutions. I promise you that anything you see or hear is purely an opinion that the media has picked up through an interview and has no relationship to what the final solution will likely be.

The deadline is fast approaching on getting final approval of pending bills. Luckily, my staff and I have been very successful in getting most of our legislation either well into the finalization stage, or have managed to tack it onto someone else's legislation. It would be most educational for any of you that could sit on either a House floor session, or a committee hearing. It would really give you a feel for the process and an understanding of the difficulty of turning an idea into a piece of legislation and that legislation into actual law.

I sincerely hope that this series of "Capitol Comments", which we have provided for your local newspapers during the session have proven to be informative, educational, and has kept you abreast of what is going on in state government. The legislative process is so speedy and fast moving, that what is printed early in the morning, can easily enough be incorrect by evening. Therefore, making the column interesting, yet factual and as current as possible, considering that almost all the newspapers in the 73rd District are weekly papers, is very difficult. It is my intent, at this time to continue a monthly news column when the session ends. I assure you that even though the session ends, the activities of the office does not slow down much. A great portion of our operation continues just the same as if the Legislature were in session.
