Public Meeting Jan. 13 Waco — Texas farmers, ranchers, dairymen and anyone else interested in agriculture are invited to attend a public meeting in Waco January 13 of the House Agriculture Committee of Congress to give their

ideas on a farm program Congressman W. R. Poage, ranking Democrat on the House Agriculture Committee, has completed arrangements with the help of Waco Chamber of Commerce. Of Gross Farm Income, As Reported By U. S. D. A.


