

The second ice storm of the season has chilled our area this week. Temperatures dropped to below freezing Saturday night and had remained at the low point through Wednesday.

#### **Rate Increases** Are Sought By WTU, Lone Star

The Santa Anna City Council was asked to grant a rate increase in Santa Anna by both West Texas Utilities Co. and the Lone Star Gas Co. at the last Thursday night meeting of the Council. Herman Ledbetter, district manager for WTU, and Bob Burton, local manager, were present for the meeting to present their request, and the gas company request was in written form.

City Council members voted to table the proposals for further study. A decision on the rate increase request will be made at the Council meeting in February.

After studying salaries of city employees, the ten employees were each given a \$25 per month salary increase.

Also at the meeting Thursday night the minutes of the previous meeting were read and approved and bills and accounts approved for payment. Mayor Thomas Wristen presided at the meeting which was attended by all members of the Council.

#### Changes Made On Disability By New Laws

Several changes were made in the disability insurance part of Social Security. One would reduce the "waiting period" from six months to five, letting benefits start with the sixth full month of disability instead of the seventh month as in 1972 and earlier years. Blind persons will now be insured for disability benefits if they are fully insured whether or not they meet the usual recency of employment provisions.

Children disability benefits will now be payable if a son or daughter becomes totally disabled before age 22 rather than before age 18 as in past law. Also, if the disability terminates, benefits can be reinstated if the son or daughter again becomes disabled within seven years of the recovery.

A change is made in the manner in which receipt of workmen's compensation benefits affect social security's disability benefits which will often enable social security payments to be increased.

#### AUSTIN'S 'MR. WEATHERMAN' IS A MOUNTAIN CITY NATIVE

The following story is copied from the December 17, 1972 issue of the Austin American Statesman. Wilbourn (Buddy) Weaver is the son of Mrs. Burgess Weaver of Santa Anna.

For over 20 years, Wilbourn Weaver has brought sunshine, ice storms, northerns and sometimes even snow to the attenion of Central Texans on his daily radio broadcasts.

And Sunday, December 17, Weaver, assistant-in-charge of the Austin Weather Service Office, was honored for his completion of 30 years of government service.

Known to many as 'Mr. Weatherman," Weaver has been forecasting the 7:20 a.m. and noon weather reports over the Central Texas Radio Network here since 1949.

Originally from Santa Anna, Weaver graduated from Baylor University in 1929. He received his meteorology and training through the U. S. Army and served at Tinker Field in Oklahoma City util 1946. After the war he was a civilian forecaster of Carswell Field in Fort Worth later joining the U. S. Weather Bureau at Big Spring until 1949 when he moved to Austin.

The Austin Weather Service is responsible for broadcasting the Austin area forecast at noon seven days and week and at 7:20 a. m. every day except Sunday.

Weaver's broadcast goes out to the Austin area and to 17 counties in Central Texas.

Seven meteorologists including Weaver run the weather service located next to the Federal Aviation Administration Flight Service Station on the ground floor of Municipal Airport.

Because the weather service's primary function is aviation observation, they work closely with the Flight Service Station to provide weather reports and briefings to pilots.

The weather service's readings include temperature dew point, barometric pressure, wind velocity and direction cloud height. Horizontal visibility, rainfall and amount of sunshine. The instruments are located alongside one of the runaways to give pilots more accumulate data when flying under instrument conditions.

The weather service, besides providing information to pilots, distributes Austin area forecasts

and weather reports over a teletyped weather wire sent as a public service to media and Department of Public Safety offices across the state.

The weather service is also responsible for information distribution of severe weather and-or tornado watches and warnings.

The collection of climate records keeps the service busy 24-hours a day. Weaver said they work n shifts with two or three men in the daytime and the man at night.

Weaver says that weather forecasting is challenging because every day the situation is different and constantly changing.

He says that in all the years he has been forecasting Austin's Weather he particularly remembers Christmas day in 1955 when the temperature hit high of 90 degrees.

"You just never knew what 's going to happen next, "he said.

#### Fast Truck Ride Not Fast Enough For Illegal Hunt

Bill Matzke was patrolling at 3:30 a.m. recently when he heard a shot. He investigated and flushed a pickup truck which was hitting speeds of more than 90 miles per hour on a winding farm-to-market in the Big Thicket.

Matzke radioed ahead to another officer who set up a roadblock, which the pickup ran.

Whe the officers finally stopped the pickup, they found two women in the cab. In the back was a dead deer and two badly shaken men.

All four were arrested and levied fines totaling \$925.



IT LOOKED TO US like the people gave a mandate to the President when he was re-elected last November, to end the Viet Nam war in his own way, but do you think the red-loving Congressmen and Senators will listen?

It boils down to what will it be—peace on President Nixon's terms or on McGovern's?

McGovern ran on a peace-at-any-price platform and was soundly defeated. The President was, in effect, told to end the war the way he had been trying to end it—by talk if possible and by force if necessary.

So what happens? The North Vietnamese reneged on a near settlement and Nixon resumed the bombing long enough to change their minds and when they agree to resume negotiations with some promise of settlement, the McGovern discredited philosophy suddenly rears its ugly head again. That borders on treason because if anything will scuttle the peace talks again it is the publicity that this bunch of peaceniks are getting.

The House Democratic caucus voted to end the war immediately by cutting off funds. McGovern, as if he had a right to demand anything after the showing he made with the people, is asking the President to appear before the senate and "explain his policies." They are signing the old familiar surrender chorus.

This peace-now song must be a welcome sound to the enemy who would like to win the peace while losing the war.

Nixon asked the Congress to do nothing to endanger the negotiations and if any request ever made snese, this one did. This bunch of pinkos are willing to gamble the very security of this country for political gain within their own ranks. They certainly are not gaining it from the people. They are willing to force this country to surrender the very things they have gained in this war at the cost of many lives and financial cost to the people, and if anything was ever at odds with the will of the majority that is.

Sen. William Fulbright made the statement, "the war has gone on long enough." Certainly it has, but the negotiations have not, and the more these communist lovers yell about it the longer the negotiations will have to go on.

It is a shame that elected representatives of the people will not recognize the will of the people who put them in office and give the President all the help they can in ending this war in an honorable fashion.

Anyone who would out his political ambitions above the welfare of his country is nothing more than a traitor, and should be dealt with accordingly.

What can we do? Write your Congressman and Senators expressing your views. Letters have more effect than anything you can do.







ASCS

A preliminary explanation of the newly-announced 1973 Feed Grain Program is being mailed to Colleman County Farmers with feedgrain bases, reports Rankin McIver, Chairman of the Agricultural Stabilization and Conservation (ASC) Committee.

"As they sort through their Christmas mail, I hope they find the explanation and put it aside for special attention," he said, explaining it is the first official word to be sent directly to farmers on the major provisions of the 1973 feed grain program.

Sign-up for the 1973 feed grain, wheat, and cotton programs begins Feb. 5 at ASCS county office and continues through March 16.

The 1973 Feed Grain Program imeludes barley, corn and grain sorghum, and producers may elect to participate under one of two options.

Commodity loans will be available to all participants in the feedgrain program on the farm's entire production. National average loan rates will be \$1.08 perbushel for corn (No. 2 basis); \$1.79 per hundredweight (\$1.00 per bushel) for grain sorghums; and 86 cents per bushel for

Since the beginning of time on earth, man has looked to the oceans, lakes, rivers, streams and springs for sustenance.

With three-fourths of the earth's surface covered by water, its resources seemed unlimited-and eternal. But man through neglect and indifference has polluted fresh water and saltwater, killing large areas for production of fish and shellfish.

The Marine Resources Division of the State Health Department is deeply involved in making certain that fresh, edible shellfish finds its way to the tables of consumers in this state and others to which it is shipped.

Marine life is a great resource in Texas, providing food as well as recreation for its inhabitants. But this resource is threatened in several ways. Many saltwater species-including shrimp as well as fish - spawn in the bays and estuaries which extend along the coast, but these spawning grounds have been filled in with dirt for commercial development or polluted with chemicals which

income. Since REAP and Water Bank fall in the latter category, they were the most vulnerable of the ASCS programs. Thus these programs have been terminated.

In addition, record farm income which is due in large part to your efforts in successfully administering ASCS programs is enabling far mers to bear, without serious economic consequences, more of the kind of expenses supplemented by REAP and Water. Bank. Thus, these two among the ASCS programs were revealed to have the lowest priority in the budget review.

The County Committee has decided to lease cotton outside the county for one year. There will be no out right sale of cotton outside the county. Permanent transfer within the county or outside the county will be carried out by owners only.

The county office will maintain a list of names indicating an interest in selling or leasing cotton allotments. Farmers who wish to have their names put on this list may come by the office and do so.

The list will include producers wishing to sell or lease out cotton acreage and separate list will be . the State Health Department is maintaned for those producers constantly checking the marine wishing to purchase or lease additional cotton acreage.

Persons outside the county inquiring about listings of allotments are to get their information from the county office as the office is prohitited from reporducing these lists.

kill the marine life itself. The chemicals come from industrial wastes as well as the chemicals which are used to control organisms which compete with man for the available supply of food and fiber-such as the spraying of cotton.

One of man's modern threats to himself has been found in the dumping of mercury into our waters. Mercury has been found in excessive quantities in fish and oysters, and pesticides also have created problems in marine life.

Commercial landings of fish and shellfish in Texas have a great economic impact on the state, and in 1970 amounted to 146.9 million pounds with a dockside value of \$53.2 million. Commercial shrimp trawlers unloading in Texas ports made 61,444 trips into bay and Gulf waters to land 88.3 million pounds of shrimp valued at \$48.6 million.

Oyster fishermen in 1970 harvested 4.7 million pounds of oyster meats valued at \$2 million. Blue crab fishermen landed 5.5 million pounds of crabs valued at \$509,000 and edible finfish landings totaled 5.3 million pounds valued at \$1.2 million.

Purity of shrimp, oysters and erabs are the primary concern of the State Health Department's Marine Resources Division.

The oyster, which lives on reefs on the bay floors, has the ability to concentrate bacteria, heavy metals and other impurities which may be present in growing waters. The oyster also has the ability to cleanse itself as the quality of its envoronmentimproves. There is some indication, however, that other marine animals do not have this same ability to the degree that the oyster has. This perhaps accounts for the fact that oysters may be of safe, edible quality and other marine animals in the same waters may not be, but store up the impurities in their bodies.

Some bay areas in Texas have been closed because of excessive mercury densities found in crabs and dystes. Some formerly closed have been reopened following tests which showed oysters and crabs of safe, edible quality.

With the aid of its laboratories, as well as federal laboratories, resources in Texas, collecting and analyzing some 1200 bay water samples in the first half of 1972. The Marine Resources Division must certify oyster and crab meat processing plants and has done so in 1972 for 103 oyster plants and 12 crab plants.

There is a continous surveillance of factors influencing sanitary quality of 1,500,000 acres of shellfish harvesting waters. More than 5,000 maps of harvesting areas have been distributed.

The challenges of seeing that only safe shellfish reach the consuming public are increasing. The increasing Texas population along the Texas coast, the pollution hazards from the everincreasing public and privatelyowned waste disposal facilities, as well as the increased use of Texas bays for commercial and recreational purposes, necessitates closer and evermore stringent surveillance.
