The Santa Anna Independent School District board of trustees met for the regular monthly session at the high school office on Tuesday night, January 9. A. D. Pettit, president, led the session. Others present were Barbara Kingsbery, Vernon Parnell and Max Eubank.

The opening prayer was led by Mr. Parnell, and minutes of the December meeting were read and approved. Sandra Cammack, school business manager, reviewed the status of the budget.

Additional insurance coverage was approved for school vehicles and vehicles traveling on school-sponsored activities.

Information on the proposed gas rate increase was reviewed by members of the board.

The meeting of the newly appointed school improvement study committee was set for Monday night, January 15. The committee, composed of about 20 local citizens, will aid the school board in determining needed improvements of the school district and make recommendations for the board.

Supt. Cullen Perry told of proposed vocational training opportunities at the area vocational training school at Brownwood and was requested to get more information on enrolling local students in the classes next fall. Cline Smith, a guest of Robert Barkley, was the only visitor at the Tuesday meeting.

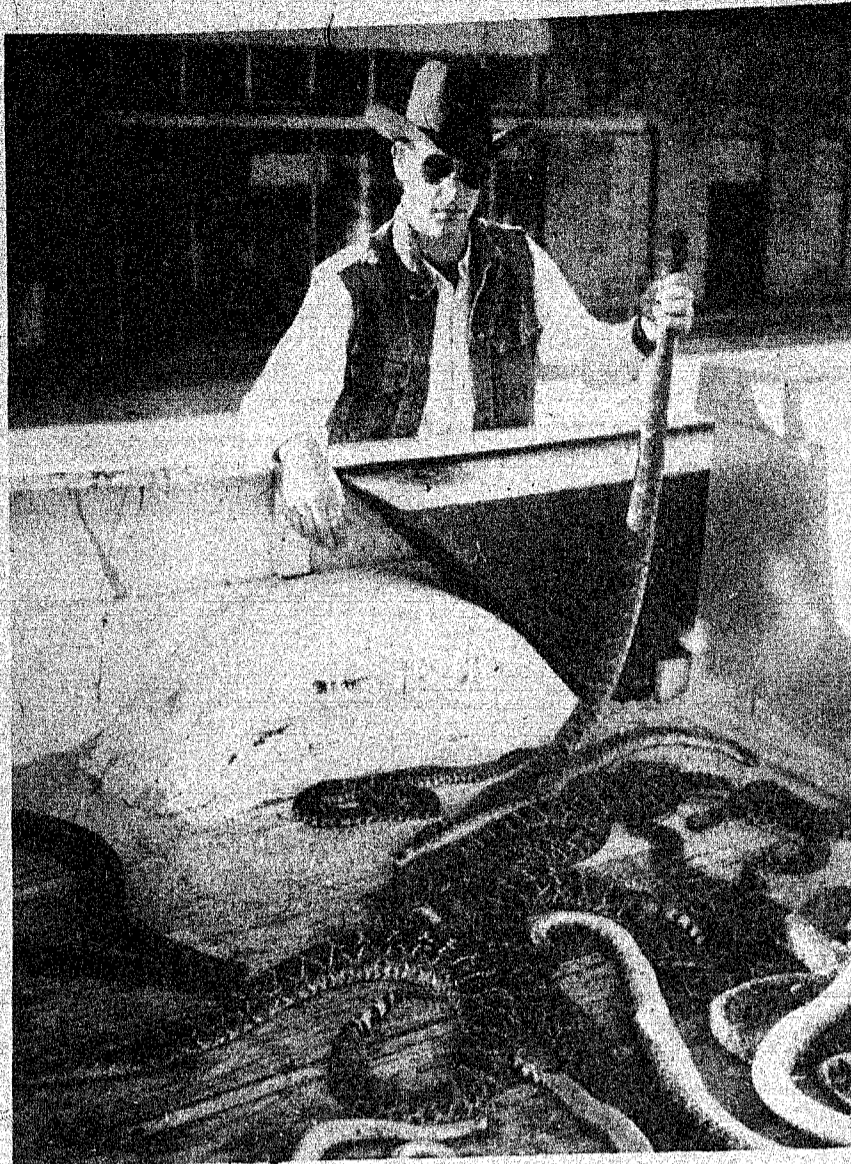
Rites Held For Mrs. McCrary, 86, At N-Side Church

In Our Opinion

THE ELECTORIAL COLLEGE was fine in its day, because the country was small and communications were slow, and many times it was a month before a candidate for president knew whether he got elected or not. Also the delegates to the college were faithful to cast their ballots like the states they represented.

This year this country had a rebellious delegate from Virginia and he cast his vote for the Libertarian party while his state voted for Nixon.

That brought on a cry from people for a reform of the electoral college in the presidential election and for the president to be elected by popular vote.

Four years ago the House voted overwhelmingly for a change but the Senate failed to pass the measure because of a filibuster. Many feel now that it would pass and several amendments are in the Congressional hopper to do so.

Americans have shown via the poll, that they favor the direct election of the president, and why not? All other offices are won by popular vote and there is no question that it is the democratic way.

However there are some drawbacks to this also. In a close election a handfull of votes might tie up the election and paralyze the presidential succession, or end up in the Supreme Court which has been famous for its odd decisions.

Another thing is that it might be a blow to states rights, because the states themselves would be ejected from the presidential process and the election itself would be federalized. The last big states right is the election of the president, and the champions of centralized government would be happy to see it taken away.

+ + + +

THE NEW DIRECTOR of the Health, Education and Welfare has said he agrees with President Nixon on busing to achieve artificial racial balance and that he will oppose it. That is the first time a director of HEW has ever made such a statement. At the same time the President has made the statement "I am against it, period."

At the same time Congress is receiving a flood of constitutional amendments in both houses aimed at halting busing.

So we will sitback and see what happens. Now that everybody knows the sentiments of the administration, will Congress accept the mandate of the people and pass anti-busing legislation or will they oppose it simply because of the powerstruggle between the Democratic Congress and the Republican administration.

For the most part, Texas Congressmen and Senators will favor the anti-busing move, but liberal-minded northern Congressmen may not be so quick to give up the fight.

Mrs. W. B. Sparkman was in Beaumont to attend the wedding of her grandson and also visited in Houston with her son and family before returning home.

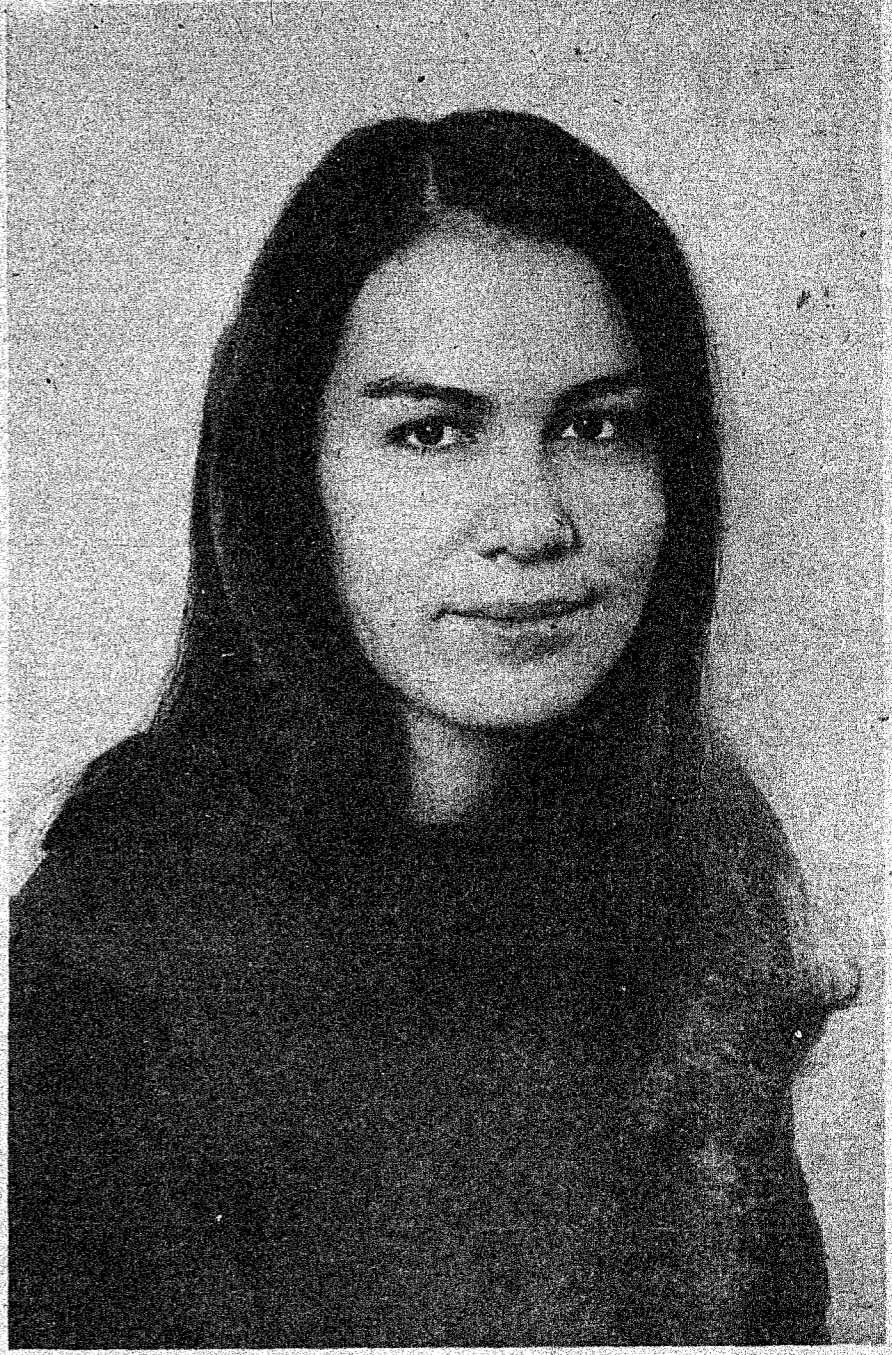

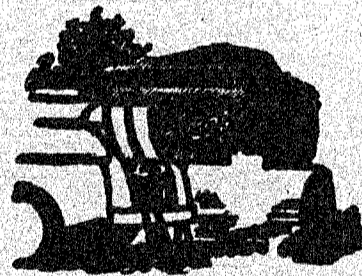

The Santa Anna FFA and Vocational Agriculture Department would like to give special recognition to our leader and chapter advisor, Mr. Billy Riley.

The son of Mrs. Clea Riley of Coleman and the late Lynn Riley, the Santa Anna FFA advisor is a graduate of Coleman High School. While in school he participated in many activities including membership in the Coleman FFA chapter, president of the Coleman High School football team.

While in the CHS chapter Riley showed many calves and had several grand champions and reserve champion steers throughout the state. He also received his Lone Star Farmer degree, which is the highest award presented by the Texas Association of Future Farmers of America.

After graduation from Coleman High School, Mr. Riley went to Tarleton State College and majored in agriculture. While at Tarleton he was elected president of the Tarleton Collegiate FFA chapter.

Since Tarleton was only a two-year school at that time, Riley transferred to A&M University to continue his agriculture major. There he was chosen vice-president of the A&M Collegiate FFA chapter.

After practice teaching in the Santa Anna Vo-Ag department and receiving his degree, Riley started teaching at Mozelle and Novice, commuting between the two schools. Later he taught at Novice, coming to Santa Anna in 1968. He replaced long-time agriculture teacher A. D. Pettit who resigned.

This year Mr. Riley is serving as president of the Coleman District Agriculture Teachers and secretary of the Area IV Agriculture Teachers. When asked how he managed to get into these two positions he replied, "I have two cut-throat friends—one lives in Coleman (Bill Hightowner) and the other lives in Bangs (C. H. Sargent)".

All of this and much, much more has taken place since Mr. Riley has been our local advisor. We will list a few of the accomplishments that his students and FFA members have made.

Along with the FFA activities, Mr. Riley teaches all four grades or levels of agriculture at SAHS and maintains the largest FFA chapter in the Coleman District, with a present enrollment of 78 members. This is larger than Brownwood, Winters, Ballinger or Coleman.

Riley has taken voting delegates to three State conventions, three area conventions, three district banquets, six district meetings, and to the meeting of the Southern Region of the FFA which includes 11 states.

He also instructs boys in woodwork and metal work and has had great success with these projects.

As busy as he is in his professional activities, Riley also has a busy home life. HEADLIGHTS HELPFUL ADVICE FOR THE WOMAN DRIVER

To maximize your chances of surviving an auto accident, buckle down to buckling up your seat belts.

Advocates of seat belts usually stress that buckling up will-in the event of an impact-tend to keep you from slamming forward into the steering wheel or instrument panel or both. But that's only part of the story.

Equally important-especially in a potential accident situation-is that seat belts keep your nailed down, keep you in position to steer and drive the car; they not only restrain your forward motion, but they keep you from sliding on the driver's seat.

Say you blow the left front tire and your car is suddenly and violently thrown into a broadside slide. The dynamics of such a situation dictate that you'll be thrown to your right, possibly even against the passenger door. You can't steer the car from the passenger side. You can't control it when you're rolled up in a ball on the floor. True, cinching your seat belt down tight may wrinkle a skirt, ruin an artfully pressed pleat, but consider the alternative.

Winter Season Challenge For Dove Hunters

AUSTIN-- Texas dove hunters will go through some unusual rituals this year-- preparations for cold weather.

Due to an experimental split dove season with a winter segment running Jan. 6 through Jan. 21, hunters can think about parkas and Thermos bottles of hot coffee instead of insect repellent and iced tea.

Texas Parks and Wildlife Department officials stress the word "experimental" when referring to the split season since next year the season could very likely revert to fall-only.

The late segment of the seasons should offer a different experience for dove hunters, and colder weather is just part of it.

Doves have different habits in the winter than those exhibited during the fall. They concentrate into flocks, and the net results are spottier shooting and more searching.

There should be few complaints of small, immature birds, though, since most of the winter kill should be composed of mature birds. Once hunters have found the doves, the action should be lively.

Hunters have been hoping for a winter season for years, but biologists say that until now they had no way to evaluate the effect of such a season on dove populations.

Now, harvest surveys and banding programs will enable them to determine the origin of doves present in Texas during January and the effect of a late season on the overall harvest.

A portion of the dove population in Texas during the winter is comprised of migrants from other states, and these may have been hunted quite heavily prior to arriving in Texas.

Biologists will be keeping a close eye on the winter kill to determine if a winter season may adversely affect the breeding populations in Texas and other states.

Until they are sure a winter season won't be detrimental, Parks and Wildlife Department officials say they cannot prudently approve a permanent winter season.

County Committee will notify producers of their allotments, bases and yields by official notices Friday January 12.

After this date cotton producers can officially begin transferring by lease or sale their cotton allotments from one farm to another. This year it may be leased outside the county for one year.

For this year farmers may participate in feed grain program by selecting Option A or Option B at the time they sign their intention to participate in the program.

Option A calls for set-aside acreage equal to 30 percent of their feed grain base. Payment will be made for 50 percent of the acreage in each feed grain base. The county average for this option is \$8.41 an acre.

Option B calls for 15 percent set-aside and limits the 1973 grain acreage to the actual acreage planted to feed grains for harvest on the farm in 1972. Payment is also made on 50 percent of the base. This average payment for this option for Coleman County is \$5.86 an acre.

The sign up for 1973 programs will begin Monday, February 5 and end Friday March 16.

The set-aside acreages under these programs must comply with the following requirements. It must be at least 132 feet wide

except where the land is terraced, the area from crown of terrace to crown of next terrace may be used. The acreage must contain at least five acres unless, (1) an entire field is designated, (2) the area offered represents the balance of the set-aside requirement, (3) the total set-aside requirement is less than the minimum, (4) set-aside is designated in a skip row planting pattern.

The set-aside acreage must in addition be equal in productivity to the land on the farm normally planted to the set-aside program crop.
