Pastor and Mrs. John Loveridge of the Seventh-day Adventist Church have purchased the Johnson home on Avenue A and moved into the home this week.


#### Jimmy Benton Is Chosen For districts which were combined to HPC A Capella

#### Mrs. Floy Havner Buried Thursday



# In Our Opinion

#### By W. T. HAYS

SPENDING BILLIONS AND BILLIONS of dollars would be an awesome task for any group, but to most of us it is beyond all comprehension. Yet we expect our representatives in Washington to do a job in seeing that our tax money is spent wisely and conservatively.

There is no way a Congressmanor Senator could go over the national budget and consider every expenditure that it contains, and if he did, there is no way he could know for sure that every department requesting funds actually needs what they ask for.

Consequently, there is no telling just how much of our tax money just goes down the drain every year for out-moded and useless bureaus that Congress and the administration don't ever realize still exist.

A good example of spending money with little or no results, is the peace corps. It is not a great expenditure, comparatively speaking, but it is still a sizeable amount.

A former peace corpsman who spent a year in Africa with a bush country tribe returned to see just what he had accomplished in his year's work.

While he lived with the tribe, in a barren, droughty area in the jungles of Africa, he helped them set up an irrigation system which would afford them the opportunity to grow their own vegetables, something they didn't have. He was given peace corps funds to buy pumps and did wells, and was helped by the tribesmen to do the work. They set up small tracts for vegetables and other crops and the irrigation system worked well.

When he returned to see the results of his work after a few years, he found the village was just like it was when he first found it. The irrigation system has just vanished. The villagers were living the same way they had lived for centuries. They were just not interested in "progress."

But a young man, just out of college, with ideals about helping backward people to have a better life, spent a year of his life and our government spent a lot of money, and for what? Just experience?

There is no telling just how many peace corps projects ended the same way and how much money we have spent in futile efforts to make the world like us. It just can't be done.

Another item that takes a large cut of our budget is the Department of Defense. Of course we need a modern military, and we want the best. But what Congressman, even those on the military affairs committee, could know what and how much the military needs to keep it first class.

Like all other departments and bureaus of the government, the defense department makes their requests, and Congress acts, and that is that.

It would take years of study to weed out all the bureaus and departments that are still funded by the government and are serving no useful purpose.

But it would be a wise step to make that study, and it would probably pay off in the long-run.

NUMBER SIX ON THE BALLOT (S.J.R. 26)

Article V, Section 8 of the Texas Constitution is amended by adding a new paragraph which:

Provides that the district court, concurrently with the county court, shall have the general jurisdiction of a probate court and in a probate proceeding shall also have the jurisdiction otherwise conferred on it by law. It also provides that the legislature may increase, diminish, or eliminate the jurisdiction of the district court or county court in probate matters, may adopt rules governing the filing, distri-bution, or transfer of cases and proceedings as between the courts having jurisdiction of probate matters, and may provide that all appeals in probate matters shall be to the courts of civil ap-

The wording of the proposed constitutional amendment as it will appear on the ballot is as follows:

"The constitutional amendment stating that the district court concurrently with the county court shall have the general jurisdiction of a probate court, and providing the jurisdiction thereof, and further providing that in any pro-bate proceeding the dis-trict court shall also have jurisdiction otherwise conferred upon it by law, and further providing that the legislature may increase, diminish or eliminate the jurisdiction of the district court or county court in probate matters, and further providing that the legislature shall have power to adopt rules governing the filing, distribution and transfer of all such cases and proceedings as be-tween district courts, county courts, and other courts having jurisdiction thereof, and further pro-viding that the legislature may provide that all appeals in such matters shall be to the courts of (civil) appeals."

Article III. Section 49-b of the Texas Constitution is amended to:

Remove the present provision which permits buying of land only by those vet-erans who served between September 16, 1940 and the date of formal withdrawal of United States troops from the armed conflict in Viet Nam. This amendment would allow all veterans who serve after September 16, 1940 to buy land from the Veterans' Land Fund, provided they are otherwise

#### NUMBER EIGHT ON THE BALLOT (S.J.R. 29)

Article XI, of the Texas Constitution is amended by adding a new Section 5(a) which:

Authorizes and requires incorporated cities, towns, and villages, regardless of population and notwithstanding the constitutional limitations on total tax rates, to levy such annual ad valorem taxes on the taxable property in the city, town or village as are necessary to pay the principal of and interest on, when due, the general obligations here inafter issued by the city, town, or village. The legislature is empowered to limit by general or special law the total principal amount of general obligations which may be issued, but unless and until the legislature acts to do so, the limitations established by statute with respect to the total principal amount of bonds which may be issued by independent school districts shall apply as the rate limitation on cities, towns, and vil-

The wording of the proposed constitutional amendment as it appears on the ballot is as follows:

"The constitutional amendment to authorize cities, towns, and villages to levy such ad valorem taxes as are sufficient to pay the principal of and interest on their general obligations hereafter issued subject to the restrictions provided by law."

#### NUMBER NINE ON THE BALLOT (S.J.R. 25)

Article VIII of the Texas Constitution is amended by adding a new Section 2C which:

Allows the Legislature, by general law, to exempt all real and personal prop-erty used by non-profit water supply corporations or cooperatives from all property taxes. The exemption would apply only to such property as is reasonably necessary to conduct the business of a non-profit water supply corporation or cooperative.

The wording of the proposed constitutional amendment as it will appear on the ballot is as follows:

"The constitutional amendment authorizing the legislature to exempt from property taxes certain property used by a non-profit water supply corporation or a nonprofit water supply cooperative.

**PUBLIC NOTICE** CONSTITUTIONAL AMENDMENTS SPECIAL ELECTION NOVEMBER 6, 1973

NUMBER ONE ON THE BALLOT (S.J.R. 8)

Article III, Sections 5, 24 and 49a and Article VIII, Section 6 of the Texas Constitution are amended to:

Provide for regular annual sessions of the Legislature. The regular session in each odd-numbered year would be for a period not to exceed 180 days. The regular session in each even numbered year would be for a period not to exceed 60 days and would be limited to consideration of fiscal matters and any emergency matters submitted by the Governor. The 60 day session could be extended by the Governor for a period not to exceed 30 days;

Provide an annual salary for members of the Legislature not exceeding \$15,000 per year and a per diem not exceeding \$18 per day for each day of each regular session or special session:

Provide that no an priation of money shall be made for a longer term than one year and direct the Comptroller to make annual estimates of anticipated revenue rather than biennial estimates.

The wording of the proposed amendment as it will appear on the ballot is as follows:
"The constitutional

amendment to provide for annual regular sessions of the legislature; and to provide an annual salary of \$15,000 and per diem for the members of the legislature, effective in January, 1975."

> NUMBER TWO ON THE BALLOT (H.J.R. 7)

Article XVI, Sections 50 and 51 of the Texas Constitution are amended to:

Include within the scope of homestead protection the real property of a single adult person which meets the other requirements of homestead property, and to provide that a family homestead may not be abandoned except with the con-sent of both spouses.

Presently a single adult person is not entitled to claim a homestead exemption and a married man can abandon a family homestead without the consent of his wife.

The wording of the proposed amendment as it will appear on the ballot is as follows:

"The constitutional amendment to include within the scope of homestead protection the real property of a single adult person which meets the other requirements of homestead property, and to provide that a family homestead may not be abandoned except with the consent

of both spouses.

NUMBER THREE ON THE BALLOT (S.J.R. 13)

Article VIII, Sections 1-a and 1-b of the Texas Con-

stitution are amended to: Extend the \$3,000 ad valorem tax exemption to the residential homesteads of unmarried adults.

The wording of the proposed amendment as it will appear on the ballot is as follows:

"The constitutional amendment to extend the \$3,000 ad valorem tax exemption to the homesteads of unmarried

> NUMBER FOUR ON THE BALLOT (S.J.R. 1)

Article XVI, Section 59, of the Texas Constitution is amended by adding a new Subsection (e) which:

Provides that no law creating a conservation and reclamation district shall be passed unless a copy of the proposed law is delivered to the commissioners court of each county and to the governing body of each incor-porated city or town in whose jurisdiction said district or any part thereof is or will be located. Each such commissioners court and governing body may file its written consent or opposition to the proposed law with the Governor, Lieutenant Governor and Speaker of the House of Representatives. Each special law creating such a district must comply with general laws then in effect relating to consent by political subdivisions to the creation of such

districts. The wording of the proposed amendment as it will appear on the ballot is as

follows:

"The constitutional establishing certain requirements relative to the enactment of laws creating certain conservation and reclamation districts."

> NUMBER FIVE ON THE BALLOT (S.J.R. 12)

Article XI, Section 7 of the Texas Constitution is amended to:

Provide that all counties and cities bordering on the coast of the Gulf of Mexico are authorized to levy a tax to pay for bonds issued for the construction of sea walls and breakwaters upon a majority vote of the resident property tax-payers. Counties and cities are presently authorized to levy such taxes and this amendment only changes the required vote from a two-thirds majority to a simple

majority. The wording of the proposed amendment as it will appear on the ballot is as follows:

"The constitutional amendment authorizing counties and cities bordering on the Gulf of Mexico to issue bonds **NUMBER SEVEN** ON THE BALLOT (H.J.R. 6)

Provide for an additional \$100 million in bonds or obligations of the State of Texas for the Veterans' Land Fund. This amendment increases the present \$400 million authorization to \$500 million;


