Prepare Your Carfor Winter

Getting your car ready for winter's severe temperatures and driving conditions should involve a lot more than just adding antifreeze. The American Petroleum Institute has developed a check list that may help you get ready for the cold weather ahead.

But first, let's look at anti-freeze. Today's cars are

Change Anti-Freeze

Anti-freeze solutions also act as rust inhibitors and water-pump lubricants and contain additives that lose their effectiveness after a year's driving.

When changing antifreeze, begin with a careful check of the condition of the radiator hoses, thermostat, and radiator. Have your mechanic "pressure test" your cooling system. Replace worn hoses before they leak.

If all systems check out, drain and flush the radiator. Replace the coolant liquid with a 50-50 mixture of water and ethylene glycol type anti-freeze. This will offer maximum protection. Do NOT use 100% anti-freeze, use the 50-50 mixture—it's cheaper and more efficient.

designed to use the "permanent" or ethylene glycol type — not the older "alcohol" base variety. Although it is called permanent antifreeze, it should be replaced at least once a year, or if your car is equipped with air conditioning, twice a year.

Do not overfill the radiator; fill only one or two inches from the top — if it is too full, the overflow that

occurs when the engine heats up will spill the anti-freeze onto the street.

PRESIDENT NIXON has suggested that Congress impose a "forced savings" on income tax payers in an effort to curb inflation.

We believe that such action would be about as administration practical as some other suggestions, when we try to foresee just what would be accomplished by such action.

In the first place, the taxpayers who really carry the load in this country are not the cause of inflation. Inflation is caused by the spending of vast sums of money and the government itself is the real culprit.

Income taxes are paid by people in the \$6,000 to \$25,000 earning bracket. Most of them are having a hard time getting along with inflation such as it is, without imposing another penalty on them. Those below that income level, pay little or no taxes and those above that group also pay very little of the income tax revenue, so the act would be discriminatory to say the least.

When we get down to it, the proper solution would probably be like one congressman put it: "Instead of raising taxes, we ought to see where we can spend them more wisely and withless waste. "That would be more help in cutting inflation than anything we can think of.

We are not smart enough to know the answer to the inflation problem, but it is evident that a lot of solutions thought out by the "Smart boys" didn't work either. It seems that nobody really knows what to do about it, but one thing we do know is that this country was founded and ran for years on the law of supply and demand. That seems to be the answer still. If business and individuals alike had less interference from the government and had to make it on their own, we believe that sooner or later things would level off.

Anytime there is a shortage of any item, prices go up, but when the supply meets the demand, then things get back to normal. But when the government steps in and limits production, or sets quotas or freezes prices, then the people just react. They do not like that kind of supervision, and, like anyone else-if they can't make something, they will not work.

Who can blame them?



High Value Set On Deer Meat Bagged in '72

AUSTIN--Texas deer hunters took home almost \$12 million worth of venison during the past season, according to Texas Parks and Wildlife Department officials.

The figure is based on the amount of boneless meat from 14,400 mule deer and 362,000 white-tailed deer killed during the 1972-73 season and the November 1972, price of ground beef chuck which averaged \$.85 per pound statewide.

The average field-dressed mule deer weighed 106 pounds and yieided an estimated 53 pounds of boneless meat, while whitetails field dressed at approximately 73 pounds and yielded slightly more than 36 pounds of boneless meat.

The total amount of boneless mule deer meat harvested in Texas was approximately 762,000 pounds and valued at more than \$647,000.

Whitetails yielded approximately 13,174,000 pounds of boneless meat valued at more than \$11,198,000.

Department officials say that rising beef prices should raise the value of venison considerably during the coming season.

Although the bag limit for white-tailed deer in many parts of Texas is three, a few hunters (approximately seven percent) harvested that many last year.

Only 37 percent of deer hunters killed two or more deer, according to a deer and turkey harvest survey for the 1972-73 hunting season conducted by the Texas Parks and Wildlife Department. The bulk of whitetail deer hunters, 62 percent, killed only one deer during the entire season.

The information from the survey came from responses to 38,774 questionnaires mailed to a random sampling of hunting license holders.

PUBLIC NOTICE CONSTITUTIONAL AMENDMENTS SPECIAL ELECTION NOVEMBER 6, 1973

NUMBER ONE ON THE BALLOT (S.J.R. 8)

Article III, Sections 5, 24 and 49a and Article VIII. Section 6 of the Texas Con-

stitution are amended to: Provide for regular annual sessions of the Legislature. The regular session in each odd-numbered year would be for a period not to exceed 180 days. The regular session in each even numbered year would be for a period not to exceed 60 days and would be limited to consideration of fiscal matters and any emergency matters submitted by the Governor. The 60 day session could be extended by the Governor for a period not to exceed 30 days;

Provide an annual salary for members of the Legislature not exceeding \$15,000 per year and a per diem not. exceeding \$18 per day for each day of each regular

session or special session; Provide that no appropriation of money shall be rm one year and direct the Comptroller to make annual estimates of anticipated revenue rather than biennial

estimates. The wording of the proposed amendment as it will appear on the ballot is as

follows: 'The constitutional amendment to provide for annual regular sessions of the legislature; and to provide an annual salary of \$15,000 and per diem for the members of the legislature, effective in January, 1975.''

> NUMBER TWO ON THE BALLOT (H.J.R. 7)

Article XVI, Sections 50 and 51 of the Texas Constitution are amended to:

Include within the scope of homestead protection the real property of a single adult person which meets the other requirements of homestead property, and to provide that a family homestead may not be abandoned except with the consent of both spouses.

Presently a single adult person is not entitled to claim a homestead exemption and a married man can abandon a family homestead without the consent of his wife.

The wording of the proposed amendment as it will appear on the ballot is as follows:

"The constitutional amendment to include within the scope of homestead protection the real property of a single adult person which meets the other requirements of homestead property, and to provide that a family homestead may not be abandoned except with the consent of both spouses.'

stitution are amended to: Extend the \$3,000 ad valorem tax exemption to the residential homesteads of unmarried adults.

Subsection (e) which: Provides that no law creating a conservation and reclamation district shall be passed unless a copy of the proposed law is delivered to the commissioners court of each county and to the governing body of each incorporated city or town in whose jurisdiction said district or any part thereof is or will be located. Each such commissioners court and governing body may file its written consent or opposition to the proposed law with the Governor, Lieutenant Governor and Speaker of the House of Representatives. Each special law creating such a district must comply with general laws then in effect relating to consent by political subdivisions to the creation of such

The wording of the proposed amendment as it will appear on the ballot is as

'The constitutional amendment establishing certain requirements relative to the enactment of laws creating certain conservation and reclama-tion districts."

> NUMBER FIVE ON THE BALLOT (S.J.R. 12)

Article XI, Section 7 of the Texas Constitution is amended to:

Provide that all counties and cities bordering on the coast of the Gulf of Mexico are authorized to levy a tax to pay for bonds issued for the construction of sea walls and breakwaters upon a majority vote of the resident property tax-payers. Counties and cities are presently authorized to levy such taxes and this amendment only changes the required vote from a twothirds majority to a simple majority.

The wording of the proposed amendment as it will appear on the ballot is as follows:

"The constitutional amendment authorizing counties and cities bordering on the Gulf of Mexico to issue bonds

paragraph which: Provides that the district

court, concurrently with the county court, shall have the general jurisdiction of a probate court and in a probate proceeding shall also have the jurisdiction otherwise conferred on it by law. "The constitutional amendment stating that the district court concurrently tne county court shall have the general jurisdiction of a probate court, and providing the jurisdiction thereof, and further pro-viding that in any probate proceeding the district court shall also have jurisdiction otherwise conferred upon it by law, and further providing that the legislature may increase, diminish or eliminate the jurisdiction of the district court or county court in probate matters, and further providing that the legislature shall have power to adopt rules governing the filing, distribution and transfer of all such cases and proceedings as between district courts, county courts, and other courts having jurisdiction thereof, and further providing that the legislature may provide that all appeals in such matters shall be to the courts of (civil) appeals."

NUMBER SEVEN ON THE BALLOT (H.J.R. 6)

Article III, Section 49-b of the Texas Constitution is amended to:

Provide for an additional \$100 million in bonds or obligations of the State of Texas for the Veterans' Land Fund. This amendment increases the present \$400 million authorization to \$500 million;

Remove the present provision which permits buying of land only by those vet-erans who served between September 16, 1940 and the date of formal withdrawal of United States troops from the armed conflict in Viet Nam. This amendment would allow all veterans who serve after September 16, 1940 to buy land from the Veterans' Land Fund, provided they are otherwise qualified;

Provide that, in the event of the death of an eligible

law.'

Article VIII of the Texas Constitution is amended by adding a new Section 2C

Allows the Legislature, by general law, to exempt all real and personal prop-erty used by non-profit water supply corporations or cooperatives from all property taxes. The exemption would apply only to such property as is reasonably necessary to conduct the business of a non-profit water supply corporation or cooperative.

The wording of the proposed constitutional amendment as it will appear on the ballot is as follows:
"The constitutional

amendment authorizing the legislature to exempt from property taxes certain property used by a non-profit water supply corporation or a nonprofit water supply cooperative.'

U.S. Department of Agriculture's farm storage and drying equipment loan program is being raised to reflect increased borrowing costs of money to Commodity Credit Corporation (CCC). The interest rate will be increased from 6.0 percent to 8.75 percent, per annum, computed on a daily basis.

In addition, the amount of down payment required by borrowers is being raised from 15 to thirty percent because of the acceleerated pace at which onfarm storage is being added. The changes will become effective for loan applications filed on or after Sept. 17, 1973.

The changes are designed to maintain program activity at a level which will more nearly reflect the current storage situation rather than the situation that has prevailed over the past several years, and they should result in a reduction of federal government expenditures in fiscal year 1974, the Department explained.

Under the farm storage and drying equipment loan program farmers can secure CCC loans to finance on-farm storage and drying facilities needed for grain and other commodities. Record use was made of the program during fiscal year 2973 when 41.046 loans were made for \$156.6 million representing more than 313.5 million bushels of storage capacity.

Storage and equipment loans have been available since 1949.

Weevils' Travel

Habits Clocked

Fall is apparently the favorite time of the year for travel by boll weevils.

While this information may not be of much help to travel agencies, the National Cotton Council says it is an important clue to scientists who are working to perfect better control methods for the cotton pests.

The distance covered by the weevils in their fall gallivanting also interests scientists. By clocking the insects' mileage, they can determine the size of an area that should be included in large-scale control experiments.

Results to date indicate that control areas should be extensive. More than 300,000 weevils were caught, marked. and released in the recent study. Some were retrapped two miles away after two months, while others flew 16

miles in two weeks. The record traveler, however, was one jet-age weevil that turned up 25 miles away after only four days.
