

The local American Legion post has been inactive for several years but was not disbanded. The charter is still intact, and only reorganization is needed to become active again.



The annual Christmas season opening in Santa Anna will be held next week, on Friday, December 7. Plans are underway for the activities on that day and for the holiday activities during the following weeks.

Local businesses are to unveil their Christmas decorations on that day, and the Lions Club Pancake Fiesta will be held during the day.

A downtown parade is planned for 2 p. m., and will feature bands. floats, and Santa Claus.

Everyone in the community is invited to be in town all day Friday, December 7, to take part in the holiday activities.

#### Proposed in Improvements Santa Anna School District voters will go to the polls on Saturday, December 15, to decide on a bond issue totaling \$600,000. The proposed improvement project has been in consideration for several years and was planned

with the help of a citizens committee. The initial project in the program will be the remodeling of the present high school building and construction of a new gymnasium. The project will also include a new home making building and covered walkways between the buildings if enough money is available. Otherwise the

pesent homemaking department

will be remodeled. The present high school building, built in 1927-28, is of sound construction. The building is of steel and masonry with the only wood in the floors ceilings and woodwork. It is basically a better building than could be built at the present time.

A new roof, using as much of the present roofing as possible, will be added under the proposed project. The exterior walls will be cleaned, and a new heating and

cooling system added. The present steam heating system is completely inadequate and has not given proper service for several years.

Better lighting, new metal windows, stair treads and ceilings are also proposed. Also planned is new floor covering, insulation, painting and redecoration as needed.

The planned improvements are to keep present and future accreditation and to bring the fine old building up-to-date to meet modern standards

The new physical education building will provide facilities for all grades and replace the present gymnasium which was constructed in 1948 as a temporary structure. However, the old gym would be left for auxiliary useas long as possible.

A homemaking building, planned to adjoin the high school on the east, would give more classroom space in the high school building. Construction of the new facility would cost about \$10,000 more than renovation of the present department and in addition release the needed space in the present building for other classes.

Local voters are being asked to help provide children in the community with good educational facilities. The plans are being made to provide buildings arranged and equipped for today's teaching methods, and to meet future needs.

Information on the proposed bond election is being prepared for each voter, and will be made available to everyone in the district within a week or two. Included in the information is the exact cost to each taxpayer. The tax increase will still be well under the tax rate of most school districts in the area.

Absentee voting in the election will be done at the school business office starting next week and continuing until December 11. The election on December 15 will be held at the Vocational Agriculture building with Glen Copeland as election judge.

The Santa Anna Independent School District is in excellent financial shape, and the proposed bond issue is the first major project for the district since the Elementary School building was constructed about 1950.

## In Our Opinion

THE ENERGY CRISIS was put on the shoulders of the people Sunday night when President Nixon told the nation what he proposes to curtail use of fuels in the months to come.

Actually his proposals will not be mandatory until Congress acts with the possible exception of the use of heating oil.

However the setting of a national 50-mile-an-hour speed limit is possibly not within the jurisdiction of the President. According to the Texas Good Roads Association, the President, nor the governor has the authority to set speed limits on highways, even though they may be federal highways or interstate highways. Only the State Legislature has that authority, and they are not in session, and probably will not be for some

Even the highway department cannot change the speed limits except for safety reasons. Conceivable the President could call the present condition an emergency.

The highway patrol, although theydo not say so publicly, are apprehensive about a 50-mile an hour speed limit. Those who are already dropping their speed on a voluntary basis, are causing problems to the law enforcement agency. They are causing traffic snarls and long lines are building up on single lane highways to the point where drivers are taking more chances in passing the slow drivers. This could become as much a hazard as the fuel shortage.

The highway department doesn't look forward to a slower speed limit in that it would cost \$800,000 to change the 35,000 speed limit signs on Texas highways.

As for the closing of service stations on Sundays, that may, or may not have very much effect on the use of fuels. Those who plan to drive on Sundays could purchase their gas on Saturday night, even though they possibly could not drive as far as they would like. Also the sale of gas cans would probably boom.

Another effect on the highway department is the fact that, if the lowering of the speed limit did save fuel, every gallon saved would cost the department five cents tax money.

Many think that a compromise on 60 miles per hour would receive a lot more cooperation from the motoring public. It will be hard for anyone who makes his living traveling from city to city to drop his speed 20 miles an hour and still cover his territory. He would either have to make his calls less frequent or cut his territory to match his travelling time, and that would mean less money for him.

Many of us would go along with most things in the matter of the fuel crisis if we were convinced that the shortage is really as bad as they sav. There is skepticism among some in knowledgeable places on whether it is as bad as we are told.

Another thing that bugs drivers is that much fuel is wasted on bad roads and poorly-timed traffic lights. Bumpy roads with frequent slow downs and stops burns up more fuel than speed, and having to stop at every intersection because of the timing of traffic lights is a major factor in fuel consumption.

## SA Adventists Start Campaign For Ministries

Seventhth-day reaction to a devaluated dollar will be reflected in the church's World Service Appeal this year. John D. Loveridge, Santa Anna pastor, explained that an increase in the goal has been necessary to help compensate for the loss in the buying power of the U.S.

Saturday evening, the 24th, is the date set to launch the campaign, which is to help become acquainted with the worldwide ministries of the church, as well as to raise funds for their service support.

"A loss to our work of \$3.5 million has resulted from the dollar devaluation,'' Loveridge said. "This problem, added to continuing inflation, makes this year's campaign more important than usual''

The immediate crisis of devaluation was met with special appropriations from the reserve funds, plus a worldwide "dollardevaluation offering" which was taken in all churches. Members were urged to increase their weekly giving. As a result no overseas personnel have been brought home.

During the next two weeks volunteers will be calling from door to door to distribute free copies of THESE TIMES magazine, which has been especially prepared for the appeal. This issue depicts the church's work around the world and reports accomplishments during the past year.

Most of the church's \$59 million budget this year is supplied by donations from its own members. This gives nonmembers an opportunity to help to whatever extent they desire.
