Smith Inducted Into **Tennis Hall of Fame**

R. C. Smith, who retired from coaching tennis after the 1985 school year, was inducted into the Texas Tennis Coaches Association Hall of Fame last Saturday night in a ceremony held at Newts Tennis Ranch in New Braunfels.

Over the years since 1975, Smith's tennis program had produced 67 regional qualifiers and 44 state qualifiers.

Smitty, as his friends and associates refer to him, retired from full time teaching on November 30, after 33 years, 20 of which were spent in Santa Anna.

After taking December off, Smith will return as a teacher in the local system in January and will be teaching 3 math classes as a halfday teacher.

In reference to Smith's tennis program, a few of his tennis players were contacted for comments. Here are some of those comments.

Rusty Buzzard, now a coach at Phlugerville, said "It was easy to play for him because he treated you with respect. He allowed you to do your best. A true coach and a leader

in the community. Thanks, coach, for all you have inspired." Buzzard was one of Smith's state qualifiers. Tommy DeLeon, a state doubles champion had this to say, "Smith is a man who has taught me something very valuable and this is to be the best you can be."

Junior Salazar, also a state champion says, "Mr. Smith is always respected by his players, other coaches and friends. He is what a tennis coach should be."

Janis Weathers Salazar told us that "He always had time for everyone. He even invented 'special gadgets' to improve my serve. He would do anything to help."

Julie Jones Clifton, a state qualifier, had this to say, "He was always there with us and for us, no matter how many hours it took. He taught us that all that hard work paid off in the end result."

Doug Warnock, a sophomore student at Angelo State University, says "If I become a coach I would hope to be as dedicated and successful as Mr. Smith." See related story inside.

The Santa Anna City Council met with all members present on Thursday, December 4, 1986. The minutes of last months meeting were read and approved.

The man whose petition called for Reporter News Saturday evening have benefitted Santa Anna all that after the results of the election were much if it had passed, because any

large chain liquor stores would have probably set up business outside the city limits, and the city would not have received taxes on sales made. Copeland said another election could be called by petition if the issue were changed-such as calling for the sale of beer and liquor, but not wine. Otherwise, a wet-dry election cannot be held for at least a year. John Stanislaw, who headed the opposition to liquor sales, said he was not aware of Makuta's charges. He said Saturday's vote reflected the community's views pretty well. "The people have decided how they want it." he said. Makuta said that Saturday's election proved that at least 445 people take an interest in the town and they will not let the city of Santa Anna dry up and die.



Anna said in an earlier quote, that the issue's defeat was "crooked as hell." In talking with that man, Mike Makuta, on Monday morning, this reporter got this quote, "I'm happy with the results. It proves to me that 37 percent of the people who voted are unhappy with what's happening in our town."

The election issue, which would have allowed the sale of beer, wine and liquor in stores, was defeated by 278 to 167 votes, Glen Copeland, election judge, said. The Coleman County Commissioners canvassed the returns Monday morning. The issue-the first wet-dry vote in

the city-would not have allowed liquor sales by the drink and, thus, would not have allowed bars to open. Nevertheless, the issue created a fair amount of controversy.

In an earlier quote to the Abilene

released, Makuta said that more people voted for the issue than the returns show. The 181 people who signed the petition calling for the election told him they voted for alcohol sales, he said, and yet that number of people does not show up in the vote tally.

Copeland, however, said all ballots were cast correctly. "I have never had an election go smoother than this one," he said.

Makuta told the Abilene Reporter News that he will try to have the election called again and that he will ask state election officials to count the vote, but he told the Santa Anna News that he will not pursue for another election. If someone else wanted to pursue the issue and try to have another election, he did not want any part of it, he said. Makuta said that he felt like it would not


At Camp Moscrip



I thank God and I praise Him that the tests came back negative. Dr. Barrett says I have some disk damage but with physical therapy it can be taken care of.

What is fear? I think fear can be put into two camps. One being the fear of the unknown. And the other the fear of the known. And at the same time what can help us overcome our fears or live with our fears can be put into two camps. Those two words are: faith and hope.

What about the known fear in your or my life. We know there is something wrong but we do not know what to do with it. Let me suggest three things we can do with known fears. First we can confess them to God. We have to acknowledge our fear. We cannot deal with fear until we come to the point of saying yes we do have fears. When we do this then we can deal with them. The second thing is to trust God. God does not know fear, we can trust one who does not know fear. And third we can thank God. Many of our fears never come to pass and the ones that do we can thank God that He is with us even in the darkest hours. I believe faith can take care of our known fears.

But what about that unknown fear. That general feeling deep down inside. We can't put our finger on it but the juices of fear are in the pit of our stomachs.

Hope is one of the greatest words in the Christian vocabulary. The very word itself shines like light in darkness, joy in sorrow, life in death. Hope is what holds it all together sometimes.

Hope has been said to be faith and

life. When that happens think of that little group of believers, suffering persecution and tribulation. Paul wrote to them these words "to the obtaining of the glory of the Lord." (2 Thess. 2:14).

Sometimes we do not know! We just have hope. There is a story of a man who had nothing but hope. A group of college students were enroute from New York to Florida for a weekend. As their bus passed through New Jersey a man dressed in a plain ill-fitting suit sat down in front of them. He had been in jail for the last four years and now he was going home. For the last three and a half years he had had no contact with his wife and children. At the beginning of his imprisonment he had written to his wife telling her that he would be away for a long time and if she wanted to forget him and marry someone else it would be alright. He would understand. One of the young people said "And you are going home not knowing." "That is right," he said. He had written his wife the week before when he knew for certain he would be getting out. He told her that if she wanted him back to tie a yellow handerchief on the oak tree that grew in front of their house. If there was no yellow ribbon, then he would continue on and not stop. When they got there, there were many Yellow Ribbons in the tree. He was going home at last!

Sometimes all we have is hope itself. But as the story tells us, we can always go back home!

THINK ABOUT IT: Faith, hope and love make up the pillars of the Christian life. Hope goes the deepest into the heart of God.







"SMITTY" WINS IT ALL !!!

SANTA ANNA NEWS

In 1981, R. C. Smith was named Texas Tennis Coach of the Year for all classes of schools. It was an honor he thought could not be topped until last Saturday night, when he was inducted into the Texas Tennis **Coaches Association Hall of Fame at** a ceremony held in New Braunfels. A host of family and friends and former students were present to watch the presentation. His wife, Pat, was there along with their children, Dick and Karen Smith of Rotan; Vickie and Robbie Drake of Angleton; and Lori of Santa Anna. Friends and tennis students in attendance included David Robinett, Stacie Gunter, Judy and Stephanie Hartman, Russell and Kathy McGough with Nikki and Amy, Ernest and Shannon DeLeon, all of Santa Anna: Tommy DeLeon of Ft. Worth; Alice and Rusty Buzzard of Phlugarville: and Junior and Janice Salazar of Coleman.

In 1983,Smith had been named Tennis Coach of the year for Class A schools and a couple years ago was honored by the Booster Club as Santa Anna's winningest coach.

"Santa Anna Wins It All" became a faniliar headline in the years since Smith started his program beginning in Jr. High and soon including High School.

It became commonplace for "Smitty's kids" to walk away with district and regional titles and then twice "his kids" came home from the state tennis tournament with the championship and runner-up medals.

Winning was an attitude with the tennis players Smith coached. He says "It wasn't my ability with the tennis racket or my knowledge of the game; it was because we had, for some reason, dedicated people who in their minds, wanted to get to the state meet." He adds, "My best asset was showing an interest in the kids. They had the dedication and went on the court expecting to win." He claims that was the key to his success as a tennis coach "in a nutshell."

A graduate of Ranger High School, Smith played his first tennis when he

and other interested students began playing on a district level although uncoached. He became serious about tennis while coaching football and track at Taylor where his fellow coaches played tennis.

A graduate of North Texas State University, Smith first came to Santa Anna in 1959. After five years he left to coach football and track at Lockhart, Valley Mills and Taylor. He returned to Santa Anna to become High School Principal in 1969 and 1970. He then went back to Taylor to coach and returned to Santa Anna in 1972 to stay.

Smith has spent 20 years altogether in the Santa Anna Schools, serving several years as superintendent. After 33 years, Smith retired from full time teaching on November 30, 1986. After taking December off, he will begin teaching part time in January when he takes on three math classes.

Thru the years he has offered adult summer tennis programs in both Santa Anna and Coleman, helping to build an interest in the sport in this area.

"Smitty's" first state qualifiers were the doubles team of David Robinett and Jody Day, both juniors, defeated in the first round of the state tourney in 1975.

The two returned to the state meet the following year after winning over their freshmen teammates Terry Day and Tommy Harris at the regional meet. Harris and Day lost in the first round of the state tournament while Robinett and Day were runners-up to the state championship.

1977 saw Harris and Day make their 2nd trip to the state tourney, advancing to the semi-finals. They were back in 1978 and won the 2nd place medals.

Smith's son, Dick, and doubles partner, Jim Young, were quarterfinalists in 1978.

May 1979 was a time to be remembered in Santa Anna Tennis History. That was the first of two times when "Smitty's kids" would bring home both the state championships and runner-up medals in boys doubles. For the first time in UIL competition, the team of Dick Smith and Don Eubank won over team-

mates Tommy Harris and Terry Day to bring home the Class B State Championship. Harris and Day had

won the district and regional titles while Smith and Eubank had gone to Austin as the regional runners-up. Day and Harris set a record by making their 4th trip to the state tournament.

Danny Guerrero was a qualifier in 1979 as a singles player, defeated in the first round but returning the next year to claim the Class B Singles Championship. He remains the only singles qualifier from Santa Anna.

Rusty Buzzard and Tommy DeLeon were the Santa Anna doubles entry in state competition in 1980, defeated in the first round.

1981 was a record year in number of Santa Anna students qualifying for state. Six of "Smitty's kids" traveled to Austin that year to compete. Daughter Lori and her doubles partner, Julie Jones (Clifton) advanced to second round. The boys doubles team of Buzzard and DeLeon made their 2nd trip. Pauly Vasquez and Junior Salazar were also there. Both boys teams bowed out after the first round of play.

Julie Jones returned in 1982 with Karen Wetsel (Smith). The girls doubles advanced to the semi-finals.

1982 was another "win it all" year for the boys doubles teams. Salazar and DeLeon defeated teammates Mike Hartman and Pauly Vasquez in the championship match.

DeLeon and Vasquez returned as partners in 1983 and won the state championship. Smith described them as the strongest team he ever coached. They had defeated the Class 2A and Class 3A state cham-

pions earlier in the year. Karen Wetsel (Smith) and Robin Hartman (Guerrero) represented Santa Anna in girls doubles, advancing to the semi-finals.

1984 qualifiers were Pauly Vasquez and Chris DeLeon advancing to the semi-finals. Doug Warnock and Johnny Vasquez were state quarter-

finalists. Doug and Chris were also quarterfinalists in 1985.

R. C. Smith hung up the tennis coaching racket after the 1985 season, but don't expect to see him inactive. He can still be found on the courts on any given afternoon. And you can bet he will be available to "his kids" for a match or to be of

help with the problems of their games. When not found on the tennis court he will probably be on the golf course as he is also an avid golfer.

This writer believes that Smith's success as a coach and teacher can

be summed up with an incident that happened in 1972 when he was urged by the basketball coach from Novice

to enter a basketball team in a peewee tournament. They needed another team to complete their brackets. Smith told him there was

no 6th grade team in Santa Anna, but he would try to put one together. He rounded up some boys and practiced only three or four times before entering the tournament and winning 2nd place.

Before the weekend was over, the scrappy little team was a crowd favorite because of their spirit and determination. When asked how he had accomplished the task, Smith

replyed that he had just never told the younsters thay did not know how
