#### **Coleman County** Tax Appraisal **Board Meets**

The Board of Directors of the Coleman County Tax Appraisal District met in regular session Monday, March 13. Barbara Kingsbery, chairman, led the session with all members present, being Harold Skelton, Charles Yarbrough, D. G. Allen and Billy McCrary. Also present was Chief Appraiser Bill Jones.

In addition to routine items on the agenda, Collier Watson and Jane Patrick met with the Board to pre-Patrick Watkins, Larry LeJeune, sent the audit report for 1994. No changes or recommendations were presented. Also given was the audit for the County Education District funds of which Mr. Jones is successor in interest for the collection.

> Tax collections for all the entities for January and February totaled just over one million dollars. The majority of the amount was received in January as people took advantage of the discount. Total collections are at nearly 84 percent with is ahead of the previous year. Panther Creek ISD leads with 88 percent collection; Santa Anna and Novice have received 87 percent of the 1994 taxes.

Mr. Jones reviewed the report that shows the local district at 100 percent according to the State Comptroller's Property Tax Division.

The first review of the 1996 budget was made, with final approval to be made in May. The budget is also reviewed by each taxing entity before final approval

Mr. Jones announced that Darrell Hohman has accepted an appointment to the Appraisal Review Board, along with Jimmy Hobbs and James Hunter. Bruce Pittard was reappointed to the Agriculture Board to serve with Don Rhone and Jerry Allen.

#### Former Santa Anna∖ Resident Annie Lora **Rollins Turns 101**

The following article was urnished to us by a reader who saw it in the Cen-Ten Senior News.

Former Santa Anna resident and a current resident of Granbury Annie Lora Rollins was honored on February 4 at Songbird Lodge. The celebration was marking her 101st birthday which was February 7.

She was born Feb. 7, 1894, the youngest of eight children of Thomas Lee Robertson and Fannie Bowers Champion. After losing her father at six months of age and her mother a few years later, she moved to Lohn in McCulloch County. In later years she moved to Coleman County where she has lived most of her life.

# Fishing Lake Ivie

Crappie fishing has been fair to good of late. Use minnows or jigs fishing about 10-20 foot depths. A few keepers are being caught in the upper end of creeks and Colorado and Concho rivers. Night fishing has been the best, especially on the Concho.

The cold weather last week made the black bass move to deeper water but as the temperatures began to warm we were finding them a little shallower again. Some keepers are being caught on spinner baits and worms up the creeks. Plastic worms fished on points in the main lake are best bet for big bass.

Fishing for smallmouth bass has been fair in 20-30 foot depths in rocky areas, along ridges and in the main lake.

Conditions are fair to good for catching channel blue catfish on trotlines baited with shad. They are located in about 10 feet of water in the river channels. Fishing for Yellow cat has also been fair, using perch and goldfish on trotlines up the rivers.
