

The 75th Texas Legislature is now half over. The major issues attracting the most press coverage are the Governor's proposed property tax changes, water issues (Senate Bill 1) and the deregulation of retail electric power. These are issues vital to Texans, however, they are only three of the large number of important topics that will face the Legislature during this session. Homestead equity lending (there are three different versions of this on the table), public school funding, additional tort reform measures and Initiative and Referendum, are only a few of the many other is-

It is my pleasure to report that a high level of bipartisan cooperation still exists in the State Legislature. Governor Bush, Lt. Governor Bullock and Speaker Laney have established great rapport and continue to work together on the issues in a commendable manner. One new challenge exists as the Federal government sends funds back to the states through block grant for such ongoing needs as Medicare, programs for the elderly, highway and transportation funding and numerous health and human service needs. This change places the burden of prioritization back on the state to determine how federal matching funds can be utilized most effectively. While this is good, it does create new challenges and responsibilities for state government.

I have introduced a number of bills and will list a few to give you an idea of the wide array of things that I will be working on during the next few weeks. They are:

*House Bill 190--Prohibits entities from condemning certain properties for the purpose of providing mitigation property for endangered species or their habitat or wetlands as required by the Federal Endangered Species Act and The Clean Water Act.

*House Bill 195--Increase the penalty for certain crimes against the elderly.

*House Bill 2020--Requires platted subdivisions to prove an adequate source of water for the proposed subdivision prior to approval of the plats and sale of property for that purpose.

House Bill 1611--Relates to the testing of natural gas piping systems in public school facilities.

*House Bill 192--Relates to the offense of criminal trespass on agricultural lands.

*House Bill 680--Provides limits of liability for industries which donate fire fighting equipment to the Texas Forest Service for redistribution to volunteer fire departments

*House Bill 828--Provids leg-

islative review and Gubernatorial suspension of certain rules promulgated by state agencies. In many ways I consider this my most important piece of legislation.

The legislative process for each bill is lengthy. Every bill first must be drafted by the Legislative Council and then filed with the Chief Clerk of the House. A separate request for a hearing must be made before a bill can be heard before the appropriations committee. The bill is then presented to that committee with appropriate testimony to support our position. Needless to say, those who oppose the legislation have the same right to state their position to the committee. Then, if one gets through this maze and the bill is approved by the committee, you hope to have the bill placed on the House calendar. Next, you have the opportunity to have your bill come before the entire House. During this process your opposition also has the opportunity to state their position to try and kill the bill, or in many cases, make amendments to your bill. This only starts the process. If the bill passes the House a member of the Senate must then be contacted to sponsor the legislation in the Senate. The Senate will go through the same committee and full Senate voting exercise. However, if a change is made between the Senate and House approved versions, a conference committee consisting of both House and Senate members must attempt to work out the differences. Then both the full House and full Senate have to vote final approval. Finally, you must have the approval of the Governor, who holds the power to veto your bill, even

after legislative passage. This session I have filed over 30 bills which have required hundreds of hours of preparation, study and debate on the part of my staff and me. This is necessary if we are to be successful with our legislative package. The involvement of House members in the legislative process varies drastically. Some carry almost no legislation, while others carry a large number of bills. In the process of securing persons to testify either in support or in opposition to legislation before the House and Senate committees, we often call on folks like yourself to come to Austin and assist us in the

Further, I feel that one of the most important things I accomplish during the session is defeating bills that harm rural Texans. Recently, I defeated a proposed amendment to the general appropriations bill which would have eliminated Regional Education Service Centers. I also helped defeat a bill which would have eliminated the Commission on Jail Standards. Both of these things, had they passed, would have been very bad for rural Texas.

My final thought is this: Government is run by those who show up. Laws are either made or killed by those who show up. It is extremely important that those citizens who are common sense business, professional, agricultural producers, educators, elderly and generally interested folks continue to be involved and "show up". I assure you that those who do not share your common sense approach to issues do show up at every single hearing and speak their piece.

On yet another note, we welcome your visit during the session, which does not end until the first of June. A number of school groups have already visited us at the Capitol, had a tour, pictures taken, and an opportunity to observe the House and Senate, as well as committees in action. Legislation To Make You-Creativity-Possible Veterans. Care Home

AUSTIN-State Representative Bob Turner (D-Coleman), David Counts (D-Knox City); Bob Hunter (D-Abilene), Rob Junell (D-San Angelo) and Elliott Naishtat (D-Austin) have coauthored legislation to help make possible a state veterans care home in Texas. House Bill 2358 gives the Veterans Land Board the authority to establish veterans assistance programs, such as veterans assistance centers or care homes.

The number of veterans 65 years of age or older in Texas currently in 504,000, with that number expected to grow to more than 525,000 by "We estimate there are 16.500 veterans in the state Medicaid program. Around 1,600 of those are in nursing homes with their care being funded by Medicaid. It's very evident to me that there is a real need for this program. Sixty five percent of the cost of the facility's construction is federally funded, with the other 35 percent being funded by the state. Fiscally, this proposal makes sense, and more important, it's the right thing to do for the veterans who have served our state and country.' Turner continued.

Currently, veterans in Texas receive nursing home care in either nursing home care units, at Veterans Administration Hospitals, or contracted community nursing homes, which currently costs the state's Medicaid approximately \$20.00 a day, per client.

According to Representative Rob Junell, Chairman of the House Appropriations Committee, the construction of such facilities in the state could produce a significant costs savings. "A recent study submitted to the legislature indicates that three 150-bed facilities, in Texas operating at 90% capacity, would save the state \$30 million. over a ten-year period. The cost savings stems from a per diem payment to the state for each day of nursing care rendered in a facility, with the veterans paying a daily copayment from the amount of their VA pension or social security." stated Junell. The current per diem rate for facilities is \$39.74.

As far as I'm concerned all military veterans are my constituents and I am here to look out for their best interest. The very least we can do is to provide for Representative Bob Turner is a military veteran. Turner served in the United States Army, retiring after 35 years of service as a Lieutenant Colonel in the U. S. Army Reserve.

Is it Taxable?

Most people know that wages from a job are part of their income, and if they have enough, they will have to pay taxes on them. Butwhat about profits from hobbies, interest, dividends or unemployment compensation? They are also part of gross income—the same as

wages and any other income that's winnings are taxable income. Trips, not specifically excluded by law. All gross income is added together included in income at their fair to find out if one owes tax and how much. Here are some other examples to consider when filing the 1996 income tax return.

Tips Are Income, Too Tips are taxable income and must be reported as wages on the tax return. This includes the value of noncash tips, like passes, tickets. goods or services. Employees must

of \$20 or more.

Pay Taxes on Odd Jobs, Too People who make \$400 or more working for themselves or doing jobs on the side will probably owe self-employment tax. This is a Social Security and Medicare tax for reople who work for themselves.

If a financial institution, credit union or government agency cancels or forgives a debt of \$600 or more, the person who owed the money will get Form 1099-C showing the amount. This form is also sent to the IRS. The canceled amount is income and must be reported on the tax return.

Everyone's Income Is Taxable

Anyone who earns or receives income from sources in the United States needs to determine if they must file a tax return. This applies to everyone, not just U.S. citizens or residents.

Foreign Income

U.S. citizens or residents who receive income from outside the United States must report all of it on the tax return unless all or part of it is exempt by U.S. law.

Unplanned Tax Side Effect

A special House panel is continuing work on a tax plan that would expand the state sales tax to more than 35 previously untaxed goods

But panel members learned their plan has an unplanned side effect: under prior law, local governments who wish to piggyback their own tax to new state sales taxes could do so. And doing so would shortcircuit Gov. George W. Bush's dream of cutting school property taxes in Texas.

State Rep. Paul Sadler, chairman of the Select Committee on Revenue and Public Education Funding, said, "We're going to make sure that if they raise additional tax revenue, they don't get to keep it."

So, the panel is looking at two ways of making sure: forbidding local governments from adding their own sales taxes to the new levies or forcing them to use the revenue to fix roads or cut city and county ad valorem taxes.

Without safeguards against "piggyback rides" on taxes by local governments, communities statewide would be able to add \$1.4 billion in new sales taxes to the \$6.6 billion they now collect in the state's two-year budget cycle.

Lawmakers have filed more than two dozen bills this session offering free or reduced tuition and fees at state public colleges and universities. Among the beneficiaries of such legislation would be children of veteran teachers, injured or disabled law enforcement officers and children in state foster care. # Lt. Gov. Bullock says it may
