SANTA ANNA HIGH SCHOOL OPENING


SUPERINTENDENT, TWELVE TEACHERS AND ABOUT 375 PUPILS BEGIN YEARS EDUCATIONAL WORK

As per schedule the Santa Anna public schools were opened last Monday morning with the entire faculty and about 350 pupils present. Other pupils have come in during the week bringing the enrollment for the first week up to about 375.

Very nearly every seat in the chapel of the new school building was occupied when Prof. Jones called order and announced the beginning of another year's school work.

After a song and invocation short but appreciative addresses were made by Bros. J. D. Allen, J. M. Yource and H. F. Brooks. Prof. Jones then announced to the school that the old order of splitting the grades in two would be done away with, except in the lower grades. Hereafter there will be no mid-term promotions. Prof. Jones gives as his reason for this change the fact that it takes three or four weeks to get the school in working order after the classes have been broken up for these halfgrade promotions.

RUSHING WORK ON ITS CUT-OFF SANTA FE BUILDING FINE RAILROAD FROM COLEMAN, TEXAS, TO TEXI-

CO, N. M.

The Santa Fe cut-off which is being constructed from Coleman, Texas, to Texico, N. M., is being completed, according to officials of the Santa Fe in this city. Trainloads of steel and ties are being rushed to the scene of tracklaying near Sweetwater. In the construction of this line only the heaviest of steel is being used and the most substantial of ties. Every tie has two tie plates and eight spikes. Temporary wooden bridges put in by the system on this line just before the track was laid are being removed and modern reinforced concrete structures are taking their places.

Nearly all of the proposed depots have been completed from Coleman to View City, and a gang of linemon are now stringing telegraph wires along the

line.

MAKING AN EXCUSE OF HARD TIMES

Money is not going to be as plentiful in Coleman county this fall and winter as it is when crops are good. It is evident now that quite a few people will not be able to meet their debts as they had planned. Some will make the shortness of the cotton crop an excuse for not paying even as much of their indebtedness as they could pay, thereby imparing their credit and injuring themselves. Fortunately these are in the minority. The great majority will pay every cent of their indebtedness possible, thus enabling their creditors to pass the money on and on to others, until presently a part of it will come back to themselves to be used again. The man who frankly and fairly does the best by his creditors that it is possible to do under the circumstances will get through any kind of hard times without embarrassment to himself or to them.

A man recently said to a prominent merchant of Santa Anna: "I had the money and could have paid you my entire account in 1907, but things looked so bad I thought probably. I might need the money myself." It is just this, brand of selfishness that makes hard times harder and panics more panicy. s interest on them, and received no salary The merchant in question was literally forced to carry this debt twelve months longer than he had agreed to do. This was doing the merchant a great injustice in order to secure for himself a very doubtful advantage: In this instance the merchant was able to carry the debt, but many a man has gone bankrupt because those whom he had trusted did not pay even what they could have paid.

Merit never comes through good luck and a noble character is never molded through chance.

THAT DEPOSITORY ARTICLE

It may seem to an outsider that a newspaper man ought always to be able to express himself so plainly that no one could misconstrue his meaning, but every editor, no matter how careful he is and no matter how good his intentions are will occasionally have his words misconstrued even by his friends.

In an article in last weeks paper the News showed how the school board was making a clear saving of \$150 per annum in handling the school funds. We thought this commendable so we said: "This is pretty good economy the school board has adopted." We meant this as a compliment to the board. Imagine then our surprise when a member of the board accused us of speaking these words in irony and as a criticism of the action of the board. He is a friend of the News and wouldn't have accused us of this if he hadn't really thought the article was written in a spirit of criticism. He was kind enough to accept our word when we explained that the sentence was written in commendation and not in irony, or with any thought of irony.

In another feature of the same article, however, we really did another man an injustice. We stated that last year was the first year that the school funds drew interest, when as a matter of fact Mr. W. R. Kelley kept the funds the year before and paid five per cent for his work. We knew this at the time we wrote the article but somehow it slipped our mind. All we can say in extenuation of this injustice to Mr. Kelley is that it was wholly unintentional and that we regret it more than anyone else does.

A REMARKABLE RECORD

On another page of this paper our readers will find a review of the work of the Campbell administration, outlining briefly the more important legislation passed since Gov. Campbell has been in office. The laws passed during this administration have been severely criticized by some of the city dailies-who, by the way, usually stand closer to the big corporations than they do to the people. -and by men whose unholy grafts have been disturbed by this legislation. In addition, quite a good many honest people have been led by the city press to believe that the financial interests of the state were being injured and that foreign capital was being driven away by Gov. Campbell's administration. In view of the wonderful industrial and educational progress the state has made in the last four years it is strange that any man could be led to accept such an idea.

We are inclined to believe that ninetenths of those who disapprove of the legislation passed during Mr. Campbell's administration get their opinions secondhanded. If, among all these laws, any of our readers can find half a dozen that are objectionable and ought to be repealed we shall be glad to have you write the News pointing out these particular laws and stating why they are objectionable. It is very difficult to make a law that is absolutely perfect and it is more than likely that some of these laws are defective in some particulars but as a whole we consider them the finest lot of laws ever made during any administration in the history of the state. And so far as we are able to see no legitimate business interest has been injured—indeed why should any honest business fear any just law? On the contrary millions of outside money has flowed into the state and has found honest, profitable and safe investment, and tens of thousands of immigrants have found nothing in our laws to deter them from making the Lone Star state their home.

A NEW POLITICAL PARTY

Last week's elections have assured us that a new political party has arisen within the nation. The victories of the insurgents over the stand-pat Republicans in Wisconsin, Michigan and New Hampshire added to the victories previously achieved in Kansas, Nebraska, Iowa and California are proof sufficient that these so-called "insurgents" have already attained to the proportions of a national party.

These insurgents differ as widely from the old line Republicans as the Democrats do--indeed there are some Democrats who were more in accord with Cannon and Aldrich during the last session of Congress than were the insurgents, who are really in sympathy with many of Mr. Bryan's ideas of government, and who had much rather see the Democrats triumph than their ancient enemies, the stand-pat Republicans.

Mose Henderson, an oldtime darkey who lives at Americus, Georgia, invited a number of local attorneys to a rattlesnake feast Tuesday of this week. Mose insists that there is nothing so juicy and toothsome as a well-cooked rattlesnake and he wanted his white friends to enjoy this savory dish. It is said that many of the older negroes esteem the rattlesnake very highly as an article of diet, claiming that its flesh is even more delicate than fish or chicken. Uncle Mose showed good judgment in inviting the lawyers. Two years ago Maine went for Taft by more than thirty thousand majority and elected a solid Republican delegation to Congress. Monday F. W. Plaisted, the Democratic candidate for governor of Maine was elected by about seven thousand majority and three or four. Democratic candidates for Congress were elected. This is the first time that Maine has elected a Democratic governor in thirty years. There is every prospect of the next Congress being Democratic by a good majority.

BRIEF RFVIEW OF CAMP-**BELL ADMINISTRATION**

IN SPEECH BEFORE THE LEGISLATURE GOVERNOR CAMPBELL REVIEWS HIS ADMINISTRATION

On invitation of that body, last Friday, Goy. Campbell addressed a joint session of the State Legislature.

For lack of space the News cannot give his speech in full, but the following review of the work accomplished during his administration is of so much historical value that we reproduce it for the benefit of our readers. Gov. Campbell spoke as follows:

'A brief review of legislation and of the policies enforced during the present administration is probably expected and is deemed appropriate on this occasion. Four years ago I received from the Democracy of this state the nomination for governor. With the nomination went a platform of principles and policies, which not/only met my approval, but which represented the heart and conscience of the great toiling and producing masses of our people. I was elected at the general election in November, 1906, and with me was elected a legislature that will, for its useful service and its fidelity to the people, ever be memorable in the history of this great commonwealth.



CHAPTER FIVE.

Miscellaneous provisions.

Art. 22. 
