This Week in Our Town

"That new Methodist preacher, Bowman, is surely a hard worker," remarked one of our business men Monday. "He is doing things up right: not letting things drift to suit his congregation, but laying down the program and pushing it through to completion, which is just an example of good business, common sense business." Bowman is building up his church wonderfully well.

"We'll be straightened out in a few days," remarked Dennis Hayes, who has just moved his grocery and market from the small room adjoining the post office to the larger one formerly occupied by the Pick & Pay. Dennis has built up a nice little business during the past few months and expansion in floor space became necessary. Dennis features better grades of meats in his market.

"Coldest winter we've had in many years," remarked Dennis Kelley Tuesday morning. "We have had some cold weather in past years, but this spell seems to outdo them all. Possibly because the wind is so keenly penetrating." Others made more or less similar statements. Temperature on the north and the south side of main street varied from 8 to 10 degrees; when the sun shone, the direct rays on the north side melting the snow while on the south side it was still freezing. Tuesday at mid-afternoon 24 degrees on the south side and 32 on the north was observed. Snowfall was all of 4 1/2 inches on the level.

"Those school kids are sure prizing up h—er, the snow—down at the corner," commented a snow-encrusted gent just as a lady stepped out of a doorway Monday afternoon. "They are snowballing everybody that comes along, are rolling some of their number in the snow, and having a hiyu time." Hear they rolled most of the men of the teaching staff. Too, reports say Pat Neff was rolled down at Waco.

"We are moving our display room to the second door east of the old location," stated the Willys representative Monday, "and want you to tell the good folks of Santa Anna where we are to be found so they will not think we have moved out." The Willys people have put a dandy car on the market and a local representative should be able to make many sales this spring.

Coleman Co. News Briefs

A crew of eight men is busily engaged this week in surveying wheat farms in Coleman county that are included in the 1940 wheat program, under the direction of the Coleman County Agricultural Conservation Association, states E. E. Hirsch, secretary of that organization. Members of the measuring crew include C. C. Burns, Y. B. Johnson, Odus Powers, William R. Brown, Ed Featherston, S. T. Burkett, Robert J. Thwing and Oliver W. Calk.

Records show that the Coleman county office of the Texas State Employment Service made 471 private placements and 491 public placements, which is a grand total of 5257 for the year of 1939. This figure includes temporary work on farms and ranches. Personal visits to the office amounted to 38,130 which shows how many people depend on the office for employment.

A broken leg received last Christmas night while playing in the snow at Denver City resulted in the death last week of Roy M. Tipton, 36, oil field worker. Mr. Tipton had been residing and working at the Texas-New Mexico border oil town for the past several months, retaining his home in the meantime at Coleman. Survivors include his widow, Mrs. Jewell Hartman Tipton, one daughter, Willie Mae, and three brothers and one sister.

J. C. (Jimmy) Marshall, formerly of Austin has accepted the position of assistant secretary-treasurer of the Coleman Production Credit Association. Mr. Marshall succeeds Aubrey Herberg, who resigned the position of assistant secretary on January 15.

J. P. Miller, Coleman ranchman, is the new polling superintendent for the Central Colorado Soil Conservation District, according to an announcement made by R. G. Hollingsworth of Coleman, former chairman of the district. Mr. Miller, present chairman of the district, was elected to the new position at a conference held at Hotel Coleman. Approximately 10,000 ballots are to be printed for the forthcoming election to be held within the conservation district, with 5,000 of those ballots to be used in Coleman county. Mr. Miller was named, delegate to the forthcoming District 5 convention which is to be held at Hillsboro on February 6.

Reginald Owen of Santa Anna recently was re-elected vice-president of the Central West Texas Log Roller's Association in convention at San Angelo.

More than 2,000 cotton allotments, 1940 model, are being mailed to Coleman County farmers, according to E. E. Hirsch, secretary of the Coleman County Agricultural Conservation Association. The 2,018 farmers receiving the allotments will learn there has been a 3 per cent reduction as compared to last year.

Promotion of Corporal Hugh C. Stoup to the rank of sergeant Air Corps, has been announced at Hamilton Field, Calif. Stoup is a native of Coleman, is a son of E. D. Stoup of that city.

Organization of a group of young adults into the Sunday Evening Forum has been concluded in Coleman, according to Rev. Robert F. Jones, pastor of the First Presbyterian Church. The group was organized from young people interested in religious trends and social questions and its members meet on Sunday evenings, after twilight services at the First Presbyterian Church.

All-American John Kimbrough and one of the Texas A. & M. assistant coaches will attend the Coleman high school football banquet slated for early in February.

Suicide Verdict in Tragic Death of 12 Year Old Schoolboy

The lifeless body of 12-year-old William J. Tucker Jr., was found Sunday hanging from a rope to garage rafters at his farm home in the Mukewater community. He was the son of Mr. and Mrs. W. M. Tucker Sr.

Justice of the Peace C. Gintz of Bangs returned a verdict of "death by his own hands from hanging."

The body of the school boy was found by his mother, when he failed to answer her calls. Mrs. Tucker had baked a cake, and her son had asked permission to clean the icing remaining in the bowl after she had finished. He was told to wait until the cake had been completely iced. He had not been remonstrated.

Mrs. Tucker tried to remove the still warm body from its hang-rope, but was unable to do so alone. She called her husband who was in the house and together the two frantically unfastened the rope and took the body to the house. Neighbors were called but when help came it was, too late.

An older brother, Ernest, was away from home when the incident occurred.

The inquest verdict was withheld until Monday morning when the investigation was completed and Justice Gintz returned his verdict.

Funeral services were set for 2:30 o'clock Monday at the Bangs Baptist church, Rev. Neal Greer officiating, with burial in the Clear Creek cemetery. Survivors are the parents and one brother.

County Agent Steel pointed out that the snow would probably help the ranges.

Capital stock of the First State bank at Talpa may be increased at a meeting of stockholders Feb. 17, according to H. E. Evans, president. Present stock is \$20,000. The amount would be increased to \$25,000 by the payment of a \$5,000 stock dividend.

New officers of the Coleman Y.O.P. were installed last week by District Deputy Grand Master R. L. Baugh and staff of Bangs. W. H. Watson is noble grand; Arthur Flippen, vice-grand; and R. L. McKenzie, secretary.

Joe Hext, 1939 football captain at Howard Payne has accepted a position as athletic coach at Talpa High School. Supt. Glynn Mitchell will continue coaching basketball for the remainder of the season.

Centennial High School students are attending classes in the Valera elementary school, according to County Supt. W. T. Graves. The Centennial building, a frame, six-room structure, was destroyed by fire last Thursday morning when a flue became over-heated.

The Short quadruplets of Jasper, Ala., were \$1,000 richer today after receipt of a check from M. C. McGehee, Houston, Texas oil man. Another gift came from Texas. It was four sweaters sent the three girls and boy by Mr. and Mrs. W. E. Badgett, the parents of quadruplets born in 1939.

The "West Texas-to-Coast Highway Association" was the name officially given to the new organization formed recently at Austin for the purpose of instigating the building of a highway from Austin to Brady via Llano.

Brown County Agent C. W. Lehmberg announced that arrangements have been made for animals shown in the Brown County Boys Fat Stock Show in Brownwood on Monday, Feb. 12, to be shipped to Fort Worth and be disposed of at a special sale on Feb. 13. All exhibitors who have animals in the shipment will be given free trips to Fort Worth.

Central Texas' underground wonderland, the Richland Springs Cavern, celebrated its reopening on Sunday. The cavern was cleaned and redecorated by Lon P. Piper of San Antonio, owner. A new lighting plant was installed. It was once a prime attraction which attracted tourists from all over the South-west and was temporarily abandoned with the destruction of its light plant six years ago.

Miss Mallie Kilgore, Brown County deputy district clerk, has completed preparation of the civil docket list of cases pending before the 35th District court which convenes in January term on Monday, Jan. 29. The docket contains 201 civil cases.

Brown county poll tax payments, were brought to 2,229 Friday when 16 persons braved the below freezing weather that prevailed all day to qualify themselves for voting in this year's elections.

Money derived from that annual Presidents Birthday Ball and from other organizations has made it possible for the Brown County Crippled Children's Committee to provide help for 85 crippled children. It was announced, included in the 85 are 20 cases of infantile paralysis. As much as \$200 has been spent on a single case in an effort to restore to health and happiness a child who otherwise would be a helpless cripple for life. Still other cripples have been provided rehabilitation thru the means of learning trades that may make them self-sustaining.

Seven McCulloch County boys left the forefront of the week for points in Arizona after having finished in Brady in the CCC.

The Brady City council is to proceed with the numbering of houses within the city limits. The body in session this week requested the city secretary to work out a plan, working up maps and designating numbers for each lot, street, and block.

All committee chairmen were reappointed for the Brady 15th Meet. July 3, 4, and 5. The committee men will meet shortly to select assistants and formulate plans for the forthcoming celebration.

Registration for the second semester at Howard Payne college began Monday with more than 500 students enrolling the first day, college officials said Tuesday.

SINCE THE WORLD WAR THE battle between the individual and the state has become intense, bitter. The rights and liberties of millions of people have been overthrown and may very easily be not if we do not place therefor "totalitarianism" in the hands of a few men and the men who grasped the power of life and death over their fellow-men have become gods. The humanitarian, social and cultural values men fought for through the generations are being destroyed. Few of us realize that in this country are a lot of people whose purpose it is to make the state the master and subdue the individual to a state of servility. We are permitting our basic rights, one by one, to be placed in the government, where some bureau head can dictate our every action and hold supreme power to enforce his dictates and punish protestation against the enslaving of freedom. Either we maintain our free democracy, free enterprise, free speech, free press, or submit as a beaten enemy to whatever penalty our victorious conquerors desire. We are either for a free nation or an enslaved nation of slaves - we mean there is no middle ground. We set up a government to be our servant, manage our affairs, enforce our laws, preserve justice. Now we slowly are turning over all our rights to a few bureau chiefs with permission for them to do with it as they will, and are no longer being just to do their duties. And all this seems a rather minor thing when you think of the millions who want just to satisfy the vanity of a Napoleon or Caesar throwing Christians to lions, burning them at the stake, torturing them on the rack. pay a whopping lot more for this great religious weekly. Under the "home-consumption" system we do all that work here at home, so you save all the difference and get the same thing you would under the system of supporting outside interests while putting your own out of business. If you must do charity, just make them a donation and spend the difference on T-bone steaks and fish and other edibles. WERE STILL FEELING THE shake administered when an effort to organize a chamber of commerce here was made by the News, at the request of several business people who thought it more appropriate for the paper to sponsor the matter instead of an individual or two, whose motives might be misconstrued. It was a terrific shock to find that of the twelve on the committee only three attended and only one person was interested sufficiently in the matter to make an inquiry as to what was done or what had become of the proposition. It was a shock that is only exceeded by the report of some one criticizing the News as talking a lot and doing nothing. The News is in no position to go out and haul in the business men of the town and force them to organize, neither is it going to combine a chamber of commerce by itself. Albert, we know the criticism does not represent the sentiment of the business men. It rankles. Every business man in town knows a C. Crump needed and needed badly. We all know the Lions Club cannot devote the time and money necessary to even play at functioning as a chamber of commerce. A lot of opposition developed in several agencies headed by C. Crump because of a certain attitude of existence of the Lions Club. As a member of that club and not wishing to see it harmed, or having it would be harmed, the question can be asked, what has the Lions Club done for the city in a commercial way? It has answered some letters, sent out some literature. A private business firm could do that. The Lions Club was never intended for commercial secretarial work and because for some reason a sympathy exists against a chamber of commerce, the Club is forced to do what it can. That is an unjust, unexcusable imposition upon the Lions Club, as we see it.

SANTA ANNA HAS A NUMBER of dairymen who own herds of tested milk producers and who deliver milk to customers in Santa Anna at live and let-live prices. With a plentiful supply, a lot of milk is imported at a rate higher than the usual Santa Anna milk producer. In other words, we hire an outsider to collect Santa Anna milk for delivery at our homes so the local milk producers can earn less money. Very fortunate this being so solicitors of corporations in other towns. The buying of milk and cream is their business. The selling of creamery butter, ice cream and other of the milk products is their business. That's legitimate and all fair and square. But when we sell our milk to them at one figure and then pay a relatively high profit for having it hauled to another town to be bottled and then hauled back to our doorsteps, something is rotten in Denmark - and it isn't the concern that gets paid for hauling milk two ways, but the individuals who prefer to pay the two way hauling instead of having it delivered direct. That is reducing your grocery bill, running our money out of town so someone else can pay taxes in another town while we are just that much short of meeting ours. Suppose we set up all of our type, then sent the type to Brownwood or elsewhere to be formed and the paper printed, then hauled back to us. You'd

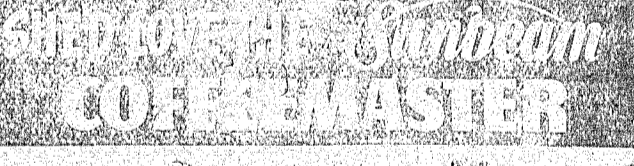
