

THE FIRST PHASE of the Watergate hearings are scheduled to end this week.

Some people have followed the television coverage of the hearings faithfully and have possibly learned a lot about some of the things that go on in the nation's capitol.

Others have continually complained because regular programing has been interrupted on the TV networks. The loudest complaint has come from the soap opera addicts, and from our point of view no program on the air could have a better soap opera plot than Watergate.

Just watching and listening would leave the impression that Washington was rampant with corruption, and there is no doubt that there is plenty going on that we don't approve of. However we must not lose sight of the fact that we have some good men representing us. This district has been very fortunate in being represented by some good men. dating back to the days of O. C. Fisher, followed by Omar Burleson and now Bob Poage. If other districts had been represented as well, then we can't help but believe that this country would be in better shape than it is now.

In fact, the entire Texas delegation is above average, and most all of them are men of character, serving their constituents in a manner that reflects the point of view of this area.

There was some enlightenment in the hearings when it was stated that some members of Congress enter the floor in no condition to serve their people. It was indicated that some "tottered to their seats too drunk to make a competent decision on anything."

Even though congressional district are large and it is hard to really know our representative, it seems to us that the voter could remedy that situation. It is hard to believe that such conditions would not be known to the people of the district represented by such a congressman or senator, and that the people would send a better representative to the national body.

Of course Washington isn't by itself when it comes to corruption. We have had our share in Texas and probably there is no government body of any stature that does not have its share.

What we, as voters, need to do is learn our candidates and when we cast a ballot for any official for anyoffice, we should be reasonably sure that he is the type of man we want to represent us, regardless of office.

If we have let our elective offices be filled with dishonest people, we can blame no one but ourselves. They get into office one way—that is through disinterest of the people.



risk to the environment. The practice being revived is strip-cropping, reports the National Cotton Council, but in the Sooner State it's being given a new twist.

In four years of tests, Oklahoma State University re-searchers have found that planting strips of sorghum with cotton increases the population of beneficial insects and reduces the need for

What happens is that harmful insects build up in the

sorghum and beneficial preding off an old conservation ators move in to eat them. Later, the predators follow the remaining insects into the cotton.

> Scientists believe stripcropping can eliminate at least two or more sprayings a season. While they view the practice as a major advance in cotton pest management, they point out that it is not effective in controlling the boll weevil.


> Experiments are under way to breed cotton plants with some resistance to the weevil, but researchers say many problems are yet to be resolved in this time-consuming approach.

### Fraud By Mail

To Eddie, the idea seemed like a sure thing. He mailed out phony invoices to a number of businessmen, billing them for ads they had never ordered, and waited for the money to roll in.

Some money did. But so did two federal investigators, who haled Eddie into court on a charge of "using the mails to defraud." In short order he landed in jail, following the path of countless get-rich-quick artists who have run afoul of the United States Post Office.

Under our legal system, most crimes are local. Robbery and riot, murder and mayhem ordinarily come under the jurisdiction of local governments.

But mail fraud is federal business, because the Constitution gives exclusive control of the postal system to the federal government.

Of course, to constitute the crime, the fraudulent scheme must include some significant use of the mails. However, that need not be the central feature. Consider, for example, the case of a man who used chicanery to sell lots in a cemetery. All of his sales were made in person, not by mail.

But he followed up with letters to his customers, partly to allay their suspicions and partly to discourage them from taking him into court. Such use of the mails, a court ruled afterward, was enough to support a federal charge against him for fraud.

Still, there must really be fraud, not just deft salesmanship. In another case a woman was accused of mail fraud because she had been selling "lucky stones" through the mail.

But at the trial, she pointed out that she had made no claim of magical virtues for her product—beyond the name itself. Dismissing the charge, the court

"There is nothing immoral in the belief that amulets affect the wearer's fortune. If (the defendant) wishes to sell lucky stones for what they are, without lying about them, she is not acting fraudulently in so doing."

When the month of August rolls around, thousands of Texas mothers suddenly realize that only a few more weeks remain until school begins.

Parents with youngsters beginning school for the first time this September, look forward to school with a little more excitement, and many mothers whose first-born are going off to school may be a bit bewildered by

In addition to the million-andone chores that must be performed in getting the youngster ready for school-new shoes, clothes, health examination - most school districts require proof of age for beginning students. A certified copy of a birth certificate is usually requested, reports the Texas State Department of

This fall there will be 221,100 new first graders in the schools througout Texas, with the total public school enrollment expected to reach 2.805.300. Continued growth of the school population is expected for the next two to three years, according to the Texas Education Agency. In addition, there will be 78,700 children enrolled in public school kindergartens.

Anticipating the rush of birth certificate requests, the Records and Statistics Section of the Texas State Department of Health has been prepared for it. Requests already are pouring in.

It takes a sizeable staff just to open the thousands of letters received daily, let alone search out a requested certificate,

remove it from the thick volume. make a certified copy, mail it out and then return the original certificate to its proper place.

Years of experience have eliminated nearly every bottleneck. The operation is smooth and fast. Usually the copy is mailed within 3 or 4 days after the request is received.

One bottleneck still remaining, however, is the individual who makes the last-minute request. Parents are requested to stop now and write for a certified copy of the birth certificate, or contact either the city registrar where the child was born or the county clerk in the county of birth.

In most cases it is an easy matter to make a trip to your county courthouse or registrar and personally request a certified copy of a birth certificate. The county clerk's office has birth records on file, as well as countless other documents.

If you write the Texas State Department of Health, Bureau of Vital Statistics, the address is 410 East Fifth Street, Austin, TX, 78701. Be sure to include the

child's name, his place of birth, the date of birth, and names of the parents-including the mother's maiden name. The State, Health As Memorials Department fee for a certified copy of the birth certificate is \$2.

Filing of birth certificates is just one function of the Records and Statistics Section of the State Health Department. Records also kept of deaths, diseases and other public health information.

There are more than 13 million birth certificates on file in the state office, and the tabulation of birth certificates is a neverending process. Last year, for example, there were just under 222,000 live births recorded in

Largest number of live births for Texas in one year was recorded in 1957. That year 249,567 babies were born alive in Texas, and their births are recorded in the Records and Statistics Section.

Just maintaining records of current births and deaths is a mammoth task. In order to do this, the statewide system includes 1,000 local registration officials who collect these records. All of these must be carefully indexed to expedite the hundreds of thousands of searches that must be made each year to process applications for birth verifications and certification.

This sounds complicated, and it







House members suggested a new voting machine (which was later ordered) and new desks for delegates. Senate planning committee spokesmen indicated they would be satisfied to bring their own desks over from across the capitol rotunda and set them up in the House middle aisle.

The revision panel agreed:

To keep the provision for real property taxation in the constitution for state purposes, but leave it t the legislature to write separate laws governing personal property taxation.

To retain the state highway users gasoline tax, with threefourths to the revenue earmarked for highway building ans onefourth for public schools. A provision was made for abolishing the highway fund levey on statewide referendum with support of two-thirds of the legislature.

To keep the Permanent University Fund and Permanent School funds in the constitution. The university fund would be altered somewhat to include present and future branches of the University of Texas and Texas A&M University.

To add to the constitution a guarnatee of "equitable" financial support for all schools and districts rich and poor.

To retain as constitutional elected members of the executive branch only the governor, lieutenant governor and attorney general, with the legislature empowered to decide if the comptroller, treasurer, secretary of state, land

commissioner and railroad commission should be elected or appointed by the governor.

CLOSED-Two "HOUSES" landmark bawdy houses-in La Grange and Sealy-were closed by local officials on request of state officials.

Gov. Dolph Briscoe, Atty. Gen. John Hill and Department of Public Safety Director Wilson E. Speir sought action after reports aired by a Houston television

Briscoe acknowledged he had received calls from La Grange area citizens both supporting and opposing the action. He said he had been told he would be petitioned by a group who want the famed "Chicken Ranch" reopened.

Hill and Speir said they found no link with organized crime in operation of the houses, but Attorney General Hill added: "It is an illegal operation. The local officials were requested to take action. They took it."

RATERAISE EXPECTED - An increase in some workmen's compensation insurance rates is due under a new law increasing benefits for those injured or killed in job accidents.

An average 19.5 per cent hike in the rates employers must pay for the coverage is anticipated under a State Insurance Board staff proposal, which would become effective if approved between September 1 and September 15.

Rates would have gone up 22.8 per cent in the absence of the federal anti-inflation program, a Board actuary indicated.

Under new law effective September, an injured worker can get up to a maximum of \$63 a week in benefits, an increase from the present \$49 top.

AGOPINIONS - A national bank does not come under definition of governmental bodies or institutions which are required to comply with the new open records act, Attorney General Hill held.

# Coleman County Has First Case Of Screwworms

Coleman County has recorded the first case of Screwworms this year. The confirmed case was southwest of Coleman near Valera.

Texas recorded well over 600 cases of screwworms by the end of July, and indications are that the number will climb during the next few months. Hot summer weather and recent rains have spurred the spread of screwworms throughout the state.

From now until mid-November is considered the crucial time for the screwworm program. Livestock and pet owners are urged to be alert for infestations and send worm samples of suspected cases to the Mission, Texas laboratory.

Infested herds of livestock are being sprayed free of charge, and sterile fly drops are being made in the areas where cases have been reported.

Collection kits for suspected screwworms are available at the county extension office and from livestock inspectors and veterinarians.

# 63 Years Ago ... in The News

The following story was clipped from an early issue of the NEWS, probably published about 1910. A HORSE THIEF

Last Saturday afternoon a man giving his name as John Taylor and his place of residence Rogers, Texas, rode into the cityon a nice looking bay horse which he endeavored to sell to 2 or 3 different parties. Finally he heard that John Banister was wanting to buy a horse and went out to his place to see him. In the meantime Hiram Wilson saw the horse and recognized him as one that he made an unsuccessful attempt to buy from Elmer McCoy of Brownwood. He called McCoy up by phone and was informed that he had hired his horse, saddle and bridle to a young man in Brownwood that day and said he would not sell the animal at all. This information was communicated to Constable Jim Scott, who went in search of the stranger for the purpose of arresting him. Pretty soon he rode up on Main street and stopped in front of Kirkpatrick's feed store. Scott walked out and caught the horse by the bridle bit

withhis left hand and at the same time grasping his quarry by the arm with his right hand and commanded him to dismount. Instead of obeying the command, he struck Scott over the head withhis bridle reins and attempted to run the horse over him. Jim held on like grim death until J. R. Banister appeared upon the scene and helped take the man off the horse to land him in city holder.

holder.

Brown County deputy Allen carried his prisoner of Coleman and placed him in jail. Sunday morning, seeing that the coast was clear, climbed on top of his cell and with the aid of a shovel soon punched a hole through the ceiling and climbed up throughit to the attic, and walked across girders to a scuttle hole whichopened an avenue of escape down the stairway. Reaching thelarge outer door of the jail he unlocked it and walked out..

At the time of his departure Sheriff Futch was out of town and the jailer was at the depot awaiting the arrival of the morning train. LATER—Since the above was put in type we are

informed that Sherrif Futch after a chase of about 85 miles, recaptured his prisioner and now has him safely housed in the county bastile. The sheriff of Callahan County assisted in the capture. Foot sore and weary from constant walking, the fugitive had sought rest in a farmer's hack and was within eight miles of Baird when the officers appeared on the scene and took him in charge. Sheriff Futch is rather small in stature, but he is of elephantine proportions when it comes to executing the mandates of the law.

# Price Controls Encourages Black Market

WASHINGTON — A law which is unworkable and not generally acceptable to people is mostly unenforceable.

Although the ceiling on beef at the retail level is not a law passed by the Congress, it is a regulation imposed by the Cost of Living Council, The Administration which the Cost of Living Council represents, is empowered under the law to impose price controls.

The affluent society in which we live is going to buy beef somewhere or somehow. Beef comsumption in the last few years has increased from 155 pounds to 234 pounds per capita in the United States. With population increases and with individual

incomes up, consumption has soared. This does not mean, of course, that everyone can afford it and is going to pay any price demanded, but it is the average and the average has to be depended upon.

Some meat wholesalers are calling the meat sales in some places as coming from the "black market." Others prefer to say it is only, as yet, a "gray" market but predict that transactions in this area will become more numerous. Other ways are being found in the trade to compensate for what they can sell a steak for and what it would bring without a ceiling price by simply letting the steak carry a tale that somehow appears on the scales.

By whatever name, reports or

illegal beef sales and purchasers are numerous and are predicted to increase as cattle slaughterers and meat supplies shrink under the Administration's continuing beef price freeze.

One gimmick being worked is the practice of buying cattle in the United States, shipping them to Canada for processing then selling dressed carcasses in the United States as "imported" meat which is uncontrolled by Phase IV ceilings. The legality of such transactions is under discussion at the moment. The chief legal advisor of the Cost of Living Council is reported to consider the finished beef brought back from Canada as illegal and not "imported" if it originates in

the United States livestock markets.

There are other "gray" market transactions, some of which appear to be legal, others questionable and some apparently illegal. When no objection is raised by either the purchaser or the seller, it is pretty difficult to get at enforcement. It becomes sort of a "hear no evil and see no evil" approach. If the purchaser of a steak wants it enough and has the money, he is not likely to pester the retailer to bring the price down. Like some other

unpopular laws, most everyone involved quietly avoids discussing the legality of the transaction and, in instances, does not really want to know.

Othr methods of avoidance are reported, such as ordering 1,000 pounds of choice beef cuts at ceiling prices but being billed for additional poundage to make up for costs not allowed by the ceiling.

The practicalities of the situation must cope with ways to circumvent the price ceiling. Meat wholesalers are telling the Cost of Living Council numerous ways to get around their regulations. One, for instance,

says that he can order choice. well trimmed brisket at a certain price. He will be told that they are out of it but that they have some "special brisket" available at 20 cents over the ceiling price for well trimmed meat. So, the purchaser gets the brisket but it is the same well trimmed quality available before.

The serious part of the whole business is that cattle will be held off the market, beef processors will curtail plant operations to wait to see what happens. Shortages follow and the scarcity runs up prices. Controls can not go on forever but when they are lifted a short supply will run prices still higher.
