LET'S HAVE A SOFTBALL LEAGUE

We are going to have a softball league in Santa Anna this summer. Every year since the war we have had a league here and so far as this writer knows, they have been a big builder for our city. The league last summer didn't work out so well, but we can profit by our mistakes and go ahead and have a good league here this year.

It looks to me like we could get representatives from several organizations here in town, such as the Lions Club, the Chamber of Commerce, the American Legion, the Fire Department, the VFW and other organizations who might be interested in sponsoring a team, to meet some night and invite all our surrounding communities to have representatives at the meeting and get a softball league organized.

As a usual thing, softball games are a good drawing card to a city. If we do not organize a league here, our citizens are going to be going to our neighboring cities to see games and some of our ball players will be playing with other teams, and the larger part of them would rather play here, but they are going to see and play ball regardless of whether we have a team or not. All our neighboring cities have already laid plans for their leagues. Most of them have started, their practice seasons and will be playing before we get started, unless we call a meeting and get things underway within the next few days.

There has been several talked to me in the past few days about what we were going to do about a ball league here. It might be that one organization could start the league by calling a meeting of all interested in playing ball. I am sure we could get a good turnout and it would not take a whole lot of work on the part of any one individual.

If someone, or some organization, will take a leading part in getting a league organized and call a meeting by the latter part of next week or the first part of next week, I believe we can get most parties interested informed of the meeting and I believe we can get one started right away.

There has been some discussion as to whether it would be permissible to use the football field to play softball on. At the last meeting of the school board they voted to let the field be used if it was turned over to some responsible party.

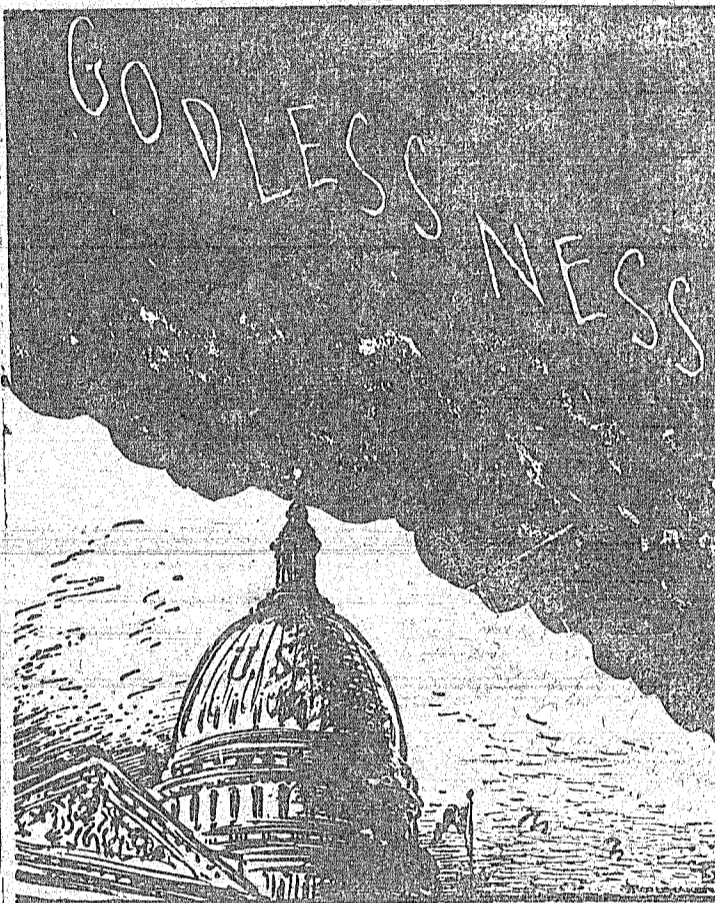

Water Restrictions Again Imposed On City Use

Elsewhere in this issue of The News is a notice to all water users concerning the restriction of the use of water in Santa Anna. According to the City Officials these restrictions will be strictly adhered to.

Some of the provisions of the new water regulations may sound pretty tough to some who have not been very careful of the use of water since it has been so scarce, but for the benefit of all the City Commission has deemed it necessary to raise the water rate for domestic consumption after the minimum amount of 2000 gallons has been used.

The minimum rate at present is \$1.75 for 2000 gallons. This rate will remain the same, but after the minimum has been used the rate will be 50c per 1000 gallons.

After Thursday of this week there will be no more washing of cars where the cars are washed with city water and lawns, gardens, etc. will have to go without water also. In fact it is prohibited to use the city water for any use other than strict domestic use.

Part three of the new regulations provides that any user of water who uses water for any use other than domestic will have his service disconnected without further notice.

The City Commission believes that under these regulations we will have water for domestic consumption for the summer and the regulation will be enforced to the word.

Our water situation is in a very critical situation. However all that is possible to do to alleviate the situation is being done. We can be thankful that so far we have not been up against it as bad as a lot of cities have, and that we have some men working with the water that are doing everything they possible can to ensure us enough water for the necessities of life.

Lions Club Entertains Large Number At Show

Approximately eleven hundred persons were entertained by the Lions Club the first two days of this week at the Negro Minstrel at the High School Auditorium. This was two nights showing with the house filled to overflowing the first night and a house full for the second showing.

This is a new kind of entertainment for Santa Anna and it is expected that the Lions may make it an annual affair.

The net proceeds are expected to run close to \$700.00, which will be used to complete the Livestock Show Barn. This will not be enough to complete the barn, but will go a long way.

S. A. Wool Ass'n Makes First Sale Of The Year

The Santa Anna Wool Association sold their first car of wool for this season this week to W. F. Drake, Jr., of San Angelo at from 53c to 61c per pound. The car weight was 30,000 pounds.

Mr. O. L. Cheaney, Secretary of the Association, said the season looks like it will be a good one and the market is going to be alright.

This car was early clip wool.

The City Officials announced this week that the annual Spring Clean-Up Drive will begin Monday morning, April 19. They request that each of you pile trash that won't burn where it can be picked up by the trucks that will canvas the town. The drive will last until all trash has been picked up.

It is hoped that all citizens of Santa Anna will cooperate in this city-wide clean-up campaign. The Clean-Up Drive is sponsored by the city of Santa Anna and the Chamber of Commerce. Members of the local Fire Department urge that during this clean-up drive, that you also remove all fire hazards from your home and premises.

The Chamber of Commerce officials, along with representatives of most major oil companies, request that all service stations join in the clean-up drive. They ask that service stations particularly clean up rest rooms and keep them that way. This is a drive that has been in progress for some time now and is being very effectively put over.

We are up against a hard situation concerning our water, but we can show that we are interested in the cleanliness of our city by joining in this drive and keeping it clean after the drive is over.

The officials of the drive ask that you burn all rubbish that will burn and pile all the rest of it where it will be easily accessible to the trucks that will pick the trash up. You are requested not to burn trash on a windy day and when you are burning it to stay close to the fire where you can keep a careful watch. Do not try to burn more than you can watch. Due to dry conditions in this area you should be particular careful about burning trash where the fire might spread.

Control Hoppers While They Are Young, Co. Agent

The grasshopper season is just ahead of us says Herman E. Jenkins, County Agriculture Agent. Mr. William J. Spicer of the Bureau of Entomology made a check for grasshoppers last week and found that some of the hoppers were hatching, especially around Valera. The grasshoppers will not hatch very readily until we get rain, but they will probably hatch in great numbers if we happen to get a few showers.
 Jenkins said the time to control the hoppers is while they are young and before they do too much damage to the field crops. The bait mixing station will operate again this year and it will start distributing poison bait any time the infestation of hoppers warrants it.
 Here are a few things that should be observed by farmers putting out poisoned bait. First, the bait should be broadcast about daylight or before the hoppers leave the ground and get upon the plants.
 Second, the bait should not be allowed to dry out; if it does, it should be brought back to the station and remixed. The farmers should not try to rewet the bait because most of the poison will be washed out and concentrated in a small amount of bran.
 Third, the poison bait should not be put out in piles or bands. It should be broadcast over the entire infested area, forming a thin covering over the ground. If the poison bait does not give a good kill, there are two more effective poisons that can be used but they will be more expensive than sodium floursilicate bait. These poisons are as follows: A 20 percent toxophene dust applied at the rate of 10 pounds per acre will give a very effective control over hoppers. It will probably cost about \$2.50 an acre. The other poison is

chlorodane and should be applied in the form of a 10 percent dust at the rate of 15 pounds to the acre. This will give satisfactory control and will cost about \$3.50 an acre. The mixing station will be at the Co-op Gin warehouse again this year. If it rains soon and grasshoppers start bothering crops the station will start distributing poison bait.

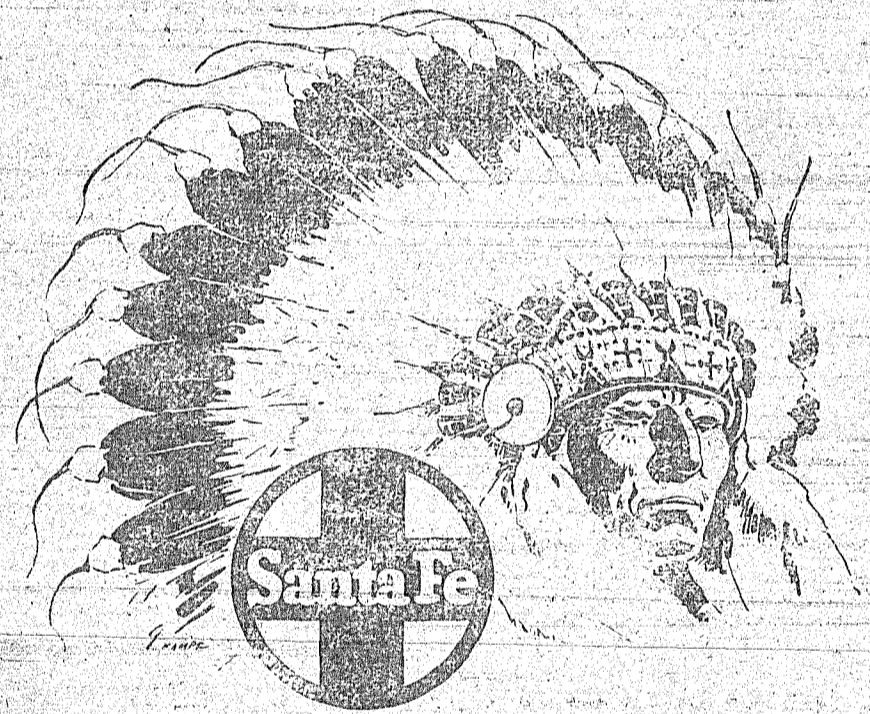

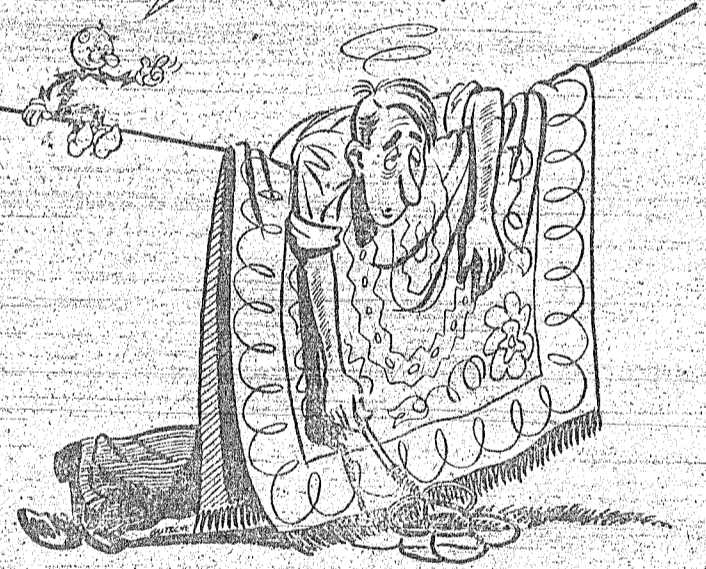

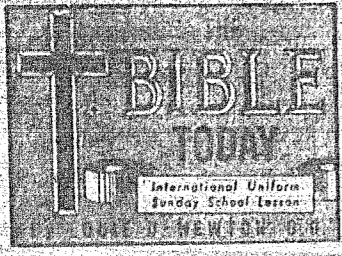

DEVOTIONAL: PSALM 124

The Return From Exile.
Lesson for April 18, 1948

COWPERS' lines come to mind as we study the dramatic return of the Jews from their exile in Babylon to Jerusalem in the first year of the reign of Cyrus, king of Persia, 536 B. C.

"God moves in a mysterious way His wonders to perform; He plants his footsteps in the sea And rides upon the storm."

And yet it is not altogether strange, for if you will turn to Jeremiah 29:4-14, you will find a prophecy given 56 years before the event that this very thing would occur.

There were two other deportations of the Jews from Babylon, prior to the incident in our lesson—the return led by Daniel, 605 B. C., and the one led by Ezekiel, 597 B. C.

THE proclamation of Cyrus, Ezra 1:1-5, records the happy word to the Jews that they would not only return, but that the temple would be rebuilt. Cyrus called upon all the people who would to make offerings by which the temple might be restored. Cyrus was acting under divine impulse in this gracious and generous proclamation.

The Lord God of heaven hath given me all the kingdoms of the earth, and he hath charged me to build him an house at Jerusalem, which is in Judah," said Cyrus, Ezra 1:2.

Fifty thousand Jews, their hearts rejoicing at the thought of returning to the land of their fathers, set out on the trek of 600 miles laden with gifts from the Persians for the restoration of the temple in Jerusalem. They could now sing the song of the Lord, and no longer did their harps hang silently on the willow trees.

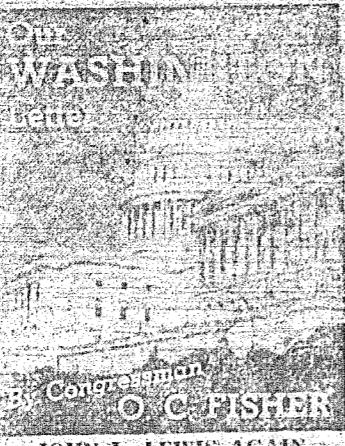
THE DECREE OF ARTAXERXES THE fourth chapter of Ezra brings us to the halting of the work in the temple, after they had raised the magnificent sum of approximately \$100,000 and had laid the foundation for the temple, with imposing ceremonies.

STICKING TO ONE'S PURPOSE WE come now to the part Haggai played in summoning the Jews to their duty and obligation to God to restore the temple. It was in the second year of the reign of Darius that Haggai received the word of the Lord: "Is it time for you, O ye, to dwell in your ceiled houses, and this house lie waste? Now therefore thus saith the Lord of hosts, Consider your ways."

GOD'S PURPOSE FULFILLED THE message of Haggai was heeded. The temple was completed, Ezra 6:13-18, and God's purpose was fulfilled. Read Psalm 126.

This brings us to the golden text: "No man, having put his hand to the plow, and looking back, is fit for the Kingdom of God." Luke 9:62. When once the returned exiles felt the iron of God's purpose surging through their veins, they quitted themselves like men, and God's power was everywhere manifest. So may it ever be with us!

page was a "coincidence", but a fact-finding board appointed by the President found that the letter from the Mine Union Dictator amounted to a strike order.

What are the facts? The Taft-Hartley law requires that in case of welfare funds for union members, such funds should be administered by a joint board of trustees comprised of three men—one appointed by the union, one by the employer, and the third to be agreed upon by the other two. That was done, and Lewis was selected to represent the miners. Ezra Van Horn to represent the coal operators, and one Thomas E. Murry was chosen for the third member of the board. But Murry resigned in January and Lewis and Van Horn haven't been able to agree on a successor.

Lewis demanded of Van Horn that he agree upon a pension of \$100 per month for 60-year-old miners with 20 year service records. Van Horn objected, saying that would deplete the \$22,000,000 welfare fund and nothing would remain for sickness and accident benefits provided for in the current contract. So an impasse was created and Lewis called the strike because Van Horn wouldn't let Lewis dictate the terms of the pension program. In an attempt to settle, Van Horn offered to go with Lewis to a Federal Judge and let the latter name a third trustee, so they would not be deadlocked. But Lewis was not interested. He preferred to strike.

How what has happened. Up to the time of this writing the miners out on strike have lost approximately \$100 million in wages. This is about three times the total amount of the accumulated welfare fund which is the pretended basis for the strike. The miners lose \$4 1/2 million in wages every day they don't work.

So it becomes very evident that the alleged reasons for the strike are phoney. Lewis has refused to bargain or negotiate, and as I pointed out on the floor of the House the other day, he is now "evidently engaged in one of his periodic public theatrical exhibitions put on for the purpose of showing the power and control he holds over the 400,000 members of the Mine Union." I have urged additional laws to curb such irresponsible

conduct by a union leader. An injunction proceeding is now going on, but that is a treatment of the symptoms rather than the disease. Until conduct such as Lewis engages in is brought under our anti-monopoly laws, just as our anti-monopoly laws in restraint of trade are controlled, and the industry-wide power Lewis now uses is controlled, the public welfare will continue to be subject to the whim of irresponsible labor bosses. And not only the public suffers but the members of the unions and their families take a terrific beating.

The House last year passed a bill to bring Lewis under the anti-monopoly laws and to curb his industry-wide monopolistic power, but those provisions were stricken in the Senate. That sort of a law is badly needed at the present time.

It was he who not for a tough policy toward Russia. That's the only way for you to keep her in line; get tough."

Masaryk was a devout Christian. It is believed these words of the Apostle Paul to the Galatians were in the mind of Masaryk in the moments before his death: "Stand fast therefore in the liberty wherewith Christ hath made us free, and be not entangled again with the yoke of bondage."

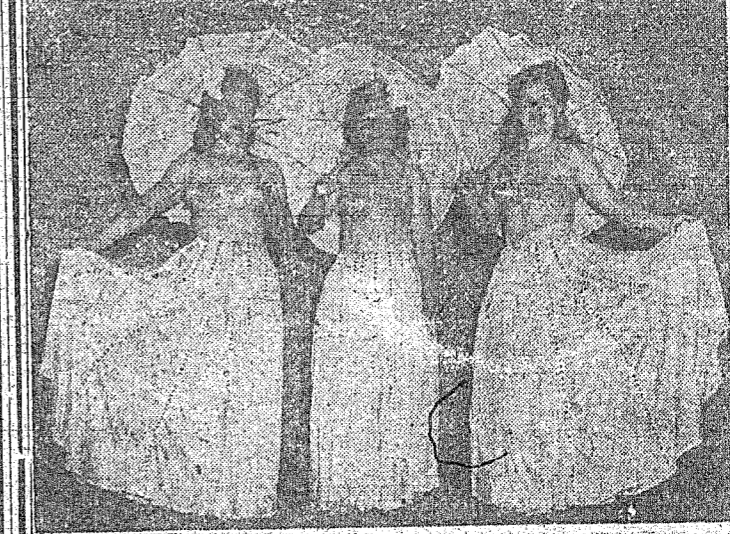

Drunken Driving On Increase Despite All Laws Forbidding It

(This is the fifth of a series of 10 articles on street and highway safety, written by nationally recognized accident prevention specialists and published by this newspaper in the interests of greater traffic safety.)

Operating a motor vehicle on streets and highways while intoxicated is universally prohibited by law, yet accidents by this cause are on the increase. A driver who has been drinking is found to be involved in one out of every five fatal traffic accidents in the United States.

Pedestrians, too, have contributed to this bad record. One out of every four adult pedestrians killed last year had been drinking.

That intoxication is now one of the leading causes of death and injury on the highway is unquestioned.

Control of the drinking driver problem has been complicated by a number of factors. First, enforcement is hampered because it is difficult to identify those who are under the influence of alcohol until some

error in driving has been committed or an accident occurs. Then, too, lack of public consciousness of the seriousness of the problem has delayed the establishment of effective countermeasures. Law enforcement which does not have substantial public backing has always failed in this country. The fact only a very small percentage of the populace, in all probability, is fully aware of the gravity of the intoxication problem in its relation to motor vehicle accidents has had a pronounced retarding effect upon the legislator, police officer, prosecutor, judge and jury.

Coupled with these basic problems are others of exceptional importance. The absence of needed legislation narrows the field of police investigation and necessarily limits the horizon of judicial decision. Again, loopholes in existing legislation permit the guilty to escape and, all too frequently, the innocent to suffer. Such a situation destroys

police morale and nurtures antagonism between the police, the prosecution and the courts. This, in turn, engenders an unfavorable public attitude.

Many drivers still believe the term "drunken driver" applies only to a person who is dead drunk or almost hopelessly disabled. Such is not the case, since persons who are very drunk are seldom able to drive at all. Investigations of accidents involving drinking drivers reveal that the greater menace is the individual who has drunk enough to have a false feeling of confidence. In reality, even a little alcohol slows down physical reactions to the extent of making a driver unsafe.

For example, a recent study revealed: first, that nearly half of the drivers involved in personal injury accidents had been drinking to some degree; and second, that the chances of such persons being involved in accidents increased so rapidly that the drivers with an alcohol con-

centration of 15 percent or more in his blood was 55 times more likely to become involved in a personal injury accident than the non-drinking driver.

Correction of this situation rests with public acceptance of the principal that "alcohol and gasoline do not mix." Competent scientific research has shown that human coordination (ability to carry out several activities at once) and ability to judge distances are affected for the worse when exposed to only a relatively small amount of alcohol.

Every driver owes it to himself, to his family, to the occupants of his car and to the users of the highway to refrain from driving after drinking.

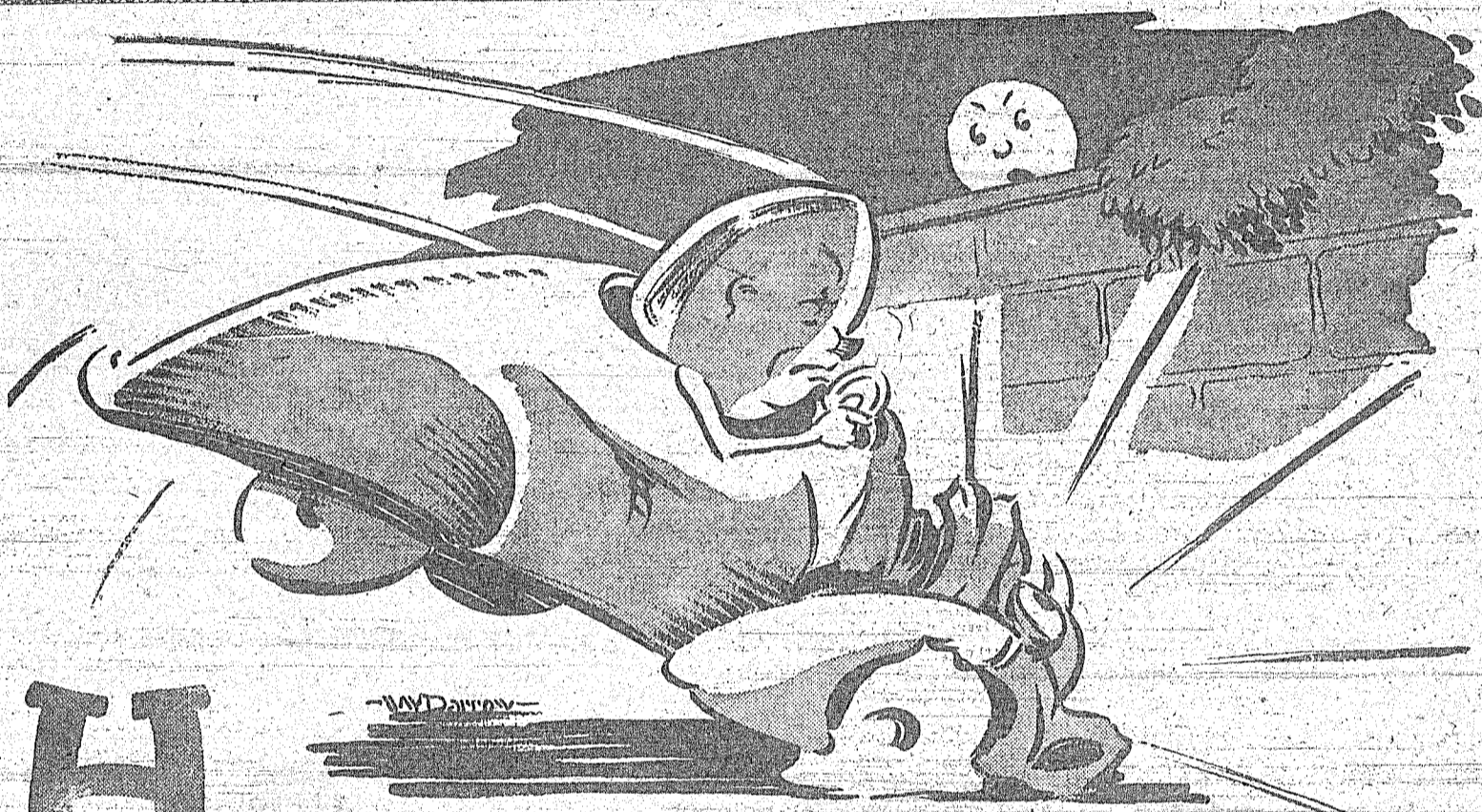

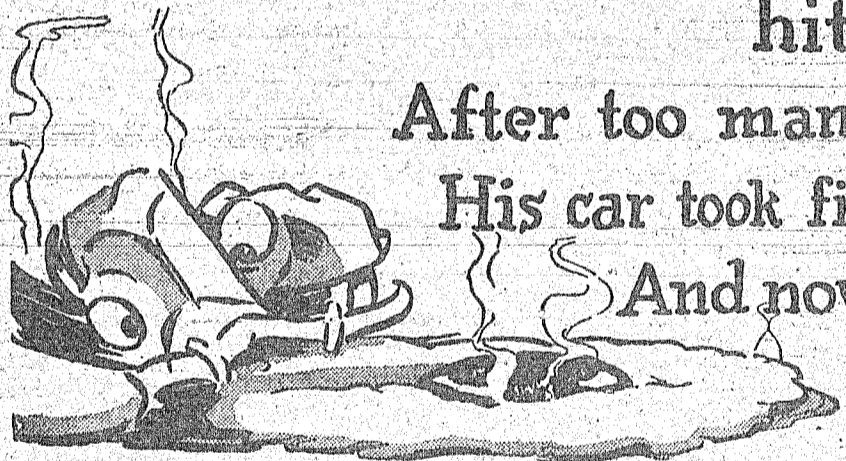


