



Panthers Lose To Baird; To Meet Rising Star Friday

The Gorman Panthers hosted the Baird Bears on Friday night and held the Bears in the first quarter until late in the second when the Bears scored. The halftime score was 7-0 but the Bears took charge in the second half and downed the Panthers 33 to 0.

The Baird score came with 2:37 left in the second period following a blocked Panther punt. The Bears got the ball on the Gorman 5 yard line then were called on a holding call which set them back to the Gorman 15. Then in just one big play Quarterback Jim Scott raced into the end zone on a quarterback keeper when the Panthers were spread out wide on defense. Britt Johnson kicked the point after and Baird held a 7-0 lead at halftime.

The Gorman and Baird bands did a fantastic job with their routines, bringing big applause from the fans.

Following the intermission the Bears got the kickoff on their own 46 and scored in just four plays with Shannon Campbell getting the final yard with 10:26 left in the third. Following runs of 19 and 5 yards and a 10 yard pass to Davenport for the score. The kick for point failed and the score was 13-0.

Then with 1:03 left in the third period the Bears scored again on a one yard run by Jim Scott. The Bear drive started on the Gorman 15 and took only 3 plays, plus a 15 yard penalty on Gorman. Johnson booted the point after and Baird led 20-0.

The Bears added another score with 8:22 left in the fourth when Travis Kenbow raced through the Panther defense for 35 yards. The kick failed and

the Bears were up 26-0.

The final Bear score came with 3:03 left in the game when Kerbow again ran through the Big Red Defense on a 31 yard scamper for the score. The score came after the Bears had recovered a Panther fumble on the Baird 49. It took the Bears five plays to get the score. Johnson added the point after and the Bears had a 33-0 District 8A win to stay undefeated in District play.

The Panther defense did a good job the first half holding the Bears to 5 first downs and 85 yards on the ground. But the Bears had drives of 67, 69, 64, and 17 in the last half.

The Panthers were led by Jeremy Bryan with 68 yards on 18 carries. Margarito Sanchez got 59 on 17 tries.

The Big Red Defense will be tested again on Friday night when they travel to Rising Star to wind up the regular season. The Wildcats have a fine team and the Panthers will really have to perform well to get a victory over the Wildcats

So let's all follow the Big Red to Rising Star on Friday and show them we are behind them no matter what.

Maxfield Achieves High Scores In **Past TAAS Tests**

Every year the TEA assess elementary schools' academic success based on their TAAS scores. Thus, Maxfield Elementary administration and teachers strive to effectively prepare students to perform to the best of their ability each spring. This past year, Maxfield Elementary students achieved high scores in reading, writing, and math and the school was just shy of being named a National Exemplary School.

According to Darvin M. Winick and Larry Toenjes out of the University of Houston, the TAAS scores alone are an unfair yardstick with which to compare schools because they don't take into account the diverse population of children within each school district. Thus, Winick and Toenjes have developed a rating system based on two numbers: the percentage of children who passed all sections of the TAAS test and the percentage of kids with educational or cultural disadvantages. They then compare schools with similar numbers and award districts a one, two, three, or four star rating. Stars are awarded based on the following criteria:

- One star if at least 30 percent of the students passed the TAAS test.

- A second star if the school ranked at or above the median passing rate on the TAAS test for schools with a similar percentage of disadvantaged stu-

- A third star if at least 70 percent of the students passed the TAAS test.

- A fourth star if the school had a passing rate on the TAAS test in the top 15 percent of schools with a similar percentage of disadvantaged students. Gorman received a four star rating in the November issue of Texas







So, if you are a parent making this important decision of whether your child is capable of taking care of themselves from the time school is dismissed in the afternoon until you get home from work . . . here is a simple CHECKLIST ABOUT SELF-CARE BY SCHOOL-AGE CHILDREN.

1. Is the child mature enough for particial self care? 2. Is the child willing to try partial self care? 3. Can the child handle problems that could arise? 4. Can the child communicate with adults? 5. Can the child handle common self care tasks? 6. Does the child feel secure and not afraid about being home alone? 7. Is there an adult nearby that could be reached in an emergency? 8. Is the neighborhood safe? 9. Is the household safe? 10. Has the child been prepared for self-care, i.e. what to do if someone knocks at the door, what information to give out/or not give out over the telephone, etc. (A "no" response to any of the above 10 questions indicates areas of concern).







SS or SSI Contuning **Disability Reviews**

If you're receiving Social Security or Supplemental Security Income (SSI) disability benefits, the law requires that your claim be reviewed periodically to make sure that you continue to be disabled. Generally, if your health has not improved or if your disability still keeps you from working, your benefits will continue.

Special funding recently authorized by Congress will permit Social Security to review the continuing disability of more than 1.3 million beneficiaries during 1996 and 1997.

Following are answers to questons we've received about the continuing disability review process:

How often will SS review my disability claim? That depends on your disabling impairment and whether it is likely to improve. Generally, your claim will be reviewed anywhere from six months up to seven years after you start receiving benefits. For example, if medical improvement can be predicted when your benefits start, your first review could take place within six to 18months. If medical improvement is possible, but can't be predicted, we will review your case every .three years. And, if your condition is unlikely to improve, your case will be reviewed only about once every five to seven years.

How does the review start? First, we'll send you a letter informing you of the review. The letter will ask you certain questions about your health, and will explain your appeal rights. The information you give us will help us decide whether further review is needed. If it is, we'll ask you to provide detailed information about any medical treatment you've had, and any work you may have done.

How will I find out about your decision? After the review, we'll sned you a letter explaining our decision, and the information we considered, if we decide that you're still disabled, On Tuesday Ina Scitern had a your benefits will continue. If we decide that you're no longer disabled, your benefits will stop three months after we informed you of our decision.

> What are some of the reasons that my benefits might stop? It's possible your benefits might stop if any of the following situations are true in your case: *New or improved medical tests show that you're not as disabled as you were when we reviewed your case in the past. Ensearch Seeks First RRC Rate Increase In 14 Yrs.

Austin -- For the first time in 14 years, Lone Star Pipeline Company Our sincere sympathy goes out to has asked the Texas Railroad Commission on Friday, October 25th to increase the rate it charges to transon Saturday, October 19th in the port gas to the 550 Texas cities it

The new combined rate, for purchasing, storing, and transporting gas to cities, would increase about 18 cents per thousand cubic feet (Mcf) or about 90 cents per month for the typical residential customer. This represents about a 3% increase for the typical customer. It is proposed to be effective November 29, 1996. The average monthly cost to a typical residential customer over a 12-month period ending June 1996 is \$2.20 lower than the same period the year Our sincere sympathy goes out to before because of a decline in the

> As part of a program to hold down costs, improve reliability and maintain safety, \$420 million has been invested in the Lone Star Pipeline system since the last such increase. The pipeline company has added two large underground salt dome storage caverns, which doubled withdrawal capacity. The company has also added three major compressor stations and has constructed interconnects with other pipelines to give Lone Star Gas greater supply options to lower gas costs and enhance supply reliability.

"We cannot predict what will happen to natural gas costs but we will continue aggressive action to reduce those costs to the lowest prudent level. The storage capacity we added assists in meeting Lone Star's peak Joe (Lewis) Shoemaker of De Leon winter demands from its residential and commercial customers and in lowering gas costs. Lone Star is able to buy gas for storage at seasonal prices that are much lower than market prices prevailing in the middle of the winter," said Mike Hunter, president of Lone Star Pipeline.

Lone Star Pipeline Company is operationally separated from Lone Star Gas Company. The Railroad commission regulates what Lone Star Pipeline Company charges to transport gas to cities. Individual cities regulate what Lone Star Gas Company charges to distribute gas to customers. Natural gas costs are determined contractually and in the market and are adjusted monthly.

Dick Williams, president of Lone Star Gas, which acquires gas in the field and distributes it, said the company is determined to make natural gas costs as affordable as possible for its customers.

"Lone Star rates for storing, transporting and distributing gas are very competitive and we are working hard to lower our natural gas costs. We still have some high-priced contracts, Sandlin, R. Lee McDaniel, Ruth dating back to the energy shortages Knowles, Elizabeth Sandlin and Billie of the late 1970's, but we are wringing virtually all those out of our sys-Dorothy Light returned home last tem within the next three years,"

> "According to a recent survey of 25 cities around the country, rates in Dallas, our largest service area, were lower than in 17 of those cities, which is good but leaves room for improvement. Our increase in storage capability and the end of an era of high priced gas purchase contracts should combine to improve Lone Star's ranking", Williams said.

According to the U.S. Bureau of Labor Statistics, inflation has driven up the cost-of-living 60% since 1982, the last time Lone Star sought a rate increase from the Railroad Commission. A GMC pickup that csot \$8,651 in 1982 is priced at \$22,500 today and the cost of pound of ground chuck at Tom Thumb has increased from \$1.28 to \$1.99.

"We believe our request for a rate increase is fully justified by the substantial increases in the cost of doing business over the past 14 years and by the substantial investment we have made to control costs, improve reliability and maintain the safety of our system", Hunter said.
