

Rev. Preston Frasier, 73, died at his home early Friday morning, December 13, when he was suddenly stricken. He resided at 308 W. Avenue N in Lovington, New Mexico. He had been in ill health for a long period of time.

Frasier was born November 21, 1912 in Comanche County and was united in marriagae to Elsie Pierce there on April 14, 1935. He was graduated from Howard Payne Uni-

Consumer Update

Christmastime is here again, and a festive atmosphere has taken the state by storm. Almost overnight, the Texas landscape has been transformed into a wonderland of tinsel-topped trees and multi-colored lighting displays, with a kindly Santa in every chimney.

After a brief absence during the energy crisis, bright lights and fancy decorations are once again an important part of our annual Yuletide celebration.

However, carelessness sometimes can cause these decorations to turn a family's happy holiday into a fiery nightmare. Last Christmas dozens of fires causing numerous injuries and thousands of dollars in property damage were reported in our

Most of these accidents are preventable, and the Public Utility Commission urges everyone to take special care when using Christmas decorations. Here are several ways you can make this holiday season safe and enjoyable:

• Do not use lights for outdoor decorations unless the lights are labeled for outdoor use. It is unsafe to use indoor electrical equipment outdoors.

 Check last year's lights closely for worn insulation, broken plugs, and strings of bulbs that no longer work. Replace any worn-out or broken equip-

Always unplug lights

you are using for decorative purposes whenever you leave your home or go to sleep.

• If you choose a live tree, select a tree that is firm and fresh, cut about two inches from the bottom of the tree, and place it in a sturdy, non-tip stand containing water. Check the tree daily to make sure it is not becoming too dry. Keep the tree away from heaters, stoves, fireplaces and other heat sources which may dry it out, and use only noncombustible or flame-retardant decorations. Remove and dispose of the tree as soon after the holidays as possible.

 If you have an artificial tree, use only non-combustible or flame-retardant decorations, and do not use lighted wax candles as decorations. Also, do not put electric lights on a metal tree. Metallic trees can become charged with electricity from faulty lights. This can cause shock or electrocution to anyone touching the energized tree.

Remember, Christmas decorations can be dangerous if used improperly. Taking special care when using these decorations will help you have a safe and enjoyable holiday season.

Social Security Administration to Issue Paper Check

DECEMBER 19, 1985

Social Security checks will have a new look on December 3, Glyn Hammons, manager of the Abilene Social Security office said today.

The familiar green punched-card checks that Social Security beneficiaries have been receiving since 1940 will be replaced with a new, more counterfeit-resistant cost-effective paper check.

The U.S. Department of Treasury's Financial Management Service the government's financial manager, began planning the paper check conversion project in the late 1970's because of new technology and the need to conform to generally accepted banking pracatices. Taxpayers will save \$6 million per year in costs of paper stock and storage space.

The new check is also more difficult to alter or counterfeit. More than a dozen security features--three times more than the old check--are contained in the design, the ink and the paper.

The design features a full-length reproduction of the Statue of Liberty on the left and a muted close-up of the Statue's head and torch on the right over a multicolored background ranging from light blue to pale peach. The letter "USA" create a



In last weeks article, I discussed the 2 part Medicare System and who was eligible. This article will concentrate on the Part A Hospitalization benefits.

Anyone can get Hospitalization benefits if you are 65 or older and are eligible for any type of monthly social security or railroad retirement benefit. You qualify if you have sufficient covered employment to be eligible for monthly retirement benefits even if you do not receive them because you are still working. Also eligible are age-65-or-over spouses of persons who are insured. Age-65or-over widows or widowers of deceased retirees or of deceased insured workers are also eligible if the worker was covered long enough at time of death to have met certain eligibility requirements.

You should apply for your Medicare card at your local Social Security office about 3 months before you become 65. Even though you cannot draw retirement benefits because you are still working, you should apply for Hospital Insurance. If you don't and are hospitalized, you can still receive benefits if you apply within one year, but payment may take some time.

If you did not contribute during your employment years to the Social Security fund you may elect to purchase Hospital Insurance coverage by paying a substantial premium. The premium changes every year but for 1986 it will be \$214.00 per month if you enroll at the earliest possible time.

In addition to the basic benefits for inpatient Hospital care, Hospital ed nursing facility care, home health services, and hospice care. You must pay part of the costs if you receive covered services. Many people carry additional private insurance-Medicare supplement policies-to cover some or all of the costs Medicare doesn't cover.

The amount you have to pay changes from year to year, depending on increases in the average cost of a day of hospitalization. The following description is based on 1986 amounts, which will increase in 1987. In no event will you have to ... Next article I will go into the Part pay more than the actual charges.

If you are admitted again within 60 days after being discharged from the hospital or skilled nursing facility, this represents a single benefit period, and you do not have to pay another initial insurance provides benefits for skill- deductible. However the hospital days in both periods count toward the 60 day maximum.

> After 60 days of hospital care in a benefit period, you can get an additional 30 days of care, but you must pay \$123.00 a day. After 90 days of hospital care, you may draw on your "lifetime reserve" of 60 days. For each day used, you must pay \$246.00 a day. It is up to you whether you want to use these reserve days or save them. Once used, the reserve days are not replenished.

1985 Crop Year **Insurance Period Ends December 31**

December 31 ends the 1985 crop year insurance period for peanuts grown in Eastland, Texas and insured by the federal crop insurance corporation (FCIC), or by a private company reinsured by FCIC, according to Ardell Kalmbach, a representative for the federal crop insurance corporation.

"Any notice of loss must be given no later than 30 days after total destruction of the unit, completiton of Harvest, or December 31, whichever occurs earlier," according to Kalmbach.

The producer who anticipates a claim should notify his or her crop insurance agent immediately.

"Under the terms of the policy, any acreage on which harvest will not be completed must be left intact until an inspection is made. Any claim for indemnity mayu be rejected if these loss reporitng requirements are not met," Kalmbach stated.




